Holyrood Parliamentary Motion

Jim Tolson: Settlement for Former Gurkha Soldiers (S3M-401) —That the Parliament expresses its deep concern at the UK Government's announcement of new guidelines for the settlement for former Gurkha soldiers, which limits applications for settlement to former soldiers who have served for 20 years or more or who have been awarded the highest military honours; acknowledges the support for the settlement of former Gurkha soldiers by former Gurkha officer, Major Bill MacKay of Dunfermline; further acknowledges over 70 years continuous service given by Sergeant Sunar Gurung, who served with Major Bill MacKay, and his six sons who all served with the Gurkha regiment, and believes that the UK Government's decision fails to recognise the long history of dedicated service to this country by Gurkha soldiers.

Fiona Mactaggart [270207]: To ask the Secretary of State for the Home Department what arrangements are made to provide childcare for women with children seeking asylum at the time of their first interview with the authorities.

Reply from Phil Woolas: Each UKBA Region has its own arrangements in place to ensure that every effort is made to ensure that children are not present when parents are interviewed about their reasons for seeking asylum. Arrangements can include rescheduling the asylum interview date to accommodate childcare arrangements, or provide childcare provision at or near UKBA premises where this is safe and sensible.

Where suitable alternative arrangements have proved impossible the asylum interview will go ahead with the child present. In these cases, the case owner will offer sufficient breaks and will fully note any disruptions on the interview record.

Karen Buck [261862]: To ask the Secretary of State for the Home Department how many people have been registered as British citizens in each English local authority area since 2005.

Reply from Woolas: The available information is shown in Annex A.

The data shows the number of registrations as a British citizen. This is broken down by the local authority which was responsible for performing the Citizenship Ceremony for those applicants over 18, who were successful in their application for British citizenship.

We are unable to provide a similar analysis for applicants under 18 years of age and these applications are shown as "Unknown". This total relates to all areas of the UK and not just England. These are applications from minors who apply direct to the Home Office, not in conjunction with a parental application. Minors are not required to attend Citizenship Ceremonies and consequently the information is not collated by local authority and could be obtained only by the detailed examination of individual case records at disproportionate cost.

The information has been provided from local management information and is not a National Statistic. As such, it should be treated as provisional and therefore subject to change.

Claire Curtis-Thomas [269155]: To ask the Secretary of State for the Home Department what assessment has she made of the effects on the economy of migrant labour; and if she will make a statement.

Reply from Phil Woolas: We know that migration has made a huge contribution to the economy and the Treasury estimated that in 2006, new migrants added around £6 billion to the economy. Even during the recession migration continues to play an important role in the UK but there needs to be a balance and we are giving greater support to domestic workers so that we can all come through the recession stronger.

Lord Tebbit [HL2953]: To ask Her Majesty's Government further to the Written Answer by Lord West of Spithead on 30 March (WA 191) concerning the average cost of deporting an illegal immigrant, what is the cost of not deporting illegal immigrants.

Reply from Lord West of Spithead: While research into the costs of illegal migration has been undertaken, this has been conducted with the aim of making general assessments on the impact of such migration, rather than producing definitive financial figures.

The two most relevant recent studies are the report of the House of Lords Select Committee on Economic Affairs regarding the economic and fiscal impact of migration which was published in October 2007 and a Home Office research paper entitled *Migration: an Economic and Social Analysis* which was published in 2001 and is available on the Home Office website.

Ian Davidson [265820]: To ask the Secretary of State for the Home Department when the worker registration scheme for nationals of Eastern European EU member states is due to expire; what options to extend it there are; whether the Government have taken a decision on an extension; and if she will make a statement.

Reply from Phil Woolas: On 8 April I announced that the UK Government would retain the worker registration scheme for a further two years, subject to a review in 12 months' time. Reply from Phil Woolas: In 2008, 375 Zimbabwean nationals were removed or voluntarily departed from the UK to Zimbabwe.

John Mann [271777]: To ask the Secretary of State for Communities and Local Government what provision she has made in her Department's budget for the integration of migrants for the next six financial years.

Reply from Sadiq Khan: The Department for Communities and Local Government has budgeted £50 million in the period 2008-09 to 2010-11 to support integration and community cohesion and to assist local authorities in preventing and managing community tensions. This includes £7.5 million to develop inter-faith activity and £4.5 million to help schools and others offer positive activities for young people. CLG has also contributed £50,000 in start-up funding to help the East of England Development Agency develop an information portal to help migrants find out more about living and working in the UK.

Communities and Local Government is also co-ordinating the allocation of the new cross-government Migration Impacts Fund. This will provide £35 million in 2009-10 to local services managing the transitional pressures of migration. It will be paid for through increases to migrant fees. Subject to a review in the autumn of the economic position and the migrant fees being received, a similar amount will be made available in 2010-11.

Viscount Waverley [HL2867]: To ask Her Majesty's Government (a) how many individuals wishing to enter the United Kingdom via the Eurostar service from Paris have been refused entry by United Kingdom immigration officials over the last four years due to falsified or invalid documents; and (b) following such refusals, on how many occasions have the same individuals reappeared with identical documents on a subsequent occasion.

Reply from Lord West of Spithead: (a) The total number of passengers that were refused leave to enter the United Kingdom at the juxtaposed controls in Paris from 2005 to 2008 was 9,069. 1,475 of these refusals were due to inadequate, falsified or fraudulent documents.

(b) All travel documents that are presented to UK Border Agency officers at the juxtaposed controls that are deemed to be falsified or fraudulently obtained are immediately seized by UK Border Agency officers and subsequently passed on to the French Police Authorities. The only exception is in the case of a British falsified or fraudulently obtained document; these would be seized and passed to the National Document Fraud Unit or Identity and Passport Service in the UK. In all cases, the presented documents are not returned to any individuals. We have no record of any individuals reappearing with the same documents being represented for entry into the UK.

Mark Oaten [271292]: To ask the Secretary of State for the Home Department what estimate she has made of the *(a)* resources required by the UK Border Agency (UKBA) to implement the requirements of Tier 4 of the points-based immigration system and *(b)* cost to UKBA of administering the requirements of Tier 4 in each of the next three years.

Reply from Phil Woolas: While the UK Border Agency continues to work with its supplier, the information requested is, at present, commercially sensitive.

Reply from Phil Woolas: The sponsorship management system (SMS) will be available from autumn 2009 for all sponsors to trial the gradual roll-out of issuing confirmations of acceptance for studies (CAS) and the associated reporting duties across migrant application types.

Mark Oaten [271295]: To ask the Secretary of State for the Home Department pursuant to the answer of 12 March 2009, *Official Report*, columns 636-7, on immigration controls: educational institutions, what criteria were applied in respect of the decision to require overseas students applying for courses to demonstrate that they have maintenance of £800 for each month of the course if studying in London, or £600 for each month of the course if studying is a reflection of student spending.

Reply from Phil Woolas: The maintenance requirement set for students studying in or outside London under Tier 4 uses the figures contained in the British Council's report "Welcome to the UK—Studying and living in the United Kingdom 2007-08". These figures were based on 2004 prices, and include the cost of accommodation, heating, lighting, food, clothing, books and daily travel for one person for a nine month academic year.

Fiona Mactaggart [258465]: To ask the Secretary of State for the Home Department what the average length of time to decide on applications for asylum received has been since 2006.

Reply from Woolas: The latest available figures show the average time to initial decisions for asylum cases decided in 2006 was eight months and in 2007 was seven months. The average length of time (in months) is calculated from date application is lodged to the date of initial decision, and relates to the year in which the decisions were made. The average figure for 2008 will be available at the same time as the annual publication in August 2009.

Information on asylum is published annually and quarterly. Philip Davies [270818]: To ask the Secretary of State for the Home Department what recent estimate she has made of the likely effect on the number of claims for asylum of permitting asylum seekers to work whilst their cases are being determined.

Reply from Phil Woolas: It is not our policy to allow asylum seekers to work. The Government believe that managed migration is a valuable source of skills and labour to the British economy and there are recognised routes into the UK for those seeking to work. However, entering the country for economic reasons is not the same as seeking asylum and it is important to maintain the distinction between the two.

We believe giving asylum seekers or failed asylum seekers permission to work would be likely to act as a pull factor and encourage asylum applications from those without a well founded fear of persecution, hence slowing down the processing of applications made by genuine refugees and undermining the integrity of the managed migration system.

The only exception is asylum seekers who have been waiting 12 months for a decision where this delay cannot be attributed to them.

Keith Vaz [252404]: To ask the Secretary of State for the Home Department what steps her Department takes to prevent members of the British National Party (BNP) from holding posts in the UK Border Agency (UKBA); and what steps the UKBA takes in circumstances when an employee is found to be a member of the BNP.

Reply from Phil Woolas: Recruitment applicants for permanent posts in UKBA are not required to provide any information about their political allegiance. However, every civil servant is expected to uphold the standards of conduct set out in the civil service management code and the civil service's anti-discrimination rules and a robust line will be taken with anyone who fails to do so.

Reply from Phil Woolas: Membership of the British National Party is not banned in the UK Border Agency. Any behaviour related to the aims and values of that organisation, which contravenes either the Civil Service Management Code or Home Office policy, will be dealt with appropriately. Any manager in grades Executive Office or equivalent and above may instigate disciplinary action.

Damian Green [269166]: To ask the Secretary of State for the Home Department which countries are on the Fast Track Processes Suitability List for asylum applications.

Reply from Phil Woolas: Section 94 (4) of the Nationality, Immigration and Asylum Act 2002 makes provision for a list of countries from which asylum or human rights claims must be certified as clearly unfounded unless the Secretary of State is satisfied that they are not.

The countries currently on the list are as follows: Albania, Bolivia, Bosnia-Herzegovina, Brazil, Ecuador, India, Jamaica, Macedonia, Mauritius, Moldova, Mongolia, Montenegro, Peru, South Africa, Serbia and Ukraine.

Gambia, Ghana, Kenya, Liberia, Malawi, Mali, Nigeria and Sierra Leone are on the list in respect of applications from men only.

Reply from Phil Woolas: The Government have ruled out an amnesty and this remains our position. An amnesty would be unfair to those who are here legally; it would act as a pull factor for even more attempts at illegal immigration; and it would counter the achievements of the UK Border Agency in toughening up our border and immigration system.

Reply from Phil Woolas: The number of unaccompanied child passengers who have been refused entry at the juxtaposed controls, since their introduction in 2004 are as follows:

(a) Paris—a total of 75 unaccompanied child passengers were formally refused entry.

(b) Brussels—a total of 29 unaccompanied child passengers were formally refused entry.

Reply from Lord West of Spithead: The attached table below shows the number of in-country applications for indefinite leave to remain on the grounds of 10 years and 14 years long residency since April 2003. It also shows how many of those applications were subsequently granted indefinite leave to remain on this basis.

The figures quoted are not provided under national statistics protocols and have been derived from local management information and are therefore provisional and subject to change. The individual figures and have been rounded to the nearest five.

Lord Hylton [HL2975]: To ask Her Majesty's Government in what ways the Gateway Programme and the Mandate Refugee Programme assist the re-settlement in the United Kingdom of refugees from Iraq, particularly those who have worked for United Kingdom armed and diplomatic services; and whether they are providing details of these programmes to other European Union member states.

Reply from Lord West of Spithead: The UK operates the Gateway Protection Programme and Mandate scheme to provide settlement to refugees from around the world, including Iraqi refugees. To date, the Gateway Programme has assisted more than 430 Iraqi refugees to resettle in the UK, of whom more than half worked for the United Kingdom armed and diplomatic services or are their dependants.

We regularly share information about our resettlement programmes with other European Union member states within the auspices of the global UNHCR annual tripartite consultations on resettlement and more informal information-sharing networks.

Baroness Gardner of Parkes: To ask Her Majesty's Government how many Gurkhas will qualify to live in the United Kingdom in consequence of the recent Home Office announcement.

Reply from Lord Brett: My Lords, this Government recognise the courage, commitment and sacrifice that the Gurkhas have given this country; indeed, they brought in rules for the first time giving ex-Gurkhas the right to settle in the United Kingdom. Based on the revised guidance published on 24 April 2009, the Government provisionally estimate that over 4,000 Gurkhas and 6,000 of their dependents will meet the new qualifying criteria for settlement.

Baroness Gardner of Parkes: My Lords, I thank the Minister for that Answer, but did not the Government fail to appreciate how extremely divisive the announced criteria would be? I am thinking of the requirement to have served for 20 years, when only officers are allowed to do so, with 15 years being the maximum for others. In view of the Government's defeat yesterday, will the Statement later give all the information necessary? Will the changes that will be proposed as a result of yesterday's defeat become effective immediately or will we have a date for when they will come into force?

Reply from Lord Brett: My Lords, the Government take seriously the role and views of Parliament. Therefore, a Statement was made in the other place yesterday evening, which I will repeat later today. On numbers, one of the major difficulties seems to be the estimate from those who are supporting the Gurkhas that only 100 people would benefit from the new government proposals, whereas the Government's estimate, which was based on Ministry of Defence figures, was 10,000, as I have just outlined. The test of this will be the examination of the 1,500 outstanding cases, which my colleague in the House of Commons, the Minister responsible for this, said would now be completed by the end of May. That will give us a much closer estimate and enable us to see who is correct—those who are very pessimistic about the number who will enter or those in the Government's ranks who believe that the number will be in the area that I mentioned. Any new policy has to await the urgent examination of these cases and take account of the debate in the other place yesterday.

Westminster Parliamentary Question

John Bercow [271643]: To ask the Secretary of State for Communities and Local Government what assessment she has made of the outcomes of her Department's consultation on a framework for inter-faith dialogue and social action within local communities.

Reply from Sadiq Khan: Following an extensive consultation process, my Department published "Face to Face and Side by Side—a Framework for Partnership in our Multi Faith Society" in July 2008. The aims of the document were to create more local opportunities both for 'face to face' dialogue between people from different religious backgrounds, and for 'side by side' collaborative social action.

We are making very good progress in implementing the framework. For instance, we will shortly be announcing the innovative local inter-faith projects around England which will be receiving funding under round 1 of the £4 million Faiths in Action scheme. We have invested £3.5 million to support the capacity of regional faith forums. We are working with the Inter Faith Network for the UK to deliver inter-faith week, a week of activities in November which will celebrate and promote inter-faith activity at local, regional and national level. A number of other commitments on the framework are also being taken forward.

Equality Bill

Maria Eagle (Parliamentary Secretary, Government Equalities Office): Some people experience discrimination because they have a combination of protected characteristics. For example, black women can face discrimination because of stereotyped attitudes or prejudice, which white women and black men in the same circumstances would not encounter. This type of discrimination is known as multiple discrimination. Currently discrimination claims can only be brought in respect of a single protected characteristic. This means that for some people who experience multiple discrimination it is difficult, complicated and sometimes impossible to get a legal remedy.

In the Government response to the consultation "Discrimination Law Review: A Framework for Fairness Proposals for a Single Equality Bill for Great Britain", published on 21 July 2008, we committed to exploring whether provisions for multiple discrimination could be included in the Equality Bill.

Following this consultation, we have developed a proposal, enabling claims combining two protected characteristics. We are now seeking views from industry, business and all interested organisations on the impact of our proposals through the publication of our discussion document, "Equality Bill: Assessing the impact of a multiple discrimination provision—A discussion document".

This document outlines our proposals in detail. It will form the basis for discussions seeking broad views, particularly from business and organisations, on the impact of a multiple discrimination provision. In particular, we are asking specific questions on the burdens the provisions may impose, particularly on employers, and the steps we can take to minimise those burdens.

The discussion will take place over the next six weeks. In the light of the discussions, we will decide whether protection from multiple discrimination should be introduced and if so how, taking into account progress on the Equality Bill which we have published today.

Advisory Panel on Judicial Diversity

Jack Straw (Secretary of State for Justice and Lord Chancellor): The challenge of forming a diverse judiciary is substantial. The work of the Judicial Appointments Commission's (JAC's) Judicial Diversity Forum and proactive trilateral work between the Ministry of Justice, the judiciary and the JAC has made this clear. While the JAC has encouraged more diverse applications to the judiciary and the efforts of the trilateral work have meant that we are now seeing increasing numbers of women and black and minority ethnic applicants for judicial office, progress has been slower than we would like. Given the personal commitment of the Lord Chief Justice and the chairman of the JAC to this cause, we need a better understanding of the factors behind this relative lack of progress and a clear agenda for how we move forward.

I have therefore decided to establish an advisory panel on judicial diversity to be chaired by Baroness Julia Neuberger with the following terms of reference:

To identify the barriers to progress on judicial diversity and to make recommendations to the Lord Chancellor on how to make speedier and sustained progress to a more diverse judiciary at every level and in all courts in England & Wales.

In considering this question the panel will:

- Examine the nature of the problem.
- Consider research undertaken on the UK system as well as considering international comparators.
- Draw on the lessons learned from current initiatives, including the JAC Judicial Diversity Forum and the follow up work from the Lord Chief Justice's conference on "A Judiciary for the 21st century".
- Draw up a list of practical measures that could be taken, identifying those that could happen quickly and those that would require legislation.

The panel is asked to report to the Lord Chancellor no later than November 2009.

The other members of the panel are Lord Justice Goldring, Professor Dame Hazel Genn, Andrew Holroyd CBE, Winston Hunter QC, Dr Nicola Brewer.

This will be work that must bring together and make the best use of the combined expertise of the senior judiciary, the JAC, the legal professions and diversity and equality advisors to identify how we can make swifter progress to a judiciary more reflective of the communities it serves.

John Bercow [271640]: To ask the Secretary of State for Communities and Local Government what progress her Department has made in improving the visibility of Black male role models since December 2007.

Reply from Sadiq Khan: The REACH report recommended that the Government should take action to improve the visibility of positive black male role models. The panel who wrote the REACH report envisioned a network of 20 national champions who would be used to challenge negative stereotyping, and support a network of black male role models in local communities. We have been working very closely with members of the REACH panel to ensure that their vision is realised.

On 3 December 2008 Communities and Local Government launched the National Black Role Model Programme, and announced the names of the 20 National Role Models. These individuals are now working as champions of the programme, engaging at a national level and spearheading the work. The Role Models are being supported by the Windsor Fellowship, an organisation with very strong links to the black community at a grass roots level whom we are now funding to deliver the Role Models Programme.

David Davies [269318]: To ask the Secretary of State for Justice how many of those detained in *(a)* young offender institutions and *(b)* prisons changed their declaration of religious faith to Muslim in each year since 2003.

Reply from David Hanson: Information on how many prisoners had changed their declared religion to Muslim is not held centrally.

The Prison Service Order on Religion (4550) sets out the process for change of religious affiliation by prisoners, which is managed locally by establishments. A copy of the Prison Service Order is in the Libraries of the House.

Baroness Warsi [HL3009]: To ask Her Majesty's Government what progress they have made in the development and implementation of a standards and recruitment framework for all chaplains engaged in public service.

Reply from Baroness Andrews: The Experience Corps were contracted in February 2008 to produce a report based on assessment, collation and analysis of data to establish an evidence base on the existing provision of Muslim chaplaincy including standards and recruitment processes, and to develop a draft framework of voluntary standards and recruitment process for institutions to consider when engaging Muslim chaplains in public service.

Following a tendering process in August 2008, the contract to pilot the draft framework of standards and recruitment process for institutions engaging Muslim chaplains in public service has been awarded to Faith Matters. Faith Matters will carry out a number of pilots in different institutions across the country over the coming months. The evaluation of the pilots will incorporate the views of relevant officers within participating institutions, as well as wider stakeholder consultation with imams, other faith leaders, chaplains, and officials from other government departments and relevant associated agencies. We expect the pilots to be completed by autumn 2009.

Using key findings from evaluation of the pilots and stakeholder consultation, Faith Matters will produce updated versions of the voluntary standards framework and recruitment process, with accompanying notes and a report listing key actions that need to be taken when implementing the documents.

Lord Tebbit [HL2952]: To ask Her Majesty's Government whether it is their policy that the western Judeo-Christian concept of human rights should be adopted by sovereign states in which the majority religions are not Christian.

Reply from Lord Malloch-Brown: The Government do not consider that international human rights standards reflect any particular religious tradition. The ideas and values underpinning the notion of human rights come from a wide range of religious, philosophical, ideological and cultural traditions. Human rights, by definition, are universal. They have also been elaborated collectively by states, particularly through the organs of the UN in such documents as the Universal Declaration of Human Rights and the various UN human rights treaties; and at a regional level in Europe, Africa and in the Americas. All UN member states, regardless of their populations' religious make-up, are bound under the UN charter to promote respect for human rights. All have also become bound voluntarily by international human rights treaties. The Government consider that all states must fulfil their international human rights obligations.

Lord Hylton [HL2974]: To ask Her Majesty's Government what action is being taken by the Commonwealth to uphold freedom of religion and the conscientious right to change one's religion, in the legislation and practice of all member states.

Reply from Lord Malloch-Brown: The Harare Commonwealth declaration of 1991 enshrines the Commonwealth's commitment to the liberty of the individual under law and equal rights for all Commonwealth citizens regardless of gender, race, colour creed, or political belief. The Commonwealth actively supports the adoption and ratification of international and regional human rights instruments, including the Universal Declaration on Human Rights, across its 53 country membership and helps to enhance the capacity of institutions in member states to promote, monitor, and protect human rights.

Baroness Warsi: To ask Her Majesty's Government what is their position on polygamous marriage in the United Kingdom.

Reply from Lord Bach: My Lords, the Government do not support or approve of polygamous marriage. It is not possible to enter into a polygamous marriage in the United Kingdom under UK law. A person who is domiciled in the United Kingdom cannot enter into a valid polygamous marriage abroad.

Baroness Warsi: My Lords, I thank the Minister for his reply, but is he aware that Chapter 13.20 of the entry clearance guidance issued by the UK Border Agency to entry clearance officers states:

"Even where it is suspected that a divorce of convenience has taken place and that a man ... is continuing to live with a previous wife, entry clearance cannot be withheld from a second wife, even if a polygamous household will be created as a result"?

Does he accept that this guidance effectively means that the Government are turning a blind eye to polygamy and that it does exist?

Reply from Lord Bach: No, my Lords, I would not accept that for a moment. I have set out the Government's policy as clearly as I can. This country recognises, and has done for many years, a marriage that has taken place abroad as being valid in England and Wales provided that it has been created in accordance with English private international law. To be recognised as valid, it must have been contracted between parties of full capacity and the marriage ceremony must have accorded with the formal requirements of the law of celebration in the country where it took place. If these conditions are satisfied, the marriage in question is normally recognised as being compliant with English private international law. This includes polygamous marriages but is not government approval of such marriages.
