Westminster Parliamentary Questions

Entry Clearances: Overseas Students

Damian Green [278542]: To ask the Secretary of State for the Home Department how many of the colleges that withdrew of their own volition from the new UK Border Agency register process currently sponsor visas for foreign students.

Reply from Phil Woolas: A total of four foreign students are currently sponsored by colleges who have withdrawn of their own volition from the UK Border Agency register. The students have leave to remain which was granted to them prior to the introduction of new procedures on 31 March 2009. If, when their current leave lapses, these students wish to seek further leave to remain to continue studying here, they will need to qualify under the points-based system.

The figures quoted are not provided under National Statistics protocols and have been derived from local management information and are therefore provisional and subject to change.

Entry Clearances: Overseas Students

Mark Oaten [280660]: To ask the Secretary of State for the Home Department if he will require universities to report on student progress under the Tier 4 rules on immigration.

Reply from Phil Woolas: No. The requirement for universities to monitor attendance rather than student progress provides the UK Border Agency with certainty that a student is following the course of study for which they were admitted rather than engaging in other activities such as employment.

Immigration

Baroness Warsi [HL4386]: To ask Her Majesty's Government what were the figures for (a) inward immigration, and (b) net immigration, in each of the past 12 years.

Reply from Baroness Crawley: The information requested falls within the responsibility of the UK Statistics Authority. I have asked the authority to reply.

Letter from Karen Dunnell, National Statistician, to Baroness Warsi, dated June 2009.

As National Statistician, I have been asked to respond to your question concerning the most recent estimate for a) inward immigration and b) net immigration, in each of the last 12 years. Official estimates of long-term immigration and net migration into the UK for 1996-2007 are given in Table 1 attached. The data are consistent with published figures.

1. Long-term International Migration (LTIM) is the most comprehensive measure of long-term international migration, and is based mainly on data from the IPS, supplemented with data on flows to and from the Republic of Ireland. Other data sources are used to make adjustments for asylum seekers and their dependants not counted by the IPS and for switchers (people who change their intentions and, therefore, their migratory status). LTIM was previously referred to as Total International Migration or TIM.

Immigration: Gurkhas

Damian Green: To ask the Chancellor of the Exchequer what assessment he has made of the effect on public expenditure of the admission to the UK of 36,000 Gurkhas residents. [275904]

Reply from Liam Byrne: The Government's position on settlement rights for Gurkhas who served in the Brigade of Gurkhas before July 1997 was set out in the Home Secretary's statement to the House on 21 May 2009. On the basis that 36,000 Gurkhas plus their dependants settled in the United Kingdom, the Government estimated that the annual cost would be approximately £1.4 billion. On the basis that 10,000 to 15,000 applicants plus their dependants settle in the UK, the Government estimate that the costs are likely to be £300 million to £400 million a year. This does not take into account the potential revenue from national insurance contributions, income tax or indirect taxes.

Asylum: Deportation

Pete Wishart [280811]: To ask the Secretary of State for the Home Department how many unsuccessful asylum seekers deported from the UK were refused entry on arrival at the country of their origin and subsequently returned to the UK in each of the last four years.

Reply from Phil Woolas: There are a variety of reasons why a person, during the removals process, may be refused entry to their country of destination. Due to this each case will be handled differently. Generally the person will be returned to the UK and re-enter the removals process.

The number of individuals refused entry to their destination country is not centrally recorded. The information requested could only be obtained by the detailed examination of individual case records at disproportionate cost.

The Home Office publishes statistics on the number of persons removed and departed voluntarily from the UK on a quarterly and annual basis.

Immigration: Oakington Removal Centre

The Earl of Sandwich [HL4202]: To ask Her Majesty's Government how many reforms recommended by HM Chief Inspector of Prisons have been implemented at Oakington immigration removal centre since her last report on the centre; and whether they will be fully implemented by the time of the expansion of the centre.

Reply from Lord West of Spithead: The Chief Inspector of Prisons' report into Oakington immigration removal centre was published in December 2008 and contained 111 recommendations. Of these, 89 were fully accepted by the UK Border Agency, and a further 13 were accepted in principle or in part. Action has been completed to implement 60 of the recommendations and progress is being made against the outstanding 42. We expect the majority will be completed by the end of the calendar year.

There are no plans to expand Oakington prior to its closure.

United Kingdom Human Trafficking Centre

Shailesh Vara [277123]: To ask the Secretary of State for the Home Department how many (*a*) children and (*b*) women over 18 years of age have been referred to the United Kingdom Human Trafficking Centre since the introduction of the national referral mechanism.

Reply from Alan Campbell: As at the end of April there have been a total of 35 referrals to the competent authorities based in UKHTC and UKBA. Of these 27 were female with nine referrals being of people under the age of 18.

Human Trafficking

Shailesh Vara [277243]: To ask the Secretary of State for the Home Department with reference to the answer of 29 October 2008, *Official Report*, columns 1087-88W, on human trafficking, how many (*a*) arrests and (*b*) convictions there were for human trafficking offences in each police force area in England and Wales in each of the last five years.

Reply from Alan Campbell: It is not possible to break down the arrest and convictions for each of the last five years.

Figures from the UKHTC indicate that since the inception of the dedicated legislation, there have been a total of 568 arrests for human trafficking offences which have resulted in a total of 114 convictions. The figures for the number of arrests which are set out by force area below include 100 cases on which the outcome is not yet known.

Females: Human Trafficking

Peter Bone [282208]: To ask the Minister for Women and Equality what her estimate is of the number of women trafficked into the UK for the purpose of sexual exploitation in 2008.

Reply from Michael Jabez Foster: The latest estimate supplied by Home Office is that at any one time in 2003, there were up to 4,000 women had been trafficked into the UK.

The UK Human Trafficking Centre is undertaking an analysis of the outcomes of Operation Pentameter 2. This analysis, in conjunction with the work based within the regional intelligence units, will inform a more up to date assessment of the extent of trafficking in the UK, which is due by the end of the year.

Human Trafficking: Prosecutions

Damian Green [276566]: To ask the Secretary of State for the Home Department how many people have been prosecuted for human trafficking offences relating to labour exploitation under the Asylum and Immigration (Treatment of Claimants EEC) Act 2004.

Reply from Alan Campbell: Figures provided by the UK Human Trafficking Centre indicate as of 24 May there have been 16 prosecutions and seven convictions for trafficking for the purposes of forced labour.

Damian Green [276567]: To ask the Secretary of State for the Home Department how many people have been prosecuted for human trafficking offences relating to sexual exploitation under the Sexual Offences Act 2003.

Reply from Alan Campbell: Figures from the Crown Prosecution Service indicate a total of 267 people prosecuted under sections 57-59 of the Sexual Offences Act 2003.

In this total there have been 106 convictions plus three for conspiracy to traffick which have arisen from sexual exploitation cases.

Westminster Petition

Immigration (Asylum Seekers)

The Petition of the Vincentian Millennium Partnership, Declares that to be an asylum seeker in 2009 in the United Kingdom can entail any or a variety of the following experiences-detention (often for years), poor housing, isolation, being moved at short notice from communities where the person has been integrated for several years with the resulting severance from their regular sources of spiritual, emotional and medical support, being denied a choice of shops through a poverty level voucher scheme which amounts to £35 per week and, most importantly, being prevented from working or from engaging in voluntary work which often leads to depression and a lack of self worth; further declares that refusal by the asylum seeker to comply with the "system" often leads to destitution and that the only alternative may be criminal activity or prostitution; notes that being an asylum seeker often means being made a scapegoat, especially by the tabloid press which often uses a case of wrong doing by one asylum seeker to demonise them all; further notes that stories about asylum seekers being given priority for high quality housing in preference to local people are blatantly untrue but become part of the myths surrounding them; and believes that to be an asylum seeker in the United Kingdom today is to live on the edge of starvation as a cruel warning to others not to come to the United Kingdom.

The Petitioners therefore request that the House of Commons urges the Secretary of State for the Home Department to ensure that those entering our country seeking asylum are treated in a just and compassionate manner which honours the long-standing British tradition of treating newcomers to these islands with welcome, respect and fairness; and further urges the Secretary of State to seek to enshrine in the Borders, Citizenship and Immigration Bill the rights of asylum seekers to adequate housing, ESOL (English as a Secondary Language) Classes, Criminal Records Bureau checks, earn a wage and contribute to taxes, engage in voluntary work, integrate into local communities, and become valued citizens of the UK.

Observations from the Secretary of State for the Home Department: The UK Border Agency proudly maintains the country's tradition of providing protection to those who need it, in accordance with the UK's international obligations. Our process for meeting those obligations is fair. All asylum and human rights claims are carefully considered on

their individual merits in accordance with the 1951 United Nations Convention Relating to the Status of Refugees and the European Convention on Human Rights (ECHR), against the background of the latest accurate, objective, sourced and up-to-date information on asylum seekers' countries of origin produced by the UK Border Agency Country of Origin Information Service.

If an individual claiming asylum demonstrates a need for international protection and they meet the definition of a refugee under the terms of the 1951 Convention, asylum is granted. If they are otherwise vulnerable they may engage our obligations under the ECHR in which case they will be granted humanitarian protection or discretionary leave. If their application is refused, they have a right of appeal to the Asylum and Immigration Tribunal (AIT) or an opportunity to seek judicial review through the higher courts. In this way we ensure that we provide protection to those asylum seekers who need it through a fair and transparent process.

Westminster Early Day Motions

Keith Vaz (1709) **Human trafficking offences** – That this House welcomes the recent sentencing of Abdul Hameed Sakhizada, Ahmed Shah Sakhizada and Abdul Wakil Niazi, the leaders of what was believed to be one of the most profitable people-smuggling networks uncovered in Europe; is extremely concerned that the global conviction rates for human trafficking remain very low at only 1.5 per 1,000 people and that out of 155 countries, 40 per cent. failed to record a single conviction for human trafficking offences; notes that human trafficking is second only to the drugs trade in terms of the amount of money made; and calls upon the Government to ensure that sufficient funding is provided to those working in the fight against human trafficking.

Downing Street e-petition

Petition: "We the undersigned petition the Prime Minister to close-down and demolish any mosques found to be promoting terrorism."

"We always read stories in the papers about how terrorism books are being sold or given away in mosques, and how hate-preachers are spreading their evil views to a crowd of eager listeners. But why does the government still give these crimes the opportunity to take place? The only way to ensure this doesn't happen is to close-down and demolish any mosque found committing these acts of treason. This will not only act as a deterrent, but will also guarantee the crime won't be committed in the same place again – because to allow such a repeat would be utter carelessness. Non-extremists who attend these mosques are also to blame, as they are happy to sit back and allow it happen. Also, any Muslims who report these criminal acts should be rewarded."

Government response: Thank you for your e-petition about any mosques found to be promoting terrorism. This Government is determined to build resilience to violent extremists and their messages of division. We believe that strong, well run Mosques that are positioned at the centre of the community are better equipped to

counter attempts by extremists to promote violent interpretations of Islam. These changes are important because they will be coming from within communities themselves. Our aim remains to create great places where people want to live, work and raise a family.

We are working closely with Muslim communities to build capacity and improve teaching and governance standards in Mosques, and to equip scholars and leaders with the skills, confidence and space to confront violent extremism.

We believe that by helping communities to strengthen their Mosques, we will enable them to become community hubs, which includes providing the highest standards of services, and safety, for children, the congregation and visitors. The Department is supporting community organisations to set, implement and regulate standards in mosques. This includes the independent Mosques and Imams National Advisory Board (MINAB), and we are also supporting the Charity Commission in their work to encourage mosques to register as charities, whilst supporting mosques which are already registered with the Commission to improve their standards of governance.

Whilst we can support them, determining the way that mosques are run is not something that the Government can do from the outside. It has to come from within. Our effort here is not only to enable mosques to act as antidotes to violent extremism elements, but to strengthen them more generally as community centres promoting cohesive communities.

Anti-sectarianism Strategy

Bill Butler: To ask the First Minister when the Scottish Government will present a national anti-sectarianism strategy to the Parliament. (S3F-1808)

Reply from the First Minister (Alex Salmond): We will present our co-ordinated national approach to tackling sectarianism in Scotland to the Parliament in October, drawing together the different strands of existing activity that are already helping our communities to overcome this long-standing issue. For example, through sense over sectarianism we are already providing £412,500 over three years to people in the greater Glasgow area to develop and implement their own ideas for tackling sectarianism; through Nil by Mouth we are providing £118,000 this year and next to tackle sectarianism in the workplace; and through our support for YouthLink Scotland we are providing education resources to tackle sectarianism at all levels.

Bill Butler: I genuinely welcome the First Minister's answer, which, following the commitment in principle that he gave me in the chamber on 18 September 2008, sets out a specific timescale for introducing a national anti-sectarianism strategy.

Will the First Minister pledge today that the strategy will contain, among other things, a commitment to a national rehabilitation programme for those who are convicted of religiously aggravated offences, a pledge to address the decline in the number of twinning programmes in schools and an acceptance that an anti-sectarianism programme should be rolled out across the primary and secondary school curriculum?

Reply from the First Minister: All those matters are being actively considered. I am sure that Bill Butler will not be disappointed with the co-ordinated strategy when it emerges in October.

I am glad that Bill Butler has welcomed the strategy and the timescale for introducing it. I am sure that he will also recognise and welcome the strong efforts that have been made in the various community initiatives that have been taken forward in schools and communities throughout Scotland. The organisations that I have listed—and I could list more—are doing vital work on behalf of us all, and they, too, will be part of the national strategy that will be announced in October.

Racially Aggravated Offences

Paul Holmes [280855]: To ask the Secretary of State for the Home Department how many racially-motivated crimes were recorded in each police force area in (*a*) each year from 1997-98 to 2002-03 and (*b*) 2008-09.

Reply from Alan Campbell: The information on police recorded crime covers some categories of offence that are deemed to be racially or religiously aggravated. Racially aggravated offences were added to the recorded crime statistics series in April 1999 and religiously aggravated offences were added in April 2002. It is not possible to separately identify those offences of a racial nature from those of a religious nature.

Data for 1999-2000 to 2002-03 is given in the following table. Data for 2008-09 will be published on 16 July 2009.

Poland

Lord Ouseley [HL4232]: To ask Her Majesty's Government what advice they give to black and Asian British citizens travelling to Poland in the light of recent experiences of persons reportedly subjected to racial abuse, harassment and threats of violence.

Reply from Lord Brett: There have been no reports in the Polish press of abuse, harassment or threatening behaviour being directed towards black or Asian British citizens in Poland. We see the risk of British citizens, irrespective of ethnic origin, being attacked in Poland as being negligible. We do not, therefore, have any plans to produce specific travel advice for black and Asian British citizens at this time. However, we constantly review our travel advice with our embassy in Poland and amend it when necessary.
