### **Holyrood Parliamentary Questions**

#### **Communities**

Richard Baker (S3W-30559): To ask the Scottish Executive what benefits it considers that the introduction of a national register of public service interpreters similar to that in operation in England and Wales would bring.

Reply from Alex Neil: The Translating, Interpreting and Communication Support Group, set up by the Scottish Government to improve the standard of translation and interpreting services, identified monitoring quality and standards of the interpretation service as a key priority. One way of facilitating this could be through the use of the existing UK wide national register or a register specific to Scotland.

Richard Baker (S3W-30560): To ask the Scottish Executive whether it would support the introduction of a national register of public service interpreters similar to that in operation in England and Wales.

Reply from Alex Neil: The national register of public service interpreters operational in England and Wales also operates in Scotland. However, it is our understanding that it is not widely used. The Scottish Government would be supportive of steps to improve monitoring of quality and data, through the use of a register if service providers felt that was the most effective way of doing so.

#### **Immigration: Asylum Support Office**

**Lord Dykes:** To ask Her Majesty's Government what steps they will take to establish the new European Asylum Support Office approved by the European Council last autumn. [HL1196]

**Reply from Lord West of Spithead:** The setting up of the European Asylum Support Office will fall initially to the European Commission, but the Government will co-operate closely with the Commission to ensure that the office is able to start work in its host country of Malta as soon as possible.

#### **Immigration: Tinsley House**

**Baroness Stern:** To ask Her Majesty's Government how many children were detained at Tinsley House immigration removal centre for more than 72 hours during 2009. [HL1125]

**Reply from Lord West of Spithead:** During 2009, 111 children were detained at Tinsley for more than 72 hours. This figure is taken from local data normally used for management information only.

Following a recent internal review, however, we have taken the decision to limit the length of stay for children to just 24 hours, after which they will be transferred to Yarl's Wood immigration removal centre.

This is an interim measure pending a programme of changes we will be making at the centre to improve facilities for children.

**Baroness Stern:** To ask Her Majesty's Government whether they have modified the education provision for children at Tinsley House immigration removal centre since HM Chief Inspector of Prisons noted it was "inadequate". [HL1127]

**Reply from Lord West of Spithead:** As we are not currently holding children at Tinsley House for more than 24 hours, planned education provided by a trained teacher is neither appropriate nor practicable.

Where children are to be held for longer than 24 hours, they are transferred to Yarl's Wood immigration removal centre, where comprehensive education provision is available for children of all ages, delivered by qualified nursery nurses and teachers.

#### Immigration: "Bogus" Colleges

**Lord Naseby:** To ask Her Majesty's Government what action they have taken in the last six months to prevent illegal immigration through the use of "bogus" colleges and to close down student loan scams used to obtain visas.

Reply from Lord West of Spithead: There are currently around 2,000 sponsors on the tier 4 register. In the past six months we have carried out around 600 inspections, suspending 140 and revoking 15 tier 4 licences. United Kingdom Border Agency staff are trained to spot forged loan documents. Applicants who use them are refused and may be banned from entering the United Kingdom for up to 10 years. On 12 November 2009, the Prime Minister announced a review of tier 4 that will report back shortly.

**Lord Naseby:** The Minister will know that I asked the question last July. Why is it still so easy for these bogus colleges to operate and to bring in illegal immigrant students? Why is it that at this time we have a large number of sham applications from Pakistani students? It would appear that the assessment of their entry requirements is done outside Pakistan by one of our embassies. Is that not a situation where that embassy has no idea of the tricks of the trade in that part of the world? Would it not be far better if the whole assessment was done by our own people in Pakistan?

Reply from Lord West of Spithead: My Lords, the noble Lord asks a large number of questions. First, I do not accept that we have not got a handle on these various colleges. There were initially some 15,000 colleges in the DIUS list, of which about 4,000 regularly had foreign students. After going through them and guaranteeing that they are bone fide colleges, we have now reduced that number to about 2,000. We have made careful checks of those colleges-I mentioned the number that we have closed down-so we have a very strong handle on that.

On the students coming into the country, it is important to keep in balance the fact that foreign students in this country, just in terms of fees, bring in £2.5 billion a year; with all the other added value, it is about £8.5 billion a year. We have to balance that against ensuring that we do not get a lot of people coming here who are not entitled to be in this country. I think we keep that balance fairly well correct and we are very good at doing those checks. I could go into more detail, but I will open it up for more questions.

**Lord Pearson of Rannoch:** My Lords, is there any truth in the suggestion that, of the 66,000 people who came to this country from Pakistan in the nine months to last September, only 29 were interviewed by British immigration officials and the rest by contracted interviewers in Pakistan or elsewhere?

Reply from Lord West of Spithead: My Lords, the system is that we look at documentation before any of the people provide their biometrics. After looking at that documentation, we assess whether we need to have a face-to-face interview. We are content that we are achieving good results. Indeed, I was speaking earlier today to the independent watchkeeper, who was appointed last year; we will see in his report, which comes out later this week, that he is fairly satisfied with the levels that have been achieved.

### **Westminster Parliamentary Questions**

#### **Equality Bill (Religious Groups)**

**Andrew Rosindell:** What recent discussions she has had with religious groups on the provisions of the Equality Bill. [313702]

**Reply from Harriet Harman:** Ministers in this House-in particular my hon. Friend the Parliamentary Secretary, Government Equalities Office-and Ministers in the Lords have had a number of discussions with religious and belief groups and have received a number of representations relating to religion or belief since the introduction of the Equality Bill. Such discussions and representations are ongoing.

**Andrew Rosindell:** Will the Minister finally admit that were it not for the successful amendment from Baroness O'Cathain in the House of Lords earlier this week, the Equality Bill as unamended would have further restricted employment for people working in religious organisations?

Reply from Harriet Harman: No, it would not. We thought that it would be helpful for everyone involved to clarify the law, and that is what the amendment that we brought forward aimed to do. That amendment was rejected. However, it would be helpful for the House to understand that there are religious jobs and non-religious jobs within organisations. For example, I would say that a pensions assistant ensuring that the records database is kept up to date was not doing a religious job. I would also say that issuing and processing invoices, even if it is done in the employment of the Church of England, is not a religious job.

To make it clear, the law applies to religious organisations when they employ people in non-religious jobs in the same way that it does to everyone else. We have always been clear that we are not going to insist on non-discrimination in relation to religious jobs such as being a vicar, a bishop, an imam or a rabbi. The law has stepped back from that and said that religious organisations can decide themselves how to do that. However, when it comes to non-religious jobs, those organisations must comply with the law, and that is how the law remains.

Mark Harper: The Minister will know that before the Government's defeat, her Bill as unamended did not even make it clear that ministers of religion would have to live in accordance with the faith of their religion. Following the Government's defeat in the other place not once but three times, by a coalition led by Conservative peers, bishops and Cross Benchers, the Bill has been improved. Can the Minister confirm that the Government will accept the decision in the other place to enable Churches to insist that key posts be held by those who live in accordance with the tenets of their faith, or will she seek to reverse that defeat in this House?

Reply from Harriet Harman: I think that the hon. Gentleman is trying to perpetrate a further misunderstanding. We are absolutely clear that we have never intended to extend the non-discrimination provisions to ministers of religion, nor have we ever tried to do so. Therefore they are exempted. We have always made it absolutely clear that they are and will continue to be exempted from the non-discrimination laws, and we have not sought to change that. There has been an issue about what is or is not a religious job, and we sought to clarify that. Our helpful clarification was not regarded as helpful in the House of Lords, and therefore the amendment was defeated. We will consider how to respond to that, but an official announcement will be made in due course, once these things have gone through the machinery, as it were. However, I would reassure hon. Members that the policy will remain as it is, and I would not want to lead them to anticipate that it will be brought forward again in this House.

### **Holyrood Parliamentary Motion**

**S3M-5629** Ken Macintosh: Holocaust Memorial Day 2010—That the Parliament notes 27 January 2010 as Holocaust Memorial Day and urges all Scots to unite in remembering the victims and survivors of the Holocaust; recognises that the lessons learned from the tragedy of the Holocaust are of fundamental importance for successive generations; believes that continued vigilance and opposition to discrimination, persecution and racism is vital if such terrible events are to be prevented from ever happening again; also wishes, however, to celebrate the legacy of hope provided by those who survived and those who helped others survive; particularly wishes to remember the Rev Ernest Levy from Giffnock, a survivor of Auschwitz Birkenau and Bergen-Belsen who died last year; notes that, despite enduring appalling suffering during the Holocaust, the Rev Levy never

lost his warmth or humanity and devoted himself to educating others, and believes that the best way to remember and pay tribute to Holocaust survivors like Ernest Levy is to ensure that their inspiring stories continues to be told to future generations.
