## Immigration and Asylum

### Westminster Parliamentary Questions

#### Naturalisation

**Nicholas Soames:** To ask the Secretary of State for the Home Department whether time spent in the UK by a foreign national on a student visa counts towards the qualifying period for naturalisation as a British citizen; and if she will make a statement. [33729]

**Reply from Damian Green:** The position has not changed since my response of 21 July 2010, *Official Report*, column 445W. Time spent in the United Kingdom on a student visa can count towards the residence requirements for naturalisation if a person meets the statutory requirements on the date of application.

Any change to the requirements for naturalisation would require legislative change. There are no plans to do so at the current time.

#### Immigration: Health

**David Evennett:** To ask the Secretary of State for the Home Department what estimate she has made of the number of non-EU nationals who have been granted temporary leave to remain in the UK on medical grounds in each of the last five years. [33586]

**Reply from Damian Green:** The UK Border Agency does not record the number of all non-EU nationals who have been granted temporary leave to remain in the UK on medical grounds in their standard reports.

To obtain such information for previous years would involve a case by case search or significant report development work at disproportionate cost.

### Immigration Controls

**Nicola Blackwood:** To ask the Secretary of State for the Home Department what impact assessment her Department has undertaken on the effect on scientists and researchers who will be transferred from Tier 1 to Tier 2 under the Government's proposed changes to the points-based immigration system. [33830]

**Reply from Damian Green:** The Government will give a degree of priority within the revised Tier 2 for high-level scientists and researchers.

We will also introduce a new Tier 1 route for people of exceptional talent, such as world-leading scientists and academics who have achieved international recognition or are likely to do so.

Details of the new arrangements will be published in due course.

**Nicola Blackwood:** To ask the Secretary of State for the Home Department what research her Department has undertaken on the effect of the points-based immigration system on low-earning but highly-qualified scientists and researchers. [33832]

**Reply from Damian Green:** Over last summer we carried out a full public consultation on our proposed changes to the points-based system, to ensure that we took a wide range of views and evidence on board and into account. Details of the new Tier 1 route for people of exceptional talent will be published in due course.

**Nicola Blackwood:** To ask the Secretary of State for the Home Department whether she plans to change the number of points allocated for (a) incomes and (b) qualifications under Tier 2 of the points-based immigration system. [33833]

**Reply from Damian Green:** We will publish full details of how the revised Tier 2 will operate in future in due course.

### Immigration: EU Nationals

**Stewart Jackson:** To ask the Secretary of State for the Home Department what estimate has been made of the number of non-EEA residents who entered the UK after having gained (a) citizenship and (b) indefinite leave to remain in other EU member states in each of the last five years; and if she will make a statement. [33194]

**Reply from Damian Green:** The UK Border Agency does not hold this information. When a citizen of the EU enters the United Kingdom, it is not evident from their passport or national identity card how they obtained EU citizenship in another country. When a non-EEA citizen wishes to enter the United Kingdom, the individual is not required to provide evidence of having obtained indefinite leave to remain in another EU member state, and it may not be evident from their passport that such status was held. This is because at the point of arrival into the United Kingdom, non-EEA passengers must instead provide a valid United Kingdom entry clearance visa.

**Frank Field:** To ask the Secretary of State for the Home Department how many applications for family visitor visas there were in each year since 1997; how many of those were granted in each such year; how many times appeals were raised against refusals of such applications in each year; how many of those appeals were upheld in each year; and what her most recent estimate is of the average cost to her Department of such an appeal in the latest period for which figures are available. [33805]

**Reply from Damian Green:** With regard to family visit visas, the number of (a) applications received; (b) visas issued; (c) appeals received; and (d) appeals allowed, in each calendar year since 2004, is shown in the following table. This information is not available for previous years.

The cost of immigration appeals are split between the Tribunals Service and UKBA. The majority of the cost falls to the Tribunals Service.

**Reply from Damian Green:** The number of appeals against the refusal of student visas that were (a) lodged and (b) allowed, in each calendar year since 2004, is shown in the following table. This information is not available for previous years.

However, an unsuccessful applicant is able to lodge an appeal on residual grounds, namely under provisions of the Human Rights Act 1998 and Race Relations Act 1976.

<sup>(2)</sup> The figures show that in 2009, a total of 9,645 appeals in this category were allowed. Many of the decisions to which these appeals relate are likely to have been made in 2008 when there was a significant increase in long-term student applications prior to the introduction of the points-based system.

**Nicholas Soames:** To ask the Secretary of State for the Home Department what her most recent estimate is of the average cost of an appeal against refusal of entry clearance. [33734]

**Reply from Damian Green:** The cost of immigration appeals is split between the Tribunals Service and UKBA. The majority of the cost falls to the Tribunals Service.

Most recent UKBA estimates (2009-10) suggest the cost of an appeal against refusal of entry clearance ranges typically between £200 and £500 per case. This unit will vary depending on the complexity of the case, with family visit visa appeals generally falling towards the lower end of this estimate.

The most recent estimate (2008-09) from the Tribunals Service indicate that a family visit visa appeal costs, on average, £504 and an appeal against other entry clearance decisions costs, on average, £577. ### Asylum

**Caroline Dinéage:** To ask the Secretary of State for the Home Department what plans she has to address the situation of failed asylum claimants who are neither legally settled nor under notice of removal. [33642]

**Reply from Damian Green:** All failed asylum seekers are put under notice of

removal when they are informed that their application has been refused. If an applicant fails to leave voluntarily their removal from the UK may be enforced by the UK Border Agency.

**Roger Gale:** To ask the Secretary of State for the Home Department what assessment she has made of the effect of the withdrawal of the policy document entitled Guidance on R(S) Policy dealing with Failed Asylum Claims Which May Have Lost the Benefit of an ELR Policy as a Result of Delay; and what estimate she has made of the number of cases which will be affected by the withdrawal of the policy guidance. [34532]

**Reply from Damian Green:** The Case Resolution Directorate (CRD) is nearing the end of its programme to review the backlog of unresolved asylum cases, and remains on track to complete the legacy programme by summer 2011. Individuals who previously fitted the criteria of the R(S) policy would have fallen within one of CRD's priorities, namely those who may qualify to be allowed to stay in the UK. It is expected that the vast majority of such cases will have already been concluded. However, an accurate estimate of the numbers potentially affected by the withdrawal of the policy was not obtained, as this would have involved the manual checking of all CRD remaining cases, which could have delayed their completion. All representations made on the basis of the R(S) policy prior to its withdrawal on 20 December 2010 will still be considered against the R(S) policy. Any representations made on the basis of R(S) after the withdrawal of the policy will be considered on a case by case basis. The small number of individuals who would have qualified on the basis of R(S) but whose cases have not yet been concluded are still likely to qualify for leave under existing immigration rules and policy.

### Asylum

**Nic Dakin:** To ask the Secretary of State for the Home Department if she will take steps to ensure that increasing the speed of decision-making on family asylum cases will not affect the fairness and effectiveness of such decisions. [34875]

**Reply from Damian Green:** The Asylum Improvement Project, which was established by the Government in the summer, is exploring new ways to improve the asylum system to speed up the processing of all applications, including family applications, while improving the quality of decision making, achieving greater productivity and efficiency in the asylum process and better, more sustainable, decisions.

We are also reviewing the decision making process for family cases as part of the review into ending the detention of children for immigration purposes and we are working with corporate partners to improve the process.

### Detainees :Sexuality

**Simon Kirby:** To ask the Secretary of State for the Home Department what consideration she has given to adding complex sexuality-related persecution claims to the list of claims unlikely to be accepted in the suitability guidance note for routing into the detained fast track procedure. [34911]

**Reply from Damian Green:** Entry to the detained fast track procedure is determined by reference to published policy available on the UKBA website. There are no plans to exclude applicants from the detained fast track process because their claims appear to relate to complex sexuality-related persecution.

However, there is an existing condition in published policy that cases may enter the process only if they are amenable to a quick, fair and sustainable decision. If, at the time of application, it is apparent that this condition cannot be fulfilled the applicant will not be entered into the process.

### Deportation: Human Rights

**Stewart Jackson:** To ask the Secretary of State for the Home Department how many deportations from the UK did not proceed as a consequence of the application of the provisions of (a) Article 3 and (b) Article 8 of the European Convention on Human Rights in each year since 2005; and if she will make a statement. [34146]

**Reply from Damian Green:** In responding to this question, we have assumed 'deportations' to mean 'removals'.

The UK Border Agency does not record this information centrally. Providing a breakdown of specific reasons for removals not to be pursued, either at initial decision stage or following a successful appeal, can only be determined by investigating individual case files which would incur a disproportionate cost.

**Reply from the Attorney-General:** The CPS has no records to identify how many people recognised as a trafficked victim under the national referral mechanism have been prosecuted for criminal offences in each of the last three years. The National Referral Mechanism was introduced on 1 April 2009, and up to 31 December 2010, 1,254 referrals have been made for potential victims of trafficking.

#### Department of Chamber and Committee Services: Ethnic Groups

**Keith Vaz:** To ask the hon. Member for Caithness, Sutherland and Easter Ross, representing the House of Commons Commission, how many people employed as Clerks in the Department of Chamber and Committee Services of the House of Commons are from an ethnic minority. [34382]

**Reply from John Thurso:** Following the post-Tebbit restructuring of the House Service, there is no longer a clear definition of "Clerk" in the Department of Chamber and Committee Services (DCCS). There are 100 people within the DCCS who are in the pool of staff liable to be circulated into posts traditionally held by Clerks. Of these, five are on secondment to the House from other organisations and are therefore not employed by the House.

Of the remaining 95 people, 86 have voluntarily supplied information on their ethnic origin. Fewer than five of them have declared themselves to be non-white.

## Westminster Parliamentary Question

### Racism: International Co-operation

**Matthew Offord:** To ask the Secretary of State for Foreign and Commonwealth Affairs what his policy is on UK representation at the proposed UN conference on anti-racism planned for 2011. [34088]

**Reply from Jeremy Browne:** The Government have not yet made a decision on our participation in the meeting in September to commemorate the 10<sup>th</sup> anniversary of the World Conference Against Racism. We recognise that it is common practice for the UN to convene meetings at regular periodic intervals to commemorate the adoption of its various social and human rights-related agendas such as the Durban Declaration and Programme of Action. But previous meetings on this issue, including the initial World Conference Against Racism as well as its 2009 review conference, were overshadowed by unacceptable and offensive anti-Semitic rhetoric and behaviour.

UK officials will work closely with colleagues in other countries to ensure that the September meeting does not become another platform for such behaviour and that the meeting addresses all ensure that any outcome from the meeting includes a clear statement on the need to further combat anti-Semitism as part of wider efforts to combat racism. Our position on participation and representation will remain under review as a result of these efforts.

#### Animals: Slaughter

**Lord Moonie:** To ask Her Majesty's Government how many abattoirs are licensed to carry out animal slaughter without stunning the animal first.[HL5579]

**Reply from the Parliamentary Under-Secretary of State, Department for Environment, Food and Rural Affairs (Lord Henley):** There are currently 346 approved slaughterhouses operating in Great Britain. There is no separate approval of slaughterhouses carrying out animal slaughter without prior stunning. However, where bovine animals are slaughtered by a religious method the restraining pen used must be approved by the Minister as required under Schedule 12 of the Welfare of Animals (Slaughter or Killing) Regulations 1995 (as amended). Eight restraining pens have been approved in England and Wales and are currently operational.

**Lord Moonie:** To ask Her Majesty's Government what representations they have made to the European Commission and the Agriculture Council about changing the regulations in respect of animal slaughtering without stunning the animal first. [HL5580]

**Reply from Lord Henley:** We have made no recent representations to the European Commission or the Agriculture Council about changing regulations in respect of animal slaughtering without prior stunning.

We were involved in discussions on the new EU Regulation (Number 1099/2009)

on the protection of animals at the time of killing which was agreed on 24 September 2009 and comes into effect on 1 January 2013. This regulation permits the use of additional national rules to improve welfare protection in relation to the slaughter of animals without prior stunning. Detailed consideration of this issue will take place over the next year as we decide how to implement the new regulation. We will consult widely on our approach before final decisions are taken.

**Lord Moonie:** To ask Her Majesty's Government what estimate they have made of the number of domesticated animals and birds slaughtered in 2010 without being stunned first.[HL5581]

**Reply from Lord Henley:** The most recent data on the slaughter of animals without prior stunning was published in March 2004 by the Meat Hygiene Service in its Animal Welfare Review. The data was collected through a survey of meat plants between 1 and 7 September 2003. The table below shows the number of animals killed over that period without prior stunning for the production of Kosher and Halal meat:

Species	Not Stunned
Cattle	365
Calves	8
Young lambs	6,845
Other sheep	11,454
Goats	62
Broilers	167,745
Hens	15,900
Turkeys	749
Ducks	610

More recent data collected by the EU Dialrel project (see <http://www.dialrel.eu/images/factsheet-assesment-practices.pdf>) shows that, of the UK abattoirs surveyed, 100 per cent of the animals and birds slaughtered for the production of Kosher meat were slaughtered without prior stunning. For Halal meat, 25 per cent of cattle and 7 per cent of sheep were slaughtered without prior stunning. The Dialrel data also indicates that no poultry were slaughtered for Halal production without stunning.
