### Westminster Ministerial Statement

### **Immigration Rules**

**The Minister for Immigration (Mr Mark Harper):** My right hon. Friend the Home Secretary is today laying before the House a statement of changes in the immigration rules that will bring about urgent changes to tackle abuse in the entrepreneur migration route while protecting genuine entrepreneurs. The changes will take effect on 31 January.

### Immigration and Asylum Westminster Ministerial Statement (continued)

In April 2011 we made some changes to the investor and entrepreneur routes to encourage greater uptake. These changes have successfully brought about a steady increase in applications from overseas.

However, it is clear that, following our tightening of other migration routes, the entrepreneur route is now being targeted by applicants seeking to abuse the immigration rules. There is strong evidence that funds to prove eligibility are being recycled among different applicants and that artificial businesses are being created. We need to tighten the current rules to allow for a meaningful assessment of the credibility of an applicant for this route.

I am therefore acting promptly to tackle this abuse, without damaging the legitimate applicants who are important to our economic growth. I am introducing a "genuine entrepreneur" test which will give UK Border Agency caseworkers the ability to test the credibility of suspicious applicants. I am also making a further change to require the necessary minimum funds to be held, or invested in the business, on an ongoing basis rather than solely at the time of the application. This will apply to those already in the UK and those who apply to come here under the entrepreneur route.

I emphasise that these are technical but important changes to improve the effectiveness of the current rules. Those seeking to abuse the immigration system will always seek new methods to do so. We are vigilant and will take swift action where we see evidence of abuse. At the same time, we will protect genuine entrepreneurs and continue to encourage them to invest in the UK where they will be made welcome.

**Reply from Mark Harper:** The UK Border Agency implemented its reconsiderations policy, and published it on its website, on 13 November 2012. The policy states the limited circumstances in which the UK Border Agency is prepared to reconsider casework decisions, including decisions on applications to enter, remain and settle in the UK on the basis of marriage and civil partnerships.

### **Entry Clearances: Business**

**Daniel Kawczynski:** To ask the Secretary of State for the Home Department how her Department distinguishes between people who want to obtain UK visas for *(a)* business purposes and *(b)* other reasons. [137992]

**Reply from Mark Harper:** Different visit categories for visa purposes are outlined in the Immigration Rules. The business visit category outlines permitted activities for film crews, news media, academic and religious workers, consultants, trainers as well as listing permitted categories for general business purposes such as attending meetings or arranging deals.

Those who want to invest in the UK by setting up or taking over, and being actively involved in running of, a business or businesses may enter the UK by applying for tier 1 (Entrepreneur) visa.

Student graduates may also apply for a tier 1 (Graduate Entrepreneur) visa if they have outstanding business ideas that they wish to put into practice.

Other reasons for visits are also outlined in legislation. We have separate visa categories for:

### Visas

**Lord Ouseley:** To ask Her Majesty's Government how many applications for visas from overseas students currently studying in the United Kingdom have been received during the past 12 months; how long it takes on average to issue visas; and how many applications remain to be determined beyond a period of three months.[HL4703]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach):** Data for applications for students applying through the tier 4 route from overseas: Visa applications received in the 12 months to September 2012: 215,867 of these, number issued: 194,660.

Average time to resolve applications (irrespective of outcome): 7.5 days applications unresolved after 90 days on 8 Jan 2013: 194.

The data are for main applicants only and do not include applications from dependents.

Some students issued visas under tier 4 during the period shown will have completed their studies, whereas others would have applied for further leave to remain in the UK.

These data are based on internal UK Border Agency management information. They are provisional and subject to change.

#### Asylum

**Jeremy Corbyn:** To ask the Secretary of State for the Home Department how many asylum seekers are supported by the National Asylum Support Service; and what the equivalent number was in (*a*) 2009, (*b*) 2010 and (*c*) 2011. [140052]

**Reply from Mark Harper:** The National Asylum Support Service was disbanded in 2006. Asylum support is now managed through regional asylum teams. The legislation in respect of eligibility for asylum support, and the categories of support available, has not changed.

Support may be provided under section 95 of the Immigration and Asylum Act 1999 to asylum seekers who would otherwise be destitute until their asylum claim is determined. Section 95 support can be provided as both accommodation and subsistence, or accommodation or subsistence only.

At the end of Q3 2012, the most recent published figure available, 19,366 asylum seekers were in receipt of Section 95 support.

The numbers of people removed or who departed voluntarily by reason of (a) failure to be able to maintain themselves economically or (c) other reasons is not available without examination of the individual records. To do so would incur disproportionate cost.

It is our policy not to disclose the countries to which we remove or deport foreign national offenders as this could jeopardise our diplomatic relations and our ability to continue to do so.

The Home Office publishes quarterly and annual statistics on the number of persons removed or departed voluntarily from the UK within *Immigration Statistics*. The data on removals and voluntary departures by destination and type are available in the latest release, *Immigration Statistics: July-September 2012*, tables rv.06 and rv.06.q, from the Library of the House and from the Home Office Science, research and statistics web pages at: <u>http://www.homeoffice.gov.uk/science-research/research-</u>

#### Human Rights

**Lord Morris of Aberavon:** To ask Her Majesty's Government whether they will place in the Library of the House the instructions to counsel who appeared before the European Court of Human Rights on behalf of the United Kingdom in the case of Eweida, Chaplin, Ladele and McFarlane; and whether those instructions were approved by the Attorney General.[HL4721]

**Reply from Baroness Stowell of Beeston:** Litigation instructions are covered by legal professional privilege and are not normally placed in the public domain. It should also be noted that, for the time being, there remains the possibility of these cases being subject to further review by the European Court of Human Rights. For these reasons it would not be appropriate to publish the instructions. In accordance with the Law Officers' convention, I can neither confirm nor deny whether the Attorney-General approved the instructions.

Lord Morris of Aberavon: To ask Her Majesty's Government whether they will place in the Library of the House a transcript of the submission of counsel who appeared on behalf of the United Kingdom in the cases of Eweida, Chaplin, Ladele and McFarlane in the European Court of Human Rights.[HL4722]

**Reply from Baroness Stowell of Beeston:** No transcript of this hearing exists, because the European Court of Human Rights does not have a transcription service. However, I am able to provide a link to the court's website, which makes available a video recording of the court's hearing of 4 September, including the statement by counsel for the UK Government:
