British Nationality

Baroness Berridge: To ask Her Majesty's Government how many British citizens have obtained their nationality by naturalisation.[HL6624]

To ask Her Majesty's Government how many British citizens have obtained their nationality by registration.[HL6625]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Information on the resident population of the UK by nationality and country of birth is published by Office for National Statistics at: http://www.ons.gov.uk/ons/taxonomy/index.html?nscl=International+Migration

Information on the total number of British citizens who have obtained their nationality by naturalisation or by registration is not available.

Data is published on the annual number of grants of British citizenship based on naturalisation and registration made in each year from 1962 to 2013 in table cz 03 of Immigration Statistics, available in the library of the House and at: https://www.gov.uk/government/collections/immigration-statistics-quarterly-release The latest edition of table cz 03 is available at:

From 1962 to 2013 there were 2.9 million grants of British citizenship based on naturalisation and 0.9 million grants based on registration. It is not possible to determine from the administrative data how many of the persons granted British citizenship since 1962 have subsequently died or changed citizenship.

Baroness Berridge: To ask Her Majesty's Government how many British citizens have nationality by being born in Britain.[HL6626]

Reply from Lord Wallace of Saltaire: The information requested falls within the responsibility of the UK Statistics Authority. I have asked the Authority to reply.

Letter from Joe Grice, Director & Chief Economist for National Statistics, to Baroness Berridge, dated April 2014 ...

ONS does not have data on the number of British nationals who were born in Great Britain. However, the Annual Population Survey provides estimates of the number of UK nationals who were born in the UK and who were resident in the UK at the time of the survey. This estimate would exclude UK nationals who were born in the UK but who are usually resident abroad.

The latest estimates use APS data for the 12-month period of January to December 2012 and show that there were 54,151,000 UK nationals who were born in the UK and were usually resident in the UK in 2012, with a corresponding margin of error of +/- 321,000. The margin of error refers to the 95 per cent confidence interval and is a measure of the uncertainty associated with making inferences from a sample.

Justice: Immigration and Asylum

The Earl of Sandwich: To ask Her Majesty's Government whether they have any plans significantly to reduce the involvement of expert non-legal members in the Immigration and Asylum Chamber; if so, in the light of the volume of deportation appeals and of unrepresented appellants, what alternative provision there will be for expert advice in sensitive cases; and how they will ensure that the public interest is fully represented on panel hearings.[HL6578]

Reply from the Minister of State, Ministry of Justice (Lord Faulks): The panel composition for Tribunals within the unified Tribunal structure are matters for the Senior President of Tribunals under the Tribunals, Courts & Enforcement Act

2007. These powers are delegated where appropriate to Chamber Presidents of individual chambers of the First-tier and Upper Tribunals. The Senior President published a consultation document regarding the deployment of non-legal members within the Immigration and Asylum Chamber in November 2013. The consultation sought views on whether senior judges within the Chamber should decide on a case-by-case basis whether a non-legal member should sit on a Tribunal panel "where the President of First-tier Tribunal (Immigration and Asylum) or a Resident Judge has decided that there are strong public interest reasons". Yarl's Wood Immigration Removal Centre

Lord Ramsbotham: To ask Her Majesty's Government why the United Nations special rapporteur on violence against women was refused access to Yarl's Wood immigration detention centre while on an official visit to the United Kingdom.

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): My Lords, a visit to Yarl's Wood immigration removal centre was never agreed as part of this fact-finding mission. However, as part of her visit, the special rapporteur, Ms Rashida Manjoo, met the Home Secretary, the Minister for Crime Prevention and the Chief Inspector of Prisons.

Lord Ramsbotham: ... As he will appreciate, it can do our national reputation no good at all if it should ever be felt that the United Kingdom is refusing access to a UN special rapporteur who is here in connection with the signature that we have given to the optional protocol on the UN Convention against Torture and Other Cruel, Inhuman or Degrading Treatment. Therefore, I hope very much that, in future, that position will be clarified, as the publicity can have done no good at all. I would be very grateful if the Minister could inform the House of what action will be taken to ensure that future visits can be properly handled.

Reply from Lord Taylor of Holbeach: I disagree with the premise of the noble Lord's question, because Ministers met the special rapporteur and were keen to support a programme for her visit that was more directly relevant to addressing violence against women and girls. That is why we offered the visit to a refuge, facilitated by Women's Aid, and supported a number of other visits for the special rapporteur, including a visit to a number of government departments, devolved Administrations and front-line agencies relevant to the reasons for her visit.

Baroness Lister of Burtersett: My Lords, the recent report by Women for Refugee Women found that many of the women in Yarl's Wood had experienced sexual violence, which surely makes it a relevant visit for the special rapporteur. What is the Government's response to that report, which showed the traumatic impact on those women of detention?

Reply from Lord Taylor of Holbeach: No one can be unaware of the fact that detention is a necessary evil. It is part of the requirements that we have in enforcing an immigration policy. However, the inspection by the Chief Inspector of Prisons found very little evidence of victimisation of women at the centre. It was felt that there was insufficient recognition of particular vulnerabilities of detained women; those points were taken and are being addressed by Yarl's Wood.

Lord Avebury: My Lords, apart from the chief inspector's findings on the lack of

recognition of the vulnerabilities of women detained in Yarl's Wood, there was also a finding that the quality of rule 35 reports was poor. Was not the refusal to admit Ms Manjoo not only a kick in the teeth for the UN, violating the terms of its mandate, but an unfortunate indication that those concerns had not been addressed, as the special rapporteur seems to have suspected?

Reply from Lord Taylor of Holbeach: No, my Lords, that is not the case. Yarl's Wood was inspected by Her Majesty's Chief Inspector of Prisons last year and, overall, the report was positive. I mentioned those aspects of which I felt it was important for the House to be aware. Detention is an essential part of effective immigration control and we take the welfare of those in our care very seriously. Her Majesty's Chief Inspector of Prisons has responsibility for ensuring that those standards are maintained.

Baroness Scotland of Asthal: My Lords, does the noble Lord not appreciate that Yarl's Wood has caused a lot of concern not only in this country but internationally, and that a failure to allow the UN special rapporteur to enter causes even more alarm, although I accept absolutely what he says about detention being necessary in some cases?

Reply from Lord Taylor of Holbeach: I have explained to noble Lords and, I hope, to the noble Lord, Lord Ramsbotham, in responding to his Question, the reasons why we felt that it was more appropriate to give the rapporteur the opportunity to see the effective measures that the Government are taking to address violence against women and girls.

Baroness Symons of Vernham Dean: My Lords, the noble Lord has been very good in explaining the meetings that the special rapporteur had and sought to say that he thought those meetings were sufficient. However, he has absolutely failed to explain to the House why the special rapporteur was denied access to Yarl's Wood. It is a very simple question, not about the meetings that she had but why, specifically, she could not go to Yarl's Wood.

Reply from Lord Taylor of Holbeach: Access to Yarl's Wood is in the gift of the Home Office, which determines whether it is suitable for people to visit it. Her Majesty's Chief Inspector of Prisons has a statutory role to address that issue. It was not a question of denying this person the opportunity to do her job. She was given every chance to take up our offers to visit refuges, but she did not choose to do so.

Lord Roberts of Llandudno: My Lords, what statement did the Chief Inspector of Prisons make following the refusal to allow the rapporteur to enter Yarl's Wood?

Reply from Lord Taylor of Holbeach: I am afraid that I cannot comment on that as I do not have the details of that question.

Asylum

Kerry McCarthy: To ask the Secretary of State for Foreign and Commonwealth Affairs what the Government's policy is on developing international frameworks and forums to provide refugees from climate-induced displacement with legal protection, including legally-worded definitions for such cases. [196876]

Reply from Mark Simmonds: The Government supports work to establish how existing international institutions and frameworks can be used to address climate change induced migration. Refugee status under existing international and EU legislation is based on the risk of persecution, and it is Government policy to avoid developing separate frameworks that could duplicate or contradict this. The Government is also committed to securing an ambitious and legally-binding

climate agreement next year at Paris COP 21 to limit the damage caused by anthropogenic climate change.

Asylum Seekers

Lord Roberts of Llandudno: To ask Her Majesty's Government what proportion of asylum applications were granted (1) in the first instance, and (2) after some form of appeal, in each year since 2010.[HL6630]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The table below shows the total number of asylum applications received in each year since 2010, and the proportion of asylum applicants in the first instance that were (1)(i) granted asylum, (ii) granted Humanitarian Protection, Discretionary Leave or Other Grants, and after some form of appeal were (2)(i) granted asylum, (ii) granted Humanitarian Protection, Discretionary Leave or Other Grants, as at May 2013 when the statistics were compiled.

Figures for 2013 will be published at the end of August 2014.

DL Discretionary Leave

The analysis of the outcomes of asylum applications are the recorded outcomes of the group (or cohort) of applicants in any one year, as at a particular time. A proportion of applications made in each of the years provided will be awaiting the outcome of an initial decision or an appeal. Applications from earlier years will inherently have had longer for the case to be processed than those from more recent years. This dataset is updated, in full, annually.

There are a large variety of routes that an asylum application can take to a final asylum outcome. As a consequence, analysis of the outcomes of asylum applications in any one year requires interpretation for a small percentage of cases. This interpretation is undertaken consistently by established computer code. The proportions and underlying figures for final outcomes of the analysis of applications for the group (or cohort) of applicants in any one year, are therefore estimated.

The Home Office publishes statistics on the outcome of asylum applications in Table as_06 (Asylum data tables Volume 1) of Immigration Statistics. The latest release Immigration Statistics October to December 2013 is available from:

Lord Roberts of Llandudno: To ask Her Majesty's Government, further to the judgment issued on 9 April by Mr Justice Popplewell in Refugee Action v Secretary of State for the Home Department, whether they have any plans to establish an inquiry into the way asylum support rates are calculated.[H L6814]

Reply from Lord Taylor of Holbeach: The Government plan to review asylum

support rates. That review will take account of the judgment and other information. The review will be completed by 9 August 2014.

Asylum: Scotland

Pete Wishart: To ask the Secretary of State for the Home Department (1) how many pregnant women in Scotland were granted section 4 support under the Immigration and Asylum Act 1999 for reasons including that they were deemed unfit to travel in each of the last five years; [197399]

- (2) at what gestation stage each pregnant women in Scotland granted section 4 support under the Immigration and Asylum Act 1999 received the decision to grant that support; [197400]
- (3) how many pregnant women in Scotland are in receipt of section 4 support under the Immigration and Asylum Act 1999; how many such women were moved to different accommodation during pregnancy; how many weeks pregnant each such woman was when she was moved; what the reason for each such move was; and if a risk assessment of each such move was undertaken which included input from a treating clinician; [197427]
- (4) what the length of time was between the date of application by each pregnant woman in Scotland for section 4 support under the Immigration and Asylum Act 1999 and the date of receipt by the applicant of that support; [197431]
- (5) how many pregnant woman in Scotland were denied section 4 support under the Immigration and Asylum Act 1999 for reasons that included an assessment that they were fit to travel; and what the gestation stage of each such woman was when that decision was made in each of the five years to 2013-14. [197432]

Reply from James Brokenshire: The information requested is not routinely collected and could be provided only by examining individual case records, which would result in disproportionate cost.

Asylum: Finance

Pete Wishart: To ask the Secretary of State for the Home Department (1) if she will make it her policy to ensure that pregnant women and nursing mothers in receipt of section 4 support under the Immigration and Asylum Act 1999 are recognised as a vulnerable group when contracting and allocating placement accommodation; [197402] (2) if she will place in the Library a copy of all guidance and benchmarking criteria used by her Department, its contractors and agents when assessing the adequacy and suitability of placement accommodation allocated to pregnant women and nursing mothers in receipt of section 4 support under the Immigration and Asylum Act 1999. [197401]

Reply from James Brokenshire: The guidance and procedures on providing accommodation to pregnant women in the asylum support system is contained in the policy document "Healthcare needs and Pregnancy Dispersal guidance", which can be found at:

The Home Office is currently considering some changes to the document following consultation with the Refugee Council and Maternity Action.

Pregnant women are already recognised as a vulnerable group in the asylum support system. Regulation 4 of the Asylum Seekers (Reception conditions)

Regulations 2005 provides that their special needs must be taken into consideration.

Children in Care: Asylum

Steve McCabe: To ask the Secretary of State for Education what responsibilities local authorities have to ensure that asylum seekers who are leaving care they entered as a child receive alternative support once they reach adulthood. [194872]

Reply from Edward Timpson: Unaccompanied asylum seeking children must be provided with the same support as for any care leaver, as set out in Volume 3 of 'The Children Act Guidance and Regulations: Planning Transition to Adulthood for Care Leavers'¹.

Financial support for looked after unaccompanied asylum seeking children should reflect their needs as eligible care leavers and their immigration needs. As for any relevant child, once an unaccompanied asylum seeking child leaves care or reaches the age of 18, a personal advisor must be appointed to support them.

Asylum: Children

Steve McCabe: To ask the Secretary of State for the Home Department pursuant to the answer of 7 April 2014, *Official Report*, column 111W, on asylum: children, what funding her Department provides to local authorities to help cover the costs of supporting careleavers who are asylum seekers; and how the Department monitors the use of that funding. [196547]

Reply from James Brokenshire: Local authorities are able to claim funding of £95 per day for each asylum seeker they support who is aged under 16 and £71 per day for each asylum seeker they support who is aged 16 or 17. Local authorities who continue to support care leavers past the age of 18 may apply for funding of £150 per week for each supported person above a threshold of 25 cases. A small number of local authorities receive extra funding because of their special circumstances, for example if they receive an exceptionally large number of cases. In order to claim the funding local authorities are required to submit detailed information about their expenditure, to ensure that it is incurred only for supporting cases eligible to the funding.

Mary Creagh: To ask the Secretary of State for the Home Department pursuant to the answer of 10 April 2014, *Official Report*, columns 352-3W, on asylum: children, if she will publish a breakdown by constituency of the number of unaccompanied asylum-seeking children in each of the last 10 years. [197188]

Reply from James Brokenshire: Figures for unaccompanied asylum-seeking children by parliamentary constituency are not collected by the Home Office.

The Home Office publishes aggregate statistics on asylum applications from unaccompanied asylum seeking children in tables as_08 and as_08_q (Asylum data tables Volume 2) of Immigration Statistics. Figures based on revised counting rules appear in the latest release Immigration Statistics October to December 2013 which is available from:

Immigration: Detention

Lord Hylton: To ask Her Majesty's Government, at the latest date, how many immigration detainees were being held in HM prisons; how many foreign national offenders, whose sentences had already expired but who had not been deported were being held; and what assessment they have made of the impact of such persons on the rehabilitation of British prisoners.[HL6579]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): For the week commencing 31 March, there were 720 immigration detainees in prisons.

Please note that the data includes a small number of individuals who have never served a custodial sentence, but who present specific risk factors that indicate they pose a serious risk of harm to the public or to the good order of an Immigration Removal Centre (IRC) including the safety of staff and other detainees, which cannot be managed within the regime applied in IRCs.

To extract this small number of cases would incur a disproportionate cost.

Foreign national offenders held in prisons beyond the end of their sentence under immigration powers are normally held in unconvicted conditions. Their presence in these prisons does not affect the rehabilitation of British nationals whose access to accredited interventions and other rehabilitation services is governed by risk of offending and offender-related need.

Human Trafficking

John Randall: To ask the Secretary of State for the Home Department if he will take steps to ensure that assets of human traffickers are frozen within 48 hours of their arrest; and if he will make a statement. [903856]

Reply from Karen Bradley: The Serious and Organised Crime Strategy, published in October 2013, sets out how the Government will make it harder for criminals to use, hide and move the proceeds of crime. The Government will, as soon as parliamentary time allows, seek to amend the Proceeds of Crime Act to enable assets to be frozen more quickly and easily.

Section 60B of the Sexual Offences Act 2003 allows for relevant land vehicle, ship or aircraft to be detained where a person has been arrested for a human trafficking offence. These powers will be brought forward and consolidated into the Modern Slavery Bill.

Human Trafficking: Children

Tim Loughton: To ask the Secretary of State for the Home Department when her Department's Personal Advocate Pilot for trafficked children will start; how non-governmental organisations will participate in the schemes; and when each pilot scheme in each participating local authority will start and end. [197530]

Reply from Karen Bradley: The Modern Slavery Bill will enable us to strengthen our response to human trafficking and modern slavery for both adults and children. We announced in January our intention to trial specialist independent advocates for victims of child trafficking.

23 local authorities that represent a wide demographic range as well as major transport hubs and asylum screening units have agreed to participate in the trial. These areas also have the highest rates of trafficking referrals to the National Referral Mechanism or are areas where we are aware of a high number of

trafficking investigations by law enforcement agencies.

We are currently considering bids from a number of voluntary and community services organisations that were identified as potential providers of the advocacy service because of the particular expertise they hold. When the trial goes live we will invite a number of relevant stakeholders, including non-governmental organisations, to inform the project through a consultative group.

We have to consider this matter following the passing in the Lords of an amendment to the Immigration Bill that has put on hold our proposals for these trials.

Police Scotland

Jackie Baillie: To ask the Scottish Government how Police Scotland tackles the barriers that might prevent people from underrepresented groups from joining the force. (S4W-20708)

Reply from Kenny MacAskill: The recruitment of police officers is a matter for Police Scotland and the Scottish Police Authority.

Police Scotland has set out in its recently published Corporate Strategy, plans to diversify its workforce through the promotion of attractive, inclusive and responsible practices including exploring alternative, flexible recruitment options to build a more diverse workforce. Lord Wallace of Saltaire: Action on inequalities in the workplace is taking place across government and public bodies and is reflected in the Government's strategies and measures to tackle disadvantage such as: the Social Mobility Strategy; the Equality Act 2010 and the Equality Strategy; the Child Poverty Strategy and the Social Justice Strategy. The Government are not complacent on these issues and know there is more to be done.

A specific example of action is the Financial Reporting Council's requirement for companies to disclose their policy on boardroom diversity, along with any measurable objectives that have been set for implementing the policy, and progress on achieving the objectives. In addition, the UK Corporate Governance Code states that companies should consider the balance of skills, experience, independence and knowledge of the company on the board, its diversity, and other factors relevant to its effectiveness as part of the board evaluation.

To ask Her Majesty's Government who first contacted (1) the Metropolitan Police Service, and (2) the Crown Prosecution Service, with the suggestion that it was unlawful for the supporters of Tottenham Hotspur to chant "yids", or that they should investigate the issue; whom they subsequently consulted; and how many meetings were held between those individuals or organisations, and at what level of seniority, to discuss the matter.[HL6475]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The Home Office does not hold the information requested. The Crown Prosecution Service has no specific policy relating to the chanting of the word "yids" by Tottenham Hotspur supporters and incurred no legal advice costs on this specific issue. The case against the three Tottenham Hotspur supporters was discontinued by the Crown Prosecution Service prior to the adjourned date of the hearing, without parties having to attend court, and without the associated costs being incurred.

The Crown Prosecution Service National Football lead has been consulted on a number of occasions regarding whether the use of the word "yid" could amount to a criminal act. The general advice given on each occasion was that each case depends on its specific facts. In relation to the case that was dropped against the three Tottenham Hotspur supporters, the police contacted the Crown Prosecution Service prior to charge. Advice was given that there was a realistic prospect of conviction. It subsequently transpired that the further evidence was not available and the case was therefore discontinued. Prior to the discontinuance a meeting took place between senior police officers and the Crown Prosecution Service officials.

Caste Discrimination

Lord Avebury: To ask Her Majesty's Government, in the light of their announcement in July 2013 that the consultation on caste legislation was expected in February or March 2014, why it has not yet been issued.[HL6447]

Reply from Lord Ahmad of Wimbledon: The Government is currently considering two issues which have developed and which have potential implications for the consultation.

In February, the Equality and Human Rights Commission (EHRC) published helpful research designed to inform the introduction of new legislation on caste, as outlined in the July 2013 announcement. However, that announcement said: "...work will also be undertaken to determine information about the extent of caste discrimination in Britain that can be used as a comparative baseline for any future consideration of the effectiveness of caste legislation."

We had intended to reflect consideration of this work in the public consultation process. However, further discussions between Government and the EHRC about

the research needed for it have revealed concerns that not only might this be difficult to commission successfully, but it could be seen as intrusive and might have an adverse effect on good relations in the relevant communities. We are therefore considering how best to proceed with the consultation in the light of this. Another recent development is the judgment in the Employment Tribunal case of *Tirkey v Chandok* which concluded that there is already legal protection against caste discrimination through the race provisions of the Equality Act 2010. We need to review recent case law to consider whether and how it may affect the way in which we implement the legislation.

We would expect the public consultation document, including our conclusions on these matters, to issue in the Autumn.
