UK Parliament Questions

Immigration Controls

Philip Davies: To ask the Secretary of State for the Home Department what steps are taken so that immigration officers ensure the removal of any face coverings before authorising an individual's entry to the UK. [197802]

Reply from James Brokenshire: All passengers wearing a veil or face covering on arrival in the United Kingdom will be asked to remove their veil so that their appearance can be compared with the photograph in their passport. If a passenger refuses to remove their veil they will be detained until they do so.

Entry Clearances

Adam Afriyie: To ask the Secretary of State for the Home Department (1) what representations she has received on removing the requirement to top up investments

held by individuals on Tier 1 (Investor) visas; [197733]

(2) what representations she has received on extending the list of investment products that individuals can use to qualify for a Tier 1 (Investor) visa. [197735]

Reply from James Brokenshire: The Home Office has had meetings with a number of immigration law firms who represent Tier 1 (Investor) clients in which these issues have been raised. The firms consider that removing the requirement to top up investments, and extending the list of qualifying investments, would attract more investors to the UK and encourage investments which would lead to greater returns.

The Government is currently considering its response to the report on the Tier 1 (Investor) route published by the Migration Advisory Committee (MAC) on 25 February 2014, which made recommendations on these issues. We will announce our decisions in due course.

Entry Clearances: Overseas Students

Frank Field: To ask the Secretary of State for the Home Department pursuant to the answer of 28 April 2014, *Official Report*, columns 526-27, on student visas, if she will publish details of the successful pilot with one university on ensuring overseas students return home once their course is completed. [197624]

Reply from James Brokenshire: Foreign national students who had been served with an adverse immigration decision were, at times, encountering a delay in receiving their travel documents back from the Home Office. On occasion, this resulted in their immigration status changing to an overstayer.

The pilot referred to was conducted through an informal relationship between the south central immigration compliance and enforcement (ICE) team and the international student advisers embedded within two local universities. Through this link, those whose leave has been curtailed, have had an adverse decision, or wish to depart the UK are provided with local assistance by the immigration enforcement team. The pilot has enabled the local ICE team to facilitate the return of travel documents quickly, resulting in an earlier departure for the student. This has benefits for both the student and university as becoming an overstayer could jeopardise future applications from students to continue their studies. During 2013-14, 50 students were assisted in this way from two universities (this is local data taken from local records that has not been sourced from an official database).

The Government is looking at how this example of local good practice can be extended nationally.

Immigration

Lord Holmes of Richmond: To ask Her Majesty's Government what plans they have to remove international students from the headline immigration figures.

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): My Lords, the Government publish immigration statistics broken down by category. The number of student immigrants may therefore be easily distinguished from other migrants. The independent Office for National Statistics' net migration statistics include students, and the Government have no plans to remove them. This makes no difference to the policy, which is that there is no cap and genuine international students are welcome.

Lord Holmes of Richmond: My Lords, the message must be clear to international students: we want you and we welcome you. Can my noble friend the Minister assure the House that the Government are doing everything to ensure that, when it comes to global higher education, the brightest and the best choose Britain?

Reply from Lord Taylor of Holbeach: I think that the whole House will agree with those sentiments. It is certainly the Government's policy, and I hope that it will be possible to persuade universities and Universities UK to take this opportunity to improve our position as the second provider of higher education to the world student population. This is a great opportunity for us, and we need to be united in sending that message.

Asylum Seekers

Lord Roberts of Llandudno: To ask Her Majesty's Government why they changed their contracting model for the provision of accommodation for asylum seekers in danger of destitution.[HL6878]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The COMPASS (Commercial and Operational Managers Procuring Asylum Support Services) project procured in accordance with the Public Contract Regulations 2006. The commercial principles behind the COMPASS procurement included:

A desire to manage demand for asylum accommodation services under a regional procurement model to create efficiency and quality from economies of scale• Appointing financially secure suppliers able to respond with potentially significant fluctuations (increases and decreases) in demand• Identifying suppliers with a proven track record and who would take the care of asylum seekers seriously• Updating the contract performance regime to align with Government procurement and Home Office strategic objectives and in recognition of National Audit Office reports into the previous accommodation contracts

Lord Roberts of Llandudno: To ask Her Majesty's Government whether the Home Office plans to re-examine its savings forecasts in the light of the additional costs incurred in the transition between contractors overseeing the Government's accommodation provision for destitute asylum seekers.[HL6880]

Reply from Lord Taylor of Holbeach: COMPASS savings are directly linked to the number of people in asylum accommodation that changes continually. COMPASS savings are therefore monitored and reappraised against Home Office forecasts continually. The latest benefits review, carried out after the end of the 2013-14 financial year, indicates that savings for that year exceeded those profiled in the original business case and that the project remains on target to deliver £140m of financial benefits during its lifetime. Savings are being made despite the supported population increasing in line with higher asylum intake.

Lord Hylton: To ask Her Majesty's Government how many applications for asylum were received from children arriving unaccompanied into the United Kingdom for each of the last three years for which figures are available.[HL6883]

Reply from Lord Taylor of Holbeach: In 2012 and 2013 there were 1,125 and 1,174 applications for asylum received from children arriving unaccompanied into the United Kingdom (Unaccompanied Asylum Seeking Children).

There are currently no comparable figures for 2011. An internal review of UASC data highlighted issues with the definitions used for data published prior to 2012. Revised UASC figures for 2011 will be published in Immigration Statistics January to March 2014 on 22 May 2014.

Lord Hylton: To ask Her Majesty's Government whether they will assess the research in progress in the Universities of Cambridge and Oxford on communicable diseases among refugees and displaced people.[HL6886]

Reply from Baroness Northover: Once the study publishes its findings, we look forward to assessing this as part of the overall body of evidence on the topic.

Lord Roberts of Llandudno: To ask Her Majesty's Government how they decide which retailers can be accessed using the Azure prepayment card given to asylum seekers. [HL6997]

Reply from Lord Taylor of Holbeach: The Azure card is provided to failed asylum seekers supported under the provisions of section 4 of the Immigration and Asylum Act 1999.

Any retail outlet that provides food and other essential living items and accepts visa transactions can apply to join the Azure card scheme. The card is currently accepted by Tesco, Asda, Sainsbury's, Morrison's, the Co-operative, Boots, Peacocks, Early Learning Centre, Mothercare, The British Red Cross, The Salvation Army and a few small independent retailers. There are ongoing discussions with other outlets that may be interested in joining the scheme.

David Hanson: To ask the Secretary of State for the Home Department how many people have been removed from the UK under the Dublin Convention in each year since 2010. [197239]

Reply from James Brokenshire: The information requested is shown in the following table:

People removed	1

2011	1,308
2012	970
2013	1,020

Note: The figures quoted have been derived from management information and are therefore provisional and subject to change. This information has not been quality assured under National Statistics protocols.

Removals fell in 2011 and 2012 because we stopped transferring asylum applicants to Greece under the Dublin Regulation in 2010. This was because it was found conditions there amounted to a breach of article 3 of ECHR. There then followed similar litigation around conditions in Italy, but we are still able to effect transfers there.

Jeremy Corbyn: To ask the Secretary of State for the Home Department what payments her Department makers to destination countries for visas allowing entry to people being deported from the UK to those countries. [198275]

Reply from James Brokenshire: We work closely with embassies from a wide range of countries to obtain travel documents, rather than visas, to assist removal. We pay a small administrative fee for these documents, which enable the removal of people who have no right to be in the UK.

Scottish Parliament Motion

S4M-10039 Jackie Baillie: Severe Funding Cut for Show Racism the Red Card—That the Parliament notes with concern the significant reduction of funding for Show Racism the Red Card (SRTRC) and its anti-sectarianism strand, Show Bigotry the Red Card (SBTRC), from £120,000 in 2011-12 to £40,000 in 2014-15; understands that this cut was not agreed with the charity despite the answer to parliamentary question S4W-20199 on 7 April 2014 stating otherwise; believes that the cut was only agreed after negotiation that other funds would be made available, which has not happened; understands that, with the significant financial pressure being placed upon it, the charity is currently unable to fill a key post, which has had a severe impact on the services it provides; believes that the work of SRTRC is vital in tackling racism and sectarianism; understands that, of SRTRC and SBTRC participants who admitted to using sectarian or racist behaviour in the past, 70.5% said they would not do so again and that 90.6% of participants said that they would report incidents thanks to the charity's input, and calls on the Scottish Government to reinstate financial support to SRTRC to 2011-12 levels to

allow it to continue to deliver its essential education and campaign work against racism and sectarianism in Scottish communities.

UK Parliament Questions

Castes

Jeremy Corbyn: To ask the Ministers for Women and Equalities when the Government plans to introduce regulations under the Equalities Act to prevent discrimination by caste and descent. [198276]

Reply from Helen Grant: There is a lack of certainty on some intrinsic issues around caste, such as what it is and how it is manifested, partly because there had never been any form of public consultation on caste. It was accepted therefore by both Front Benches during the parliamentary debate on this issue last year that the whole process, up to and including the commencement of legislation, would take time and should include a consultation on the proposed legislation. The Government is currently considering two issues which have developed and which have potential implications for the consultation stage. We would expect the public consultation document, including our conclusions on these matters, to be issued in the autumn. We will then be in a position to consider plans to introduce regulations. You may also wish to note the answer given to Lord Avebury by Lord Ahmad of Wimbledon, on 6 May 2014, Official Report, columns 331-32.

Racial Discrimination

Philip Hollobone: To ask the Secretary of State for Communities and Local Government how much financial support his Department provided to Hope not Hate in each of the last three years; and what steps he takes to prevent the use of such monies for party political campaigning. [198044]

Reply from Stephen Williams: 'Hope Not Hate' has not received any financial support from the Department for Communities and Local Government.

This Department provided Searchlight Educational Trust, a registered charity, with a grant of £66,000 in the financial year 2012-13 to establish community partnerships to foster integration in four neighbourhoods.

Following completion of the project, Searchlight Educational Trust changed their name to Hope Not Hate Educational Ltd. We monitored progress with the project closely and are satisfied that the funding for Searchlight Educational Trust was used for purposes outlined in the funding agreement and that no funding was used for party political campaigning. Conditions in the funding agreement prevent funds being spent on political campaigning. Furthermore, an organisation that exists for political purposes would not meet the criteria for charitable status-so we would be unable to award them grant under the Charities Act 2006.

I am aware that it has been claimed that the Department has funded campaigning by Hope not Hate against a certain political party. This is completely untrue.

Female Genital Mutilation

Baroness Valentine: To ask Her Majesty's Government what training is available for general practitioners in identifying cases of female genital mutilation.[HL6866]

Reply from the Parliamentary Under-Secretary of State, Department of Health (Earl Howe): The Government published the guidance, *Multi-Agency Practice Guidelines: Female Genital Mutilation* in 2011, which provides advice to health professionals and the steps to be taken when dealing with suspected or actual female genital mutilation (FGM).

The Department is working with NHS England, Health Education England and the Royal Colleges to develop materials and training to support National Health Service staff including general practitioners to better identify and support girls at risk of FGM. Further announcements on this work will be made in due course.

An FGM NHS Choices page (www.nhs.uk/fgm) was recently launched containing information and support for frontline professionals who are concerned about the practice and are seeking advice.
