# **Scottish Parliament Questions**

### **Immigration (Economic Benefits)**

**John Mason:** To ask the Scottish Government what the economic benefits of immigration from the European Union are to Scotland. (S4O-03753)

**Reply from the Minister for Europe and International Development (Humza Yousaf):** The Scottish Government recognises the importance of migration for healthy population growth and sustainable economic growth. European Union migrants play a valuable role in our economic prosperity and will always be welcome in Scotland. A University College London report that was published earlier this month made the value of EU migrants clear. It found that, between 2001 and 2011, recent European migrants made a net contribution of £20 billion to the United Kingdom economy.

John Mason: I thank the minister very much for that response. My understanding is that

certain sectors in our economy are very dependent on folk from overseas, including those from European Union countries. Will he join me in deploring the anti-immigration hysteria that has been encouraged by some political parties?

**Reply from Humza Yousaf:** John Mason makes a very valid point. Where concerns and tensions exist we have a duty to address them, but politicians must not be tempted to use inflammatory rhetoric in the pursuit of cheap political gain.

I felt disheartened and angry when I read the comments from the UK Secretary of State for Defence, Michael Fallon, about towns and cities being "swamped" and "under siege" from immigrants. We must condemn such distasteful language, which is, frankly, straight out of the British National Party's handbook.

Immigrants contribute culturally, socially and even—thank god for it—through their cuisine, so EU migrants are very, very welcome in Scotland.

Jamie McGrigor: I fully recognise the many benefits that immigration, especially from Eastern Europe, has brought to Scotland and to the tourism industry in particular, not least in my region of the Highlands and Islands. However, does the minister agree that it is paramount that we ensure that we have a fair immigration system that favours those who want to come here to work hard and contribute to Scottish society rather than those who wish only to reap benefits?

**Reply from Humza Yousaf:** I do not see anybody advocating, and I have never come across a politician or political party that advocates, illegal immigration. We all want to clamp down on those who choose to abuse the system, and that is absolutely correct. However, we must understand that being part of the European Union means that, for every person who comes from Eastern Europe to work in Scotland, there is a Scot who has a retirement villa on the Costa del Sol. It is a two-way process, which we enjoy.

I agree with Jamie McGrigor that there are vital sectors that need immigration, and the UK Government's immigration rules are completely counterproductive in filling those skills gaps. That is why the Institute of Directors, the Scottish Trades Union Congress and Universities Scotland have requested a measure of devolution on immigration.

We will chew over what the Smith commission has said on the matter as one of the issues for consideration. I am sure that Jamie McGrigor, given the geography that he represents, will wish to make further representation on the matter too.

### **UK Parliament Ministerial Statement**

#### Immigration Act 2014: Marriage and Civil Partnership

**The Minister for Security and Immigration (James Brokenshire):** I am pleased to inform the House that, subject to Parliamentary approval of the necessary secondary legislation, I plan to implement important new provisions under Part 4 of the Immigration Act 2014 to tackle sham marriages and civil partnerships on Monday 2 March 2015.

Part 4 of the Act will give us a much stronger platform for effective, systematic action to disrupt and deter sham marriages and civil partnerships and prevent them gaining an immigration advantage.

It will extend the marriage and civil partnership notice period from 15 days to 28 days for all couples in England and Wales marrying following civil preliminaries or forming a civil partnership.

Couples involving a non-European Economic Area (non-EEA) national who wish to marry in the Church of England or the Church in Wales will be required to complete civil preliminaries and give notice at a register office.

## Immigration and Asylum UK Parliament Ministerial Statement (continued)

From 2 March 2015 I also plan to implement under Part 4 of the Act a new referral and investigation scheme for proposed marriages and civil partnerships across the UK involving a non-EEA national who could benefit in immigration terms. All proposed marriages and civil partnerships involving a non-EEA national with limited or no immigration status in the UK, or who does not provide specified evidence that they are exempt from the scheme, will be referred to the Home Office. Where we have reasonable grounds to suspect a sham, we will be able to extend the notice period in these referred cases to 70 days in order to investigate and take appropriate enforcement or casework action where we establish a sham. A couple will be unable to get married or enter into a civil partnership on the basis of that notice if they do not comply with an investigation under the scheme.

By extending the notice period and channelling to the Home Office all proposed marriages and civil partnerships which could bring an immigration benefit, the new system will give us much more time and information to identify and act against sham marriages and civil partnerships before they happen and, where they do go ahead, we will have the evidence we need on file to be able to refuse any subsequent immigration application in terms which will withstand appeal.

The referral and investigation scheme will be extended to Scotland and to Northern Ireland from 2 March 2015, subject to Parliamentary approval of the necessary secondary legislation. Those who give notice of marriage or civil partnership before 2 March 2015 will not be affected by the changes.

Transitional arrangements will apply for couples where at least one party is resident overseas, who have made arrangements before 2 March 2015 for a marriage or civil partnership in England and Wales and who intend to give notice and get married or form a civil partnership in one visit on or after that date. Couples in this situation will be able to apply, at the time of giving their notice of marriage or civil partnership to the registration official, to have the notice period reduced to 15 days.

Transitional arrangements will also apply for couples involving a non-EEA national who before 2 March 2015 have been granted, or have applied for and are later granted, a common licence to marry in the Anglican Church in England and Wales. Couples in this situation will be able to marry on the basis of that licence and will not be required to complete civil preliminaries before marrying.

**Reply from James Brokenshire:** The Life in the UK test was significantly revised in March 2013 to place the emphasis on British history, culture and democracy. It is intended to help those seeking to live permanently in the UK to gain a basic understanding of the democratic principles underlying British society, and of aspects of British culture and traditions.

### **Immigration Statistics**

**Philip Davies:** To ask the Minister for Policing, Criminal Justice and Victims to make a statement on the latest immigration figures.

**Reply from the Minister for Policing, Criminal Justice and Victims (Mike Penning):** ... Yesterday the Office for National Statistics published the latest quarterly figures on net migration. ...

Such mass immigration makes it very difficult to maintain social cohesion. The Government have set about reforming the immigration system and made it clear that it will be fairer for British citizens and legitimate migrants. These rules are tough. We would like to see net migration reduced to what it was in the 1990s, as the Prime Minister has set out. As successive net migration statistics have shown, where we can control net migration, our reforms are working. Net migration from outside the EU has dropped by 25%, but net migration from inside the EU has grown. It is a really difficult situation and we are trying desperately to control it.

Although net migration from outside the EU is down, net migration from within Europe is up by 75%. It is not just about the figures that were released yesterday—that is the indication in all the recent figures. That is why the Prime Minister is outlining today the action he will take when he becomes the next Prime Minister in his negotiations with the EU on the benefit system for migrants coming to this country.

We have already taken unprecedented action to control benefits for those from the EU and outside the EU. We are continuing to consider how this can be done and how we can control it even better. We have reformed benefits, health care and housing rules to make them among the tightest in Europe and we intend to go further. The reforms we have made, including cutting EU jobseeker entitlements, will save British taxpayers £500 million over the next five years. ...

**Philip Davies:** I am grateful to the Minister for that reply. These latest figures are not just disappointing, they are catastrophic. ...

We know that the EU is not going to budge on the principle of the free movement of people and therefore we need to leave. Will the Minister explain why the part of the immigration figures that the Government can control—non-EU immigration—also went up in the past year and what the Government are doing to bear down on that?

Do the Government agree that these levels of immigration are completely unsustainable? Does the Minister accept that we cannot cope culturally with immigration at these levels? Does he agree that the NHS cannot cope with immigration levels of this magnitude? Does he accept that we cannot provide the school places fast enough and that we cannot build the houses needed for this level of immigration? We would have to build an entire Bradford district every two years to keep up and it is ridiculous to think that that is possible in any way. ...

**Reply from Mike Penning:** ... I agree with many of his views, but not with some of the views he has made public today. ...

**Seema Malhotra:** The truth is that this net migration target is the worst of all worlds. It does not include illegal immigration, where we know enforcement has worsened, yet it has encouraged the Government to target valuable university students. Their numbers have flatlined even though, as the Government know, they bring billions into Britain and build relationships that contribute to strong trade links in the future. And it is just wrong to include refugees in the target. ...

### **Overseas Students**

**Lord Ashcroft [**HL2850] To ask Her Majesty's Government whether they have any proposals to follow the Canadian example of allowing foreign students the opportunity to work in the United Kingdom for a limited period before they return home.

**Reply from Lord Bates:** The UK has an excellent offer for international students, which already includes a number of options for those who wish to stay to work or set up in business after their studies.

Students who get a graduate job paying an appropriate salary can stay after their studies by switching into the Tier 2 route. There is no limit on the number of these places, which are exempt from the cap on economic migrants.

Graduates who wish to undertake a period of professional training relating to their degrees before pursuing a career overseas may do so by switching into an appropriate Tier 5 scheme.

Those completing a PhD or other doctoral qualification can stay for a year under the Tier 4 Doctorate Extension Scheme, which allows completing students to work, gain experience in their chosen field, or set up as an entrepreneur, again with no limit on numbers.

Those who wish to stay to develop a business idea can do so under the Graduate Entrepreneur scheme, the first in the world of its kind. All they need is an endorsement from their Higher Education Institution that they have a genuine and credible business idea, and to have enough funds to support themselves.

This is therefore likely to under-report the total figure as it will not capture data where individuals have variances in their personal details recorded on the different databases.

#### Asylum: Middle East

**Lord Alton of Liverpool** [HL2748] To ask Her Majesty's Government how many refugees from the Christian communities of Iraq and Syria have been received into the United Kingdom in the last 12 months; and whether they intend to review immigration and asylum provisions for such Christian refugees in the light of the continuing attacks upon them in their home countries.

**Reply from Lord Bates:** All asylum claims are considered on a case-by-case basis in accordance with our international obligations, taking full account of the conditions in the country concerned. The Home Office does not systematically record the basis of a person's asylum claim or the reason(s) why a person might be granted asylum, and therefore does not have accurate data on how many Christians from Iraq and Syria have claimed or been granted asylum in the UK.

In terms of reviewing our immigration and asylum provisions, the Home Office has recently updated its country information and guidance on Iraq and plans to do likewise on Syria shortly. The guidance to decision makers – as informed by the accompanying country information – recognises the precarious situation in parts of Iraq under the control of, or being contested by, the Islamic State in Iraq and the Levant (ISIL). It also recognises that particular groups, including Christians, are at heightened risk and are therefore likely to qualify for protection.

We continue to monitor the situation closely and, as the situation changes and more up-to-date information becomes available, we can and will update the country information and guidance to reflect this.

**Reply from James Brokenshire:** The Home Office publishes quarterly and annual statistics on the number of refugees that have been resettled in the UK within Immigration Statistics Release. The data on nationals of Syria that have been resettled under the VPR scheme are available in the Immigration Statistics: April – June 2014, table as.19 from GOV.UK on the statistics web pages at:

#### Asylum: Syria

Caroline Lucas [214593] To ask the Secretary of State for the Home Department, what recent discussions she has had on UNHCR's request for more resettlement places for Syrian Refugees in 2015-16; if she will make it her policy to expand the Syrian Vulnerable Persons Relocation scheme ahead of UNHCR's global pledging conference in December 2014; and whether she or another Minister will attend that conference.

**Reply from James Brokenshire:** With over 3.2 million Syrian refugees now in Syria's neighbouring countries, the Government believes that humanitarian aid and actively seeking to end the conflict are the most effective ways for the UK to help the majority of those displaced, rather than large scale resettlement. We have made our position on this clear in relevant discussions with international partners and the United Nations High Commissioner for Refugees (UNHCR). We are aware that states have responded to the crisis in different ways; it is right that the international community should consider all available means to relieve the suffering of Syrians displaced by the conflict.

To complement our humanitarian aid, we operate the Syrian Vulnerable Persons Relocation scheme to relocate the most vulnerable displaced Syrians who cannot be supported effectively long term in the region to the UK. The scheme is based on need rather than fulfilling a quota; however, we expect it to help several hundred people over three years. This is in addition to our consideration of asylum claims lodged in the UK under our normal rules. However, we strongly believe that we should continue to focus on aid rather than resettlement as the best way for the UK to maximise our impact, and we therefore have no current plans to expand the scheme.

**Reply from James Brokenshire:** As part of the contract competition undertaken in 2014, Sprakab and Verified provided strong evidence of the quality of the services offered. There are dedicated formal arrangements in place to monitor our suppliers' compliance with the contract terms.

Sprakab also has its own internal quality checks, and - through the Swedish Migration Board – a sample of its tests are externally checked by the Immigration and Naturalisation Services (IND) of the Netherlands.

The quality of assessments made by Sprakab, have been thoroughly scrutinised by the Courts on a number of occasions. Where any criticisms have been made

about methodology, changes have been made to address them. Most recently, in 2014, the Supreme Court agreed that Sprakab's analyses were admissible in evidence, and for the conclusions they expressed to be given weight according to the reasoning and expertise used to support them.

#### Illegal Immigrants

**Christopher Chope** [213890] To ask the Secretary of State for the Home Department, how many people have been prevented by UK Border Force officers from entering the UK illegally in the last year for which figures are available; and how many of those people have been prevented more than once from entering illegally.

**Reply from James Brokenshire:** Between April 2013 and March 2014, Border Force and other agencies detected around 18,000 clandestines at the juxtaposed ports in France, while a further 16,570 people were refused entry at UK ports.

Please note, the figures on both clandestines and refusals represent the number of detections/refusals of illegal immigrants, not the number of individuals detected/refused, and so includes instances where the same person is detected on multiple occasions.

Between April 2013 and March 2014, there were 420 recorded instances where a person has been refused entry more than once. Please note this is the number of multiple instances, not the number of individuals who have been refused.

Data is not held on the corresponding figure for clandestines detected. This figure is derived from management information, subject to internal quality checks and may be subject to change.

**Reply from James Brokenshire:** The Home Office regularly receives written questions and correspondence from Honourable Members and their constituents about this issue. Since 2010, we have clamped down on illegal immigration.

The Immigration Act 2014 is a landmark piece of legislation which builds on the Government's ongoing reforms to our immigration system to ensure it works in our national interest.

The Act will have a major impact on the Home Office's work to secure our borders, enforce our immigration laws and continue to attract the brightest and the best to the UK.

The Act puts the law firmly on the side of those who respect it, not those who break it.

Key measures from the Act which are now in force including the introduction of enhanced duties for registrars to report suspected sham marriages and civil partnerships; new powers to streamline the recovery of illegal working penalties; the ability to remove harmfulindividuals before their appeals are heard if there is no risk of serious irreversible harm.

The Act also Strengthens requirements for the courts to have regard to Parliament's view of the public interest in immigration cases raising Article 8-making clear the right to a family life is not to be regarded as absolute and unqualified.

New powers to revoke the driving licences of known illegal immigrants are also included in the Act.

The information is based on management information only and has not been subject to the detailed checks that apply for National Statistics publications. These figures are provisional and are subject to change.

Data on the numbers of women placed on constant observation to prevent self harm prior to 2012 is not recorded electronically and cannot be provided without examination of individual records at disproportionate cost.

**Reply from Karen Bradley:** Businesses required to comply with the transparency in supply chains provision, now included in the Modern Slavery Bill, will be required to publish their annual slavery and trafficking statement on their website. They must also include a link to the slavery and human trafficking statement in a prominent place on their website's homepage.

Where a business uncovers slavery or trafficking in their supply chains they will be encouraged to report their concerns or findings to the relevant authorities in that jurisdiction. The statutory guidance to support businesses in understanding what kinds of information they may wish to include in any slavery and trafficking statement may include guidance on reporting concerns.

# **Racism, Religious Hatred, and Discrimination**

### **UK Parliament Questions**

### Antisemitism

**Guto Bebb** [215618] To ask the Secretary of State for the Home Department, what assessment she has made of changes in the number of anti-Semitic incidents in the UK; and if she will make a statement.

**Reply from Lynne Featherstone:** The UK Government takes all forms of hate crime very seriously. We deplore all religious and racially-motivated attacks. Between 2012-13 and 2013-14 police-recorded race hate crime increased by 4% (an increase of 1,595 offences) and religious hate crime by 45% (an increase of 700 offences) in England and Wales. The increase in recorded hate crime shows that more victims are coming forward and that the police are improving the way they identify hate crimes, and we welcome this.

The Community Security Trust monitors levels of antisemitism. Their most recent report, published at the end of July covering the period of January to June 2014, highlighted that there had been a 36% increase in the number of antisemitic incidents recorded compared to the same period in 2013 (307 incidents in 2014, compared to 223 in 2013). Following this, they recorded 314 antisemitic incidents in July, and 229 in August, making the combined total for those two months higher than the total for the whole of 2013.

When these events occur it is vital that the police take action to engage effectively with communities. Police forces in England, Wales, and Northern Ireland have recently been issued with new guidance for dealing with hate crimes, which includes advice on dealing with incidents and how to monitor and deal with community tensions.

We have also established a working group to tackle antisemitism which brings together community representatives and experts from across government to help explore issues affecting these communities.

**Guto Bebb** [215644] To ask the Secretary of State for Foreign and Commonwealth Affairs, what discussions he has had (a) with his counterparts from Belgium, France and the Netherlands and (b) in EU fora about the incidence of anti-Semitic attacks in those countries.

**David Lidington:** The British Government is committed to combating anti-Semitism wherever it is found and supports the efforts of EU partners to tackle racism in all its forms.

As current Chair of the International Holocaust Remembrance Alliance (IHRA), we will be discussing the recent rise in anti-Semitism across Europe (and particularly Holocaust denial and denigration) with European partners and others at the IHRA's Plenary Meetings in Manchester in December.

The Foreign and Commonwealth Office also works very closely with the European Commission against Racism and Intolerance, which provides expert advice on tackling anti-Semitism to other EU Member States.

The British Government was represented by the Parliamentary Under Secretary of State for Communities and Local Government, my Hon Friend the Member for Portsmouth North (Ms Mordaunt), at the tenth anniversary of the Organization for Security and Cooperation in Europe (OSCE) Conference and Declaration on Anti-Semitism, held in Berlin on 13 November. We hope the OSCE as a whole will take note of, and act upon, recommendations made at that conference.

#### Antisemitism

**Lord Blencathra** [HL2806] To ask Her Majesty's Government whether they consider that the current law is sufficient to deal with hate messages against Jews on social media, including Twitter.

**Reply from Lord Faulks:** Yes. The Government is absolutely clear that abusive and threatening behaviour online – whoever the target - is totally unacceptable. A number of offences may be committed by abusing others on social media. A message sent by means of a public electronic communications network, such as a message on Twitter, which is grossly offensive, indecent, obscene or menacing may be an offence under section 127(1) of the Communications Act 2003. Sending indecent, grossly offensive or threatening material to another with the purpose of causing distress or anxiety to a person to whom the material is communicated, including by means of the internet, is an offence under the Malicious Communications Act 1988.

Internet abuse could also amount to an offence under the Protection from Harassment Act 1997 if it is carried out as part of a 'course of conduct' which amounts to harassment or puts someone in fear of violence.

Changes to the law being taken forward in the Criminal Justice and Courts Bill will increase the maximum penalty for offences under the Malicious Communications Act 1988 to 2 years imprisonment, and will mean that the current requirement that prosecutions are brought within 6 months of the offence being committed will no longer apply. The Bill will also extend the time within which prosecutions under section 127 of the Communications Act 2003 may be brought, to up to three years from commission of the offence, as long as this is also within 6 months of the prosecutor having knowledge of sufficient evidence to justify proceedings.

These steps will help to ensure that people who commit these awful crimes are prosecuted and properly punished. Where any crime is motivated by or demonstrates hatred based on the race or religion of the victim, the courts will take this into account in passing sentence.

The Secretary of State for Scotland (Alistair Carmichael): ... I would echo the comments of Lord Smith in the foreword to his report: "This agreement is, in itself, an unprecedented achievement. It demanded compromise from all of the parties. It shows that, however difficult, our political leaders can come together, work together, and reach agreement with one another."

In preparing the report, Lord Smith heard from a wide range of Scottish civic institutions and members of the public. Over 400 submissions were received from organisations and groups, and over 18,000 submissions, including e-mails, letters and signatures to petitions, from people across Scotland.

The Smith commission has today produced comprehensive heads of agreement ... [that] provide for a durable but responsive constitutional settlement for Scotland within the United Kingdom. They give greater financial responsibility to the Scottish Parliament, with an updated fiscal framework for Scotland, consistent with the UK fiscal framework. For the first time, over 50% of the money spent by the Scottish Government will be raised by the Scottish Government. ...

Government are committed to ensuring that Scotland and the whole of the United Kingdom continue to prosper from our single domestic market, our social union and the strength that comes from the pooling and sharing of risks. ...

To support the preparation of the draft legislation, I have invited key Scottish stakeholders representing a wide range of sectors to form a stakeholder group. I shall provide further details of the membership and terms of reference of the group in due course, but it is my intention that it will support the Government's work translating the heads of agreement into the draft legislation that we shall publish by 25 January.
