## Immigration and Asylum

### Scottish Parliament Questions

#### **Post-study Work Visa (Discussions with the United Kingdom Government)**

**Chic Brodie:** To ask the Scottish Government what recent discussions it has had with the UK Government regarding reintroducing the post-study work visa in Scotland. (S4O-04131)

**Reply from the Cabinet Secretary for Education and Lifelong Learning (Angela Constance):** The Scottish Government is committed to working with the UK Government, as the Smith report recommended, to ensure that a post-study work route is put in place to allow talented international students to remain in Scotland after graduation to gain further experience and contribute to our economy and society.

Scottish Government and UK Government officials met on 23 January, and again on 13 March, to discuss a potential post-study work route that would allow international students to remain in Scotland for a defined period of time after graduation.

**Chic Brodie:** Recent evidence to the Economy, Energy and Tourism Committee suggested that Scotland has a significant global presence in the software games industry, but that its growth is hampered partly by an inability to retain foreign information technology students who have qualified here as a result of the current visa application regime.

On that basis, does the cabinet secretary agree that the sooner visa management and approval are devolved fully to Scotland, the better?

**Reply from Angela Constance:** Yes, I agree with Chic Brodie, and I agree that the immigration system needs to respond to Scotland's specific needs. That means supporting economic growth by enabling our industries to attract and retain the best and the brightest global talent. It is time that the UK immigration system delivered that for Scotland.

There is cross-sectoral support for the reintroduction of post-study work visas. As a country, our higher education sector and our economy need to be connected to new and emerging economies in particular.

## UK Parliament Questions

### Population: International Migration

**Lord Green of Deddington:** To ask Her Majesty’s Government what is their latest assessment of the impact of international migration on the population of the United Kingdom, taking into account the children of immigrants already in the United Kingdom.

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Bates):** My Lords, the Office for National Statistics publishes results from the Annual Population Survey. In the year ending December 2013, an estimated 7.8 million people were born outside the UK, while 4.9 million were non-UK citizens. For the calendar year of 2013, births in the UK to non-UK born mothers accounted for 25% of all live births. That is why we need to reduce immigration.

**Lord Green of Deddington:** ... Does the Minister agree with me that a sensible level of immigration is a natural and valuable part of an open society and economy? Indeed, there are a number of Members of this House whose very presence attests to that. Is the Minister aware that of the increase in the UK population over the past 10 years, at least two-thirds was due to immigration, and that if you include the natural increase in the number of migrants who are already here, that percentage becomes 80%? Will he therefore instruct his officials to clarify the position so that the public finally and fully understand the impact of immigration on our society? Lastly, is he aware that if net migration is allowed to continue at present levels, in the next 10 years we will have to build the equivalent of the city of Birmingham every two years, with the schools, hospitals, et cetera, that will be necessary?

**Reply from Lord Bates:** ... The noble Lord, Lord Green, referred to a figure of two-thirds and suggested that that could rise to 80%. The figure that we have to hand on this is 53%. However, we are absolutely at one on needing a firm but fair immigration policy to protect the public services of this country and provide opportunities for those who want to come here to work. ...

**Baroness Hussein-Ece:** My Lords, is it not the case that Her Majesty’s Government,

political leaders and civic leaders need to make a case for the positive impact that immigration has had on this country? Of all doctors in the NHS, 26% were foreign-born and 85,000 nurses were born abroad. The care system would collapse without immigrant labour. Does the Minister think that the constant negative narrative of immigration, without the positive, is detrimental to British society—a society that has always been one of tolerance which values and upholds democracy in building better institutions? Do the Government not really need to take the lead on this?

**Reply from Lord Bates:** That is true, but that sensible and rational view was drowned out when the lid was taken off immigration and the controls taken away so that under the previous Government we had net migration of 2.5 million. That fed into a change in the narrative away from the fact that most people who come to this country make an absolutely outstanding contribution to it and we are blessed to have them.

**Baroness Afshar:** My Lords, is the Minister aware that, if we did not have immigrants or the children of immigrants, we would not have buildings, schools, a vibrant food industry or vibrant markets? They contribute and their contribution creates a multiplier effect, which means that they create money that goes around. They should not be underestimated.

**Reply from Lord Bates:** I certainly assure the noble Baroness that that contribution is not underestimated and that it is not going to stop. We want people who want to come here to study, to work, to invest and to visit. We want all those people to come. What we are doing is drawing a line to say that we must get much tougher with those who want to come here and abuse our openness. ...

**Lord Tomlinson:** My Lords, will the Minister explain to the House how the Prime Minister got immigration figures so stunningly wrong when looking at this country's need for overseas students? He promised us that immigration would be controlled at tens of thousands rather than hundreds of thousands. His words in emphasising that were, "No ifs, no buts". If he can get those figures so stunningly wrong, why should we believe any of the statistics that are coming from the Government on immigration?

**Reply from Lord Bates:** It could well be that when the Prime Minister made those remarks the country was in the depths of despair in 2010. Since then, we have had a jobs miracle. We are creating more jobs than the rest of Europe put together. As a result of that, not surprisingly, the place where people want to come to find work is the only place where the jobs are being created. That is in the UK.

**Lord Skelmersdale:** My Lords, would my noble friend accept that the real problem is not immigration but integration?

**Reply from Lord Bates:** That is a more philosophical point—and a good one. It is one reason why we need to work on those other programmes of integration through the education system and through ensuring that people have a sense of what British values are and feel part of this country.

### Immigration Controls

**Lord Stoddart of Swindon [HL5411]** To ask Her Majesty's Government, in the light of the latest net migration figures, what is their assessment of the United Kingdom's ability to control immigration numbers in the context of European Union and international rules and interventions.

**Reply from Lord Bates:** The immigration system we inherited was open to abuse and gave little consideration to whether migrants could support themselves or contribute to the UK when they arrived. This Government has reformed the

immigration system by tackling abuse of student visas, cutting access to benefits and closing visa routes for those coming to the UK without a job.

In addition this Government has tightened up access to benefits, clamped down on more than 850 bogus colleges and increased the level of English required to come and stay here. The Immigration Act 2014 is making made it much tougher for illegal immigrants to remain in the UK by restricting their access to work, housing, benefits, healthcare, bank accounts and driving licences.

As a result of these changes, family visas granted are down by a third compared to the year ending September 2010 and student visas granted are down by over a quarter. Since July we have revoked over 5,000 driving licences and removed more than 500 foreign criminals since July 2014 under the new non-suspensive powers. These changes have demonstrated that it is possible to reform and reduce immigration.

Net migration from within the EU has doubled since 2010. That is why, as the Prime Minister has said, we will continue the reforms this Government has introduced to crack down on the abuse of free movement, continue the reforms this Government has introduced on access to benefits, and insist that there are new arrangements in place for future Member States to prevent a repeat of the mass migration that resulted from the previous Government's failure to impose robust transitional controls in 2004.

**Andrew Smith** [226568] To ask the Secretary of State for the Home Department, what proportion of leave to remain applications have been treated as falling outside normal service standards in each six-month period in the last four years.

**Reply from James Brokenshire:** New service standards have applied to leave to remain applications submitted to UK Visas and Immigration on or after 1 January 2014. Comparing the performance against new service standards to the performance against previous service standards is not possible given the change in methodology at that time.

However, reporting on UK Visas and Immigration's performance against service standards is now more detailed than prior to 1 January 2014 and can be found in the temporary and permanent migration section of the quarterly migration transparency data release, available at:

**Richard Burden** [226793] To ask the Secretary of State for the Home Department, what

assessment she has made of the relative effectiveness of (a) the Vulnerable Persons Relocation Scheme and (b) comparable schemes being implemented by other EU member states.

**Richard Burden** [226794] To ask the Secretary of State for the Home Department, how many people have (a) applied and (b) successfully resettled in the UK under the Vulnerable Persons Relocation Scheme (i) in total and (ii) in each month since September 2014.

**Reply from James Brokenshire:** The Government is deeply concerned about the crisis in Syria, the suffering and hardship it is causing for millions of displaced Syrians in the region, and the strain it is placing on their host countries. That is why we launched the Syrian Vulnerable Persons Relocation (VPR) scheme, offering protection in the UK to some of the most vulnerable refugees, who cannot be supported effectively in the region. The scheme is based on need rather than fulfilling a quota, but we have said that we expect it to help several hundred people over three years, and we remain on track to deliver that commitment. We therefore have no current plans to change the way the scheme operates. However, we continue to monitor the situation in Syria and the surrounding region and work closely with the United Nations High Commissioner for Refugees (UNHCR) to identify the most vulnerable people displaced by the conflict to ensure that the scheme remains responsive to need.

However given the scale of the crisis, we believe the most effective way to ensure the UK's help has the greatest impact for displaced people and their host countries is through substantial humanitarian aid and actively seeking an end to the conflict so that refugees can return to their homes and livelihoods safely. We have committed £800 million in response to the crisis, making us the second largest bilateral donor in the world, and UK funding is helping to support hundreds of thousands of displaced people in the region, providing food, healthcare and essential supplies. Compared with aid, resettlement can only ever help a minority of those in need.

The VPR scheme does not form part of the UN quota but runs in parallel with the United Nations High Commission for Refugees' (UNHCR) own Syria Humanitarian Admission Programme. The Government has been clear that this is a crisis of international proportions and needs a fitting response from the international community.

EU member states have responded to the Syrian crisis in different ways and it is for each state to decide how they help those displaced by the crisis. The UNHCR is best placed to comment on the policies of other countries regarding Syrian refugees.

#### Asylum: Children

**Lord Roberts of Llandudno** [HL5788] To ask Her Majesty's Government what assessment they have made of whether the needs and rights of refugee and asylum-seeking children, as set out in Article 22 of the United Nations Convention on the Rights of the Child, are being met in the United Kingdom.

**Reply from Lord Bates:** In line with its international obligations, the UK grants protection to those who need it. Our domestic law provisions apply to children from overseas when they are in the UK. These, and our own policies, ensure that

they receive the same protection and access to services as any other child permanently or temporarily deprived of his or her family environment for whatever reason, as set out in Article 22 of the UN Convention on the Rights of the Child. When it is in the best interests of the child concerned, the UK endeavours to trace the families of unaccompanied asylum seeking children. The UK would comply, where appropriate, with any request from the United Nations, or from an organization affiliated to the United Nations, on these matters.

### Asylum: Housing

**Sarah Teather** [227673] To ask the Secretary of State for the Home Department, what assessment her Department has made of the adequacy of support provided under sections 4 and 95 of the Immigration and Asylum Act 1999.

**Reply from James Brokenshire:** Asylum seekers are supported under section 95 if they would otherwise be destitute. Failed asylum seekers are supported under section 4 if they would otherwise be destitute and there is a temporary barrier that prevents their departure from the UK.

The assistance available to both groups consists of accommodation (with gas, electricity and water provided free) and a weekly allowance to buy food and other essential items. They are also able to access healthcare and education.

The Home Office keeps these arrangements under regular review and is satisfied they are an effective way of ensuring people are not left destitute.

**Lord Roberts of Llandudno** [HL5545] To ask Her Majesty's Government how many people received support under section 4 of the Immigration and Asylum Act 1999 in the last year for which they have records, broken down by nationality.

**Reply from Lord Bates:** At the end of 2014, there were 4,994 failed asylum seekers and their dependants receiving support under Section 4.

The figures provided in the table are a subset of latest statistics published in the Immigration Statistics Release by the Home Office, in Table as\_18\_q "Asylum seekers in receipt of Section 4 or Section 98 support, and decisions to grant Section 4 support as at the end of the quarter", available from the link below.

The Home Office publishes quarterly and annual statistics on people receiving support within the Immigration Statistics release. A copy of the latest release, Immigration Statistics October – December 2014 is available from

**Andrew Rosindell** [226930] To ask the Secretary of State for Education, what steps her Department is taking to ensure that faith schools do not divide local communities.

**Reply from David Laws:** All schools, including faith schools, have a legal duty to promote community cohesion. ## Scottish Parliament Questions

### Racial Discrimination

**Christina McKelvie:** To ask the First Minister what action the Scottish Government is taking to tackle racial discrimination. (S4F-02671)

**Reply from the First Minister (Nicola Sturgeon):** There is absolutely no place for racism or, indeed, any discrimination in a civilised society. The Scottish Government is strongly committed to equality, including race equality, which is reflected in our key strategies and in our continued support for organisations that promote race equality, tackle racial discrimination and challenge racism. More than £800 million from the equality budget from 2012 to 2015 has supported activity to promote race equality and to address racial discrimination through a range of projects at local and national levels. As part of the work to shift attitudes and provide a strong message about the Scotland in which we want to live, we launched last November the latest phase of the one Scotland campaign, entitled “Scotland believes in equality”. That includes a focus on race. In addition, along with our race equality partners and Scotland’s minority ethnic communities, we are working towards producing a race equality framework by spring 2016.

**Christina McKelvie:** I thank the First Minister for all the work that has been done. I direct her to article 14 of the European convention on human rights, which provides that “The enjoyment of the rights and freedoms set forth in this Convention shall be secured without discrimination on any ground such as sex, race, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth or other status.”

Given that that is the highest standard of anti-discrimination policy in the European Union, does the First Minister join me in condemning the disgusting and downright discriminatory words of David Coburn MEP directed to the Minister for Europe and International Development, Humza Yousaf, and in reasserting that there is no place in Scotland or Europe for sexist, racist or homophobic discrimination?

**Reply from the First Minister:** I know that I speak on behalf of the entire Parliament when I condemn David Coburn’s utterly reprehensible comments. Yesterday, the Scottish Parliament stood in solidarity with our friend and colleague Humza Yousaf and voted unanimously to censure Mr Coburn. My clear view is that he is not fit to represent the people of Scotland in the European Parliament or anywhere else.

I also take the opportunity to condemn unreservedly the vile homophobic abuse that was directed at Ruth Davidson on Twitter last night and this morning. The individual in question has been identified and, this morning, their membership of the Scottish National Party was suspended pending a full disciplinary process.

**Reply from Fergus Ewing:** Scotland's natural larder will be showcased over the next 12 months at events the length and breadth of the country to raise awareness of the role food and drink plays in the country's cultural identity and in shaping the nation's economic success.

The Scottish Government is also currently working with BEMIS (a national umbrella body supporting minority ethnic community organisations in Scotland) to develop their plans to engage a multi-cultural Scotland in the Year of Food and Drink. This builds on the success of the multi-cultural Homecoming celebration in 2014 led by BEMIS, supported by a £40k funding contribution from the Scottish Government, which attracted over 6000 participants to 43 diverse events across the country designed by communities themselves. For 90% of the communities involved in the multi-cultural Homecoming celebration this was the first time they had participated in a national celebratory event of this scale and all of the organisations involved expressed a willingness to participate in the future.

Further announcements on partner plans to specifically engage Scotland's multi-cultural communities in the celebration of the 2015 Year of Food and Drink will follow in due course.

### **Female Genital Mutilation/Early Forced Marriage**

**Mark Pawsey** What recent progress [has the] Department [for International Development] made on its policies and programmes to tackle female genital mutilation and early forced marriage. [908142]

**Reply from the Secretary of State for International Development (Justine Greening):** Last year's girl summit achieved unprecedented international commitments to end both practices. We are now tracking to ensure that those commitments and deliverables are delivered, and supporting national efforts in more than 25 countries. The UK is the largest donor on female genital mutilation and we are implementing major new programmes to end child and forced marriage.

**Mark Pawsey:** Violence against women is always unacceptable, but female genital mutilation is child abuse and illegal. In the UK, there is increasing awareness of this repugnant practice as a result of the work of agencies such as the Kaiza project in my constituency. What efforts are the Government making to improve international awareness of efforts to combat FGM and to bring the perpetrators to justice in courts across the world?

**Reply from Justine Greening:** I commend the work of the Kaiza project in my hon. Friend's constituency. It does absolutely vital work locally. Internationally, we are working closely with national Governments in the affected countries to support the development and implementation of legislation and policy to end FGM. When a case reaches prosecution, it means that there has been a failure to prevent a girl from being cut, so our programme is focusing particularly on prevention.

**Ann Clwyd:** As the Minister knows, I have a particular interest in this subject, as I changed and tightened up the law in 2003. The Easter holidays are coming up, and many young girls will be taken out of the UK to their countries of origin in the school holidays to have FGM practised on them. What are we doing across Departments to protect those girls from that awful fate?

**Reply from Justine Greening:** There are two things. First, there is improved guidance from the Department for Education and, secondly, the right hon. Lady will know that at the girl summit last year we broadened the ability to prosecute people who are taking girls abroad to be cut.

**Malcolm Bruce:** I commend the Secretary of State, her Department and her Ministers for their campaigning work on this issue on behalf of women and girls. May I ask her not to hold back in countries such as Sierra Leone, where secret societies perpetrate female genital mutilation? The girls do not even know what is happening to them and they do not discuss it. Will she work with campaigners in that country to ensure that the matter is addressed?

**Reply from Justine Greening:** My right hon. Friend is right to address that point. In spite of the challenges that Sierra Leone faces with Ebola, FGM has, ironically, stopped. This is because it was one of the main ways in which the disease could spread. The key now is to prevent those practices from coming back, and I am already having discussions on that. ...
