# **UK Parliament Questions**

## **Immigration: Married People**

**Carol Monaghan** [24971] To ask the Secretary of State for the Home Department, how many people with spouses or partners with UK citizenship have been granted a visa to enter the UK in each of the last five years.

**Reply from James Brokenshire:** The available information is shown in the table attached.

Information on spouses or partners of UK citizens is not available as it is not held on centrally collated statistical databases and could only be produced at disproportionate cost by examination of individual case files.

#### **Migrant Workers**

The following four questions all received the same answer

**Ruth Cadbury** [23985] To ask the Secretary of State for the Home Department, what assessment she has made of the effect Tier 2 migration is having on the (a) pay and (b) terms and conditions of UK employees.

**Ruth Cadbury** [23986] To ask the Secretary of State for the Home Department, if she will take steps to ensure that Intra Company Transfer Tier 2 visas cannot be used to replace a UK worker who has been made redundant.

#### **Migrant Workers: ICT**

**Ruth Cadbury** [23987] To ask the Secretary of State for the Home Department, what information her Department holds on what the average salary of a Tier 2 worker on an Intra Company Transfer visa is in the IT industry; and how this compares to the industry average.

**Ruth Cadbury** [23988] To ask the Secretary of State for the Home Department, what assessment she has made of the potential for Tier 2 Intra Company Transfer visas to be used to replace UK workers with outsourced overseas workers in the IT industry.

**Reply from James Brokenshire:** Tier 2, the skilled worker route, is designed to fill roles which cannot be filled by a suitable resident worker. The immigration rules, and UK employment law, do not allow workers to be made redundant and directly replaced.

It is a decision for businesses whether to outsource certain functions. We are, however, mindful of concerns that use of the Intra-Company Transfer (ICT) category for third party contracting may undercut or displace resident workers.

That is why, in June last year, we commissioned the Migration Advisory Committee (MAC) to examine the ICT category as part of its wider review on Tier 2. The MAC published its report on 19 January and it can be found on the gov.uk website at: <u>https://www.gov.uk/government/publications/migration-advisorycommittee-mac-review-tier-2-migration</u>

Chapter 6 of the report sets out the MAC's findings on the ICT category, including its use for third party contracting, the salaries paid to IT workers and the impacts on the resident labour market. The MAC found that salaries for these transferees were clustered around the 25th percentile of earnings for resident workers in IT occupations (the current minimum permitted under the immigration rules).

The Government is currently considering the MAC's findings carefully and will announce any changes in due course.

## **Visas: Catering**

#### The following three questions all received the same answer

**Greg Mulholland** [22777] To ask the Secretary of State for the Home Department, how many applications for Tier 2 visas were made by people holding job offers to become chefs in each year since such visas were introduced; and how many such applications were successful.

**Greg Mulholland** [22778] To ask the Secretary of State for the Home Department, what representations she has received on lowering the Tier 2 visa scheme's minimum salary threshold for chefs.

**Greg Mulholland** [22779] To ask the Secretary of State for the Home Department, if she will make an assessment of the effect of the Tier 2 visa scheme's minimum salary threshold on the ability of curry restaurants to recruit chefs from abroad.

**Reply from James Brokenshire:** Acquiring this information on visa applications from chefs would involve examining each individual case record held by UK Visas & Immigration for the Tier 2 category. To do so would incur a disproportionate cost. The Home Office regularly receives representations to lower the criteria (including the salary requirement) for sponsoring chefs under Tier 2, the skilled worker route. Tier 2 is, however, reserved for graduate level occupations. We continue to welcome the very top chefs who promote innovative and authentic cuisine here in the UK — and these types of skilled chefs are on the shortage occupation list. The salary threshold applied to chefs was based on expert advice from the independent Migration Advisory Committee.

We have been clear, however, that the restaurant industry needs to move away from an unsustainable reliance on migrant workers. We want to nurture more home-grown talent and encourage young people in this country who want to pursue a skilled career. This means the restaurant sector offering training to attract and recruit resident workers to meet their staffing needs.

The industry is starting to make progress in this area, recruiting and training more chefs in the UK, and this needs to continue.

## **Social Services: Migrant Workers**

**Paul Blomfield** [24741] To ask the Secretary of State for Health, what assessment he has made of the effect of the £35,000 minimum income threshold on the numbers of migrant workers in the adult social care workforce who will be eligible to stay in the UK from April 2016 onwards.

**Reply from Alistair Burt:** Skills for Care, the partner in the sector skills council for social care, in England, collects information on the adult social care workforce in England. Skills for Care estimates show that between 1,500 and 2,500 migrant workers in adult social care regulated professional roles may not have an income sufficient for settlement. However, the vast majority of these roles are registered nurses who are exempt from the requirement to earn £35,000 whilst the role is or has been on the shortage occupation list.

## Children in Care: Asylum

The following two questions both received the same answer

**Stuart C. McDonald** [25428] To ask the Secretary of State for Education, how many care leavers in (a) 2014 and (b) 2015 who were aged 19, 20 or 21 in 2013 and 2014 and housed in accommodation considered (i) suitable and (ii) unsuitable were former unaccompanied asylum-seeking children looked after by the local authority.

#### Children in Care

**Stuart C. McDonald** [25346] To ask the Secretary of State for Education, how many care leavers aged between 19 and 21 local authorities were in contact with in (a) 2014 and (b) 2015; and how many such care leavers were former unaccompanied asylum-seeking children.

**Reply from Edward Timpson:** Information on care leavers in (a) 2014 and (b) 2015, who were aged 19, 20 and 21 in 2013 and 2014 is not available. However, the information for care leavers aged 19, 20, or 21 in 2014 and 2015 is shown in the tables below:

#### **Asylum: Finance**

**Lord Roberts of Llandudno** [HL5500] To ask Her Majesty's Government how long asylum seekers have to wait before they receive financial support upon arrival in the UK.

**Reply from Lord Bates:** Upon claiming asylum if an applicant presents as destitute they are entitled to access support services whilst a formal application for financial support is considered.

Destitute asylum seekers are usually accommodated in an Initial Accommodation facility, which is typically delivered as hostel style, full board accommodation.

The length of time someone will stay in an Initial Accommodation centre will vary from person to person according to their particular circumstances.

However, the Home Office aims to process their application for financial support and move straightforward cases to longer term dispersal accommodation in participating dispersal towns and cities within 19 days.

## Asylum

**Lord Alton of Liverpool** [HL5450] To ask Her Majesty's Government what action they are taking to prevent hostels requiring asylum seekers to wear red wristbands before providing food and to stop property companies singling out the accommodation used by asylum seekers by having their doors painted red.

**Reply from Lord Bates:** On 20 January my Rt. Hon. Friend the Immigration Minister (James Brokenshire), in response to the articles in the press regarding asylum seeker accommodation in Middlesbrough, announced an audit of asylum accommodation as a result of the allegations made (regarding the use of a single paint colour on asylum seeker properties).

The Home Office has asked for assurance from all accommodation providers that there are no further policies or practices that allow asylum seekers to be identified as such by the public.

## **Asylum: Housing**

The following four questions all received the same answer

**Dan Jarvis** [23356] To ask the Secretary of State for the Home Department, when (a) her Department and (b) the contractor G4S became aware of concerns that asylum seekers were being housed in properties with doors that are all uniform or nearly uniform in colour.

**Dan Jarvis** [23357] To ask the Secretary of State for the Home Department, when she expects the inquiry announced by her Department on 20 January 2016 into the housing of asylum seekers in the north-east of England to report its findings.

**Dan Jarvis** [23358] To ask the Secretary of State for the Home Department, if she will take steps to ensure that asylum seekers are not housed in properties that make their status as asylum seekers easily identifiable.

#### Asylum: North East

**Dan Jarvis** [23355] To ask the Secretary of State for the Home Department, whether contractors have housed asylum seekers in properties with doors that are all uniform or nearly uniform in colour in regions other than the North East.

**Reply from James Brokenshire:** Home Office officials are working closely with our housing providers to ensure that asylum seeker accommodation is not easily identifiable. I am not aware of a uniform door colour being the practice in any other region. My officials have also spoken to our housing providers to tell them that such a practice is not acceptable.

I was first made aware of this issue when The Times contacted the Home Office in mid-January. G4S has investigated correspondence and discussions on the issue of external door colour in the North East and has confirmed that it was raised in 2012 by a Middlesbrough local councillor and was considered by the G4S audit and assurance team, no complaints from asylum seekers relating to this matter were found and a response was issued.

As I said to the House on 20 January, I instructed officials to look into this issue as a matter of urgency and I expect that the audit will be concluded on the Home Office side very shortly.

**Reply from James Brokenshire:** In line with government transparency commitments details of the standards required are already in the public domain. ## **Asylum: Housing**

**Stuart C. McDonald** [25466] To ask the Secretary of State for the Home Department, how many people have been accommodated in hostel-type accommodation provided by Compass in each Compass region in each month since 1 April 2015; and how many such people have been held under (a) section 98, (b) section 95 and (c) section 4 of the Immigration and Asylum Act 1999.

**Reply from James Brokenshire:** In general, there are two types of accommodation used for asylum seekers. First, Initial Accommodation ("IA") which is mainly full board and is provided while the support application is being

assessed. Second, "dispersal accommodation", generally shared flats, maisonettes and houses, is provided once the person is found to be eligible for support. The length of time someone will stay in an Initial Accommodation centre will vary from person to person according to their particular circumstances. However, the Home Office aims to process their application for financial support and move straightforward cases to longer term dispersal accommodation in participating dispersal towns and cities within 19 days. The Home Office does not centrally record the number of people housed in initial accommodation under each section of the 1999 Act. It could only be provided at disproportionate cost.

#### Asylum: Syria

**Tulip Siddiq** [25352] To ask the Secretary of State for the Home Department, what further steps she is taking to ensure that unaccompanied asylum-seeking children in Syria can be resettled in the UK through (a) the Gateway Protection Programme, (b) the Vulnerable Persons Relocation Scheme, (c) the Mandate Refugee Scheme and (d) other schemes or programmes.

**Reply from James Brokenshire:** Since the launch of the expanded Syrian Resettlement Scheme last September, we have resettled more than 1000 vulnerable Syrians, around half of whom are children.

On 28th January the Government announced further initiatives to assist unaccompanied children in the region. The initiatives will complement the very significant existing aid and assistance the UK has given in response to the Syrian conflict and migration crisis; including our existing resettlement programmes.

As announced last week, the Government will work with the Office of the United Nations High Commissioner for Refugees (UNHCR) to lead a new initiative to identify and resettle unaccompanied children in the exceptional cases where it is in the child's best interests to do so. The UK Government is working with UNHCR to establish the numbers and specific needs of these unaccompanied children in order to establish a resettlement process which best addresses the requirements of these vulnerable children.

# **UK Parliament Early Day Motion**

**Virendra Sharma (1043) Family and business visas for Indians** – That this House notes that since 2012 immigration rules have more than tripled the amount of money required under financial (minimum income) rules; is concerned that such stringent requirements have been accompanied by a reduction in the variety of income sources which may be considered; is further concerned that such a sum is pushed to an onerously high rate when there are children to be taken care of; further notes that this rate is significantly higher than the minimum wage; worries that the UK has now been ranked as the least family-friendly country to migrate to; notes that while the Chancellor of the Exchequer has announced relaxed visas for Chinese business leaders, such a proposal for Indians has not been forthcoming; notes that the long-standing relationship between the UK and India is being put in jeopardy not long after the Indian Prime Minister called the UK India's route into the EU; and calls on UKVI and the Government to assess and reform the unfair system they have implemented. http://www.parliament.uk/edm/2015-16/1043

# Immigration and Asylum (continued) UK Parliament Petition

#### Treatment of asylum seekers

The petition of residents of the UK, Declares that the petitioners are gravely concerned about the manner in which asylum seekers are currently treated in the UK; further that the 2015/16 Immigration Bill threatens to make those seeking sanctuary even more vulnerable; further that the Bill will leave more families homeless and further isolate an already marginalised group; further that recommendations made by the All-Party Parliamentary inquiry into the use of immigration detention have been excluded from the Bill; further that the petitioners have a moral responsibility as Christians to be a voice for those who have no voice; further that Pope Francis has said that refugees and asylum seekers are our brothers and sisters; and further that a local petition on this matter was signed by 3,000 people.

The petitioners therefore request that the House of Commons urges the Government to reconsider the findings of the All-Party Parliamentary inquiry into the use of immigration detention to adopt the inquiry's recommendations in order to improve the treatment of asylum seekers in the UK. ... **Observations from the Minister for Immigration (James Brokenshire):** The Immigration Bill does not affect the support provided to asylum seekers and their families, who will continue to be provided with free furnished accommodation and a weekly cash allowance to cover their other essential living needs.

The Bill restricts the support available to those whose applications for asylum have been rejected, and who are therefore illegal economic migrants. Support will still be available where there is a genuine obstacle that prevents the person from leaving the United Kingdom at the point their asylum claim or any appeal is finally determined.

Detention plays a vital role in maintaining effective immigration control and the protection of our borders. Recommendations made in the all-party parliamentary group report of their inquiry into the use of immigration detention were brought to the attention of Stephen Shaw CBE, the former Prisons and Probation Ombudsman for England and Wales, who was commissioned by the Home Secretary in February 2015 to undertake an independent review of policies and operating procedures that have an impact on detainee welfare. Mr Shaw's report was published on 14 January by means of a written statement, which also set out the Government's initial response to his report.

**Lord Ouseley** [HL5672] To ask Her Majesty's Government what assessment they have made of the levels of social cohesion in towns in Britain, such as Boston in Lincolnshire.

**Reply from Baroness Williams of Trafford:** Over generations, we in Britain have built a successful multi-racial, multi-faith democracy. According to the 2013/14 Community Life Survey, 85 per cent of people agreed that their local area is a place where people from different backgrounds get on well together. But the job of building a more cohesive country is never complete and we recognise the scale of the challenge in some communities. That is why the Prime Minister has charged Louise Casey to carry out a review of how to boost opportunity and integration in these communities and bring Britain together as one nation. We will use her interim report to inform our plans for funding a new wider Cohesive Communities Programme, focusing resources on improving integration and extending opportunity in those communities that most need it.

**Reply from Baroness Williams of Trafford:** Both the Department for Education and Ofsted have commissioned and published a number of studies over the past six years that focus on how to improve the education of Gypsy and Traveller children. These include:

The Department for Education regularly publishes and monitors data on the educational progress and achievement of pupils from Gypsy and Irish Traveller backgrounds attending schools in England. This data includes annual statistics on the attainment of pupils from these groups in the year 1 phonics screening check; teacher assessments at the end of key stage 1 and national assessments at the end of key stages 2 and 4; and on levels of pupil attendance at, and exclusion from, school. Inspection reports published by Ofsted include commentary where appropriate on the quality of school provision for Gypsy and Traveller pupils and their progress and attainment.

The previous Government's Ministerial Working Group on Gypsy and Traveller inequalities published a report in April 2012, which included 28 commitments from across Government to help reduce the inequalities experienced by Gypsies and Travellers. The document can be found at:

#### **Racial Discrimination**

**Steve Rotheram** [23776] To ask the Secretary of State for Communities and Local Government, what steps he is taking to tackle racist and discriminating behaviour.

**Reply from Marcus Jones:** This Government deplores racism in all its forms and is determined to ensure everyone has the opportunity to get on in life free from harassment and fear.

50 years ago Britain introduced its first race equality legislation and in that time our country has undoubtedly become fairer. The Equality Act 2010 protects all individuals against racial and other forms of discrimination.

On 12 October 2015 a new Cross Government Hate Crime Action Plan was announced, to drive forward action against all forms of hate crime. This will be taken forward in partnership with communities to ensure we target the harm that hate crime causes. More broadly, my rt. hon. Friend, the Prime Minister has set out a series of ambitious government commitments to reduce racial inequalities by the end of the current Parliament in 2020.

## **Racially Aggravated Offences**

**Steve Rotherham** [23781] To ask the Secretary of State for the Home Department, what estimate she has made of trends in the rate of race-related crimes in England and Wales over the last five years.

**Reply from Karen Bradley:** The Crime Survey for England and Wales estimates that there were 106,000 incidents of race hate crime a year, based on the combined data from the 2012/13 to 2014/15 surveys (the most recently available figures). There has been a clear downward trend in the number of hate crime incidents between the 2007/08 to 2008/09 and 2012/13 to 2014/15 crimes surveys, which have fallen by 28% for all hate crimes over this period. The Home Office also collects information from the police on hate crimes. This shows that were 42,930 race hate crimes recorded by the police in 2014/15, a 15% increase on the previous year. This increase is largely thought to be due to improvements in recording practices by the police over the last year rather than a real increase in race hate crime. However, it is possible in some police forces areas that recording may not be the only reason and there could be an element of real increases in certain areas.

The Government is committed to tackling all forms of hate crime, including that perceived to be racist by the victim or any other person. That is why we

announced in October last year the intention to bring forward a new cross Government hate crime action plan. This is being developed with the communities most affected by hate crime and will be published later this year.

#### **Employment: Bullying**

**Charlotte Leslie** [23757] To ask the Secretary of State for Business, Innovation and Skills, what steps his Department is taking to reduce the incidence of workplace bullying.

**Reply from Nick Boles:** Bullying and harassment have no place in today's workplace environment and are unacceptable wherever they occur. The UK has a strong safety net of legislation to protect people from harassment in the workplace. This covers harassment on the grounds of sex, race, disability, religion or belief or sexual orientation and age. In addition, harassment is a criminal offence and victims have a right to damages.

The best way to address unacceptable behaviour in the first instance is within the workplace. That's why my Department's supports the Health and Safety Executive Management Standards approach for work-related stress which includes a standard for relationships at work that covers unacceptable behaviour such as conflict, bullying and harassment. The Management Standards help organisations manage the causes of work-related stress in a simple and pragmatic way.

The Advisory, Conciliation and Arbitration Service (Acas) also aims to support better employment relations by offering free impartial advice. Acas operates a nationwide telephone helpline for employers and employees, they can be contacted on: 0300 123 1100. Acas recently published new guidance addressing the need to conduct fair and thorough grievance and disciplinary investigations; and published new research seeking better solutions to deal with bullying.

Acas also offers training and business solutions including free eLearning and advisory booklets explaining how employers and individuals can tackle and prevent bullying, ill treatment and harassment more effectively in Britain's workplaces - raising employee motivation, attendance and productivity.

**Lord Starkey** [HL5333] To ask Her Majesty's Government what estimate they have made of the number of Muslim students who have been unable to progress to higher education because their religious principles do not permit them to take out an interest-bearing student loan.

**Reply from Baroness Evans of Bowes Park:** The Government consulted in April 2014 on an Alternative Finance product that could be offered to students alongside traditional loans. 20,000 responses were received with 94 per cent believing there is a demand for Alternative Finance.

The Government is working on the development of a Takaful Alternative Finance product and as part of this will be working with the Muslim community and others to understand the likely take-up of the product.

#### Female Genital Mutilation: Education in Schools

**Baroness Featherstone;** To ask Her Majesty's Government how many schools are now using personal, social, health and economic education classes to inform their pupils on female genital mutilation.

**Reply from Baroness Evans of Bowes Park:** My Lords, female genital mutilation is child abuse and a crime. An effective multiagency approach is key to safeguarding girls from FGM and schools play an important role in this, as they do in safeguarding children from all forms of abuse. Schools have the autonomy to tailor their local PSHE programme to reflect the needs of their pupils, including teaching about FGM, drawing on the resources and evidence provided by experts and organisations such as the PSHE Association.

**Baroness Featherstone:** I thank the Minister for that Answer, but in a way she makes my case for me, because we have a safeguarding duty to the 60,000 girls who are at risk. If we do not inform them about the risks of FGM—what to look for and who to go to—then I believe we are derelict in our duty. Does the Minister agree with me that one of the best ways to protect girls is to make teaching on FGM mandatory, whether through PSHE or other means, and will she now commit to do so?

**Reply from Baroness Evans of Bowes Park:** My Lords, since 2014 FGM has been included in the PSHE programme of study so that is now an option for teachers, but we believe that it should be up to schools to have the autonomy to reflect the needs of their pupils. Of course teaching about FGM is one option that they can include, but we believe it is up to schools to think about the needs of their pupils and the communities that they serve, and it is for them to decide what best to cover and how best to cover it within their curriculum.

**Baroness Massey of Darwen:** My Lords, would the Minister agree with me that, however good schools' PSHE programmes are — and some are excellent — schools

cannot mop up all the ills of society? Would she further agree that this is a highly sensitive issue, which is about the law and violence against women, and therefore needs delivering to teachers and pupils in a sensitive and expert way by people such as the school nurse or a doctor? It is not a case that can be taken very lightly.

**Reply from Baroness Evans of Bowes Park:** I entirely agree with the noble Baroness, which is why we shall be shortly publishing for the first time statutory multiagency guidance for front-line professionals on FGM specifically, which will apply to schools and children services as well as police and healthcare professionals. It is essential that everybody works together to support any young women who may be in this position and make sure that, as a community, all agencies are working together to help tackle this crime.

**Baroness Jenkin of Kennington:** Would my noble friend please update the House on the current state of protection orders?

**Reply from Baroness Evans of Bowes Park:** As noble Lords will be aware, protection orders were fast-tracked last summer to come into place before the summer holidays, so that any girls at risk could benefit from these new orders. Eighteen FGM protection orders were issued between July and September. That is the first set of data that we have.

**Lord Morris of Aberavon:** My Lords, while individual prosecutions are matters for the Director of Public Prosecutions, are the Government satisfied that the law is adequate, and will they consider an investigation as to why there are so few prosecutions?

**Reply from Baroness Evans of Bowes Park:** As I said, we will shortly issue the statutory multiagency guidance, which we believe will help teachers, for instance, and other professionals to be able to identify this risk more easily and therefore to work with the police. The Serious Crime Act 2015 introduced a new mandatory duty on teachers, social workers and health professionals to report to the police known cases of FGM involving victims under the age of 18. Again, we believe that reports of these cases should assist the police; I have also mentioned protection orders. Therefore, we are building a framework within which professionals can work to help to tackle this crime.

**Baroness Butler-Sloss:** Does the noble Baroness know how much training the NHS gives to its front-line staff so that they are able to recognise this situation and deal with it?

**Reply from Baroness Evans of Bowes Park:** As I say, we are introducing a range of statutory guidance. Since April 2015, the NHS has collected enhanced data on women and girls seen by the NHS who have been subject to FGM. The second quarter of this data from July to September 2015 reported that 17 girls under 18 had come to the attention of the NHS. Therefore, with the enhanced data collection, the guidance we are introducing and our attempt to join up the NHS with schools and the police, we are starting to see progress in helping professionals identify this issue.

**Baroness Corston:** The noble Baroness referred just now to the role of schools. When I represented a multicultural constituency in the other place, one of the things that used to concern me was the instance of girls being suddenly taken away for long holidays, and we tried very hard to raise this with schools to see whether they were being taken away for this purpose. It would be useful to know whether this is included in the guidance to teachers. I point out to those colleagues who have been in this House for quite a while that nobody here ever raised this issue for as long or as often as our late friend Baroness Rendell—Ruth Rendell. I suggest that we set up some initiative on FGM in Ruth's name.

**Reply from Baroness Evans of Bowes Park:** I will be very happy to take the noble Baroness's suggestion back to the department. As regards the question she raised about teachers being able to identify this, I went on to the PSHE Association website to have a look at the section on FGM, and the issue that the

noble Baroness raised is mentioned there, as are a number of other useful elements of guidance. As I have said, with new statutory guidance coming in and the updating of the safeguarding guidance for schools, we are attempting to get as much information to teachers as we can so that they can play their role in helping to protect young women.

**Lord Storey:** My Lords, can I come back to PSHE? The Minister has highlighted its importance—indeed, the Government's own website says how important it is. Will she confirm that PSHE has to be taught only in maintained schools, so that the 70% that are academies, as well as free schools, do not have to teach it? Does she not think, given the importance of PSHE and this issue, that it should be taught in all schools and that advice and guidance should be given to all schools?

**Reply from Baroness Evans of Bowes Park:** We state clearly in the introduction to the national curriculum that we expect all schools to deliver high-quality PSHE. Of course, the noble Lord will be aware that, when inspecting, Ofsted considers how a school ensures the spiritual, moral, social and cultural needs of its pupils. Ofsted inspects all schools—maintained, academies and free schools—so this enables PSHE to be considered in a proportionate and integrated way as part of their inspection.

#### Schools: Counter-terrorism

**Jim Cunningham** [24479] To ask the Secretary of State for Education, what representations she has received in the last year from (a) Christian, (b) Jewish and (c) Muslim faith schools on the Counter Extremism Strategy used in schools; and if she will make a statement.

**Reply from Edward Timpson:** This Government believes all children should be educated in a safe environment, whether in a school or out of school.

Department officials have briefed representatives of faith schools, including Christian, Jewish and Muslim schools, on matters relating to the Government's Prevent and Counter-Extremism strategies. The Department received a number of queries from both faith schools and non-faith schools on how to implement the Prevent duty. The Department has issued practical advice to schools to help them understand their role under the new Prevent duty, and also launched a dedicated counter-extremism helpline in 2015 to enable front line staff, governors, and others to raise concerns directly. The Department has combined all its existing advice in the new Educate Against Hate website[1], which was launched by the Secretary of State on 19 January.

The Department recently completed a call for evidence on proposals for the registration and inspection of out-of-school settings providing intensive education which were announced in the Counter-Extremism Strategy. Over 3,000 people, including representatives of the Christian, Jewish and Muslim faiths, completed the response form, either online or manually. The Department received a significant number of further representations to the consultation by email and post. All responses and representations are being logged, analysed and verified.

We will be publishing a response to the consultation in due course, in line with Cabinet Office guidance.
