### **Scottish Parliament Motion**

**Reply from Robert Goodwill:** Where a person subject to immigration control has made an immigration application before their previous leave to remain expires and is asked to demonstrate their right to work by an employer under the provisions to prevent illegal working in the Immigration Asylum and Nationality Act 2006, the Home Office provides a checking service which will confirm whether the individual has a continued entitlement to work pending a decision on their application.

### **General Practitioners: Foreign Nationals**

**Steve McCabe** [63607] To ask the Secretary of State for the Home Department, pursuant to the Answer of 27 January 2017 to Question 61413, on general practitioners: foreign nationals, whether GPs are on the Shortage Occupation List.

**Reply from Robert Goodwill:** The Tier 2 (General) annual limit is divided into monthly quotas. Since its introduction, the monthly quotas have been oversubscribed only during the period of June to October 2015. To-date, the annual limit has not been reached. Places in the limit are prioritised according to whether the job is in a shortage occupation or PhD-level occupation, and by salary. No monthly quota has ever been allocated solely to occupations on the Shortage Occupation List.

The Shortage Occupation List is based on recommendations from the independent Migration Advisory Committee. General Practitioners do not currently appear on the list. The list can be found at the following link:

Luciana Berger [63892] To ask the Secretary of State for Health, what estimate he has made of the number of nationals of other EU countries working in the NHS as midwives; what assessment he has made of the potential effect of the UK leaving the EU on the number of such midwives; and what assessment he has made of the potential effect on NHS productivity of that change in the number of such midwives.

**Reply from Philip Dunne:** NHS Digital publishes data on the nationality of staff working in the National Health Service in England. Nationality is self-reported within the NHS human resources and payroll system, the electronic staff record.

In October 2016, 1,363 (5.2%) midwives working in NHS trusts and clinical commissioning groups declared their nationality as other European Union nationals, excluding the United Kingdom. This is out of a total headcount of 26,099.

The October data is the most recent data available.

The potential effect on nationals and productivity of leaving the EU will be dependent on the outcome of negotiations. The Prime Minister has been clear that she wants to protect the status of EU nationals already living here. It is the Government's aim to get the best settlement for the UK in all areas including the healthcare system.

**Reply from Philip Dunne:** Health visitors are often included as nurses in workforce statistics; therefore for clarity we have provided a breakdown of nurses and health visitors, nurses excluding health visitors and health visitors only.

NHS Digital publishes data on the nationality of staff working in the National

Health Service in England. Nationality is self-reported within the NHS human resources and payroll system, the electronic staff record.

The following table shows the total headcount of nurses and health visitors working in NHS trusts and clinical commissioning groups in October 2016, and the number that declared their nationality as other European Union nationals, excluding the United Kingdom.

**Reply from Philip Dunne:** NHS Digital publishes data on the nationality of staff working in the National Health Service in England. Nationality is self-reported within the NHS human resources and payroll system, the electronic staff record.

In October 2016, 911 (9.5%) doctors working in the psychiatry group within NHS trusts and clinical commissioning groups declared their nationality as other European Union nationals, excluding the United Kingdom. This is out of a total headcount of 9,544.

The October data is the most recent data available.

The potential effect on nationals and productivity of leaving the EU will be dependent on the outcome of negotiations. The Prime Minister has been clear that she wants to protect the status of EU nationals already living here. It is the Government's aim to get the best settlement for the UK in all areas including the healthcare system.

**Reply from Robert Goodwill:** The information and evidence required in respect of employment and dividend income relied upon to meet the income threshold for partner entry clearance applications under Appendix FM to the Immigration Rules is set out in part 3 of appendix 2 to the visa application form 4A and in sections 5 and 6 of the Immigration Directorate Instructions for Appendix FM 1.7 Financial Requirement. ### **Refugees: Children**

**Catherine West** [63727] To ask the Secretary of State for the Home Department, pursuant to the Written Statement of 8 February 2017, HCWS467, on immigration, on what date she decided to change the number of unaccompanied child refugees taken by the UK under the Dubs amendment.

**Reply from Robert Goodwill:** There is no change to the number of unaccompanied children to be transferred to the UK under section 67 of the Immigration Act. Under the Immigration Act we made a commitment to transfer a specified number of unaccompanied refugee children to the UK, following consultation with local authorities on capacity.

On 8 February, the Government announced that we will transfer the specified number of 350 children to the UK under section 67 of the Immigration Act. This includes the more than 200 children already transferred from France as part of the UK's support for the Calais camp clearance.

The UK has contributed significantly to hosting, supporting and protecting the most vulnerable children affected by the migration crisis. In the year ending September 2016, the UK granted asylum or another form of leave to over 8,000 children. By the end of this Parliament, we will have resettled 20,000 Syrian nationals through our Syrian Vulnerable Persons Resettlement Scheme and a further 3,000 of the most vulnerable children and their families from the Middle East and North Africa region under the Vulnerable Children's Resettlement Scheme.

### Refugees: Children

**Thangam Debbonaire** [64076] To ask the Secretary of State for the Home Department, pursuant to her oral contribution of 9 February 2017 on unaccompanied child refugees, Official Report, columns 637-652, what the evidential basis is for her determination that the need for the scheme arising from the Dubs assessment has ceased.

**Reply from Robert Goodwill:** Under the Immigration Act we made a commitment to transfer a specified number of unaccompanied refugee children to the UK. On February 8, the Government announced that we will transfer the specified number of 350 children to the UK under section 67 of the Immigra-tion Act following consultation with local authorities on capacity. This includes the more than 200

children already transferred under section 67 from France as part of the UK's support for the Calais camp clearance.

The Government has a clear strategy for addressing the migration crisis; we invest significantly in upstream interventions and we resettle the most vulnerable directly from the affected regions, including children. It is right to focus our efforts on resettling refugees from the region, and thereby avoiding perilous journeys to Europe, particularly by the most vulnerable children. That is why we have committed to resettle 20,000 Syrian nationals through the Syrian Vulnerable Persons Resettlement Scheme and 3,000 of the most vulnerable children and family members under the Vulnerable Children's Resettlement Scheme over the course of this Parliament.

We will continue to meet our obligations under the Dublin Regulation. Furthermore, the UK has established a £10 million Refugee Children's Fund to support the needs of vulnerable refugee and migrant children arriving in Europe.

**Reply from Rory Stewart:** Through our support to the Office of the United Nations High Commissioner for Refugees, we protect children from violence, abuse, and exploitation. DFID also has specific programming targeting displaced children. For example, UK Aid in Syria and the region has provided over 920,000 children with psychosocial support, such as mental health care or psychosocial counselling.

**Reply from Robert Goodwill:** All asylum claims lodged in the UK are carefully considered on their individual merits against a background of relevant case law and up to date country information. We ensure that claimants are given every opportunity to disclose information relevant to their claim before a decision is taken, even where that information may be sensitive or difficult to disclose

We continually work to improve the quality of decision-making to ensure that we properly consider all the evidence provided and get decisions right the first time. UK Visas and Immigration has an internal audit process, consisting of reviews by senior case workers and independent auditors, which assesses whether Home Office policy has been followed.

### **Asylum: Housing**

**Anne Main** [63853] To ask the Secretary of State for the Home Department, what steps her Department is taking to ensure that people granted asylum in the UK in initial accommodation are properly supported for the duration of their stay.

**Reply from Robert Goodwill:** Asylum seekers are usually moved from Initial Accommodation to Dispersed Accommodation before their asylum claim is decided. When a supported asylum seeker is granted leave they are given 28 days accommodation and support to allow them to access mainstream benefits and the labour market and secure accommodation. The Home Office works closely with Department of Work and Pensions (DWP) to ensure that claims for mainstream benefits are processed during the 28 day grace period.

**Tulip Siddiq** [64668] To ask the Secretary of State for the Home Department, how many asylum applicants have been detained in each year since 2013, and how many of those applicants were detained in (a) a short-term facility, and (b) an Immigration Removal Centre.

### Children: Detainees

**Tulip Siddiq** [64636] To ask the Secretary of State for the Home Department, how many children have been detained by UKVI after submitting an asylum application in each year since 2013.

**Reply from Robert Goodwill:** The information requested is not recorded on Home Office systems. We do report on the number of decisions made an asylum claims, and, separately, on the number of persons detained for immigration purposes.

However, we do not have a combined set of data which would allow the question to be answered, and to cross-match these data sets over the period requested (since January 2014) would require a manual data matching exercise.

### **Detention Centres**

The following three questions all received the same answer

**Caroline Lucas** [63654] To ask the Secretary of State for the Home Department, what her policy is on granting hon. Members clearance to visit immigration removal centres outside of their constituency.

**Caroline Lucas** [63655] To ask the Secretary of State for the Home Department, how many hon. Members have (a) requested and (b) been granted clearance to visit (i) immigration removal centres and (ii) Yarl's Wood Immigration Removal Centre in the last three years for which figures are available.

**Caroline Lucas** [63656] To ask the Secretary of State for the Home Department, what the average time taken is to respond to requests by hon. Members to visit immigration removal centres.

**Reply from Robert Goodwill:** The requirement to obtain the permission of the Secretary of State to view an immigration removal centre (IRC) is set out in the Detention Centre Rules 2001. In addition to security and safety considerations, visits to view IRCs can affect the regime for detainees and are therefore subject to careful consideration and management to minimise disruption and intrusion.

All requests for visits by Honourable Members require the agreement of the Minister for Immigration, with local constituency MPs generally given priority over non-constituency MPs.

Management information shows that over the last 3 years 22 Honourable Members have requested to visit an IRC, including Yarl's Wood, of which 21 were granted clearance to visit. This is provisional management information and has not been assured to the standard of Official Statistics.

### Yarl's Wood Immigration Removal Centre

**Kate Osamor** [63781] To ask the Secretary of State for Health, whether women in Yarl's Wood Immigration Removal Centre are tested for TB, HIV and malaria on arrival from (a)

West Africa, (b) East Africa, (c) South Africa and (d) South-East Asia.

**Reply from Nicola Blackwood:** Healthcare in Immigration Removal Centres (IRCs) is commissioned by NHS England. Testing for infectious diseases among new entrants to IRCs, including Yarl's Wood, is guided by advice from Public Health England and, where applicable, National Institute for Health and Care Excellence guidance.

New entrants to all IRCs have a symptom-based questionnaire at first reception screening where healthcare staff ascertain whether patients have either signs or symptoms of tuberculosis (TB) or past history of infection or recent contact with someone with TB.

Since 2014, IRCs are advised to offer testing for HIV, hepatitis B and hepatitis C to new entrants as part of an 'opt-out programme' for blood-borne virus testing promoted by Public Health England, NHS England and the Home Office through the National Partnership Agreement.

Testing for malaria is usually done following presentation of symptoms consistent with malaria in someone with a history of travel from endemic countries and is not done routinely on asymptomatic patients.

On 8 February, the Government announced that we will transfer the specified number of 350 children to the UK under section 67 of the Immigration Act. This includes the more than 200 children already transferred from France as part of the

UK's support for the Calais camp clearance.

We will announce in due course the basis on which further children will be transferred from Europe to the UK under section 67 of the Immigration Act to the specified number.

In 2016, we transferred over 900 unaccompanied minors to the UK from Europe, including more than 750 from France as part of the UK's support for the Calais camp clearance.

On February 8, the Government announced that we will transfer the specified number of 350 children to the UK under section 67 of the Immigration Act. This includes the more than 200 children already transferred under section 67 from France as part of the UK's support for the Calais camp clearance. This number has been agreed following consultation with local authorities on their capacity to accommodate and care for unaccompanied children. We will announce in due course the basis on which further children will be transferred from Europe to the UK under section 67 of the Immigration Act to the specified number.

The primary responsibility for unaccompanied children in Europe lies with the State in which they are present. It is not possible for a child in France to claim asylum in the UK, and there is no application process under section 67 of the Immigration Act or the Dublin Regulation.

The UK has also established a £10 million Refugee Children's Fund to support the needs of vulnerable refugee and migrant children arriving in Europe.

### **Scottish Parliament Oral Answers**

### Tackling Islamophobia

**Angus MacDonald:** To ask the Scottish Government what action it is taking to tackle Islamophobia. (S5O-00690)

Reply from the Cabinet Secretary for Communities, Social Security and Equalities (Angela Constance): We invested more than £500,000 in 2016-17 to promote interfaith relations and engagement between civic Scotland and different faith communities. We are developing an ambitious programme of work following the report of the independent advisory group on hate crime, prejudice and community cohesion, which includes running a hate crime awareness-raising campaign this year. In January, the Minister for Community Safety and Legal

Affairs announced an independent review of hate crime legislation.

**Angus MacDonald:** I am pleased to hear of the progress that is being made, but the fact remains that Islamophobia continues in my Falkirk East constituency and beyond. It has been suggested to me by groups that have been on the receiving end of Islamophobia in the Falkirk district that a relaunch of the one Scotland, many cultures campaign would help to show Scotland as the diverse, multifaith and multicultural society that it is, committed to promoting one Scotland where many cultures can thrive side by side. Will the cabinet secretary give that some consideration?

**Reply from Angela Constance:** Yes—absolutely. As I alluded to in my original answer, we are developing an awareness-raising campaign around the impact of hate crime as part of our one Scotland campaign. That campaign continues to have an online presence, but we will look at how we can develop it further. Some of the important recommendations from the independent advisory group on hate crime, prejudice and community cohesion were around public education and how we promote a clearer understanding of hate crime and its impact, and how we really get across the strong message that it must not be tolerated and must be reported at every opportunity. I hope that that gives some reassurance to the member and to the Parliament.

**Anas Sarwar:** Despite the Government's efforts, Islamophobic hate crime has actually doubled in the past year in Scotland. What specific measures will be taken to support Muslim communities to better report Islamophobic hate crime? How can we set examples through people being convicted for Islamophobic hate crime? Does the Government share any data about Islamophobic hate crime with any organisations that monitor the trends in Islamophobia?

**Reply from Angela Constance:** Mr Sarwar is absolutely right to point to an increase in Islamophobia in terms of crimes reported. The most recent hate crime statistics, which were published by the Crown Office and Procurator Fiscal Service, show an increase in the number of charges where conduct was derogatory to Islam from 71 to 134. We know that that is not attributable to a single event pattern; it is due to a general rise in reporting. Any crime is regrettable, and it is particularly important that such crime is reported so that a firm stance can be taken.

A review has been undertaken of the effectiveness of third-party reporting, which was one of the important recommendations in the independent advisory group report. There were also recommendations on data, which we are currently working through. It is important to have good and robust data that gives more granular detail on the causes and conditions in which such crime flourishes.

It might be of some reassurance to Mr Sarwar that we will produce a plan of action in the very near future. As part of our determination to tackle prejudice in all its forms, we have introduced three-year funding for the equality budget, which will support the important work that is undertaken by diverse groups, including groups that work in our communities to tackle hate crime and prejudice in all its forms.

Ofcom's process for complaints covers content on television, radio and on demand programme services. The Broadcasting code includes rules designed to protect viewers and listeners from harm and offence – such as what can be screened on TV before the 9pm watershed. Other areas of the Broadcasting Code address issues such as impartiality and accuracy, sponsorship and commercial references as well as fairness and privacy. ### **Religious Hatred: Christianity**

**Baroness Berridge** [HL5298] To ask Her Majesty's Government what assessment they have made of the case for a Christian hate crimes unit, additional to the Jewish and Muslim hate crimes units in the Department for Communities and Local Government.

**Reply from Lord Bourne of Aberystwyth:** The Government set out its commitment to reduce the harm caused by all hate crime, including that which is religiously motivated, in '<u>Action against hate: the UK government's plan for tackling hate crime</u>' which was published in July 2016.

The Department for Communities and Local Government (DCLG) does not have specific units for antisemitic or anti–Muslim hate crime. Rather, we support Working Groups to bring members of those communities, where religiously motivated hate crime is at the highest levels, together with Government and other agencies to discuss what more we can do to tackle anti - Semitism and anti-Muslim hate crime. DCLG also supports the cross-Government Hate Crime Programme, which coordinates the response to all forms of hate crime across Whitehall and the Criminal Justice Agencies.

DCLG supports the police website 'True Vision' and, in January 2017, the Communities Secretary announced £25,000 extra funding for True Vision to work with Christian Groups, including Churchwatch. The project will assess the nature and extent of anti-Christian hate crime, reassure affected Christians and raise awareness of reporting mechanisms for hate crime. The findings of the research will help inform our future activity to challenge hate crime, which is unacceptable in any community.
