Migrant Workers

Alison Thewliss [69081] To ask the Secretary of State for the Home Department, what assessment she has made of income thresholds for Tier 2 visas; and if she will make a statement.

Reply from Robert Goodwill: The Government commissioned the independent Migration Advisory Committee to undertake a comprehensive review of the Tier 2 route in June 2015. In carrying out its review, the MAC issued two public calls for evidence (from 18 June to 2 July 2015 and from 2 July to 24 September 2015) and consulted extensively with over 200 organisations, including professional bodies in the health sector across all parts of the UK.

The changes we are making to Tier 2 salary thresholds, which will come into effect on 6 April 2017, therefore reflect the latest evidence provided by the MAC and are measured and balanced. They will contribute to the Government's objective of reducing net migration to sustainable levels and to incentivise employers to upskill and train resident workers, whilst making sure they can continue to access the workers they need to

Peter Kyle [69364] To ask the Secretary of State for the Home Department, with reference to case 507/12, heard at the European Court of Justice, if she will take steps to ensure that EEA female citizens residing in the UK who give up work or seeking work because of the physical constraints of the late stages of pregnancy and the aftermath of childbirth retain the status of worker under EU law.

Reply from Robert Goodwill: The Home Office has incorporated the European Court of Justice's ruling in the case of *Jessy Saint Prix v. Reply from Robert Goodwill: Information on Tier 1, Tier 4, and short-term study (previously referred to as 'student visitor') grants (by calendar year) is published quarterly; latest data in the Home Office's 'Immigration Statistics, October - December 2016', Visa data tables volume 1, table vi_04, available from the <u>https://www.gov.uk/government/publications/immigration-statistics-october-to-december-2016/list-of-tables#visas</u>

Published tables do not contain visa figures for 2017. Our next released publication, on May 25, will contain Q1 2017 figures.

Immigration: EEA Nationals

Paul Blomfield [66324] To ask the Secretary of State for the Home Department, if she will change the text of EEA Permanent Residence refusal letters to remove the instruction to recipients to make preparations to leave the UK.

Reply from Robert Goodwill: The Home Office does not send letters to European Economic Area (EEA) nationals instructing them to make preparations to leave the UK. The refusal letters notify them that, on our assessment of the evidence provided, we are unable to confirm that they have acquired permanent residence.

The Home Office also provides applicants with information on options available to them, for example, clear guidance on providing the necessary evidence to make a successful application in the future, and of their right of appeal.

Immigration: EEA Nationals

Caroline Lucas [68486] To ask the Secretary of State for the Home Department, what her Department's policy is on whether EEA citizens will be removed from or refused reentry to the UK on the basis that they do not have comprehensive sickness insurance; and if she will make a statement.

Reply from Robert Goodwill: The Free Movement Directive requires those who wish to rely on periods of residence as a student or self-sufficient person in order to acquire permanent residence to have held comprehensive sickness insurance for the relevant qualifying periods.

While failure to meet this EU law requirement will lead to a refusal of documentation certifying that the applicant has a right to reside, our longstanding practice is that European Economic Area (EEA) national students or self-sufficient persons will not be removed from the UK solely because they do not have comprehensive sickness insurance. This is because the failure is relatively straightforward to rectify and establish a right to reside in the UK.

Where applications for documentation are refused or rejected, the reasons are explained to applicants and they can, if they wish, apply again with the necessary supporting evidence, although we do not compel them to do so.

Reply from Robert Goodwill: Statistics on outcomes of applications for registration certificates for European Economic Area (EEA) nationals are published quarterly in the Immigration Statistics. These include data for

Deidre Brock [68727] To ask the Minister for the Cabinet Office, how many nationals from other EU countries residing in the UK have been (a) self-sufficient and (b) students for a period during that residence.

Reply from Chris Skidmore: The information requested falls within the responsibility of the UK Statistics Authority. I have asked the Authority to reply.

Letter from John Pullinger: As National Statistician and Chief Executive of the UK Statistics Authority, I am replying to your Parliamentary Question asking how many nationals from other EU countries residing in the UK have been (a) selfsufficient and (b) students for a period during that residence (68727). It is not possible to directly answer the question from currently available data sources. Firstly, no estimate is available of EU nationals living in the UK who are or have been self sufficient.1 However, we can provide an estimate of the number of EU nationals residing in the UK in 2015 who originally immigrated to study. The Annual Population Survey (APS) collects information on year of arrival and reason for immigration. The APS is a sample survey based on households and does not include people living in most types of communal establishments. 2 Of particular relevance for this question, it will exclude students living in halls of residence with non-UK resident parents. To provide a response to your question we have used data collected from APS for the 2015 calendar year, which are the latest data available. The APS estimates that for 2015 there were 309,000 nonUK EU nationals living in the UK (with a confidence interval of +/- 25,000), whose original reason for migration was formal study. These figures can be found in table 2.5 of the Annual Population of the United Kingdom by Country of Birth and Nationality publication.3 This estimate will include those who stated formal study as their main reason for arrival, irrespective of when this was. No estimate is available of those who declared another main reason for coming to the UK, but subsequently undertook study.

Immigration: EU Nationals

Deidre Brock [68728] To ask the Secretary of State for the Home Department, how many applications for permanent residency from nationals from other EU countries who have been in the UK for a continuous period of five years have been rejected due to the applicant being (a) self-sufficient or (b) a student for a period during that residency without a comprehensive sickness insurance policy in each of the last five years.

Reply from Robert Goodwill: The information requested is not collated on centrally held statistical databases and could only be produced at disproportionate cost by examination of individual case files.

Applications for documentation certifying permanent residence are refused where they do not meet the requirements set out in EU law in the Free Movement Directive. The Free Movement Directive is clear that those who wish to rely on periods of residence as a student or self-sufficient person must have held comprehensive sickness insurance in order for their residence to count towards permanent residence status.

Asylum

Liz McInnes [69301] To ask the Secretary of State for the Home Department, if she will

ensure that all local authorities take in a fair share of asylum seekers.

Reply from Robert Goodwill: The Government is committed to ensuring a more equitable distribution of asylum seekers across the UK. However, one needs to consider that not all asylum seekers receive Home Office support or accommodation while their claim is considered. The Immigration and Asylum Act 1999 introduced the policy of national dispersal, designed to share the impact of supported asylum seekers across the whole of the UK. Since 2015, the Home Office has been working closely with local authorities across the UK to increase the number of areas that participate in the dispersal scheme; this activity has increased the number of dispersal areas by a third.

Information on the average length of time between asylum application and maternity payment is not routinely collected and could only be provided by examination of individual case records, which would result in disproportionate cost.

Asylum: Hearing Impairment

Alison Thewliss [68748] To ask the Secretary of State for the Home Department, pursuant to the Answer of 13 March 2017 to Question 67025, which support groups are engaged by the Home Office to support asylum applicants who are deaf and hard of hearing.

Reply from Robert Goodwill: Asylum claims made by those who are deaf or hard of hearing are processed in a way that ensures that claimants are not disadvantaged. Where available, officials will use hearing loops, signers or allow the submission of written evidence. These methods have ensured cases have progressed without the need for support groups however should specialist support be necessary to progress a case then we would of course engage accordingly.

Those granted asylum or resettled in the UK have the right to access disability support services offered by local authorities.

Asylum: Children

Geoffrey Cox [69137] To ask the Secretary of State for the Home Department, how many children she plans to resettle in the UK under the Dubs amendment in the next six months.

Reply from Robert Goodwill: On 8 February, the Government announced that we will transfer the specified number of 350 children to the UK under section 67 of the Immigration Act 2016 following consultation with local authorities on capacity. This includes the more than 200 children already transferred under section 67

from France as part of the UK's support for the Calais camp clearance. Further transfers are expected to begin shortly.

Imran Hussain [69501] To ask the Secretary of State for the Home Department, what steps the Government is taking to ensure that the unique needs of unaccompanied asylum-seeking children are met during integration into education, care and health services.

Reply from Robert Goodwill: Local authorities have a statutory duty under the Children Act to ensure that they safeguard and promote the welfare of all children, regardless of their immigration status or nationality. Under these arrangements, unaccompanied asylum seeking children are assessed with regard to their individual needs and provided with access to education, accommodation, and psychological and health services, as would be provided to any other looked after child in the UK. They are also provided with a personal social worker. We work closely with Department for Education and local authorities to support effective access to, and delivery of, these services to this group of children.

Imran Hussain [69503] To ask the Secretary of State for the Home Department, what measures are in place to ensure that the receipt of unaccompanied asylum-seeking children (a) incorporates young person-centred practice and (b) is efficient.

Reply from Robert Goodwill: The Home Office takes its responsibility for the welfare of children very seriously and immigration officials receive specific training on responding to children's needs. As soon as possible after claiming asylum, identity details of unaccompanied children are registered and a welfare interview conducted to identify any safeguarding concerns. All unaccompanied asylum seeking children are referred to the local authority children's services so that accommodation and welfare needs can be assessed and appropriate provision made. A referral is also made to the Refugee Council Children's Panel which is an independent voluntary organisation funded by the Home Office to provide advice and guidance to unaccompanied children on the asylum process.

Reply from Robert Goodwill: The National Transfer Protocol, which provides guidance on the operation of the National Transfer Scheme and can be found at https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/5_34258/Interim_National_UASC_transfer_protocol.pdf, sets out that a child's best interests must be at the heart of transfer decisions. This will include taking account of an unaccompanied child's peer and sibling groups and ensuring that unaccompanied children can maintain contact and, wherever possible, are placed in the same local authority area as their siblings.

Detention Centres: Guard Dogs

Stuart McDonald [68452] To ask the Secretary of State for the Home Department, what her policy is on use of dogs to patrol (a) immigration detention centres and (b) Dungavel immigration removal centre.

Reply from Robert Goodwill: The requirement to maintain the security of an immigration removal centre (IRC) is set out in the Detention Centre Rules 2001. The published Detention Services Operating Standards set out the requirement for each IRC to have a local security strategy, which includes searching procedures to detect and deter threats to the security or control of the centre.

The Operating Standards also require a full-length physical perimeter search to be conducted daily.

Immigration (Trafficking)

Stuart McDonald [68451] To ask the Secretary of State for the Home Department, how many people who passed through the National Referral Mechanism as victims of modern slavery or of human trafficking with positive conclusive grounds status were granted discretionary leave to remain in the UK in (a) 2014-15, (b) 2015-16 and (c) 1 April to 31 December 2016.

Reply from Robert Goodwill: Our records indicate that the number of individuals who received a positive conclusive grounds decision from the National Referral Mechanism who were granted discretionary leave to remain in the UK were as shown in table 1 below.

The question has been interpreted as referring to people holding only discretionary leave status following an earlier positive conclusion grounds decision. The grant of limited leave may not have been in the same year as the positive conclusive grounds outcome.

- 1. These statistics have been taken from a live operational database. As such, numbers may change as information on that system is updated.
- 2. Data showing latest case grant. Please note that the DL category includes all types of "Limited Leave".
- 3. Data only shows those cases where the grant occurs after the positive conclusive grounds outcome.
- 4. A person might have been granted another form of leave such as asylum instead of a grant of DL, the asylum grant could have occurred at any point during their immigration history.
- 5. The data is part of a wider data set which looks at different type of grants

individuals might have received using the following hierarchy - Asylum (at any point during their immigration history), HP, DL & ILR (after the positive conclusive grounds stage).

6. The National Referral Mechanism (NRM) is the process by which people who may have been victims of modern slavery are identified, referred, assessed and supported in the United Kingdom. ("Modern slavery" is a term that covers slavery, servitude and forced or compulsory labour and human trafficking.) The initial referral goes through a two stage process: a reasonable grounds stage and then, for those with a positive reasonable grounds outcome (where it is considered that the person is a potential victim of trafficking/slavery), a conclusive grounds stage (where the person is considered to be a confirmed victim of trafficking/slavery).

We cannot determine if the grant is linked to the fact that the person was also a victim of trafficking.

Lord Roberts of Llandudno [HL6021] To ask Her Majesty's Government what was the average length of time taken to determine a second or subsequent further leave to remain application made on the basis of (1) family, and (2) private, life in (a) 2015, and (b) 2016.

Reply from Baroness Williams of Trafford: Home Office Systems cannot be interrogated in a way that will provide any meaningful response to the question. A manual review of all applications submitted within the stipulated timeframe would be needed in order to provide an accurate response and this would incur a disproportionate cost to the public purse.

Therefore, the average length of time taken to determine a second or subsequent further leave to remain application made on the basis of (1) family, and (2) private, life in (a) 2015, and (b) 2016 cannot be provided.

Asylum: LGBT People

The following three questions all received the same answer

Lord Scriven [HL6080] To ask Her Majesty's Government how many asylum seekers who have been recorded as LGBT have been held in detention over the last 12 months and what was the length of detention in each case.

Reply from Baroness Williams of Trafford: On 27 February 2017, the Home Office responded to an FOI request asking for information relating to detainees who identify as LGBT in the immigration detention estate. The FOI asked for information relating to detainees who identify as LGBT in the immigration detention estate. This question concerns asylum seekers in detention who have been recorded as being based LGBT.

The FOI response, provided below, set out the number of individuals in detention who have disclosed their sexual orientation as LGBT as a snapshot (on 18 November 2016) and as a total number for the period from 1 January to 18 November 2016, see table below.

Service providers are required to provide opportunities for detainees who wish to do so, to safely disclose their sexual orientation and to ensure that those individuals can easily access support and assistance.

The data you have requested in relation to LGBT asylum seekers held in detention over the last 12 months and the length of detention in each case is not readily

available. It is not incumbent upon a detained individual to declare their sexuality. The required information would only be recorded in the case notes sections within the Home Office database or held solely on the paper files. The time required to examine individual cases and extrapolate the required data, would exceed the £800 cost limit.

Anti-poverty policy and programme

S5W-08138 Alex Rowley: To ask the Scottish Government what action it has taken to (a) fill evidence gaps on (i) how and (ii) to what extent people from minority ethnic groups are accessing benefits to which they are entitled and (b) ensure that all anti-poverty policy and programme areas are fully impact-assessed for equality.

Reply from Jeane Freeman: The Race Equality Framework committed the Scottish Government to fill the gaps in current knowledge on how and to what extent minority ethnic people are accessing the benefits they are entitled to. The Framework covers the period 2016-2030, and we have already taken some action on this front.

During the social security consultation, we spoke directly to minority ethnic groups and listened closely to what they told us in terms of the issues they faced of access and culture with a view to ensuring that the delivery of our social security system understands and can support action to overcome these barriers.

The benefit take up campaign launched in March 2017 was the first phase of our work in this area. This work will be developed over the course of the parliamentary term. We will continue to listen to and take views from a range of equality organisations on how best to increase take up amongst groups that are currently under represented as part of this process. We remain absolutely committed to working with our partners to ensure that all groups and communities access what they are entitled to.

More widely social security Experience Panels will ensure that those in receipt of benefits are involved in designing the social security system in a meaningful way. By sampling from DWP lists of current recipients, and by having separate panels for each benefit (or group of benefits) each panel will be representative of people in Scotland currently receiving the devolved benefits. The sample has been drawn using the National Record of Statistics postcode list for Scotland so will cover all

areas of Scotland. We will also work closely with key organisations to ensure that minority ethnic communities are fully represented on the panels.

An initial equality impact assessment was published as part of the social security consultation with a request for respondents to help develop this further for publication alongside the Social Security Bill.

Independence Referendum (Assessment of Support)

Lewis Macdonald: To ask the Scottish Government what assessment it has carried out of public support for a second referendum on Scotland leaving the United Kingdom. (S5O-00828)

Reply from the Minister for UK Negotiations on Scotland's Place in Europe (Michael Russell): The current Scottish Government was elected last year with the largest ever constituency vote since the beginning of devolution on a clear manifesto pledge that "the Scottish Parliament should have the right to hold another referendum ... if there is a significant and material change in the circumstances that prevailed in 2014, such as Scotland being taken out of the EU against our will." That specific "material change" is now taking place. We believe that the people of Scotland should have the final choice over their future once the terms of Brexit are clear.

Lewis Macdonald: I take it from that answer that the Government has carried out no assessment of public attitudes on this matter since the Brexit referendum on 23 June. Has the minister considered the opinion poll evidence, which Professor John Curtice summed up in a blog on 2 March? That evidence is that Scottish voters are overwhelmingly opposed to a second independence referendum before the final outcome of Brexit negotiations is clear. Does the minister agree that the priority for the Scottish Government for the next two years should be to protect Scotland's vital interests in those negotiations and to secure the repatriation of powers over devolved areas from Brussels to Holyrood rather than to promote a further referendum that the Scottish people do not want?

Reply from Michael Russell: Those two objectives are not mutually contradictory, of course. Indeed, this very day, I received a letter from David Davis that looks forward to working together on some of the issues that lie ahead. Lewis Macdonald is wrong about that matter and about the opinion poll evidence, which shows a split of about 50:50 in those circumstances. Very clear indications of public support are often available in the opinion polls. I draw attention to the opinion polls that show that the Labour Party is in third place in Scotland. That is an indication of the public support for Lewis Macdonald, his point of view and the Labour Party.

Lewis Macdonald: On a point of order, Presiding Officer. I assume that Mr Russell has inadvertently confused my question about support for holding a referendum with a different question about support for independence. Will he correct the record at this point?

The Presiding Officer (Ken Macintosh): That is not a point of order, Mr Macdonald, but I am sure that the point has been noted by the minister. ...

Adam Tomkins (Glasgow) (Con): ... it has been said that "To propose another referendum in the next parliament without strong evidence that a significant number of those who voted No have changed their minds would be wrong and we won't do it"; and, "If I, the SNP, those who believe in independence, can't shift opinion from September 2014, we won't earn the right to ask the question again".

Both of those statements are direct quotations from the First Minister. Was she wrong? If she was not wrong, why have ministers changed their minds?

Reply from Michael Russell: The member knows very well that the manifesto on which the First Minister, I and everyone on this side of the chamber stood—I read it out in my original answer, to which the member was clearly not listening—says: "the Scottish Parliament should have the right to hold another referendum ... if there is a significant and material change in the circumstances that prevailed in 2014 such as Scotland being taken out of the EU against our will."

The member has clearly seen what has been taking place today. He has clearly seen the attitude of the Prime Minister. In all those circumstances, that manifesto commitment has been fulfilled and will be followed.

Secondly, I make the point that it is a dangerous position for any Opposition to believe that it can veto a majority in the Parliament that is based on a manifesto commitment. That is not democracy, and those who choose to depart from that cannot, by definition, be democrats.

Female Genital Mutilation

Michael Gove [68103] To ask the Secretary of State for Education, what steps her Department is taking to protect girls from female genital mutilation.

Reply from Edward Timpson: The Department for Education's vision statement, Putting Children First, published in July 2016, set out our commitment to protecting children from all forms of abuse, including female genital mutilation (FGM). The Children and Social Work Bill, currently before Parliament, will help us to deliver the change needed to secure a system that meets children's needs.

As well as that wide-ranging work on safeguarding, we are currently funding two voluntary sector organisations working to safeguard girls from FGM. The Foundation for Women's Health Research and Development (FORWARD) and the Midaye Somali Development Network have been allocated a total of over £600,000 for work from December 2016 until March 2018.

On 1 March the Secretary of State made a statement to this House announcing her intention to put Relationships and Sex Education on a statutory footing. There will be a comprehensive programme of engagement, followed by full public consultation, and I know that those campaigning on issues such as FGM will want to contribute to that discussion.
