**Reply from Robert Goodwill:** No psychiatrists currently on a Tier 2 visa will attract the immigration skills charge.

The immigration skills charge will not apply where an individual has already been assigned a Tier 2 Certificate of Sponsorship at the time the regulations come into force.

There is also an exemption to the immigration skills charge for PhD level occupations.

**Kate Green** [68894] To ask the Secretary of State for Justice, how many (a) children under 18 and (b) young people aged 18 to 24-years of age (i) applied for legal aid through the Exceptional Case Funding Scheme (ECF) and (ii) were granted ECF in immigration cases in (A) 2013-14, (B) 2014-15 and (C) 2015-16.

### **Legal Aid Scheme: Children and Young People**

**Kate Green** [68895] To ask the Secretary of State for Justice, how many (a) children under 18 and (b) young people aged 18 to 24-years of age received legal aid funding in each of the last seven years.

**Reply from Oliver Heald:** The Legal Aid, Sentencing and Punishment of Offenders Act 2013 was introduced under the Coalition Government and took effect in April 2013. Section 10 of the Act provided for the Exceptional Case Funding scheme, to address those cases which would not ordinarily be eligible for legal aid under the post-LASPO regime, but where an individual's Convention rights would be breached in the absence of having funded representation.

As the ECF scheme has developed, providers have familiarised themselves with the legislative framework, which has also been clarified by various judgements during this time. This has led to an increase in the volume of successful applications.

**Reply from Robert Goodwill:** The enforcement action that the Office of the Immigration Services Commissioner (OISC) is able to take against registered advisors is set out in the Immigration and Asylum Act 1999 and the Commissioners Complaints Scheme

34. If a complaint is substantiated, in whole or in part, it will be included in the organisation's and adviser's regulatory history.

35. The Commissioner may:

- leave the determination on file for consideration at the next relevant application for registration. Practice points may be issued;
- consider and conclude that the organisation and/or an adviser should have their authorisation immediately cancelled; or
- lay a Disciplinary Charge before the First-tier Tribunal (Immigration Services).

**Hilary Benn** [63409] To ask the Secretary of State for the Home Department, what her policy is on the timing of the return of original documents to people applying for (a) citizenship, (b) further leave to remain and (c) indefinite leave to remain.

**Reply from Robert Goodwill:** The majority of Citizenship applications are submitted through the Nationality Checking Service and original documents are returned to the customer immediately. For other applications where there is a requirement to submit an original document, documents are returned when the application is decided.

Where a request for return of documents is received we aim to return them within 10 working days.

On European applications for Permanent Residence, applicants can apply online and have their passport checked and returned immediately through participating local authorities.

**Roger Godsiff** [69980] To ask the Secretary of State for the Home Department, what assessment she has made of the implication for her policies of the finding of the Thematic Report on migrant and refugee children, published by the Council of Europe on 10 March 2017 that Europe's treatment of child refugees increases the risk of radicalisation; and if she will make a statement.

**Reply from Robert Goodwill:** The Government notes the Council of Europe's report on migrant and refugee children and is committed to implementing policies which do not inadvertently create incentives for children to make dangerous journeys into and across Europe and place their lives in the hands of people traffickers and criminal gangs. That is why we have focused our efforts on providing support in and around regions of conflict, and on providing safe and legal routes for children to come to the UK via our resettlement schemes. The Government is also working with law enforcement agencies and governments across Europe to clamp down on those seeking to exploit or radicalise human beings. The welfare of all children in the UK is a priority and unaccompanied asylum seeking and refugee children are entitled to the same care and support as any other looked after child.

**Reply from Robert Goodwill:** Since 2015, the Home Office has been working closely with accommodation providers and local authorities across the UK to increase the number of areas that participate in the asylum seeker dispersal scheme; this activity has already increased the number of dispersal areas by a third and continues to encourage those local authorities that aren't participating to do so.

### **Immigrants: Detainees**

**Robert Ffello** [53631] To ask the Secretary of State for the Home Department, what community-based alternatives to detention her Department developed and implemented as a result of the report by the All Party Parliamentary Group on Refugees and the All Party Parliamentary Group on Migration, published in March 2015, and the report by Stephen Shaw, Review into the Welfare in Detention of Vulnerable Persons, Cm 9186, published in January 2016.

**Reply from Robert Goodwill:** There is always a presumption of liberty and detention is only ever used sparingly and for the shortest period necessary. For those individuals with no right to remain in the UK, we expect them to leave the country of their own volition and the Home Office has programmes to support voluntary return.

The Home Office expects that current and planned reforms, and broader changes in legislation, policy and operational approaches will lead to a reduction in the number of the most vulnerable detained and the duration of detention before removal.

### **Detainees: Pregnancy**

**Nusrat Ghani** [69792] To ask the Secretary of State for the Home Department, how many women recorded as pregnant have been held in immigration detention since the Immigration Act 2016 came into force; and how many of those women left detention to be removed from the UK.

**Reply from Robert Goodwill:** Through section 60 of the Immigration Act 2016, which came into force on 12 July 2016, we have placed a 72 hour limit on the detention of pregnant women for the purposes of removal, extendable to up to a week in total with Ministerial authorisation.

It may not always be appropriate for healthcare professionals to disclose confidential medical information that the patient has asked not to be disclosed. Subject to these limitations, Home Office management information indicates that 27 pregnant women were detained in the immigration detention estate between 12 July 2016 and 31 December 2016. This resulted in 5 pregnant women being removed from the UK.

The section 60 limitations, along with a new policy on adults at risk in detention, and other improvements to caseworking processes, represent a comprehensive package of safeguards for pregnant women in the immigration system.

## Deportation

**Steve Reed** [70991] To ask the Secretary of State for the Home Department, how many (a) men and (b) women have been deported from the UK in each of the last five years.

**Reply from Robert Goodwill:** The number of enforced returns by gender is published in table rt\_03 (returns data tables) in 'Immigration Statistics, October - December 2016', available from the Home Office website at:

The term 'deportations' refers to a legal definition of a specific set of returns. Deportations are a specific subset of returns which are enforced either following a criminal conviction or when it is judged that a person's removal from the UK is conducive to the public good. The deportation order prohibits the person returning to the UK until such time as it may be revoked. Published information on those deported is not separately available. As such, the question has been interpreted as referring to enforced returns. In an enforced return, it has been established that a person has breached UK immigration laws and / or has no valid leave to remain in the UK. They have declined to leave voluntarily and the Home Office enforces their departure from the UK.

**Reply from Sarah Newton:** The National Referral Mechanism pilot has been testing a new model for identifying and referring victims, processing cases and making effective decisions. The pilot has been dealing with both child and adult potential cases of modern slavery and the evaluation will consider decision making and timeliness for both cohorts. The final stage of the evaluation is currently underway and it is anticipated that the findings will be ready for publication summer 2017.

## UK Parliament, House of Lords Written Answers

### Digital Technology: Migrant Workers

**Lord Cromwell** [HL6557] To ask Her Majesty's Government, further to the oral answer by Lord Ashton of Hyde on 27 March (HL Deb, col 355), and in the light of the call by the Coalition for a Digital Economy in its report *Global Britain: From local startups to international markets*, published in February, to allow the highly skilled into the country through a minimum six-month visa to enter the UK and seek work, whether they intend to take steps to provide visas more quickly for such workers who are invited to work in the UK; and if so, what are those steps, and what is the proposed timescale for the implementation of any necessary changes to the visa application process.



**Reply from Baroness Williams of Trafford:** The current Points Based System already provides for ways in which highly skilled migrants from outside the European Economic Area can work in the UK. The Tier 1 (Exceptional Talent) route allows leading digital technology talent endorsed by Tech City UK to enter the UK without needing a job offer from a sponsoring employer.

The Government is committed to ensuring that the UK remains open for business and continues to grow and thrive – and ensuring our new relationship with the EU works for employees and employers will be important in the months ahead.

For individual skilled migrant workers invited by an employer to work in the UK, their visas are routinely processed within three weeks, with premium services available for applicants who need faster decisions. Some jobs in digital technology, as identified by the independent Migration Advisory Committee, are recognised shortage occupations and are exempt from the Resident Labour Market Test.

### **Digital Technology: Migrant Workers**

**Lord Cromwell** [HL6558] To ask Her Majesty's Government, further to the oral answer by Lord Ashton of Hyde on 27 March (HL Deb, col 355), whether they intend to address the need for people from overseas with the requisite digital technology skills to be able to come to work in the UK during the Brexit negotiation process; if not, what assessment they have made of the impact of failing to address that need in the short-term on the UK economy; and if so, what steps they are taking to support access to the skills required in that sector.

**Reply from Lord Ashton of Hyde:** We seek to guarantee the rights of EU citizens who are already living in Britain, and the rights of British nationals in other member states as early as we can. This remains an early priority for the forthcoming negotiations. We will control immigration so that we continue to attract the brightest and the best to work or study in Britain, but manage the process properly so that our immigration system serves the national interest. As part of that it is important that we understand the impacts of different options on different sectors of the economy and the labour market. We are taking action across the entire education and training pipeline to ensure we have the digital skills to maintain our world leading digital economy.

**Baroness Lister of Burtersett** [HL6559] To ask Her Majesty's Government what proportion of individuals pursuing appeals in (1) the First-tier Tribunal (Immigration and Asylum Chamber), and (2) the Upper Tribunal (Immigration and Asylum Chamber), did not have representation, for each year, since December 2012.

**Reply from Lord Keen of Elie:** The proportions of individuals pursuing appeals

that did not have representation are:

(1) the First-tier Tribunal (Immigration and Asylum Chamber)	25%	21%	21%	20%
(2) the Upper Tribunal (Immigration and Asylum Chamber)	12%	12%	10%	10%

The data are based on the number of disposals recorded as not represented and are reported in calendar years.

### Asylum

**Baroness Lister of Burtersett** [HL6681] To ask Her Majesty's Government what is their estimate of the number of refused asylum seekers currently in the UK who have no immediate prospect of leaving.

**Reply from Baroness Williams of Trafford:** The UK has a long and proud tradition of providing a safe haven to those who genuinely need our protection.

All asylum and human rights claims are carefully considered on their individual merits in accordance with the UK's obligations under the 1951 United Nations Convention Relating to the Status of Refugees and the European Convention on Human Rights.

Where a decision has been made that a person does not require international protection, and there are no remaining rights of appeal or obstacles to their return, the Home Office expects unsuccessful asylum seekers to return voluntarily to their home country. The Home Office can assist persons who wish to return voluntarily. The Home Office's preferred option is for those who have no legal basis to remain in the UK to leave voluntarily and we offer assistance to those who choose to do so. But if an individual does not leave the UK voluntarily, then it will become necessary to enforce their removal.

The Home Office closely monitors developments in all countries of return and takes decisions on a case-by-case basis in the light of international obligations and the latest available country information. The Home Office only enforces removal when it and the courts conclude that it is safe to do so, with a safe route of return.

Enforced removals are carried out in the most sensitive way possible, treating those being removed with respect and courtesy.

**Reply from Baroness Williams of Trafford:** Where a failed asylum seeker has agreed to return to their home country voluntarily, the Home Office Voluntary Returns Service (VRS) will assist them with obtaining travel documents required by the receiving country to facilitate entry. VRS will provide their travel costs to the embassy or High Commission and will also cover the cost of the travel document if required.

Where a failed asylum seeker does not choose to return voluntarily, the Home Office will engage directly with the relevant embassy or High Commission to obtain the required travel document for return.

### Asylum: Children

**Reply from Baroness Williams of Trafford:** The current family reunion policy meets our international obligations. Widening it to allow children to sponsor family members would create additional motives for them to be encouraged, or even forced, to leave their family, and risk hazardous journeys to seek to enter the UK illegally. This would play into the hands of criminal gangs who exploit vulnerable people, and goes against our safeguarding responsibilities.

The Government believes that the best interests of children are reflected in their remaining with their families and claiming asylum in the first safe country they reach; this is the fastest route to safety.

**Reply from Baroness Williams of Trafford:** Mandate plays an important part in facilitating the resettlement of refugees in various locations across the world. There is no specific quota or target for the number of people resettled via Mandate. The referral of cases (and the corresponding numbers of arrivals) under Mandate is dependent on the UN High Commissioner for Refugees (UNHCR) identifying cases which meet its criteria.

Mandate operates in addition to the Gateway programme which resettles 750 people a year. This is in addition to our commitment to resettle 20,000 people

under the Syrian Vulnerable Person's Resettlement scheme and 3,000 people under the Vulnerable Children's Resettlement scheme.

**Lord Scriven** [HL6481] To ask Her Majesty's Government how many people identified as LGBT were held in asylum detention centres for more than (1) one month, (2) two months, (3) six months, and (4) one year, over the last two years.

**Lord Scriven** [HL6482] To ask Her Majesty's Government in relation to those claiming asylum on the grounds of being LGBT, how many cases have not been determined after (1) one year, and (2) two years, from the date of the individual claiming asylum.

**Reply from Baroness Williams of Trafford:** On 27 February 2017, the Home Office responded to an FOI request asking for information relating to detainees who identify as LGBT in the immigration detention estate. The FOI asked for information relating to detainees who identify as LGBT in the immigration detention estate. These questions concerns asylum seekers, who have been recorded as being LGBT, and the numbers held in detention and the time taken to determine their asylum claims.

The data you have requested in relation to LGBT asylum seekers over the last 2 years is not readily available. The required information would only be recorded in the case notes sections within the Home Office database or held solely on the paper files. The time required to examine individual cases and extrapolate the required data would exceed the cost limit.

We are currently reviewing how and when to publish information on LGBT asylum claims though no decision has yet been taken regarding either a final timetable or the methodology of any such release.

This is one of a number of reforms necessary to implement the wider immigration bail provisions in Schedule 10 and it will be commenced alongside those other provisions in due course.

**Baroness Lister of Burtersett** [HL6236] To ask Her Majesty's Government what progress they have made in introducing detention reviews for those held in immigration removal centres.

**Reply from Baroness Williams of Trafford:** Any individual detained within immigration detention is already subject to regular review, both on a scheduled basis and whenever there is any change in circumstances that might be material to the decision on whether or not to continue detention. Reviews are carried out at successively more senior levels the longer the detention continues.

Following publication of the Government's response to Stephen Shaw's Report into the welfare in detention of vulnerable persons on 14 January 2016, work has been ongoing to design a more effective case management process to replace the existing procedure for reviewing detention. This includes a more proactive approach to the review of detention, through Case Progression Plans which show the monitoring and review of ongoing detention and with a focus on return or, if appropriate, release. Case Progression Plans are currently being piloted across the Home Office and are subject to evaluation.

**Lord Alton of Liverpool** [HL6210] To ask Her Majesty's Government what is their response to the findings of the *Report on an unannounced inspection of Morton Hall Immigration Removal Centre* by HM Chief Inspector of Prisons, published on 21 March, in particular that (1) too many detainees were held for prolonged periods, (2) the average length of detention was high, (3) children were detained for long periods of time due to failures in age assessment processes, (4) in one case, an incorrect Home Office age assessment led to the detention of a child for 36 days before social services confirmed that the boy was 16 years old, (5) the adults at risk policy was not yet widely understood, (6) there had been a three-fold increase in incidents of self-harm since the previous inspection, (7) the causes of self-harm had not been sufficiently analysed and there was no strategy to reduce it, and (8) four detainees had narrowly escaped fatal or serious injuries as a result of self-harm during the previous year.

**Reply from Baroness Williams of Trafford:** The Government takes the welfare of detainees extremely seriously and has carefully considered the HM Chief Inspector of Prison's (HMCIP) report on Morton Hall immigration removal centre. The service improvement plan will be published on the HMCIP website shortly.

We will closely monitor progress towards implementing these recommendations. Stephen Shaw CBE has been invited to carry out a short review later this year to assess progress against his previous review into the welfare in detention of vulnerable persons.

**Baroness Lister of Burtersett** [HL6234] To ask Her Majesty's Government, in the light of the *Report on an unannounced inspection of Morton Hall Immigration Removal Centre* by HM Chief Inspector of Prisons, published on 21 March, what assessment they have made of the reasons for children being detained at the centre for (1) 12 days, (2) 36 days, and (3) 151 days, during the last year.

**Reply from Baroness Williams of Trafford:** The Home Office does not comment on individual cases.

The Home Office policy is not to detain children. Where there is doubt as to the age of an individual, Immigration Enforcement will detain individuals who claim to be a child (under 18) until they are referred to a local authority for a Morton-compliant age assessment. Individuals who frustrate the age assessment and identification process may incur a lengthened period of detention. All three individuals were later identified as children and released into the custody of local authorities.

The Government will respond to HM Chief Inspector of Prisons Report on the unannounced inspection of Morton Hall immigration Removal Centre in due course.

long-term detainees.

**Reply from Baroness Williams of Trafford:** A training presentation pack on Detention Services Order (DSO) on the care and management of adults at risk in the detention estate (08/2016) was circulated to all Home Office Immigration Enforcement staff in the immigration detention estate, including staff at Morton Hall immigration removal centre (IRC) in September 2016.

The final version of DSO 08/2016 was published on 27 February 2017. Home Office business embedded trainers are delivering training on the DSO to staff in the IRCs, including supplier and healthcare staff. Staff at Morton Hall IRC received training in February and a refresher training session will be added to the annual training schedule for NOMS staff at the centre.

### **Morton Hall Immigration Removal Centre**

**Lord Scriven** [HL6245] To ask Her Majesty's Government, with reference to the *Report on an unannounced inspection of Morton Hall Immigration Removal Centre* by HM Chief Inspector of Prisons, published on 21 March, what assessment they have made of the relationship between the absence of limits on the length of time an individual can be detained and the incidence of self-harm in immigration detention centres.

**Reply from Baroness Williams of Trafford:** All incidents of self harm are treated very seriously and every step is taken to prevent incidents of this nature. Staff at all centres are trained to identify those at risk of self harm so that action can be taken to minimise the risk. Notices in various languages are displayed in IRCs setting out that where a detainee is concerned about a fellow detainee this should be brought to the attention of a member of staff. Formal risk assessments on initial detention and systems for raising concerns at any subsequent point feed into established self harm procedures in every IRC. These are in turn underpinned by the Home Office Operating Standard on the prevention of self-harm and detention services order 06/2008, Assessment Care in Detention Teamwork (ACDT).

## Scottish Parliament Written Answers

### Islamophobia

**S5W-08278 Anas Sarwar:** To ask the Scottish Government, further to the answer to question S5O-00690 by Angela Constance on 23 February 2017 (Official Report, c. 2), what steps it is taking to ensure that Islamophobia is not a barrier to young Muslims participating in politics and society.

**Reply from Angela Constance:** We are committed to tackling Islamophobia in all its forms, and we recognise the importance of ensuring that young Muslims are able to participate fully in society at all levels. We will continue to tackle hate crime, encourage people to report it, and challenge prejudice and intolerance wherever it exists. Our vibrant and multi-faceted minority communities make a significant contribution to our national life – we will ensure that continues to be recognised and celebrated.

We are supporting a programme of work through a coalition of equality organisations to increase representation of women, disabled people, and those from Black Minority Ethnic communities and faith groups – as well as Lesbian Gay Bisexual Transgender and Intersex communities - in politics.

Young Scot is working with the Scottish Government's Race Equality Team, through a co-design model for race equality in Scotland of young people from minority ethnic backgrounds and communities in realising the vision and ambition of the Race Equality Framework. To advance race equality, tackling racism and addressing the barriers that prevent people from minority ethnic communities from realising their potential.

We have provided over £300,000 of funding to Show Racism the Red Card, Amina and Interfaith Scotland from the Equality Budget during 2016-17 to help promote equality and address discrimination. Of this funding Amina has been delivering workshops in secondary Schools since 2012 to tackle Islamophobia and raise awareness of Islam.

On World Interfaith Harmony Day - 7 February 2017, Interfaith Scotland and St. Ninians School collaborated on an Interfaith event to encourage harmony between all regardless of faith. This was attended by over 200 young people attended from 6 schools.

Show Racism the Red Card has a project Tackling Contemporary Racism delivers a transformative educational programme to young people across Scotland to educate against formation of racist attitudes including Islamophobia.

**S5W-08279 Anas Sarwar:** To ask the Scottish Government, further to the answer to question S5O-00690 by Angela Constance on 23 February 2017 (Official Report, c. 2), in light of the barriers arising from Islamophobia and gender stereotyping, what steps is it taking to enable young Muslim women to participate in politics and society.

**Reply from Angela Constance:** I refer the member to the answer to question S5W-08278 on 13 April 2017 which addresses this question in part and is available on the Parliament's website, the search facility for which can be found at: <http://www.parliament.scot/parliamentarybusiness/28877.aspx>

In addition, we are committed to tackling gender stereotyping in all its forms, and we recognise the importance of ensuring that young Muslim women are able to participate fully in society at all levels. We are taking a range of steps to advance

gender equality and tackle violence against women, and a draft delivery plan for our Equally Safe strategy was published on 23 March setting out ambitious steps in this area.

The Scottish Government is funding Amina £111,534 and Council of Ethnic Minority Voluntary Organisations Scotland (CEMVO) with funding of £62,000 for 2016/17. CEMVO is establishing a minority ethnic Women's network and aiming to hold a number of related events in 2017 to link in to the Race Equality Framework (REF) actions. The first event was held on 22 February, with over 90 women attending. As well as looking at the vision, purpose and structure of a possible network for Minority Ethnic women, discussion took place on employability issues, with potential solutions identified. Additionally over the course of 2017 we will organise a series of Themed Roundtables linked to REF themes involving policy officials with key experts from a range of statutory and third sector organisations and academia. One of these Roundtable events will focus on employability and, amongst other sources, will consider the feedback gathered at the minority ethnic women's network event.

Amina works to promote equality for Muslim Women by tackling prejudice, hate crime and inspiring community cohesion. Amina's Building Bridges project focuses on Muslim, Minority Ethnic women in Dundee to provide information and support on a range of areas from mental wellbeing to registering to vote. Building confidence and participation that strengthens Muslim, Minority Ethnic women of all backgrounds to fulfil their potential and participate fully.

### **Online racist bullying**

**S5W-08498 Annie Wells:** To ask the Scottish Government, further to the answer to question S5F-00477 by Nicola Sturgeon on 17 November 2016 (Official Report, c. 23), what steps it has taken to tackle the specific issue of online racist bullying.

**Reply from John Swinney:** Bullying of any form is entirely unacceptable and we need to be vigilant in challenging any racist and abusive behaviour in our schools. We want all children and young people to learn tolerance, respect, equality and good citizenship to address and prevent prejudice. In March 2016, we published the Race Equality Framework for Scotland, and are taking forward a number of actions to ensure that minority ethnic pupils have confidence in, and are effectively supported by, approaches in schools to prevent and respond to prejudice-based bullying and racist behaviour or incidents.

In addition, we funded 'Show Racism the Red Card' (Scotland) £50,000 in 2016-17 to deliver a programme of anti-racism education to young people in Scottish schools.

All schools and local authorities should have anti-bullying policies in place. The Scottish Government agreed to a request from the Scottish Parliament's Equalities and Human Rights Committee for further engagement on the development of the Government's refreshed anti-bullying guidance with a range of stakeholders. This revised guidance will be clear that all types of bullying, including prejudice-based bullying is unacceptable and must be addressed whenever and wherever it arises.

To support a proactive approach to addressing bullying, the Scottish Government fully funds respectme, Scotland's anti-bullying service to provide direct support to



local authorities, schools, youth groups and all those working with children and young people to build confidence and capacity to address all types of bullying effectively.

The Scottish Government has also been working across government and with key stakeholders to update our action plan on child internet safety to ensure we have appropriate frameworks of training, support and information in place for professionals and families, including children and young people. The updated action plan will be published in April 2017.

### **Discrimination in schools**

**S5W-08512 Rachael Hamilton:** To ask the Scottish Government what procedures are in place to ensure that schools provide a safe environment for their students and staff, free from all forms of discrimination.

**Reply from John Swinney:** The Scottish Government want all children and young people to be free from discrimination so that they can learn and reach their full potential. That is why education in Scotland is underpinned by policies and legislation which have equality and diversity at their hearts, such as Curriculum for Excellence, Additional Support for Learning, GIRFEC and the Equality Act. In this way we help schools and local authorities work towards eliminating discrimination, advancing equality of opportunity and fostering good relations.

We recognise too that pupil safety and wellbeing begins with a whole-school ethos which is founded on positive relationships. Authorities and schools have available to them a range of strategies and approaches for promoting positive relationships and behaviour. Support and training in these approaches is provided by Education Scotland's Rights, Support and Wellbeing Team.

The safety of school staff and school staff's responsibilities under equality legislation are matters for individual local authorities as their employers. In terms of teacher responsibilities to pupils, the Standards for Registration set by the General Teaching Council for Scotland (GTCS) require teachers to commit to the principles of democracy and social justice through fair, transparent, inclusive and sustainable policies and practices in relation to the protected characteristics of the Equality Act 2010. The GTCS's Code of Professionalism and Conduct on Equality and Diversity require teachers to engage and work positively with pupils, help pupils understand different views, perspectives and experiences and develop positive relationships as well as recognise that they are role models.

### Religious Dress and Symbols: Workplace

**David Amess:** What assessment the Church of England has made of the implications of the European Court of Justice ruling of March 2017 on wearing religious dress and symbols in the workplace. [909693]

**Reply from the Second Church Estates Commissioner (Dame Caroline Spelman):** The Church of England was very concerned by the judgment of the European Court of Justice that stated that blanket bans on the wearing of political, philosophical or religious signs do not amount to cases of direct discrimination, because that conflicts with the pre-existing rulings of the European Court of Human Rights. By leaving the European Union, we presumably stand some chance of resolving such inconsistencies.

**David Amess:** Does my right hon. Friend agree that this is yet another reason to be pleased that last year the British people took the decision to leave the European Union? The ruling was deeply offensive to people of all faiths and totally unnecessary.

**Reply from Caroline Spelman:** Yes, and it was completely at odds with the statutory purpose of the Church of England, which was put far better than I possibly could by the head of the Church, Her Majesty the Queen, when in 2012 she made it clear that the Church of England “has a duty to protect the free practice of all faiths in this country.” That is what we should be able to do if we can resolve this inconsistency.

**Reply from Theresa May:** Anti-Semitism continues to be a problem in this country which is why it is right that, as a Government, we are able to demonstrate the seriousness with which we take it, as we do for other forms of hate crime.

This Government has led the way in adopting the International Holocaust Remembrance Alliance working definition of anti-Semitism and continues to build on the solid work of the cross-Government working group on tackling anti-Semitism, which ensures that we are alive to any issues and concerns of the Jewish community and can respond quickly. I and ministerial colleagues are in regular contact with representatives of the Jewish community, including the Jewish Leadership Council, the Board of Deputies of British Jews, the Community Security Trust and other key stakeholders. Concerns about the levels of anti-Semitism and anti-Semitism on the internet are discussed by the relevant Cabinet ministers as and when the need arises, and with international counterparts.

**Baroness Manzoor** [HL6561] To ask Her Majesty's Government what action they are taking to tackle racially motivated attacks against (1) ethnic minority women, and (2) asylum seekers and refugees.

**Reply from Baroness Williams of Trafford:** The Government deplores all racially motivated attacks. A strong legal framework is in place to tackle hate crime including criminal offences of incitement to racial hatred and racially or religiously aggravated assault and criminal damage. This Government published a new hate crime action plan in July 2016. The Government supports a range of programmes including Tell MAMA, True Vision and Stop Hate UK that focus on encouraging victims including ethnic minority women, asylum seekers and refugees to report hate crime and signposting them to services that provide support for victims.

The Government's Building a Stronger Britain Together (BSBT) programme includes a range of organisations working with different communities across England and Wales that support women and girls from ethnic minorities.

The Government is running a UK-wide campaign to encourage low-paid workers to check their pay to ensure they are getting the National Minimum Wage (NMW). By law, all workers aged 25 and over must be paid at least the National Living Wage, or, if they are younger, the National Minimum Wage rate relevant to their age group.

Minimum wage rates increased on 1 April 2017:

- the apprentice rate is now £3.50 per hour
- the rate for 16 to 17 year olds is now £4.05 per hour
- the rate for 18 to 20 year olds is now £5.60 per hour
- the rate for 21 to 24 year olds is now £7.05 per hour
- the rate for people aged 25 and over is now £7.50 per hour
