Scottish Parliament Written Answer

Refugees

S5W-11743 Pauline McNeill (Labour): To ask the Scottish Government what action it is taking to ensure that Syrian refugees receive the support required under the refugees action plan, and what plans it has to review whether the support offered by the assigned integration support teams is meeting their needs.

Reply from Angela Constance: The operation of refugee resettlement schemes is reserved to the UK Government and managed by the Home Office. Support for refugees arriving under the Syrian Resettlement Programme is provided by local authorities, who report to the Home Office on delivery of the programme in their areas.

The New Scots refugee integration strategy provides a framework for the integration of all refugees and asylum seekers in Scotland. The Scottish Government is working with COSLA and the Scottish Refugee Council and a wide

range of other partners to develop the next New Scots strategy for publication in early 2018.

Clive Betts (Labour) [105140] To ask the Secretary of State for the Home Department, how many refusals of indefinite leave to remain were overturned on appeal between March 2016 and March 2017; how many of these appeals were not challenged by her Department; how many of those cases have been processed; and how many of those cases have been processed; and how many of those cases have been processed where her Department offered no challenge.

Reply from Brandon Lewis: The information on appeals is not readily available and could only be obtained at disproportionate cost through the examination of individual case files.

Immigration: EU Nationals

Stephen Gethins (SNP) [105047] To ask the Secretary of State for Exiting the European Union, whether EU nationals granted permanent residence prior to the EU referendum taking place will retain the right to reside in the UK, irrespective of the outcome of negotiations with the EU, which they currently enjoy.

Reply from Robin Walker: As set out in the Government's policy paper, EU citizens, including those granted permanent residence status prior to the EU Referendum, will need to apply for settled status, which will give them the right to reside in the UK.

Qualifying EU citizens will be given time to apply for their new residence status after our exit, so they can be reassured that there will be no cliff-edge at the point of the UK's withdrawal from the EU. The UK is ready to offer an even more streamlined process for current holders of permanent residence.

As the Prime Minister set out in her speech in Florence, we are confident that we can find a way forward that makes a success of this for all of our people, and that

Immigration: EU Nationals

Emma Reynolds (Labour) [105311] To ask the Secretary of State for the Home Department, what the timetable is for EU nationals to apply for special status.

Reply from Brandon Lewis: All qualifying EU citizens and their family members will be given adequate time to apply for the new settled status. A grace period of blanket permission will last from EU exit day for a fixed period of time, which we will specify in due course, but which we expect to be up to two years.

The Government intends to introduce a voluntary scheme to enable eligible EU citizens and their family members to apply for this status before the UK leaves the EU, if they wish to do so. We will publish further details regarding the timetable in due course but we intend to launch in 2018.

Thangam Debbonaire (Labour) [105327] To ask the Secretary of State for the Home Department, what terms of reference she has set for the study of the economic and social contributions and costs of EU citizens in the UK that she has commissioned from the independent Migration Advisory Committee; and whether other studies covering social and cultural contributions will be commissioned.

Reply from Brandon Lewis: On 27 July, my Right Honourable Friend the Home Secretary commissioned the Migration Advisory Committee (MAC) to gather evidence on patterns of EU migration and the role of migration in the wider economy, ahead of our exit from the EU, as well as aligning the UK immigration system with a modern industrial strategy

We have asked the MAC to report by September 2018 but the MAC may wish to provide interim reports throughout the period. The full commission is available online at:

Reply from Brandon Lewis: UKVI's published timescale for processing standard visa applications is 12 weeks (60 working days) for straightforward settlement applications, and three weeks (15 working days) for straightforward non-settlement applications.

If an application is not straightforward and expected to take longer than the standard processing timescale, UKVI will write to the customer within the standard processing time and explain what will happen next.

David Linden (SNP) [105263] To ask the Secretary of State for the Home Department, if she will review the (a) efficacy of procedures and (b) adequacy of the time taken to process visit visas for Malawians.

Reply from Brandon Lewis: UKVI continually reviews its global visa operation to improve performance and ensure value for money while maintaining excellent customer service.

UKVI's published timescale for processing standard visa applications is three weeks (15 working days) for straightforward non-settlement applications and 12 weeks (60 working days) for straightforward settlement applications.

If an application is not straightforward and expected to take longer than the standard processing timescale, UKVI will write to the customer within the standard processing time and explain what will happen next.

We also offer a Priority Visa Service for Malawi nationals who wish to pay to have a decision expedited.

Israel: Visas

Chi Onwurah (Labour) [10164] To ask the Secretary of State for the Home Department, whether Israel and the UK have reciprocal visa requirements for visits of six months or less; and whether there are any additional requirements that Israel places on UK citizens visiting Israel that the UK does not place on Israeli citizens visiting the UK.

Reply from Brandon Lewis: The UK and Israel do not have reciprocal visa requirements, including for visits. Such requirements are matters for the respective country.

The Immigration Rules for visitors - <u>https://www.gov.uk/guidance/immigration-rules/immigration-rules-appendix-v-visitor-rules</u> - set out the requirements that applicants must meet in order to visit the UK. These include that the applicant must satisfy the decision maker that they are a genuine visitor who will leave the UK at the end of their visit and will not make the UK their main home through frequent or successive visits.

Roger Godsiff (Labour) [106686] To ask the Secretary of State for the Home Department, whether the Government plans to remove the UK from the EU framework on refugee protection before a new policy is in place.

Reply from Brandon Lewis: The UK will remain a full participant in the Common European Asylum System, where we have opted in, until we leave the EU. We remain bound by the Refugee Convention and ECHR, and this will not change when we leave.

We are committed to maintaining our cooperation with the EU on migration and asylum, and we are ready to discuss the exact nature of this cooperation as part of the wider negotiations on leaving the EU.

Refugees: Child Tax Credit

Patrick Grady (SNP) [105980] To ask the Secretary of State for the Home Department, what discussions she has had with the Treasury and HM Revenue and Customs on fast track access to child tax credits for families who have been through the refugee family reunion process.

Reply from Brandon Lewis: The family reunion policy allows those granted asylum or humanitarian protection to apply for their partner and children under the age of 18 to join them in the UK, provided they formed part of the family unit before the person fled their country. Other family members may also be allowed under the policy if there are exceptional or compassionate factors.

The immigration status of those granted protection and their family members

brought to the UK under the policy allows them to study, take employment and apply for tax credits and other benefits.

Reply from Brandon Lewis: The Government takes the allegations raised by BBC Panorama, and the welfare of immigration detainees generally, very seriously. The Government's policy remains that detention should be used only sparingly and for the shortest period necessary. Stephen Shaw is currently reviewing Home Office progress against his 2015 recommendations in relation to the welfare of vulnerable people in immigration detention and the Government will keep its policies under review accordingly.

UK Parliament, House of Lords Oral Answers

Immigration: International Students

Lord Holmes of Richmond (Conservative): To ask Her Majesty's Government, in the light of the Office for National Statistics' Exit Check data released in August, whether they will consider the removal of international students from the net migration figures. ...

Reply from the Minister of State, Home Office (Baroness Williams of Trafford): My Lords, the recent publication of exit checks data shows that our reforms since 2010 to tackle abuse in the education sector have worked. Net

migration statistics are produced by the independent Office for National Statistics. There is no limit on the number of international students who can come to the UK. As long as students are compliant with Immigration Rules, they should make a very limited contribution to net migration numbers.

Lord Holmes of Richmond: My Lords, since 2010, the number of international students coming to the UK has fallen by 6%, while the global market has increased by 7%, with an estimated cost to the UK economy of £9 billion. Does my noble friend agree that this summer's statistics clearly evidence that there is no material issue with international students overstaying their visas, as 97.4% stayed within those terms? Does she also agree that we need to get out the message, through the FCO, the British Council and all channels and good offices: "Students of the world, you are so welcome here—come study in the UK and be part of our future"?

Reply from Baroness Williams of Trafford: I agree totally with the points that my noble friend makes. It is very pleasing to see that students are in a very compliant environment. To the year ending June 2017, there was a 9% increase in Russell group universities, and a 17% increase in all student visas granted for Chinese nationals. To bring up a point made in a previous Question, I mention that the proportion of Indian students coming to study in the UK at a higher education institute has increased from around 50% in 2010 to around 93% in the year ending June 2017.

Lord Hannay of Chiswick (Crossbench): My Lords, does the Minister recognise that citation of selective statistics is not terribly convincing—the Indian figure, for instance, being 50% down over recent years? She sits on the Government Bench, which continually tells us that we have to respect votes. Does she therefore recognise that it might be better if her reply respected the vote of this House by a majority of 94 that students should not be considered as economic migrants, which they are not? Will the Government's White Paper on immigration, due in a few weeks, cover that issue?

Reply from Baroness Williams of Trafford: I appreciate that within statistics we can say all sorts of things. However, it is not a myth about the Indian students. People who come here and use services and infrastructure for more than a year are counted as migrants.

Baroness Smith of Newnham (Liberal Democrat): My Lords, at present, the number of international students is clearly more than 100,000. If the Government persist in their commitment to keep immigration under the tens of thousands, does that mean that there is no scope for increasing the number of international students, for which there appears to be cross-party support as it would benefit the UK economy? I refer to my interests as recorded.

Reply from Baroness Williams of Trafford: There are well over 100,000 students. In the 2015-16 academic year, 438,000 students enrolled—almost half a million—and visa applications sponsored by universities are 19% higher than they were in 2010. There is no limit on the number of international students who come to this country, and we welcome them all.

Earl Atlee (Conservative): My Lords, what special characteristics do students have that mean that they do not use public services or public transport and do not need accommodation?

Reply from Baroness Williams of Trafford: My noble friend points out precisely why they are included in the migration statistics.

Lord Watts (Labour): Are not the figures the Minister gives for the Russell group distorted by the fact that some of those universities have a special visa system?

Reply from Baroness Williams of Trafford: There has been a tier 4 visa pilot that is possibly what the noble Lord is referring to—and we will evaluate its effectiveness. However, he actually makes a case for the fact that we welcome international students here.

Lord Gordon of Strathblane (Labour): I jump back to the point made by the noble Earl, Lord Attlee: if we applied that logic, surely we would start to treat tourists as immigrants.

Reply from Baroness Williams of Trafford: A tourist should come here for a specified length of time, which is not usually a year and is generally under three months. When that stay becomes a year, that person becomes somebody who avails themselves of the infrastructure and public services of this country.

Baroness Greengross (Crossbench): My Lords, does the Minister not agree that the students in the figures that she cited would have registered before there was any thought of Brexit and so forth? As someone who spent several years at the London School of Economics, I am very aware of the bond of respect and loyalty to the country where people study and live for sometimes four or five years; it is very well known. The benefits to that country whether in trade, political co-operation or security matters are immense. Can the Minister not say that students should be considered quite separately from other immigrants who come to this country?

Reply from Baroness Williams of Trafford: I am afraid that I cannot say that. But my parents were immigrants to this country. They went to university in another country but certainly made this country their home. I agree that the bond that the student has with the country where they study often means that they stay here to work and contribute hugely to the economy of this country. In fact, the MAC is conducting a study on the effect of student migration and will report soon.

Lord Cormack (Conservative): Cannot my noble friend accept that there is an overwhelming view in this House that it would be sensible and entirely prudent to treat students separately, particularly at this juncture in our national affairs?

Reply from Baroness Williams of Trafford: I am neither deaf nor blind to the views of noble Lords on student migration.

Lord Rosser (Labour): I hesitate to intervene in the sense that, frankly, I could not do a more effective demolition job on the Government's policy than the noble Lord, Lord Holmes of Richmond, did. But I still do not think that we have heard from the Minister why the Government apparently see the overriding need to keep international students in the net migration figures, bearing in mind that the evidence shows that their removal would not make any significant difference to those figures. Is she able to explain to us why the Government are not prepared to stand up now and say that they are about to change their policy? From the response that she gave, which appeared to be a glowing one on the number of students coming into the country, can I take it that the universities are still quite happy that international students are retained within the net migration figures?

Reply from Baroness Williams of Trafford: What the noble Lord said about high compliance lends credence to the fact that our reforms are working in this area. We wish to continue to attract international students to study in the UK and we absolutely recognise the cultural and financial contribution that they make to this country. That is why we have commissioned the study that I referred the noble Baroness to, and why we do not limit the number of genuine international students who come here to study and from whom UK businesses can recruit.

Race Disparity Audit

col 181 The First Secretary of State and Minister for the Cabinet Office (Damian Green): ... This exercise has been unprecedented in scale, scope and transparency. It covers detailed data on around 130 different topics from 12 Departments. The first product of the audit is the website ... It has been developed through extensive engagement with members of the public from across the UK, public service workers, non-governmental organisations and academics. ...

Although the past few decades have witnessed great leaps forward in equality and opportunity in British society, the audit shows that there is much more still to do if we are to end racial injustice. ... It tells us in which public services there are the largest disparities and whether those are increasing over time or diminishing, and about the influence of poverty and gender on the wider picture. ...

... on some measures there are very significant differences between ethnic minority

groups. Education attainment data show that there are disparities in primary school that increase in secondary school, with Asian pupils tending to perform well and white and black pupils doing less well, particularly those eligible for free school meals. Finally, on other measures, it is white British people who experience the worst outcomes, such as in relation to self-harm and suicide in custody, or smoking among teenagers. ...

... I commit that the Government will take action with partners to address the ethnic disparities highlighted by the audit. ...

The approach that the Government are taking is "explain or change". When significant disparities between ethnic groups cannot be explained by wider factors, we will commit ourselves to working with partners to change them. ...

col 182 **Dawn Butler (Labour):** ... We cannot ignore the fact that the actions of this Government have contributed to the burning injustices in our country. They have failed to understand the value of equality impact assessments, which the last Prime Minister described as "red tape"....

The Government should reintroduce race equality audits and impact assessments, independently assess the Treasury, introduce "blind" sentencing in the criminal justice system, and implement their responsibilities under the public sector equalities duty. ...

col 184 **Damian Green:** ... Simon Woolley of Operation Black Vote has said: "The findings from the Race Disparity Audit present us with a real opportunity to make transformative change in tackling persistent race inequality" ... He actually went on to say: "Yes, some findings make uncomfortable reading, but unless these things are laid bare we can't begin to resolve them." ...

col 185 I would encourage [the SNP spokesman] to encourage his colleagues in the Scottish Government to take part in this process, because so far we have found it quite difficult to get the equivalent information for some areas in Scotland that are completely devolved. Facts and figures on reserved matters in Scotland, where they are available to the UK Government, are included in the audit, but at the moment there are no devolved facts and figures, and I genuinely think that it would help people in Scotland if those could be added to the audit figures. ...

For example, we do not necessarily ask someone what their religion is when they go to the jobcentre, and I suspect that many people would find being asked for too much information intrusive, so we have to work with the material we have. ...

col 189 ... [The audit] reveals the huge differences between areas that look similar demographically or in their ethnic makeup. ...

Preet Kaur (Labour/Co-op): ... Why have Sikhs, who are recognised as a separate ethnic group in legislation, been excluded from the audit? Will he put that right by ensuring that Sikhs are not further discriminated against and that the 2021 census will include a Sikh ethnic tick box?

Damian Green: ... Religion is not routinely collected in many of the 130 data sets, so it would be impossible to include. It is not a question of excluding any particular group. ...

col 192 **Clive Betts (Labour):** ... Following the Macpherson report, there was a requirement that all schools had to report racially motivated incidents in school to their local authority. In 2010, that requirement was dropped, so there is now no information coming from academies or free schools, no local statistics and no national statistics on racist incidents in schools. ...

The above House of Commons statement was repeated in the Lords.

col 115 **Baroness Gale (Labour):** ... Will [the Minister] confirm how many groups and organisations were consulted as part of the race audit? Will he confirm whether there are plans to extend the audit's analysis to devolved regions such as Wales, Scotland and Northern Ireland? Can he confirm for the House what steps the Government will take to tackle the racial disparities exposed in this audit and other reports released recently? What is their timescale for taking action, and what framework will they be using to judge improvements? ...

col 116 **Baroness Burt of Solihull (Liberal Democrat):** ... this audit shines a light on the prejudice and bias that continue to blight the lives of black and ethnic minority members of our communities. It lays out the challenges we face as a society ... This comes alongside another report, by the Runnymede Trust, on the impact of austerity on black and minority ethnic women in the United Kingdom. It shows that BME households are being hardest hit by austerity, with a drop in living standards of 19.2% for black households and 20% for Asian households. ...

col 117 **Lord Young of Cookham (Conservative):** ... No other country has done this. It was a complicated exercise. We wanted to make sure that the data were of the right quality, and that has contributed to the delay from the hoped-for date earlier this year. We are taking steps to address some of the problems that have been mentioned ...

The Minister ... is meeting the devolved regions tomorrow. The initial indications are that the Welsh Assembly is quite anxious to participate but so far the Scottish Parliament has been somewhat more reluctant, as my right honourable friend said in another place. The devolved regions hold some of these statistics. We have provided only statistics for data that are reserved; the devolved Assembly and the Scottish Parliament have many of the local data. I very much hope that they will either join in this or take it forward in their own way. ...

col 118 ... I think there has been enormous change and improvement in social attitudes, underpinned by relevant race equality legislation. ... there was a spike—I hope it was just a spike—after the referendum result, and that poses a challenge to all those government departments with responsibility for promoting good relationships. There is particular responsibility for the police on the law and order front. ...

One positive fact that emerged from this audit was that 85% of ethnic minority people believe that they are British and identify very strongly with their community. That is a very positive sign. ...

col 119 The Lord Bishop of Chelmsford: ... although, let me be clear, the Church of England has nothing to teach anyone else on this subject—our record is not a good one—in the diocese of Chelmsford, where I serve, which includes the east London boroughs, which have some of the most diverse communities in Europe, we have found that of course there is racism and xenophobia but there is also what has been explained to me as unconscious bias. It is not quite the same as racism; it is those things which prevent us from seeing each other as clearly as we need to. Both in the Church of England generally and in the diocese where I serve, we have done a lot of training over the past couple of years to help people to see their own unconscious bias towards people, and this is already bearing fruit in the church context with black and global majority people coming forward into positions. I wondered whether the Government had looked at that both for us and in wider society to try to move the debate on beyond the binary thing of, "Somebody is a racist or they are not".

col 120 **Baroness Howells of St Davids (Labour):** ... we are not talking about black people—this is about white people, and the Aryan myth of white superiority. I would be very grateful if somebody did some sort of exercise to bring forth that myth of white superiority. ...

Lord Young of Cookham: ... One thing this audit does is to demolish the myth of white superiority. According to the indicators, white children leaving school do much worse than particular ethnic minority groups. As I said in the Statement, white children are more prone to smoke than children from other ethnic minorities. It helps to identify those areas in which ethnic minorities are outperforming the white British. If I refer to black people, that is the language used in the report, on the website and in the Statement. ...

col 123 **Baroness Benjamin (Liberal Democrat):** ... a lot of young black and Asian minority children do not know about their history. ... When I visited prisons, I realised just how much black men did not know about their history and how they felt let down by the education system not focusing on who they are. To move forward you need to know where you have been and where you have come from. ...

Lord Young of Cookham: ... I very much hope that schools will teach not just British history but history more generally, particularly in those areas where they have children coming from a wide variety of different backgrounds. ...

Pupils: Bullying

Stephen Timms (Labour) [10107] To ask the Secretary of State for Education, what recent assessment she has made of trends in the level of bullying in (a) primary and (b) secondary schools since 2010.

Reply from Nick Gibb: Our most recent assessments of the levels of bullying in schools were published in July this year within The National Foundation for Educational Research (NFER) Teacher Voice Survey and the Omnibus Survey of Pupils and their Parents / Carers.

Questions in the <u>NFER Teacher Voice Omnibus</u> and a senior leader booster survey found that for each type of bullying asked about, the majority of respondents said they had rarely or never seen them occurring amongst pupils over the previous 12 months. This ranged from 73% of respondents saying they had rarely or never seen bullying based on sexist or sexual language, to 94% of respondents who said they had rarely or never seen anti-Semitic bullying. The most commonly observed form of bullying was sexist/related to sexual language with 27% reporting seeing it 'sometimes', 'often' or 'very often'. For all types of bullying asked about in the survey, the proportion of respondents saying they had seen or received reports of them occurring in the last 12 months was higher in secondary schools than primary schools.

The Department's <u>Omnibus Survey of Pupils and their Parents/Carers</u> found that nearly half of pupils (45%) said they had been bullied at least once in the past year. This survey did not cover primary age pupils.

Although we plan to ask these questions on an annual basis going forward, this was the first time these surveys have asked about levels of bullying and so we do not have comparable data to assess trends.

However, a separate survey published in 2015 - <u>wave 2 results from the Longitudinal Study of Young People in England 2 (LSYPE 2)</u> - compared bullying among two cohorts of 14 year olds (year 10) from 2004 and 2014. It found that 30,000 fewer people in year 10 said they had been bullied in the last twelve months - a drop from 41% in 2004 to 36% in 2014. The analysis of later LSYPE2 waves will also include bullying figures. These findings will be published when the analysis is complete and quality assured.

Migrant Workers: EU Nationals

Tom Brake (Liberal Democrat) [10323] To ask the Minister for Women and Equalities, what assessment her Department has made of the levels of discrimination against EU citizens in the UK in relation to (a) employment and (b) redundancy since June 2016.

Reply from Nick Gibb: Employment discrimination on grounds of nationality is in most cases prohibited by the Equality Act 2010 and will remain so, but the provisions in the Act do not distinguish between EU and non-EU nationals, nor between British and non-British EU nationals, and statistics in this area do not allow these distinctions to be made.

The Government Equalities Office sponsors the Equality and Human Rights Commission, which has powers to enforce the Equality Act 2010 in cases where it suspects unlawful discrimination in employment may have occurred.
