Scottish Parliament Motion

S5M-10504 Kezia Dugdale (Labour): Co-op Bright Future Scheme Supports Victims of Trafficking and Modern Slavery – That the Parliament notes the plight of victims of trafficking and modern slavery and recognises the difficulties that victims have in rebuilding their lives and, particularly, in finding employment; welcomes the Bright Future scheme established by the Co-operative Group, which provides survivors with a fourweek paid work placement leading to a non-competitive interview and the possibility of a job offer at the end of the process; further welcomes that the first victim of trafficking and modern slavery in Scotland is now part of the scheme in Edinburgh and wishes Frank well on the scheme, and calls for other employers to consider supporting this scheme. http://www.parliament.scot/parliamentarybusiness/28877.aspx?SearchType=Advance&ReferenceNumbers=S5M-10504

Immigrants

Helen Hayes (Labour) [126634] To ask the Secretary of State for the Home Department, how many people have limited leave to remain, who (a) are prohibited from working and (b) are not eligible for access to public funds.

Reply from Caroline Nokes: No Recourse to Public Funds is the default condition for grants of leave to remain in most categories.

Data is not held in the requested format, and to establish whether a migrant did not or did not have the no recourse to public funds, or prohibition from working condition applied would require individual examination of records. This would incur disproportionate cost.

Reply from Lucy Frazer: The First Tier Tribunal (Immigration and Asylum Chamber) was created during the 2010-11 financial year. The costs recorded include the Upper Tier Tribunal. Full cost data for both the First and Upper Tier Tribunal has only been reported since 2012.

Refugees: Syria

Tulip Siddiq (Labour) [126567] To ask the Secretary of State for the Home Department, what recent steps her Department has taken to encourage the participation of local authorities in the Syrian Vulnerable Persons Resettlement Scheme.

Reply from Caroline Nokes: Local authority participation in refugee resettlement is voluntary. We are grateful to those who have welcomed refugees into their communities, arranging accommodation and supporting their integration under this and other schemes to date, and will continue to work closely with local authorities and Strategic Migration Partnerships to encourage participation and convert pledges into resettlement places for refugees.

The Home Office publishes the number of resettlements under the Vulnerable Persons Resettlement Scheme as part of the Immigration Statistics Quarterly Release, available at https://www.gov.uk/government/collections/immigration-statistics-quarterly-release. A quarterly breakdown of this scheme's resettlements by local authority is also available from October 2015 onwards. This data can be found in the Asylum data tables volume 4 on sheets as 19q and as 20q.

Asylum: Employment

Roger Godsiff (Labour) [111061] To ask the Secretary of State for the Home Department, what assessment the Government has made of the potential merits of allowing asylum seekers to work while their application is progressing.

Reply from Caroline Nokes: Asylum seekers are not allowed to work in the UK unless their claim has been outstanding for at least 12 months through no fault of their own. The policy is designed to protect the resident labour market so that access to employment is prioritised for British citizens and lawful residents, including those granted refugees status. We have no plans to change this policy.

Immigration Bail

Edward Davey (Liberal Democrat) [126818] To ask the Secretary of State for the Home Department, what assessment she has made of the potential effect the repeal of section 4(1) of the Immigration and Asylum Act 1999 will have on the number of people who are released from immigration detention on immigration bail.

Reply from Caroline Nokes: The repeal of section 4(1) is not expected to have any discernible effect on the number of people released from immigration detention on immigration bail

Paragraph 9 of Schedule 10 to the 2016 Act contains powers to provide accommodation to people released from detention on bail and to those who require it in order to avoid a breach of their Article 3 rights. Additionally, individuals granted immigration bail who are asylum seekers or failed asylum seekers can access support provided under sections 95 or 4(2) of the 1999 Act if they would

otherwise be destitute and meet the normal eligibility criteria.

Immigration offenders who can leave the UK to avoid a breach of their human rights are expected to do so.

Slavery

Tulip Siddiq (Labour) [126948] To ask the Secretary of State for the Home Department, what recent steps the Government has taken to raise public awareness of modern slavery and human trafficking.

Reply from Victoria Atkins: The Government continues to use communications as an essential means of raising public awareness of modern slavery.

Building on the success of the 2014 'Slavery Happens Here' campaign, the Home Office has carried out tailored communications activity to raise awareness of modern slavery in high-risk communities in the UK and overseas, most recently in Nigeria.

In September 2017, Crimestoppers and the Gangmasters and Labour Abuse Authority launched a joint campaign to encourage the public to spot the signs of modern slavery and to report any suspicions to Crimestoppers. The Home Office also posts regularly about how to identify and report modern slavery on our Twitter, Facebook and Instagram social media channels.

In October 2017, the Government published awareness raising and victim identification guidance for public sector staff as well as signposting public sector organisations to training resources on modern slavery. In August 2017, the National Crime Agency held a media briefing to raise awareness of modern slavery and the response. As a result, the Modern Slavery Helpline received an unprecedented number of calls that month.

In January 2018 the National Crime Agency launched the Invisible People exhibition which uses striking images by an award-winning photographer to portray the signs of slavery and inform the public how to report it.

The display of modern slavery material in public areas is also a Government priority. Border Force, in collaboration with the Modern Slavery Helpline, has led a digital and print modern slavery campaign across UK ports and airports nationwide. The campaign provides advice and guidance about modern slavery for passengers and encourages greater disclosure to officers by vulnerable potential victims or passengers who may have seen something suspicious.

Asylum: Deportation

Lord Roberts of Llandudno (Liberal Democrat) [HL5540] To ask Her Majesty's Government how much notice failed asylum seekers are given to leave the UK.

Reply from Baroness Williams of Trafford: There is no specific notice period for failed asylum seekers to leave the UK.

Individuals, including failed asylum seekers, with no leave to remain and no further outstanding applications are expected to leave the UK voluntarily at the earliest opportunity. The Home Office provides assistance and advice to facilitate voluntary returns

If an individual refuses to leave the UK voluntarily, the Home Office will pursue an enforced return. They will be issued with a 'notice of liability for removal', which sets out that they can be removed after seven calendar days if they are not detained, and 72 hours if they are detained.

Family groups are provided with greater support and advice and will be invited to attend a family return conference. The notice of liability for removal is a minimum of two weeks after the family return conference.

Deportation: LGBT People

Baroness Barker (Liberal Democrat) [HL5271] To ask Her Majesty's Government what checks they conduct to ascertain the adequacy of non-governmental organisation support to prevent hate crime attacks upon the return of LGBT deportees to their countries of origin.

Replt from Baroness Williams of Trafford: It is the responsibility of the state of the person's country of origin to offer effective protection. Where applicable, the Home Office's country policy and information notes include references to non-governmental organisation support that may be available to LGBT persons in countries of origin. This uses evidence taken from a range of sources such as local, national and international organisations, including human rights organisations, information from the Foreign and Commonwealth Office, and trusted media outlets.

UK Parliament, House of Lords Written Answer

Ritual Slaughter

Baroness McIntosh of Pickering (Conservative) [HL5539] To ask Her Majesty's Government what assessment they have made of the proportion of meat (1) sold as Halal which has not been slaughtered in accordance with Halal requirements, and (2) not sold as Halal which has been slaughtered in accordance with Halal requirements nonetheless.

Reply from Lord Gardiner of Kimble: There are currently no specific EU or national requirements governing the sale and labelling of Halal or Kosher meat. Where any information of this nature is provided voluntarily, it must be accurate and must not be misleading.

It is for Muslim religious authorities to determine what is Halal and as such some Halal accreditation bodies will accept meat from animals that are stunned prior to slaughter as Halal, whereas others will only accept meat from animals slaughtered without stunning.
