Scottish Parliament Motions

S5M-13447 Mary Fee (Labour): Scotland Welcomes Refugees – That the Parliament notes the action taken by Serco to issue lock change notices on a number of properties occupied by asylum seekers in Glasgow; believes that the UK Conservative administration's "hostile environment" immigration and asylum policy is callous; considers that asylum seekers are vulnerable individuals who have been the victims of some of the world's most cruel dictators and repressive regimes and have had to flee persecution and war; believes that every human being has the right to an affordable, habitable and safe home, free from the threat of forced eviction; understands that Article 14 of the Universal Declaration on Human Rights states that everybody is entitled to seek asylum;

recognises what it considers Scotland's long history of welcoming refugees and asylum seekers from all over the world after various global conflicts; understands that, across Scotland, over 2,500 refugees have been welcomed through the Syrian and vulnerable children's resettlement schemes, and welcomes the news that Renfrewshire Council has housed over 30 Syrian families in the region under these programmes.

Immigration: Personal Records

David Lammy (Labour) [136372] To ask the Secretary of State for the Home Department, how many landing cards have been destroyed in each of the last eight years.

Reply from Caroline Nokes: There are two different types of landing cards, "non-controlled" or "controlled". Non-controlled cards (which account for c.95% of all non-EEA arrivals in 2016) are kept for a maximum of 28 days before they are destroyed.

Controlled cards relate mainly to those passengers who arrive in the UK for non-visit purposes such as settlement and this data is retained for 15 years.

We do not record centrally the number of landing cards destroyed.

The available published information on the number of non-EEA nationals entering the UK is published in Home Office's Immigration Statistics, year ending March 2018, Admission table ad_01 available from

Undocumented Migrants: Commonwealth

Alistair Carmichael (Liberal Democrat) [135905] To ask the Secretary of State for the Home Department, whether her Department plans to provide free legal advice to Commonwealth citizens who have lived in the UK since before 1971 and who now may face deportation because of a lack of documentation.

Reply from Caroline Nokes: There will be no charge to obtain new documents or a residence permit. The simple process and the dedicated team assigned to help resolve individual cases should mean that individuals will not need to seek legal advice.

Those who arrived in the UK before 1 January 1973 are protected by virtue of their status provided by the 1971 Immigration Act. They will not be liable for deportation and will be able to regularise their stay.

Immigration: Windrush Generation

Catherine McKinnell (Labour) [147437] To ask the Secretary of State for the Home Department, what information his Department holds on the number of members of the Windrush generation who are (a) sleeping rough and (b) staying in temporary accommodation while waiting for a decision on their legal right to remain in the UK.

Reply from Caroline Nokes: Information about members of the Windrush generation who are sleeping rough or staying in temporary accommodation is not automatically reported to the Home Office.

Where any member of the Windrush generation does not have the documents they need to show their status the Government continues to urge them to come forward to the Taskforce so that we can help them. If people are homeless the Home Office can work with Local Authorities to secure temporary accommodation.

EU Nationals: Health Services

Vince Cable (Liberal Democrat) [137398] To ask the Secretary of State for the Home Department, what steps her Department is taking to ensure eligible EU citizens have access to healthcare after (a) the UK leaves the EU and (b) June 2021.

Reply from Caroline Nokes: The draft Withdrawal Agreement (WA) published in March guarantees the rights of EU citizens and their family members living in the UK, and UK nationals living in the EU.

EU citizens living in the UK by 31 December 2020, along with their family members, will be able to stay and continue their lives, with the same access to healthcare, benefits and other public services that they enjoy now. They will need to apply for status under the EU Settlement Scheme by 30 June 2021 to secure and demonstrate these rights thereafter.

Migrant Workers: Conditions of Employment

Julie Elliott (Labour) [157162] To ask the Secretary of State for the Home Department, whether the Government has received representations on (a) Tier 2 and (b) other migrant migrant workers' days of industrial action being classified as unpaid leave.

Reply from Caroline Nokes: The Home Office has previously received a number of representations on the general principle of Tier 2 and other migrant workers' days of industrial action being classified as unpaid leave.

It is not the Government's policy to prevent migrant workers from engaging in legal strike action; and, to date, I am not aware of any case where a migrant worker has had their leave curtailed or been removed as a result of doing so. To put the matter beyond doubt, however, we amended the guidance for Tier 2 and 5 sponsors on 18 July to make clear that there will be no immigration consequences for any migrant worker who takes part in legal strike action.

We will be making a similar change the relevant Immigration Rules at the next available opportunity in the Autumn.

Asylum

David Linden (SNP) [157240] To ask the Secretary of State for the Home Department, if he will make an assessment on the implications for his Department's polices of the report A Hostile Environment, published by Refugee Rights Europe in February 2018.

Reply from Caroline Nokes: The Home Office and its accommodation providers are committed to protecting the rights of asylum seekers and providing them with safe, secure and suitable accommodation whilst asylum claims are considered. We have a range of policies and procedures to ensure that this is the case and we will continue to thoroughly inspect, investigate and resolve any allegation that standards of accommodation and service are not being delivered in accordance with the contract, when specific information is received.

We remain in regular discussion with Providers, service users, non-governmental organisations and other stakeholders about ways to improve the services provided and we will be making a number of improvements to the design of the future contracted services as a direct result of such feedback. The Refugee Rights Europe report was not formally shared with the Home Office but we have retrospectively considered the recommendations made and will ensure that they continue to be taken into consideration as part of our ongoing engagement and improvement plans.

Immigration

Viscount Waverley (Crossbench) [HL9819] To ask Her Majesty's Government whether UK citizens not owning property in the UK will be required to satisfy immigration authorities of income and property in the UK when applying for either EU or non-EU spouses and close family members to enter and reside in the UK after Brexit.

Reply from Baroness Williams of Trafford: The Government is considering a range of options for the future immigration system. We will build a comprehensive picture of the needs and interests of all parts of the UK, including different sectors, businesses and communities, and look to develop a system that works for all. We will make decisions on the future immigration system based on evidence and engagement. That is why we have asked the independent Migration Advisory Committee to advise on the economic and social impacts of the UK's exit from the

EU. When building the new system, various aspects including the creative sector will be taken into account, to ensure the future immigration system works for sectors.

We will set out proposals in the autumn.

Immigration: EU Nationals

Viscount Waverley (Crossbench) [HL9818] To ask Her Majesty's Government whether they will ensure the continuity of rights for all EU citizens after Brexit.

Reply from Lord Callanan: The Prime Minister has been clear that safeguarding the rights of EU citizens living in the UK, and UK nationals living in the UK, is her first priority for negotiations.

We have reached an agreement with the EU on the rights of EU citizens living in the UK, as set out in the draft legal text of the Withdrawal Agreement. The agreement confirms that all EU citizens legally resident in the UK by December 2020 will be able to continue living their lives broadly as now.

The Home Office published a Statement of Intent on 21 June, providing further details about how EU citizens and their families can obtain settled status. The process will be straightforward and streamlined and we will support applicants to get the right outcome.

We have published a White Paper on the EU (Withdrawal Agreement) Bill which will implement the Withdrawal Agreement we reach with the EU in UK law. This sets out the detail on how the Bill will legislate for key elements of the Withdrawal Agreement, including the agreement on citizens' rights.

Refugees

Lord Scriven (Liberal Democrat) [HL9809] To ask Her Majesty's Government how many applications for indefinite leave to remain submitted by refugees have been delayed by the Home Office by at least 12 months since July 2017.

Reply from Baroness Williams of Trafford: We do not publish this data for this specific group of applicants but as per the In-Country migration statistics published in May 2018, 99.7% of settlement applications were decided within the six-month service standard. This figure will include applications made by refuges on the Settlement Protection route.

Refugees: Children

Lord Dubs (Labour) [HL9842] To ask Her Majesty's Government how many children initially relocated to the UK under section 67 of the Immigration Act 2016 have subsequently been reunited with family members; and whether those relocations will be included in the specified number of 480 children to be transferred under section 67 of that Act.

Reply from Baroness Williams of Trafford: The Dublin Regulation establishes a clear mechanism for unaccompanied children who have claimed asylum in another EU Member State to be transferred here to have their asylum claim assessed if they have a qualifying family member legally present in the UK, and where transfer is in the child's best interests.

Unaccompanied children who are relocated to the UK under section 67 of the

Immigration Act 2016 are placed in the care of a local authority. Any child relocated under section 67 occupying a space offered by a local authority will count towards the specified number of 480. Local authorities will review a child's care needs on an ongoing basis. If a child has relatives in the UK, the local authority may subsequently decide that placement with that family is in the child's best interests. However, this is a decision for local authorities, not the Home Office.

Baroness Cox (Crossbench) [HL9778] To ask Her Majesty's Government, in the light of the statement on the resettlement of White Helmets by the Foreign Secretary and the International Development Secretary on 22 July, whether members of that group will be resettled in the UK.

Baroness Cox (Crossbench) [HL9779] To ask Her Majesty's Government, in the light of the statement on the resettlement of White Helmets by the Foreign Secretary and the International Development Secretary on 22 July, what estimate has been made of the costs to (1) the Exchequer, and (2) local government of (a) exfiltrating members of that group from Syria to the UK, (b) maintaining this group together with their families in the UK for five years, and (c) providing additional security for local communities in the UK given the group's reported links to jihadist extremists in Syria.

Baroness Cox (Crossbench) [HL9780] To ask Her Majesty's Government, in the light of the statement on the resettlement of White Helmets by the Foreign Secretary and the International Development Secretary on 22 July, whether they will ensure that before members of that group are relocated in the UK, local councils will be informed of the controversial reports relating to the White Helmets and appropriate financial and security support will be given to those councils.

Reply from Baroness Williams of Trafford: In addition to the costs of staff time associated with facilitating the departure of White Helmets personnel and dependents from Syria we have agreed, with partners, to cover the costs of their transportation and temporary stay in Jordan through the relevant UN agencies, as necessary. We are not yet in a position to estimate the final UK contribution.

As with all refugees resettled under the Vulnerable Persons Resettlement Scheme, funding would be allocated to local authorities on a per capita basis, with tariff amounts and payment terms clearly set-out in the scheme's funding instructions. There is also an exceptional cases fund to assist the most vulnerable refugees.

We take the security of our resettlement process extremely seriously. When potential cases are submitted by the UNHCR for consideration, they are carefully screened and considered for suitability for entry to the UK. We take the utmost care to ensure that those people coming here undergo rigorous vetting.

We take the utmost care to ensure that those people coming here undergo rigorous vetting. We retain the right to reject individuals on security, war crimes or other grounds.

Reply from Christina McKelvie: The Equality Act 2010 (Specific Duties) (Scotland) Regulations 2012 (as amended) place a number of specific duties on listed public authorities including a duty to report progress on mainstreaming the equality duty, a duty to publish equality outcomes and a duty to gather and use employee information.

The Scottish Government published its Equality Outcomes and Mainstreaming Report (http://www.gov.scot/Publications/2017/04/4384) in April 2017.

The 2012 Regulations apply to Health Boards constituted under section 2 of the National Health Service (Scotland) Act 1978; a Special Health Board constituted under that section; the Scottish Police Authority; and the Chief Constable of the Police Service of Scotland. Therefore as listed public authorities they are required to report under the 2012 regulations (as amended).

Modern apprentices: discrimination, bullying, or harrassment

S5W-17731 Monica Lennon (Labour): To ask the Scottish Government what work it has undertaken to monitor and tackle discrimination, bullying or harassment experienced by modern apprentices, and how many cases were reported in the last five years on grounds of (a) gender, (b) race, (c) disability, (d) religion and (e) sexual orientation.

Reply from Jamie Hepburn: Modern Apprentices are employed and Skills Development Scotland (SDS) makes clear through the apprenticeship training contracts that zero tolerance of bullying, harassment and discrimination should apply to Apprentice employers.

The Modern Apprenticeship 2018-19 specification, which each training provider is required to comply with, makes clear that:

"Participants following a Modern Apprenticeship framework must be subject to the same policies and procedures as other employees of the organisation with which they are employed and the Provider must use all reasonable endeavours to ensure that each Participant is informed by his or her employer of their rights..."

Skills Development Scotland monitors any complaints of discrimination, bullying and harassment through their <u>Complaints Procedure</u>. Skills Development Scotland is unable to disclose the number of complaints received in relation to discrimination, bullying or harassment as the numbers are particularly small. Disclosure would therefore risk identification of individuals and contravene SDS obligations under the Data Protection Act.

SDS actively investigates any cases which are reported to their Skills Investment Advisers through their ongoing contract monitoring of training providers.

In addition, SDS works with training providers and employers to continually signpost them to appropriate training opportunities which are available to help them tackle discrimination, bullying or harassment in the workplace and signpost them to appropriate advice and guidance relating to diverse recruitment and embracing diversity in the workforce.

S5W-17685 Anas Sarwar (Labour): To ask the Scottish Government whether there is any funding scheme in Scotland for the securing of places of worship similar to the scheme recently announced by the UK Government.

Reply from Aileen Campbell: We are clear that any form of hate crime or prejudice is completely unacceptable and will not be tolerated. We are taking a range of steps to tackle hate crime as set out in our ambitious Tackling Prejudice and Building Connected Communities Action Plan, and have established a multiagency Action Group to drive this work forward.

While there is no specific security funding scheme for places of worship, we are fully committed to working with Police Scotland and others to safeguard all communities and potentially vulnerable people and sites, and would encourage organisations with concerns about their security or the safety of their members to contact Police Scotland.

We are working to build inclusive, resilient and safe communities in Scotland where everyone feels connected, has a sense of belonging and feels valued.
