## **Westminster Debate**

Immigration, Asylum and Nationality Act 2006 (Duty to Share Information and Disclosure of Information for Security Purposes) Order 2008

Lord West of Spithead (Parliamentary Under-Secretary of State, Home Office) rose to move, That the draft order laid before the House on 10 January be approved.

The noble Lord said: My Lords, this order is made under Sections 36(4) and 38(4) of the Immigration, Asylum and Nationality Act 2006. Section 36 of the 2006 Act introduced a requirement for the Secretary of State, in so far as she has functions under the immigration Acts, Her Majesty's Revenue and Customs and a chief officer of police to share certain passenger, crew, freight, service and other travel-related information where the information is likely to be of use for immigration, police or Revenue and Customs purposes. Section 38 of the 2006 Act introduced a statutory gateway to allow for the disclosure of similar information to the security and intelligence agencies where the information is relevant to their statutory purposes. This order concerns the information that will be shared under these two provisions. For reasons of brevity, I will refer to the border agencies when speaking collectively about the Border and Immigration Agency, UKvisas, the police and Her Majesty's Revenue and Customs.

As Security Minister, I am responsible for a wide range of measures to improve our security arrangements and this order is a key component in our efforts to enhance the security of this country. The increase in global travel brings great social and economic benefit, but it is also placing increasingly heavy demands on our border controls and border agencies. In order to meet these demands, the Government are putting in place the most comprehensive package of institutional and practical immigration reform ever announced, including the establishment of a UK border agency, a unified border force and the e-borders programme.

Neither e-borders nor other joint working arrangements between the agencies will be able to function effectively without this order, as their success is dependent on an ability to share, routinely and in volume, data relating to people and freight crossing the border. Data sharing in this form is not permitted under current powers, which require a case-by-case decision on the justification for disclosure. This is a serious obstruction to the work of the agencies. For example, under existing arrangements, examination of travel data independently by each of the border agencies may result in three interceptions against the same individual, rather than one co-ordinated response. Indeed, one agency may have intelligence on an individual who is also of interest to the other border agencies, but the other border agencies, being unaware of this, would not make a request for those data. This does not help the border agencies to carry out their functions effectively and it does not help the traveller.

This order seeks to address these and other obstacles to joint working between the border agencies by placing an obligation on them to share the travel-related information specified in the order to the extent that it is likely to be of use for immigration, Revenue and Customs or police purposes. This travel-related information can essentially be broken down into three clear categories: information about a passenger's or crew member's travel documents or journey; information held by the border agencies, which relates to a passenger or crew member, or their journey, or a freight movement; and information about or related to freight.

## **Westminster Parliamentary Questions**

**David Laws** [187149]: To ask the Chancellor of the Exchequer how many migrant workers from (a) inside and (b) outside the EU were in employment in the UK in each quarter since 1984.

**Reply from Angela Eagle:** The information requested falls within the responsibility of the National Statistician, who has been asked to reply.

Letter from Karen Dunnell, dated 22 February 2008:

As National Statistician, I have been asked to reply to your Parliamentary Question about how many migrant workers from (a) inside and (b) outside the EU have been in employment in the UK in each quarter from 1984 to 2008. (187149) The attached table gives figures for Q4 from 1992 on a seasonal quarter basis and from 1997 on a calendar quarter basis. These estimates have not been seasonally adjusted. Comparable estimates are not available prior to 1992 or for 1998 and 2000.

The data for analysing migrant workers comes from the Labour Force Survey. The National Statistics method for estimating the number of migrant workers employed in the UK is based on the number of people at a given time who were born abroad, are of working age (16 - 64 for men, 16-59 for women), and in employment. This question has been answered on this basis.

As with any sample survey, estimates from the LFS are subject to a margin of uncertainty.

**Stewart Jackson** [188118]: what recent estimate she has made of levels of net migration to the UK.

**Reply from Liam Byrne:** In 2006, the net inflow of migrants to the UK was 191,000. For those who take an interest in the issue, as I know the hon. Gentleman does, that is about 15 per cent. lower than the year before and about 22 per cent. lower than in 2004.

**Stewart Jackson:** My constituency has borne, and continues to bear, the brunt of the shambles that this Government call an immigration policy. Does the Minister think that my constituents will be reassured by a policy involving a belated points-based system but no upper limit on the number of people allowed to come to the United Kingdom?

Reply from Liam Byrne: I respect the passion with which the hon. Gentleman presents his argument, and I know that he recently held a debate in the House—I think it was last week—on the impact on public services that he sees locally. However, when I look at the proposals for caps on migration, I find it difficult to see how they would capture, touch or affect more than one in five of the newcomers who entered the UK in 2006. I believe that the points system will capture at least three in five, and I therefore think it is the right way forward for carefully controlling migration to the United Kingdom.

**Gerald Kaufman:** With regard to the administration of immigration law, will the Minister take whatever action is open to him to stop solicitors taking up asylum, leave to remain and nationality cases in which there is no need for legal representation—cases for which these greedy shysters grab money, and which they far too often bungle, so that they then have to come back to Members of Parliament? In addition to taking whatever action he can, will he ask the Law Society to investigate?

**Reply from Liam Byrne:** The position in my right hon. Friend's constituency sounds a little bit like that in mine, but he has a far more distinguished record than I have in helping constituents with errors made by immigration lawyers who claim to be acting in their clients' best interests. One of the biggest things that we can do to help resolve the problem this year is to make the law far simpler. That is why later this year we will introduce a Bill to simplify the immigration system and immigration law, some of which dates back pretty much to when I was born.

**Joan Humble** [188113]: What account she takes of the contribution of foreign students to the UK economy in taking decisions on student visas.

**Reply from Liam Byrne:** Foreign students benefit our country to the tune of almost £8.5 billion a year. Students will be included in the new points system, which will make the system easier to police.

**Joan Humble:** I thank my hon. Friend for that reply. Overseas students make a valuable contribution to this country's economy. Universities recognise both that and their role as sponsors under this new visa scheme, but they are still unclear about how it will be administered. Will he talk to education institutions about how the new certificates will be administered and, above all, how the new registration requirements will be monitored?

Reply from Liam Byrne: My hon. Friend is right that big changes will be introduced in the granting of visas to students under the points system. In particular, a new register will come into place with much tougher obligations on colleges to report events such as non-attendance and extended periods of absence, but, more importantly, students will, for the first time, be tied to a specific institution—they will not be able to come in under the sponsorship of one organisation and switch in-country to another. As these are big changes, I plan to publish blueprints of how the new system will work as early as possible so that there is as much time as possible for us to discuss the details with universities. I will certainly make sure that I talk to universities in my hon. Friend's area as we try to get these proposals right.

**Mark Pritchard:** Foreign students undoubtedly make a valuable contribution to this country's economy, but with one in five students dropping out of full-time education, many of whom are foreign students, how confident is the Minister that universities are communicating foreign student drop-out rates to the Border and Immigration Agency?

Reply from Liam Byrne: We introduced changes in April last year, through a change to the immigration rules, that made it mandatory for education institutions to keep effective records on, for example, enrolment, and to report those records to the BIA when asked to do so. The new proposals under the points system take that tightening of the system a stage on, so that it becomes mandatory for universities and other higher education institutions to report not only students who do not turn up for their course, but extended periods of absence. We are giving universities time to prepare for these changes because we realise the new burdens that will be put on them, but I think the hon. Gentleman would agree that the system needs to be tighter in future.

**David T.C. Davies:** Is the Minister aware that a large number of language schools are completely bogus and are nothing more than a front to get people illegally into this country? What action is he taking against such bogus language schools?

**Reply from Liam Byrne:** We are determined to take colleges off the register of licence sponsors whenever we come across evidence of such abuse, and if the hon. Gentleman has information about colleges perpetrating such abuse I would, of course, be grateful to receive it. Well over 100 colleges have been taken off the register over the last year and a half, thanks to the work of the BIA.

**Jim Sheridan:** Foreign students make a valuable contribution to many of our disciplines, particularly in manufacturing industry. However, there is one discipline through which they make little contribution to the UK economy: journalism. Will my hon. Friend therefore make sure that foreign journalists who apply for visas come here on the basis that they deal with factual evidence and factual evidence only?

**Reply from Liam Byrne:** I am grateful to my hon. Friend for that observation. It is important for it to be much harder for organisations to get on to the appropriate register in years to come. Under the points system, it will be easier to police new regulations on how colleges get on to the register. I will, of course, look at any new ideas for such requirements that my hon. Friend might like to suggest.

**Chris Huhne** [186469]: To ask the Secretary of State for the Home Department whether foreign nationals will be required to carry identity cards with them at all times within the UK; and whether the police will have powers to arrest and detain anyone whom they believe to be a foreign national until such time as their identity is proved.

**Reply from Liam Byrne:** The UK Borders Act 2007 expressly provides that regulations may not make provision to require a person to carry an identity card for foreign nationals at all times. The police may arrest and detain a person but only where there is suspected involvement in an offence and not simply because they believe the person to be a foreign national.

**Chris Huhne** [186470]: To ask the Secretary of State for the Home Department in what ways the requirement for foreign nationals to have identity cards within the UK will be monitored; and what assessment she has made of the likely effect of such monitoring on community relations.

**Reply from Liam Byrne:** When the new requirement for foreign nationals to apply for an identity card under the UK Borders Act 2007 commences this year, we will record how many cards we issue—and to whom. Details of our roll-out strategy will shortly be published. We do not expect the new requirements to affect community relations, although we are presently engaging with the Commission for Equality and Human Rights about this.

**Stephen Williams** [188044]: To ask the Secretary of State for the Home Department (1) how many applications for *(a)* indefinite leave to remain in the UK and *(b)* a travel document are awaiting a decision from the Border and Immigration Agency;

(2) [188045] what the current average time for processing applications is for (a) indefinite leave to remain in the UK and (b) a travel document at the Border and Immigration Agency.

**Reply from Liam Byrne:** Information on the total number of indefinite leave to remain applications awaiting decision is not held centrally and would require extensive examination of cases held in the regions and other areas of BIA attracting a disproportionate cost.

There are 972 applications awaiting a decision within the travel document section of BIA.

Statistical information on time taken to process applications is not collated.

Service standards are published annually on the BIA website in the form of general caseworking service standards reports. These cover both charged (those with an associated fee) and non-charged applications. While such reports can provide overall performance against targets, they do not differentiate between different streams of casework, such as indefinite leave to remain or those applying for travel documents.

The current published standards for processing charged applications are 70 per cent. of postal applications to be decided within 20 working days, with 90 per cent. of postal applications decided within 70 working days. For charged applications made in person at the Public Enquiry Office we aim to complete 98 per cent. of applications in 24 hours.

For non-charged postal applications we will decide 25 per cent. within 20 working days and 30 per cent. within 70 working days. For non-charged applications made in person at the Public Enquiry Office we aim to complete 98 per cent. of applications in 24 hours.

**Damian Green** [185472]: To ask the Secretary of State for the Home Department (1) whether her Department has received representations from the Church of England on the points-based immigration system;

- (2) [185477] whether (a) the Church of England, (b) its dioceses and (c) its individual parishes will be entitled to obtain licences to sponsor immigrants;
- (3) [185478] whether (a) the Roman Catholic Church, (b) its dioceses and (c) its individual parishes will be entitled to obtain licences to sponsor immigrants.

**Reply from Liam Byrne:** The Border and Immigration Agency is discussing with the Church of England our proposals for the points based system of migration.

Religious organisations, including the Church of England and the Roman Catholic Church, will be entitled to apply to the Border and Immigration Agency for a licence to sponsor migrants. They will be free to decide at what level they seek registration.

- (3) [185111] how many people from (a) Cyprus, (b) the Czech Republic, (c) Estonia, (d) Hungary, (e Latvia, (f) Lithuania, (g) Malta, (h) Poland, (i) Slovakia and (j) Slovenia have left the worker registration scheme having worked in the UK continuously for 12 months.

**Reply from Liam Byrne:** Information on the number of nationals from the 2004 accession states who held a UK working visa on 1 May 2004 could be obtained only by detailed examination of individual case records at disproportionate cost.

The Home Office has published guidance on the worker registration scheme for 'A8' nationals, those from the 2004 accession states excluding Cyprus and Malta, and employers. This includes a booklet entitled "Living and Working in the UK", detailing their rights and responsibilities from 1 May 2004. This is available on the Border and Immigration Agency website:

The number of 'A8' nationals who have left the worker registration scheme is not known as there is no requirement to "de-register" once an individual has worked in the UK continuously for 12 months. The "Accession Monitoring Report May 2004 to September 2007" gives information on 'A8' nationals and their intended length of stay. **Lord Hylton** asked Her Majesty's Government [HL1945]: Whether they have removed from the United Kingdom any children with failed asylum applications; if so, how many; and to which countries.

**Reply from Lord West of Spithead:** The accompanying table shows the number of children recorded as having claimed asylum at some stage (as principal applicants and as dependants of principal applicants) who were removed from the UK in 2006, broken down by destination. This is the latest complete year for which figures are currently available.

An unaccompanied child under the age of 18 would not be considered for removal from the UK unless it has been established with the country to which the child is to be removed that adequate reception arrangements are in place. Officers must liaise with social services and/or the nominated guardian with responsibility for the care of the child in the UK to ensure the removal is effected in the most sensitive manner possible.

A child under the age of 18 recorded as being a principal asylum applicant may not necessarily be unaccompanied; they could, for example, be living with a relative who, in turn, may or may not have status in the UK.

Reply from Parmjit Dhanda: 'Improving Opportunity Strengthening Society: The Government's strategy to increase race equality and community cohesion' (published in 2005) and its related two annual progress reports, set out some of the steps Government have taken since 1997 to tackle community tensions that can undermine community cohesion. For example in its work with partners to monitor tensions and provide support for local areas experiencing particular challenges. More recently 'The Government's Response to the Commission on Integration and Cohesion' (published in February 2008) provides a new clarity on, and commitment to, delivering cohesive and integrated communities. This includes for example: a commitment to the new public service agreement twenty-one to build cohesive, empowered and active communities; increased investment in community cohesion; and a commitment to establish specialist cohesion teams to provide advice and support to local authorities facing cohesion challenges.

The UK was among a small number of countries that worked hard to ensure that the issue of anti-Semitism was included in the 2001 Declaration and Programme for Action. We will seek to ensure that anti-Semitism receives due attention at the Durban Review Conference.

**Reply from Jim Murphy:** Officials from the Foreign and Commonwealth Office have been in discussions with their Canadian counterparts on the Durban Review Conference. My right hon. Friend the Foreign Secretary has not discussed this with the Canadian Government.

**Reply from Jim Murphy:** The Durban Review Conference has not yet been discussed at the level of European Union Foreign Ministers. It has, however, been a regular item on the agenda of meetings at official level.

**Lord Lester of Herne Hill** [HL1997] asked Her Majesty's Government: Whether any other member state of the European Union has given effect to Directive 2000/43/EC by confining the reverse burden of proof to claims of discrimination on ethnic or racial grounds, excluding discrimination on the ground of colour.

**Reply from Baroness Andrews:** Council Directive 2000/43/EC—the race directive—laid down a framework for combating discrimination on grounds of "racial or ethnic origin" in the member states of the European Union. It did not cover discrimination on grounds of colour.

In the UK, the directive was implemented by secondary legislation under Section 2(2) of the European Communities Act 1972. The amending regulations, which included the change to the burden of proof, could not therefore apply to grounds, such as colour, omitted from or excluded by the race directive itself.

Legislative arrangements vary from member state to member state, and each will have implemented the directive in the way it sees as most appropriate. We do not have up-to-date information on precisely how each of the other 26 member states of the European Union has implemented the race directive.
