#### **UK Parliament Ministerial Statements**

#### **Changes in Immigration Rules**

The Secretary of State for the Home Department (Mrs Theresa May): The Government keep visa regimes under constant review to ensure that the UK has the right visa requirements set in the right places, aligned to risk. Today I am laying changes to the immigration rules to provide a new, straightforward and free alternative to a visa for short-term visitors from Oman, Qatar and the United Arab Emirates (UAE). We intend to extend similar arrangements to Kuwait later in 2014. Britain is open for business and genuine visitors and tourists coming here to enjoy our world-class attractions, study or do

business are always welcome.

Passport holders of Oman, Qatar and the UAE will, from 1 January 2014, be able to travel to the UK visa-free if they have obtained an electronic visa waiver (EVW) document online at least 48 hours in advance of travel to the United Kingdom, and present the document to an immigration officer upon request on arrival.

This simple online form means there is no fee, there will be no requirement to give biometrics or attend a visa application centre. Guidance will be published on the Home Office website. Some visitors may still prefer a long-term multi-entry visit visa and the facility to obtain these visas will remain.

I am also laying a change relating to the Vatican City. Holders of non-national travel documents require a visa before travel to the United Kingdom. This rule includes holders of service, temporary service and diplomatic passports issued by the Holy See. The Government have assessed the procedures for issuance of these documents and consider that they are robust enough to merit an exemption from the visit visa requirement. Nationals and citizens of the Vatican City are already exempt from the visa requirement.

The changes also include minor amendments to the rules for armed forces and for graduate entrepreneurs.

Alongside these changes, UK visas and immigration continues to be focused on delivering excellent customer service to business and leisure visitors and ensuring that the UK maintains a competitive visa system that can innovate in order to serve the everchanging needs of business and ensure Britain succeeds in the global race.

#### **Immigration Transparency Data**

The Minister for Immigration (Mr Mark Harper): The Government are committed to openness and transparency to enable the public to hold the Government and other public bodies to account. This Government have made more data available than ever before. The Home Office contributes to that agenda by regularly releasing information about its work, spend and outcomes in a publicly accessible and open format.

This includes information about the immigration family returns process on our website. Unfortunately between 15 and 28 October 2013 some personal data were available on the Home Office website as part of a spreadsheet alongside the regular data set, in error. This was identified by Home Office officials on 28 October 2013 and the personal information was removed immediately. The personal data related to the names of 1,598 main applicants in the family returns process, their date of birth and limited details about their immigration case type and status. It did not include personal addresses or financial information.

The Department has taken steps to establish whether the data were viewed or accessed outside of the Home Office. That analysis suggests there were fewer than 30 visits to the relevant webpage. It has not been possible to ascertain whether those who visited the webpage went on to open the data sheet in question or accessed the part of the data sheet which contained the personal information.

#### **Migration Impact Fund**

**Baroness Scotland of Asthal:** To ask Her Majesty's Government why the Migration Impact Fund was cancelled; and whether a needs-based assessment has been conducted on the provision of support for local councils, housing associations, schools and hospitals with large Roma populations.[HL3493]

Reply from the Parliamentary Under-Secretary of State, Department for Communities and Local Government (Baroness Stowell of Beeston): The last Administration's Migration Impact Fund was ineffective and did not represent value for money, especially in light of the need to tackle the deficit left by the last Administration.

This Government has adopted an alternative approach of introducing stronger controls on immigration and addressing the "pull" factors that previously led to unsustainable impacts on this country. The Prime Minister recently outlined our plans to tackle benefit tourism and the abuse of free movement rights within the European Union.

We also have clear integration strategy to bring together disparate communities, including, for example, supporting English language training.

#### **Travellers**

**Lindsay Roy:** To ask the Minister for the Cabinet Office what estimate he has made of the number of Roma currently residing in the UK. [179018]

**Reply from Nick Hurd:** The information requested falls within the responsibility of the UK Statistics Authority. I have asked the authority to reply.

Letter from Caron Walker, dated December 2013: ... ONS is responsible for the census in England and Wales. The census is a devolved matter in Scotland and Northern Ireland, where it is the responsibility of the Registrars General for Scotland and Northern Ireland respectively. However, ONS has a responsibility to collate statistics for the UK where possible.

There was not a separate category for 'Roma' in the ethnic group questions in any of the UK censuses. However, anyone who wished to record their ethnicity as 'Roma' could do so by using the write-in options. The number of people who described themselves as 'Roma' is not included in any census standard outputs. In order to supply you with the information requested, the three census offices have produced a table (CT0112) which shows the number of people in the UK who described themselves as Roma is 785.

Although you have asked for information on Roma, you may be interested in statistics of Gypsy/Traveller/Irish Traveller. Information has been extracted from published 2011 Census Key Statistics tables KS201EW, KS201SC and KS201NI. The ethnic group question categories were not labelled the same in each of the UK censuses but they do provide comparable statistics. The question category labels and the relevant statistics are shown as follows.

England and Wales: 'Gypsy or Irish Traveller'—57,680

Scotland: 'Gypsy/Traveller'—4,212 Northern Ireland: 'Irish Traveller'—1,301 Table KS201EW is available from

#### **Immigration**

**George Galloway:** To ask the Secretary of State for the Home Department what recent estimate she has made of the number of Bulgarian and Romanian migrants who will come to the UK after accession; and what estimate she has made of the number of those migrants who will claim welfare benefits. [179553]

**Reply from Mark Harper:** The Home Office regularly monitors and analyses overall migration data to help inform policy decisions. However, we have not prepared forecasts of likely inflows from Romania and Bulgaria once restrictions are lifted. The Government accept the view of the independent Migration Advisory Committee that to produce such estimates would not be sensible, or helpful to policymakers.

Rather than produce speculative forecasts, we are focusing on cutting out the abuse of free movement between EU member states and addressing the factors that drive European immigration to Britain. Across Government, we are working to ensure that our controls on accessing benefits and services, including the NHS and social housing are among the tightest in Europe. On 27 November 2013 the Prime Minister announced a number of measures to put this principle into effect.

#### **Immigration Controls**

**Julian Sturdy:** To ask the Secretary of State for the Home Department what discussions she has had at the EU on delaying the relaxation of the UK's border restrictions due to take place on 1 January 2014. [177558]

**Reply from Mark Harper:** In June 2005, the previous Government signed the accession treaty with Romania and Bulgaria. In doing so, they granted all Romanians and Bulgarians the right to come to Britain for an initial period of three months, and then longer if they are exercising treaty rights to work or study; or are otherwise self sufficient. The treaty came into effect in 2007, and as a result the seven-year transitional controls relating to unrestricted working will end this year.

From 1 January 2014, Romanians and Bulgarians will have the right to free movement across Europe on the same terms as other EU nationals.

The Government is clear that EU citizens who benefit from the right to free movement must adhere to the responsibilities this brings with it. The Government does not tolerate the abuse of free movement rights and is working at a domestic level and with other member states to tackle such abuse. The Government has consistently raised the problem of the abuse of free movement at meetings of the Council of Ministers.

#### **Visas**

**Lord Hodgson of Astley Abbotts:** To ask Her Majesty's Government what research was undertaken to support the statement in the Home Office Research Report 71 Student Visitors that abuse of the student visitor visa system is "minimal".[HL3474]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord

**Taylor of Holbeach):** The research examined a sample of student visit visa applications between 2011-12 taken from the Home Office Central Reference System and a sample of student visitors not requiring visas arriving at Heathrow airport in November 2012.

The results show that the visitor route is being used as the government intended—attracting high value, low risk migrants who contribute positively to economic growth. It also makes clear that short-term students are attending accredited institutions and most are doing English language programmes or university exchanges. There is no evidence of displacement from the main student route, for longer periods of study at higher levels, into the student visitor route.

Key indicators of abuse—including forgeries and enforcement arrests—for those who entered the UK on a student visitor visa are low.

#### **Entry Clearances: Married People**

**Paul Murphy:** To ask the Secretary of State for the Home Department what estimate her Department has made of the proportion of wage earners who fall below the £18,600 threshold for spousal visas in (a) the UK and (b) Wales. [177539]

**Reply from Mark Harper:** The income threshold was set after considering advice from the independent Migration Advisory Committee (MAC) on what the threshold should be to ensure that the sponsor could support their spouse or partner and any dependants independently without them becoming a burden on the taxpayer. The MAC's report was published in November 2011 and is available at the following link.

The MAC estimated that an income threshold of £18,600 to sponsor a spouse or partner would not be met by around 45 % of applicants. This was based on the sponsor's earnings in the UK in a sample of applicants of high-volume nationalities.

In addition, the impact assessment of the new family immigration rules noted at page 19 that the Annual Survey for Hourly Earnings suggested that around 40% to 45% of UK residents earned less than £18,600 a year. The impact assessment was published on 13 June 2012 and is available at the following link. It did not discuss earnings in Wales or any other part of the UK.

**Paul Murphy:** To ask the Secretary of State for the Home Department if her Department will give consideration to amending the spousal visa application system to take into account potential job offers of the migrant spouse towards the minimum income threshold. [177540]

**Reply from Mark Harper:** We have no current plans to take into account potential job offers of a migrant spouse or partner when they apply for entry clearance to come to the UK. This is subject to the outcome of the Secretary of State's appeal in MM and Others, in which this and other detailed aspects of the Immigration Rules for the minimum income threshold are being considered.

A migrant spouse or partner with an appropriate job offer here can apply under Tier 2 of the Points Based System. Those using the family route to come to the

UK must be capable of being independently supported by their sponsor or by their joint savings or other income. Where, or once, the migrant spouse or partner is in the UK with permission to work, we will take their earnings from employment here into account.

**Paul Murphy:** To ask the Secretary of State for the Home Department if her Department will give consideration to introducing a regionalised minimum income level for spousal visa applications. [177541]

**Reply from Mark Harper:** We have no current plans to introduce a regionalised minimum income threshold for spouse or partner visa applications. The independent Migration Advisory Committee (MAC) considered this issue in its November 2011 report on the income threshold, which is available at the following link:

The MAC noted a number of arguments against setting a different income threshold by region and concluded that there was no clear case for doing so.

For example, it would mean that a better-off sponsor in a relatively less well-off region would have to meet a lower income threshold than a poorer sponsor in a higher income region, and a requirement that varied by region could lead to sponsors moving to a lower threshold area in order to meet the requirement before returning once a visa was granted. The Government agreed with this assessment. Having a single, national income threshold also provides clarity and simplicity for applicants and caseworkers. The lawfulness of this approach was endorsed by the High Court in MM and Others.

#### **Illegal Immigrants**

**Stephen Barclay:** To ask the Secretary of State for the Home Department what recent estimate she has made of the number of illegal migrants currently in the UK. [178317]

**Reply from Mark** Harper Government estimates on the number of illegal migrants currently in the UK are not available. Given the clandestine nature of illegal migrants, any estimation is extremely difficult and there would be considerable uncertainty around any estimates.

#### **Asylum: Finance**

**Barry Sheerman:** To ask the Secretary of State for the Home Department what financial provisions are available to successful applicants for support under section 4 of the Immigration and Asylum Act 1999; what underlying principles her Department relies upon to determine the exact level of financial support offered under that section; and what calculations her Department used to determine that this level of financial support is adequate to cover medical, food and transport costs of such applicants. [178714]

**Reply from Mark Harper:** Successful applicants are provided with accommodation and an "Azure Card" that can be used to buy food and other essential items to the value of £35.39 per week. They are also eligible to receive free health care and can apply for extra assistance to cover the costs of travel to essential appointments.

The level of assistance is customarily reviewed annually. When last considering whether to change the level of financial support provided the Government took into account a range of comparators, such as the level of income support, the

Office for National Statistics and the Department for Work and Pensions survey data on average household spending and the rates paid in other EU member states. The level of support agreed also reflects the temporary nature of the support provided and the fact that accommodation is provided fully furnished with no utility costs to pay.

**Barry Sheerman:** To ask the Secretary of State for the Home Department what steps her Department is taking to broaden the range of (a) supermarkets and (b) local retail shops that accept Azure payment cards. [178755]

**Reply from Mark Harper:** The Azure Card is already accepted by Tesco, Asda, Sainsbury's, Morrison's, the Co-operative, Boots, Peacocks, The British Red Cross, the Salvation Army and a few small independent retailers.

#### **Asylum: Legal Aid Scheme**

**Barry Sheerman:** To ask the Secretary of State for Justice what impact assessment his Department has carried out to determine the effect of changes to legal aid on people in the process of (a) applying for asylum, (b) reapplying for asylum and (c) applying for support under section 4 of the Immigration and Asylum Act 1999. [178713]

The Government will be undertaking a post-implementation review of the legal aid provisions within LASPO in three to five years' time, which will also include a review of the civil legal aid proposals that are taken forward as part of Transforming Legal Aid.

#### **Asylum**

**Matthew Offord:** To ask the Secretary of State for the Home Department how many failed asylum applicants have successfully asserted Article 8 of the European Convention on Human Rights as mitigation in asylum appeals in each of the last five years. [177913]

**Reply from Mark Harper:** The information is not readily available and could be obtained only at disproportionate cost.

**Graham Brady:** To ask the Secretary of State for the Home Department what guidance she has given to companies managing contracts for the dispersal of asylum seekers as to the minimum notice period which should be provided to local authorities before significant numbers of asylum seekers are placed in their local authority area. [178288]

**Reply from Mark Harper**: There is no minimum notice period to be served prior to asylum seekers being placed in a local authority area. However under the COMPASS contract, providers are required to consult with local authorities to minimise the impacts of the dispersal of asylum seekers on local services and ensure planning is not adversely affected.

**Angus Brendan MacNeil:** To ask the Secretary of State for the Home Department if she will take steps to allow British citizens to be permitted to work while checks are being undertaken under the Asylum and Nationality Act 2006. [178653]

Reply from Mark Harper: British citizens can evidence their right to work to an

employer under the checks to prevent illegal working in the Immigration, Asylum and Nationality Act 2006 by simply producing their UK passport, or their National Insurance number in combination with their full birth or adoption certificate or certificate of naturalisation or registration as a British citizen. Employers should conduct this straightforward document check before the person's employment commences. An employer is not required to contact the Home Office to seek confirmation of someone's right to work, except in specified circumstances involving non-EEA nationals with a time-limited status in the UK.

**Mike Hancock:** To ask the Secretary of State for the Home Department pursuant to the answer of 20 November 2013, *Official Report*, column 906W, on asylum, what steps she is taking to ensure that all failed asylum applicants are recorded whether they leave the UK voluntarily or otherwise. [179544]

Reply from Mark Harper: Any removal of a failed asylum seeker organised by the Home Office, whether enforced or voluntary, is recorded on our Case Information Database (CID). There are, however, instances where applicants leave the United Kingdom voluntarily without informing the Home Office. In such cases, we are able to retrospectively record the departure on CID after conducting 'post departure checks'. However, these checks do not cover all possible departure routes, or eventualities—such as when an individual leaves on false document. As a result, we are unable to ensure 100% of departures are recorded.

#### **Asylum: Appeals**

**Paul Blomfield:** To ask the Secretary of State for the Home Department in how many asylum cases where the applicant has appealed to HM Courts and Tribunal Service has the Secretary of State's decision been withdrawn prior to the scheduled hearing date in the last 12 months; and how many of the cases where decisions have been withdrawn by the Secretary of State have subsequently had no further decision issued. [175606]

**Reply from Mark Harper:** In the last 12 months the Secretary of State for the Home Department, my right hon. Friend the Member for Maidenhead (Mrs May) has withdrawn the appeal prior to the hearing date in 20 cases. In all 20 cases, the Home Office has made a further decision.

The data on which our response is based are management information which have been subject to internal quality checks. The information has been provided by and assured by the Home Office Performance Unit but has not been quality assured under national statistics protocols.

**Lord Roberts of Llandudno:** To ask Her Majesty's Government how the policies in Detention Service Order 03/2013 and Chapter 55.10 of the Enforcement Instructions and Guidance are being applied to food- and fluid-refusing detainees whose condition deteriorates to a point where they are critically ill or at end of life; and whether there are additional policy criteria which are being applied to the continued detention of food- and fluid-refusers.[HL3812]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The policies and procedures set out in the Detention Services Order and Chapter 55.10 of the Enforcement Instructions and Guidance are being applied consistently in line with established legal principles. The Home Office's general approach to the handling of cases of food and fluid refusal in

immigration detention has been consistently upheld by the Courts, most recently by the Court of Appeal.

#### **Immigrants: Detainees**

**Sarah Teather:** To ask the Secretary of State for the Home Department how many people currently held in a prison solely on immigration grounds have never been found guilty of a criminal offence in the UK. [178696]

**Reply from Mark Harper**: For the week commencing 2 December 2013, there were 957 immigration detainees held in prisons.

This includes a small number of individuals who have never served a custodial sentence. These individuals present specific risk factors that indicate they pose a serious risk of harm to the public or to the good order of an Immigration Removal Centre (IRC), including the safety of staff and other detainees, which cannot be managed within the regime applied in IRCs.

In order to extract the small number of cases who have not served a custodial sentence would incur a disproportionate cost as this would involve looking at individual records.

#### **Deportation: Appeals**

**Sadiq Khan:** To ask the Secretary of State for the Home Department how many unsuccessful appeals by foreign nationals deported under section 32 of the UK Borders Act 2007 there were using (a) the European Convention on Human Rights and (b)the 1951 Refugee Convention in each year since the implementation of that Act. [178454]

Reply from Mark Harper: We are only able to report on data that is captured in certain mandatory fields on the Home Office's Case Information Database (CID). Additional data relating to the specific details of appeals lodged against the European Convention on Human Rights and Refugee are only recorded in the case notes sections within the database or held solely on the case file. In order to provide the requested information on the reasons given for lodging an appeal, we would need to undertake a manual case by case search of records. We have estimated that to gather and collate the information you have requested would exceed the cost threshold.

**Sadiq Khan:** To ask the Secretary of State for the Home Department what articles of the European Convention on Human Rights were used as part of the appeal by foreign nationals deported under section 32 of the UK Borders Act 2007 who unsuccessfully appealed against their deportation in each year since the implementation of that Act. Reply from Mark Harper: We are only able to report on data that is captured in certain mandatory fields on the Home Office's Case Information Database (CID). **Caroline Lucas:** To ask the Secretary of State for the Home Department whether witnesses to the investigation into allegations of sexual abuse of detainees at Yarl's Wood Detention Centre have been deported; and whether such witnesses were interviewed before any deportation took place. [175942]

**Reply from Mark Harper:** No individuals identified to date as witnesses have been removed since the allegations were made.

Bedfordshire police are investigating the allegations and the Home Office is offering full assistance to that investigation.

**Reply from Mark Harper:** The hotline to report human trafficking concerns, managed by Border Force, has received three calls from airlines since its launch in October 2011. All three calls related to trafficking concerns identified by airline staff on board flights bound for the UK.

**Fiona Mactaggart:** To ask the Secretary of State for the Home Department what assessment her Department has made of the success of the human trafficking free phone number 0800 783 2589 since it was launched in June 2011; and how widely that number is publicised. [177995]

**Reply from James Brokenshire:** The Metropolitan police free phone number is used for reporting trafficking concerns to the specialist human trafficking unit. At the time of launch the number was publicised through a non-governmental organisation developed poster campaign aimed at target communities and partner agencies where potential victims or those who support them might see the number. It is also available on a range of websites.

No formal assessment has been made of the Metropolitan police hotline. However, since its launch in 2011 it has received 133 calls reporting trafficking suspicions or seeking anti-trafficking advice.

**Fiona Mactaggart:** To ask the Secretary of State for the Home Department how many children under 18 years have been referred to the National Referral Mechanism (NRM) as being trafficked for (a) domestic servitude and (b) other forms of exploitation since the NRM came into operation. [177997]

**Reply from James Brokenshire:** Between 1 April 2009 and 3 December 2013 there were 1,190 minors referred into the National Referral Mechanism (NRM). Of these, 105 were recorded as cases of domestic servitude. There were 1,085 child referrals recorded as other types of exploitation.

**Fiona Mactaggart:** To ask the Secretary of State for the Home Department whether National Referral Mechanism (NRM) statistics are adjusted to reflect circumstances in which a victim of trafficking is initially given a negative NRM decision but then receives a subsequent decision that they are conclusively a victim of trafficking either in a court of law or as a result of a competent authority settling before a judicial review. Reply from James Brokenshire: The National Referral Mechanism (NRM)

captures amendments to trafficking decision outcomes. Quarterly NRM statistics reflect the status of a person's case at the time of publication.

**Fiona Mactaggart:** To ask the Secretary of State for the Home Department whether her Department's counting rules include a separate category of crime for (a) human trafficking and (b) other forms of modern slavery. [177993]

**Reply from James Brokenshire:** The Home Office Counting Rules for crime (HOCR) has a separate category for crimes of human trafficking for sexual exploitation. Other crimes relating to trafficking and modern slavery are not separately categorised within the HOCR but are included within other offence classifications.

**Nigel Dodds:** To ask the Secretary of State for the Home Department what recent consultation she has had with the devolved administrations on the prevention of human trafficking. [179653]

**Reply from James Brokenshire:** Ministers from the devolved Administrations are members of the Inter-Departmental Ministerial Group on human trafficking which I chair. This group meets regularly to provide the strategic coordination and oversight of efforts to tackle this horrendous crime.

We are also engaged with the devolved Administrations in the development of the forthcoming Modern Slavery Bill.

#### **Human Trafficking**

**Fiona Mactaggart:** To ask the Secretary of State for Justice whether aftercare providers under his Department's contract supporting victims of trafficking require a data subject access request before releasing information from a victim's file in order for other organisations outside the contract to provide assistance to the victim. [177992]

**Reply from Damian Green:** Under the terms of their contract with the Ministry of Justice, the Salvation Army and their sub-contractors work closely with a range of other partners to support all victims to secure appropriate support. Victims can be referred to other services without the need for providers to submit a Subject Access Request and this is working well.

The contract is aimed at helping some of the most vulnerable people in society and therefore protecting their safety and security is our primary concern. Personal data relating to victims supported by the Salvation Army and its sub-contractors are handled in line with the provisions of the Data Protection Act.

Given its sensitive nature, the Ministry of Justice's contract with the Salvation Army contains a standard clause to ensure victims' personal data (their case files) are not divulged to any third party unless this has been directed in writing by the Department. This is to help protect vulnerable people from being put at risk.

Where other organisations have requested access to a victim's case file, the Salvation Army is contractually obliged to notify the Ministry of Justice who will consider it as a formal Subject Access Request.

included in the interim constitution that would be put in place at the time of independence. After independence, a constitutional convention would consider how to protect and promote equality further.

**Christina McKelvie**: As we all know, equality comes in many forms. I take the opportunity to welcome the commitment in the white paper to end detention and to close Dungavel. Given that it is migrants' rights week next week, can the minister tell us what provisions will be put in place to make refugees and those who seek sanctuary feel welcome in an independent Scotland, as outlined in "Scotland's Future"?

**Reply from Shona Robison**: As a nation that will play a socially responsible role in the world, an independent Scotland would continue to provide a place of safety for people who seek asylum. The asylum process in an independent Scotland will be robust and humane, with clear adherence to human rights and equality principles and to the rule of law.

As Christina McKelvie mentioned in her question, we would close Dungavel and end the inhumane practice of dawn raids. However, independence would also enable us to address asylum seekers' access to employment, education and accommodation. As she did, I welcome migrants' rights week next week. I am sure that it will be an opportunity to highlight many of the issues.

**Kezia Dugdale**: Can the minister tell us why the white paper guarantees us our own Eurovision entry but does not guarantee gender equality in an independent Scotland?

Reply from Shona Robison: Gender equality is a significant part of the white paper—on page 106, as Kezia Dugdale has been told on a number of occasions. We will consult on a target for female representation on company and public boards and we will, if necessary, legislate as appropriate. I do not understand what Kezia Dugdale's alternative to that is, because I cannot see it anywhere. The white paper has put gender equality very much on the agenda and will allow us to move forward to becoming the progressive Scotland that we all want.
