## **Holyrood Parliamentary Motion**

**Patrick Harvie** (S3M-1794): **UN Convention on the Rights of the Child Should Protect All Children**—That the Parliament welcomes the UK Government's review of its general reservation to the UN Convention on the Rights of the Child (UNCRC); recognises that the reservation prevents children seeking asylum and trafficked children in Scotland from realising their rights as children; acknowledges the support that members across the Parliament have given to ensuring that asylum-seeking children are treated with dignity and respect as children; notes that the United Kingdom will be assessed on its implementation of the UNCRC later this year, and calls on the Scottish Government to support the removal of the reservation.

## Immigration and Asylum (continued) Westminster Parliamentary Questions

**Chris Mullin** [201000]**:** To ask the Secretary of State for the Home Department to which countries there is currently no safe route of return for failed asylum seekers.

**Reply from Liam Byrne:** There are no countries to which the United Kingdom does not remove failed asylum seekers on the basis of the safety of the route. Officials consider not only the merits of the individual case but also the most effective means of achieving a safe and successful return. While there is no policy not to return to any country or territory, our ability to return may of course from time to time temporarily be affected by legal challenge. This is currently the case with Zimbabwe, where we have undertaken to the High Court that we will not enforce the return of failed asylum seekers to Zimbabwe until the current country guidance litigation is resolved, and that remains the case.

**Jenny Willott**[199959]: To ask the Secretary of State for the Home Department how many complaints were made to the Border and Immigration Agency in each year since establishment, broken down by the nature of complaint; and if she will make a statement.

**Reply from Liam Byrne:** Data can be provided from 2000 for service delivery complaints and 2001 for misconduct complaints.

**Mark. Hoban** [199010]: To ask the Secretary of State for the Home Department how many *(a)* illegal immigrants and *(b)* failed asylum seekers detained by the police have been sent unaccompanied to immigration detention or removal centres in each of the last five years.

**Peter Lilley** [199161]: To ask the Secretary of State for the Home Department what estimate she has made of the proportion of immigrants who will be affected by the introduction of the proposed points-based system.

**Reply from Liam Byrne**: The Office for National Statistics produces total international migration (TIM) estimates of the number of people legally entering and leaving the country each year. The TIM calculations are based largely from data from the International Passenger Survey (IPS) which gives both the reasons for entry to the UK and the citizenship of those arriving.

Once fully established, the points based system will cover non-EU work-related migrants, students and their dependants. We estimate this will cover close to six in 10 of the non-British inflow.

**David Davis** [199145]: To ask the Secretary of State for the Home Department what the offences are for which an immigration officer can (*a*) detain and (*b*) arrest an individual at a UK port.

**Reply from Jacqui Smith:** There are 50 offences for which an immigration officer may arrest and detain an individual at a United Kingdom port. A full list of offences is contained in Annex A.

Under section 2 of the UK Borders Act 2007 a designated immigration officer at a port in England, Wales or Northern Ireland may also detain (for a maximum of three hours) any individual who the officer thinks is subject to a warrant for arrest or may be liable to arrest by a constable for any offence, pending arrival of a constable.

**David Davis** [200546]: To ask the Secretary of State for the Home Department what recent estimate she has made of the number of failed asylum seekers in the UK.

**Reply from Jacqui Smith:** Since the phasing out of embarkation controls in 1994, no Government has been able to produce an accurate figure for the number of people who are in the country illegally and that includes failed asylum seekers. By its very nature it is impossible to quantify accurately and that remains the case.

As part of the Government's 10-point plan for delivery, by Christmas 2008 the majority of foreign nationals will be counted in and out of the country. This is part of a very wide ranging programme of border protection which also includes the global roll-out of fingerprint visas, compulsory watch-list checks for all travellers from high-risk countries before they land in Britain and ID cards for foreign nationals.

**David Davis** [197487]: To ask the Secretary of State for the Home Department what assessment she has made of the report of the Children's Commissioner, published on 3 March 2008, insofar as it relates to unaccompanied asylum-seeking children; whether she plans to take steps to address such issues; and if she will make a statement.

**Reply from Jacqui Smith**: The UK Border Agency is carefully considering the report and, before responding formally to each of the recommendations, have met representatives of the Children's Commissioner on 3 April. Work to improve the arrangements for unaccompanied asylum seeking children has already addressed a number of the report's recommendations.

**Peter Lilley** [199708]: To ask the Secretary of State for the Home Department what the evidential basis is of her estimate that the annual inflow of immigrants contributes £6 billion to the economy; and what estimate she has made of the annual expenditure of immigrants on goods and services, including repatriated earnings.

**Reply from Liam Byrne**: The evidential basis for the impact of migration on trend economic growth is set out in the joint Home Office—DWP submission to the House of Lords Select Committee on Economic Affairs The economic and fiscal impact of immigration.

According to official data from the Office for National Statistics, migration added around 0.5 percentage points per annum to growth in the working age population between mid 2001 and mid 2006, and, therefore to overall trend output growth. On this basis, the contribution of migration to economic growth in 2006 would have been some £6 billion.

The information requested on expenditure and remittances falls within the responsibility of the Office for National Statistics. No statistics are collected on expenditure by immigrants on goods and services. The available information on remittance payments was laid out in a letter from the National Statistician to Lord Lament of Lerwick on 19 November 2007, *Official Report, House of Lords,* columns WA47-48, in answer to his parliamentary question of that date, to which I refer the hon. Member.

# **Race Relations**

## Westminster Debate

Lord Hameed My Lords, one of the most divisive elements in our present-day lives is religion. This was never meant to be so, but extremists in many faiths are bent upon exploiting religion for their own nefarious political agendas. Although there is much warmth and friendship in this House, there is a great deal of fear and hatred in the world outside. As the threats in our daily lives have increased, many eyes have turned in the direction of Islam, from whose corner the recent spate of tragic events has emerged. In looking at Islam through its main reference source, the Holy Quran, we see a religion completely at odds with the actions of the perpetrators of the vile act of terrorism committed in its name. This resulted in voices being raised and questions asked. Do Muslims hate other faiths? Is Islam mainly the religion of fanatics? Are we to witness the start of a clash between Islam and other faiths?

As these questions reverberated, for many Muslims this was a time for challenge and despair. Many now viewed with scepticism Islam's message of peace and compassion; for if it was true, why, they asked, is it associated with violence and intolerance towards non-Muslims and the poor treatment of women? The answer is that both Muslims and non-Muslims use the holy book of Islam, the Koran, selectively. The events of 9/11 in New York and 7/7 in London, in Spain, Bali and other places, were despicable acts committed by misled youths, wrongly in the name of Islam. Islam not only prohibits the killing of the innocent but is also most severe on the act of suicide. There is a clear Koranic instruction against taking one's own life. I therefore have no problem stating from the august Floor of your Lordships' House, for all to hear, especially my co-religionists from the Muslim world, that exploding bombs as an act of suicide to kill innocent people in buses, bazaars, aeroplanes, trains, schools, places of worship or anywhere else, is totally un-Islamic and against the teachings of the Koran. All Muslims, therefore, must do everything to stop this evil depravity.

## **Parliamentary Questions**

**Gordon Prentice** [202016]: To ask the Secretary of State for Justice what consideration he has given to proposals that religious court should be allowed to arbitrate on some family and matrimonial disputes; and if he will make a statement.

**Reply from Bridget Prentice:** The United Kingdom does not accommodate religious legal systems as such in this country's laws and there is no intention to change this. Under section 10A of the Matrimonial Causes Act 1973, as amended by the Divorce (Religious Marriages) Act 2002, a court may refuse a decree absolute of divorce to parties who have not given their spouses a religious divorce although it does not allow recognition of the religious divorce. Currently, this provision only applies to members of the Jewish faith. However, it is open to any prescribed religious group to apply to the Lord Chancellor for recognition under this law should it wish to do so.

In Muslim family disputes, the parties may choose to have their financial affairs and decisions about their children decided by a Sharia Council. If the parties wish to have that decision recognised by English authorities, they are at liberty to draft a consent order embodying the terms of the agreement and submit it to an English or Welsh court. This allows it to be scrutinised by an English or Welsh judge to ensure that it complies with English legal tenets. If the decision is made into a court order the English and Welsh courts can enforce it.

Any member of any community has the right to refer to an English court at any point, particularly in the event that they feel pressured or coerced to resolve an issue in a way with which they feel uncomfortable.

**Jim Cunningham** [201659]: To ask the Secretary of State for the Home Department (1) what steps the Government has taken to reduce the number of forced marriages; [201657]

(2) what steps the Government has taken to assist those who have been subject to forced marriage.

**Reply from Vernon Coaker:** In January 2005, the joint Forced Marriage Unit (FMU) was set up by the Home Office and the Foreign and Commonwealth Office. The FMU leads on Government policy on forced marriage and has developed guidelines for professionals (the police, education professionals, health and social workers) on how to deal with cases of forced marriage. In addition, as part of the National Domestic Violence Delivery Plan, the FMU coordinates an outreach programme to raise awareness of the problem, and runs a dedicated support and advice helpline for victims of forced marriage. The FMU also works with embassies and high commissions overseas to rescue and repatriate those British citizens forced into marriage overseas.

Last year the FMU:

assisted approximately 400 victims of forced marriage (168 of these were overseas cases);

spoke at over 80 awareness raising events around the country;

contributed to the passage through Parliament of the Forced Marriage (Civil Protection) Act 2007. One of the provisions of the Act is to make the guidelines for professionals statutory; and also

assisted in the development of the 'Honour Network'—a helpline to support survivors of forced marriage.

We have also established an Honour Based Violence Steering Group, led by the Home Office, to identify actions and develop a work programme to address honour based violence and also develop a more dedicated approach to respond to the needs of Black, Asian and minority ethnic victims of domestic violence over the next few years.
