Immigration

Evan Harris [303647]: To ask the Secretary of State for the Home Department by what date he expects the target of deciding all applications for a residence card as the spouse of an EEA national within six months to be met.

Reply from Phil Woolas: UKBA has made significant progress to bring European applications within service standards. All new complete applications for residence

cards submitted from 29 July 2009 onwards are being dealt with within six months UKBA has significantly reduced the number of outstanding older cases.

Of the remaining cases, a significant proportion are complex or were not submitted with adequate supporting information. To address this issue the agency has written to affected applicants and-once the required documentation is provided-the cases will be concluded. All such cases should be resolved by early 2010.

Evan Harris [303648]: To ask the Secretary of State for the Home Department what steps he is taking to ensure that the target of deciding all applications for a residence card as the spouse of an EEA national within six months is met.

Reply from Phil Woolas: UKBA has made significant progress to bring all European applications within service standards. All new complete European applications submitted from 29 July 2009 onwards are being dealt with within service standards with complete EEA1 applications currently decided and dispatched within a matter of working days. UK Border Agency has reduced the number of outstanding cases from approximately 77,000 in April to 38,000 in November. This has been done through a combination of interventions; increased resources, process improvement and performance management focus.

Of the remaining cases, a significant proportion are complex or were not submitted with adequate supporting information. To address this issue the Agency has written to affected applicants and-once the required documentation is provided-the cases will be concluded. All such cases should be resolved by early 2010.

Immigration

Chris Huhne [302881]: To ask the Secretary of State for the Home Department how many children from each country of origin aged (a) 17, (b) 12 to 16, (c) five to 11 and (d) under five years old have been detained under immigration rules in each of the last 12 years.

Reply from Alan Johnson: The requested information is not available; however, in August 2009 the Control of Immigration Quarterly Statistical publication was expanded to include information on persons entering detention, total number of persons leaving detention and the number of families with children held in detention. This information is available split by age (to separately identify children), and will be published quarterly in the future; however data for earlier years will remain unavailable. Information on the number of children under the age of 18 entering detention solely under Immigration Act powers in Q1-Q3 2009 by age and country of nationality is available in:

Entry Clearances

Angus MacNeil [300921]: To ask the Secretary of State for the Home Department how many (a) leave to remain, (b) indefinite leave to remain and (c) student visa (tier four) applications have been refused in the last five years.

Reply from Phil Woolas: Statistics on leave to remain and indefinite leave to remain (settlement) applications refused for the last five complete years, 2004-08, are provided in the following table.

Provisional calendar year totals for 2009 are due to be published in February 2010. The leave to remain refusals total for 2009 will include in-country applications from non-EEA students that have been considered and refused under tier 4 of the points-based system from 31 March 2009.

Provisional leave to remain and indefinite leave to remain quarterly data for the first three quarters of 2009 were published on 26 November in the "Control of Immigration: Quarterly Statistical Summary, United Kingdom-Third Quarter 2009". Entry Clearances: Overseas Students

Adrian Sanders [302084]: To ask the Secretary of State for the Home Department if he will assess the financial effect on language schools teaching English as a foreign language of proposed reforms to Tier 4 of the points-based system.

Reply from Phil Woolas: The Prime Minister announced on 17 November 2009 that a review of tier 4, the student tier of the points based system, would be conducted by a joint team from the UK Border Agency and the Department of Business, Innovation and Skills. The review team have been asked to assess whether the current tier 4 policy strikes the appropriate balance between facilitating access of genuine students to education in the UK and preventing abuse by economic migrants.

The review is looking at evidence gathered from the early stages of tier 4, which was launched in March this year, to look at the case for or against any policy changes. The review will consider all of the available data and evidence, including the potential financial impact of the proposals on the different parts of the education sector such as the English language sector.

Entry Clearances: Overseas Students

Bill Wiggin [301427]: To ask the Secretary of State for the Home Department whether there are plans to change the student visa process; and if he will make a statement.

Reply from Phil Woolas: There are no current plans to change the student visa process introduced on 31 March 2009 with the introduction of tier 4 of the points based system. A review of certain aspects of the system was announced on 12 November.

Jim Cousins [303281]: To ask the Secretary of State for the Home Department how many applications for entry to the UK under the points-based immigration system had been made by overseas students on the latest date for which figures are available; how many such applications were granted, and in respect of how many such applications the customer service standards set by his Department in relation to such applications were not met.

Reply from Phil Woolas: The number of visa applications for entry as a student under tier 4 of the points based system that were (a) received, and (b) refused, since the implementation of tier 4 on 31 March to September 2009 was 245,915 and 36,434, respectively. Processing times for tier 4 applications against UK Border Agency customer service standards are shown in the following table. Entry Clearances: Skilled Workers

Frank Field [302155]: To ask the Secretary of State for the Home Department how many (a) work permits with a length of more than 12 months and (b) highly skilled migrant programme permits were issued in 2008-09.

Reply from Phil Woolas: The UK Border Agency issued 60,305 work permits with a length of 12 months or more and 10,775 highly skilled migrant programme permits in the financial year 2008-09. Figures are rounded to nearest five. The figures quoted are not provided under National Statistics protocols and have been derived from local management information and are therefore provisional and subject to change.

Frank Field [302154]: To ask the Secretary of State for the Home Department how many permits have been granted under (a) Tier 1 (general), (b) Tier 1 (post study entry), (c) Tier 2 (shortage occupation), (d) Tier 2 (intra-company transfer), (e) Tier 2 (resident labour market test), (f) Tier 4 (students) and (g) Tier 4 (working holiday makers) scheme in each month since they came into operation.

Reply from Phil Woolas: The following tables provide detail of the numbers of incountry grants of leave to remain and out of country visas issued under (a) Tier 1 (General), (b) Tier 1 (Post Study Work), (d) Tier 2 (Intra-Company Transfer), (f) Tier 4 (students) and (g) Tier 5 (Youth Mobility Scheme) in each month since they came into operation. Information relating to approved applications in shortage occupations (c), or for those jobs where a resident labour market test is required (e), is held on the UK Border Agency Sponsor IT System is available only at disproportionate costs. The working holidaymaker scheme ended on 26 November 2008. A similar scheme Youth Mobility Scheme has been introduced within Tier 5 of the Points Based System. Immigration: Detention Centres

The Lord Bishop of Ripon and Leeds [HL128]: To ask Her Majesty's Government what plans they have to end the practice of holding children in immigration detention centres.

Reply fromLord West of Spithead: We would rather not detain families with children and would prefer that they left the UK voluntarily where the courts have upheld a decision of the UK Border Agency that they must leave the country. However, where they fail to leave after being given every opportunity and incentive to do so, the agency has no other option, other than to separate the family, but to detain in order to enforce their departure. Where detention is prolonged, it is normally because the family has made a last minute application to the court to frustrate the removal. However, we are investigating approaches which would reduce the need to use detention to enforce removal for families with children. We promote the assisted voluntary return scheme with the International Organization for Migration throughout the asylum process to provide assisted voluntary returns which cater for families' needs and allow a return that is dignified and sustainable. The agency is working in partnership with Glasgow City Council and the Scottish Government to pilot an initiative in Glasgow to offer temporary housing and a package of support to a selection of families whom the UK Border Agency and the courts agree do not require international protection.

Unaccompanied children are, exceptionally, detained in very limited circumstances. These are primarily for their safety and only overnight while alternative arrangements with the local children's services are made for their care.

Lord Hylton [HL402]: To ask Her Majesty's Government what plans they have for releasing Eritrean nationals held in immigration detention centres, in particular those who have claimed asylum.

Reply from Lord West of Spithead: Detention is an essential component in maintaining an effective immigration control. It is usually appropriate in the following circumstances: initially, while a person's identity or basis of claim is being established; where there are reasonable grounds for believing that a person will fail to comply with the conditions attached to the grant of temporary admission or release; as part of a fast-track asylum process; or to effect removal. The decision to detain, or to maintain detention, including those of Eritrean nationals, is made on a case by case basis taking account of the individual circumstances in each case. Imminence of removal and risk of harm to the public are among the factors considered in reaching a decision. There is no policy precluding the return of Eritrean nationals either to third countries or to Eritrea. Nor are there any plans to move away from a case by case approach to Eritreans who are held in immigration detention centres, whether or not they have claimed asylum. Detention is kept to the minimum period necessary for the purpose for which it was authorised and is not unduly prolonged. Individuals may prolong their own detention by, for example, refusing to co-operate with the redocumentation process or by frustrating lawful attempts at removal. Detention in each individual case is subject to review at increasingly senior levels within the UK Border Agency to ensure that it lasts only as long as it continues to be justified and necessary. We believe that the current policies support a requirement to enforce our immigration laws and we therefore have no intention of changing them at this time.

Immigrants: Detainees

Bob Russell [303633]: To ask the Secretary of State for the Home Department if he will make it his policy not to detain asylum seekers and immigrants whose deportation is not imminent and who are not considered to be a serious threat to society; and if he will make a statement.

Reply from Phil Woolas: Detention is an essential component in maintaining an effective immigration control. It is usually appropriate in the following circumstances: initially, while a person's identity or basis of claim is being established; where there are reasonable grounds for believing that a person will fail to comply with the conditions attached to the grant of temporary admission or release; as part of a fast-track asylum process; or to effect removal.

The decision to detain is made on case by case basis taking account of the individual circumstances in each case. Imminence of removal and risk of harm to the public are factors, among others, considered in reaching a decision.

Detention is kept to the minimum period necessary for the purpose for which it was authorised and is not unduly prolonged. Individuals may prolong their own detention by, for example, refusing to cooperate with the redocumentation process or by frustrating lawful attempts at removal. Detention in each individual case is subject to review at increasingly senior levels within the UK Border Agency to ensure that it only lasts as long as it continues to be justified and necessary.

We believe that the current policies support a requirement to enforce our immigration laws and we therefore have no intention of changing them at this time.

Immigration Controls: Foreign Workers

Claire Curtis-Thomas [301223]: To ask the Secretary of State for the Home Department what effects changes in the labour market test for obtaining a work permit have had on the number of domestic workers (a) applying for and (b) obtaining jobs in the UK.

Reply from Phil Woolas: The flexibility of the points-based system allows us to support UK workers and at the same time meet the recruitment needs of businesses and support the economy. Since April this year, the RLMT has been strengthened to include a requirement to advertise skilled jobs in Jobcentre Plus, so that resident workers have a single source-their local job centre-to access all skilled vacancies. This strengthening of the resident labour market test was introduced to better support resident workers looking for skilled jobs. I announced on 24 November that, on the Migration Advisory Committee's recommendation the test would be further strengthened by increasing from two weeks to four weeks the minimum period that jobs must be advertised in order to satisfy the test. No formal assessment of the impact of the changes has yet been undertaken.

Chris Huhne [302884]: To ask the Secretary of State for the Home Department to which countries children seeking asylum aged (a) 17, (b) 12 to 16, (c) five to 11 and (d) under five years old have been deported in each year since 1997.

Reply from Alan Johnson: The requested information is not available prior to 2004; however, the following table shows the number of removals and voluntary departures of children asylum cases under the age of 18, including dependants, from the United Kingdom between 2004 and 2008, by age group and country of destination. The figures provided include children in family groups. Where they have been found by the UK Border Agency and the independent courts to have no basis of stay in the UK they are expected to leave the country or face an enforced removal. Wherever possible they are given the opportunity to make a voluntary departure. The UK Border Agency only consider returning an unaccompanied child with no legal right to remain in the UK to their country of origin if safe and adequate reception arrangements are in place.

Reply from Lord West of Spithead: The attached table shows information on the number of principal asylum applicants accepted at Oakington, Harmondsworth and Yarl's Wood detained fast-track centres, of which asylum applicants subsequently achieved refugee status or humanitarian protection in each of the years 2000 to 2008.

Westminster Early Day Motions

Bob Spink (394) UK population and immigration – That this House is concerned that net immigration was 163,000 in 2008 and that this level of immigration will result in the UK population exceeding 70 million in 20 years; notes that 70 per cent. of the forecast population increase is due to immigration; recognises that to maintain the UK's population below 70 million, net inward migration would need to be reduced from 237,000 in 2007 to a maximum of 50,000 a year; and calls on the Government to restrict net inward migration to 50,000 a year and to withdraw from European agreements that remove the UK's ability to control immigration.

Damian Green (397) Language schools and the points-based system tier 4 review – That this House is concerned that the proposals in the Home Office consultation regarding limiting Tier 4 student visas to only higher educational institutions would have serious consequences for genuine language schools; recognises the role English language schools play in local communities and economies; is extremely concerned about abuses of the student visa system for immigration purposes; and calls on the Government to crack down on bogus colleges and students, but opposes unnecessary restrictions on the applications of students to legitimate language schools.

Sectarianism

Bill Butler (S3W-29199): To ask the Scottish Executive how many anti-sectarianism events the First Minister has attended in 2009, broken down by (a) date, (b) venue and (c) organisations involved.

Fergus Ewing: The First Minister has hosted anti-sectarian events and has seen the positive outcomes of Sense over Sectarianism twinning schools projects for himself. He regularly has meetings and events with stakeholders which involve tackling sectarianism, such as his address to the Edinburgh Inter Faith Association in St John's Church on 22 January, the meeting he hosted with faith leaders at Bute House on 16 June and his annual meeting with Action of Churches Together in Scotland, which took place in the Scottish Parliament on 4 November.

Lead responsibility for this area of work rests with me, as Minister for Community Safety, and I regularly visit anti-sectarian projects and initiatives to see the positive impact these are having on our communities. I was delighted that some of these projects were featured at the event I hosted, to celebrate the achievements of those who are delivering initiatives to tackle sectarianism at the Scottish Youth Theatre on 23 November, and which I am pleased you were able to attend.

Westminster Parliamentary Question

Anti-Semitism

David Amess[303921]: To ask the Secretary of State for Culture, Media and Sport what recent steps he has taken to reduce the incidence of anti-Semitism in (a) football and (b) other sports; what recent representations he has received on that matter; what recent meetings he has had with the Football Association on that matter; and if he will make a statement.

Reply from Gerry Sutcliffe: While I have received no recent representations or held any recent meetings on the issue of tackling anti-Semitism in sport, I remain fully committed to a sporting landscape free from all forms of discrimination. To this end:

- (a) Football treats anti-Semitism as it does all forms of racism as an offence under the ground regulations, giving the clubs and Police powers to deal with it should it occur. The Football Association's (FA) close working relationship with the clubs, the Police and the Crown Prosecution Service also ensures that all incidents of discrimination in football are brought to justice. In addition, The FA's anti-Semitism and Islamophobia working group, chaired by my hon. Friend the Member for Bassetlaw (John Mann) and established in July 2008, continues to explore the issues and make recommendations to the FA Board. With the Premier League and the Professional Footballer's Association, the FA also provides funding for the "Kick It Out" campaign, which tackles anti-Semitism and other forms of discrimination.
- (b) Other sports that receive Government funding through Sport England and UK Sport do so on the basis of their compliance with the Equality Standard for Sport. The standard forbids discrimination on the grounds of gender, marital status, race, colour, religion, disability, age, occupation, religion or political opinion other than that in accordance with legal justification.
