### Holyrood Parliamentary Motion

**S3M-5591 Christina McKelvie: Stop the Traffik**—That the Parliament supports the work of Stop the Traffik, the international campaign against people trafficking; notes that people trafficking is a growing concern, with up to an estimated four million men, women and children being trafficked across borders and within their own countries every year; joins Stop the Traffik's 1,000 member organisations in 50 countries worldwide in condemning the outrage of this ongoing enslavement of human beings; further notes the reported success that Stop the Traffik has had in forcing Cadbury, Mars and Nestlé to reduce the amount of chocolate that they use from Côte d'Ivoire, where thousands of children whom have been trafficked are used to harvest the cocoa beans that make over a third of the world's chocolate; endorses the campaigns at [www.stophetraffik.org](http://www.stophetraffik.org) to encourage confectionary manufacturers to increase their use of certified fairly traded cocoa beans, to encourage business travellers to learn how to recognise and report incidences of trafficking and to raise awareness of the dangers of the 2012 Olympic Games being used as an opportunity by people traffickers, and congratulates the Rev John Carswell and his colleagues at Cadzow Parish Church in Hamilton on organising a fundraising and awareness-raising concert in aid of Stop the Traffik, which will take place on the evening of 20 February 2010.

## Westminster Ministerial Statement

### Immigration and Nationality Services (Charges)

**The Minister for Borders and Immigration (Mr. Phil Woolas):** My right hon. Friend the Secretary of State for the Home Department is today laying regulations for the fees for immigration and nationality services that are set at levels above the normal administrative costs of the service. The Government review the fees on a regular basis and makes appropriate changes as necessary. We have continued with our strategic approach to charging; setting certain fees above cost on the basis of the value of the service.

These fees must be set out in regulations before both Houses of Parliament and are subject to the affirmative procedure. The fees for these applications allow us to generate revenue which is used to fund the UK immigration system and to set certain fees below cost recovery to support wider Government objectives. The revenue generated will contribute towards the development and delivery of the new points based system, the rollout of ID cards for foreign nationals and investment in IT capability both overseas and in the UK. This coming year we will continue to strengthen that capability in underpinning technology and process improvement. For transparency, I have included the estimated unit cost for each route, so that it is clear the degree to which certain routes are set above cost.

We have succeeded in limiting the extent of our general increases, by taking a more targeted approach to fees adjustment which is consistent with both the UK Border Agency's strategic charging principles, and also with broader Government objectives. We have made several amendments to the UK settlement fees and we have proposed a nominal 10 per cent. fee for all applications for UK-based dependants to reflect the fact that each individual brings a processing cost to us. Full details of all fees changes are outlined in the explanatory memorandum accompanying these regulations.

Finally we will continue to generate revenue to fund the transitional impacts of migration. The migration impacts fund has played a vital role in helping ease the pressures on certain communities.

I am publishing today the fees for immigration and nationality services that are set at levels above the normal administrative costs of the service alongside these regulations. I will announce our proposals for the fees for immigration and nationality fees that are set below the administrative costs of the service when we lay negative regulations in February 2010.

The Office for National Statistics collects data on nationality on the Annual Population Survey which covers residents of the UK. The latest estimates available are for the 12 month period of April 2008 to March 2009. The estimates of the number of UK residents for each other EU member state are given in Table 1.

**Reply from Phil Woolas:** The United Kingdom Border Agency does not keep a central record of the level of courses proposed by student visa applicants. The information requested could therefore be obtained from individual records only at disproportionate cost.

Between April and September 2009, 264,205 applications were received and 180,773 visas issued under Tier 4 of the Points Based System (Students).

**Mark Oaten:** To ask the Secretary of State for the Home Department how many colleges which have had tier 4 sponsor licences revoked are registered with Companies House. [311359]

**Reply from Phil Woolas:** As at 14 January, 13 education providers have had their Tier 4 sponsorship licence revoked, of which 11 are registered with Companies House.

**Mark Oaten:** To ask the Secretary of State for the Home Department how many visa applications have been made to study in (a) higher education institutions, (b) further education colleges, (c) sixth form colleges and (d) schools in the UK since March 2009. [311737]

**Reply from Phil Woolas:** The United Kingdom Border Agency does not keep a central record of the types of educational establishments proposed by student visa applicants. The information requested could therefore be obtained from individual records only at disproportionate cost.

Between April and September 2009, 264,205 applications were received and 180,773 visas issued under Tier 4 of the Points Based System (Students).

### Entry Clearances: Overseas Students

**Virendra Sharma:** To ask the Secretary of State for the Home Department how many colleges approved by the UK Border Agency between December 2008 and December 2009 were subsequently suspended and their licence either not issued or cancelled. [311858]

**Reply from Phil Woolas:** Of the colleges admitted to the Register of Sponsors for Tiers 2, 4 and 5 during the period 1 December 2008 and 31 December 2009 as of 18 January 2010 the UK Border Agency has revoked the licences of 13 sponsors and suspended a further 85. The figure quoted is not provided under National Statistics protocols and has been derived from local management information and is therefore provisional and subject to change.

**Virendra Sharma:** To ask the Secretary of State for the Home Department how many students who failed to attend college or to pay their fees were returned to their country of origin between December 2008 and December 2009. [311859]

**Reply from Phil Woolas:** The information requested is not centrally recorded and could be obtained only at disproportionate cost.

**Virendra Sharma:** To ask the Secretary of State for the Home Department how many student spouse visas were issued from the beginning of December 2008 to December 2009. [311860]

**Reply from Phil Woolas:** With the introduction of tier 4 of the points based system (students) on 31 March 2009, the UK Border Agency kept a separate record of visas issued to partners of students. Hitherto, both partners and children of students were recorded in the same category, "Student Dependent".

### Detention Centres: Children

**Jim Cunningham:** To ask the Secretary of State for the Home Department what his assessment is of progress made in improving provision for families with children at immigration removal centres; and how much has been spent on making such improvements in the last 12 months. [310109]

**Reply from Phil Woolas:** We take the welfare of children in our care very seriously and are proud of the investment made to improve services at Yarl's Wood over the last couple of years, the main centre for holding families with children. These include:

- A dedicated Ofsted inspected school delivering 30 hours per week of tuition by qualified teachers for children aged five-16 years.
- A crèche staffed seven days a week from nine-five by appropriately qualified child care professionals for children under school age.
- Professional supervision and support for teaching staff, in the form of oversight from the head teacher of another establishment.
- Establishment of a softer and more child-focused reception area and further provision of age-appropriate activities such as a bouncy castle, and a library of games and toys for use in the children's rooms.

- Relocation of the youth club to a larger room with access to grassed outside play area.
- The introduction of a fortnightly children's forum and development of dedicated children's complaints forms.
- The provision of a midwife, healthcare visitor, paediatric nurse and child counselling services.

The improvements we have made have been considered and acknowledged by the likes of the Children's Commissioner for England, the Independent Monitoring Board and HM Chief Inspector of Prisons.

At the same time, we have recently conducted an internal review of the services provided at other centres where children may be detained. This highlighted a number of areas where improvements need to be made at Tinsley House. A programme of improvement has commenced, and while this is being undertaken, we have taken the decision to reduce the maximum period of stay for families with children from 72 hours to 24 hours.

Services provided for children are funded within the operating contracts for centres, the value of which is commercially confidential. It is therefore not possible to provide a figure on how much has been spent on improvements in the last 12 months.

### Detention Centres: Children

**Greg Mulholland:** To ask the Secretary of State for the Home Department what recent discussions he has had with the UK Border Agency on policy on detention of children in immigration removal centres. [311098]

**Reply from Meg Hillier:** I recently assumed responsibility for overseeing the policy surrounding the detention of children for the purposes of immigration control and held discussions with UK Border Agency officials about the main policy issues in December. Families with children are detained only where they have failed to leave the UK voluntarily despite the courts having upheld a decision of the UK Border Agency that they have no legal basis of stay in the country. Detention is necessary to effect removal in these circumstances. We aim to keep such detention to the minimum period necessary and, to this end, it is subject to frequent and rigorous review, including ministerial scrutiny in those minority of cases where detention lasts for 28 days or more.

### Repatriation: Expenditure

**Dominic Grieve:** To ask the Secretary of State for the Home Department how much was spent on the reintegration scheme in 2008-09. [311017]

**Reply from Phil Woolas:** Reintegration assistance to support enforced and voluntary removals is provided by Assisted Voluntary Returns programmes and the Facilitated Returns Scheme.

The cost of the 2008-09 Voluntary Assisted Return and Reintegration programmes is currently not available as it is subject to audit, which will be made available in spring 2011.

The chief executive of the UK Border Agency will provide information to the Home Affairs Committee on FRS expenditure when she writes in January 2010.

not part of the court system in England and Wales, and are not unified under one system. Marriages conducted under sharia law are not legally recognised in England and Wales unless they also comply with the provisions of the Marriage Act 1949. The English and Welsh courts do not legally recognise divorces granted by any faith groups. The Government do not maintain statistics on either marriages or divorces conducted by sharia councils.
