# Westminster Ministerial Statement

### **UK Border Agency Strategy**

**The Minister for Borders and Immigration (Mr. Phil Woolas):** I am today publishing a new strategy entitled "Protecting our Border, Protecting the Public". Copies will be available in the Vote Office and in the Libraries of both Houses.

Since its creation in 2008, the UK Border Agency has become one of the UK's largest law enforcement bodies, operating across the UK and in 135 countries overseas. It stands at the forefront of efforts to protect the United Kingdom from overseas threats posed by dangerous people, goods and materials, while at the same time enforcing our immigration rules and facilitating the flow of legitimate travel and trade on which our economy depends.

This document both clarifies the extent of our law enforcement activities and sets out our vision as to how, over the next five years, we will develop our capability to protect the public from the harm caused by illegal immigration and smuggling. It also sets out how the agency will support the work of its criminal justice partners in tackling non-immigration crime committed by foreign nationals in the UK.

In support of the wider Government priority of tackling organised crime, the document identifies tackling organised immigration and smuggling crime as a key priority for the

agency, with particular focus on the detection of class A drugs at the border and the targeting of groups that facilitate illegal entry or stay in the UK. The underlying themes of the strategy include encouraging compliance with our immigration rules, the benefits of disrupting criminal activity before it reaches our shores and greater targeting of the assets of criminal groups.

Tackling border and immigration crime and protecting the public is a responsibility that the UK Border Agency shares with law enforcement partners, such as the police and Serious and Organised Crime Agency. The UK Border Agency has much to contribute, for example through the e-Borders programme; but success will be multi-agency. We already have strong partnership arrangements; our regional immigration crime teams for example, are comprised of both border agency and seconded police officers. We also have local immigration teams across the country that work alongside the police, HM Revenue and Customs, local authorities and other local partners to ensure compliance with, and enforce, our immigration laws.

This strategy explains our relationship with the wider law enforcement community and sets out how we will work more closely together to deter, disrupt, detect and deal with crime, in order to make the UK a hostile environment for criminals and a safer place for the public.

# **Westminster Parliamentary Questions**

#### Visas

**Lord Marlesford:** To ask Her Majesty's Government whether visas for immigrants are granted in response to requests from companies which are having difficulty in finding bus drivers; and, if so, how many such visas have been granted in the last 12 months. [HL1691]

**Reply from Lord West of Spithead:** Bus driving is not registered as a skill shortage under tier 2 of the points-based system.

**Lord Crisp:** To ask Her Majesty's Government why citizens of Pakistan are required to leave their passports with the Consulate whilst applying for a United Kingdom visa, thus precluding their travel elsewhere. [HL1853]

**Reply from Lord West of Spithead:** In accordance with the Immigration Rules (paragraph 320(3)), all visa applicants are required to produce a valid national passport or other document satisfactorily establishing their identity and nationality. These checks need to be carried out by the Entry Clearance Officer prior to fixing a vignette sticker into the passport, when a visa is granted. If the passport has to be handed back during the decision phase, and the applicant then recalled when the decision is made, this will complicate the process and could cause delays, and inconvenience, to applicants.

**Lord Crisp:** To ask Her Majesty's Government whether they make or will make special arrangements for academics from Pakistan who collaborate on a regular basis with British academics to have their visas to the United Kingdom expedited. [HL1854]

**Reply from Lord West of Spithead:** Our general policy is to deal with visa applications strictly in turn. We believe that to give priority to applications in any particular category would be unfair to other applicants. We will, however, prioritise individual applications if necessary e.g. if there are urgent, compassionate circumstances.

Current waiting times in Islamabad are three weeks; applicants are advised to take this into account before making an application.

**Lord Laird:** To ask Her Majesty's Government how many dependants of students from countries outside the European Union granted visas to study in the United Kingdom have themselves been granted visas and admitted in the past five years. [HL1975]

**Reply from Lord West of Spithead:** The latest available statistics relating to the number of dependants of students (1) granted visas (prior entry clearance) and (2) admitted to (given leave to enter) the United Kingdom, excluding EEA and Swiss nationals, in the five calendar years from 2004 to 2008, are given in the table below. Data for 2009 are scheduled for publication in August 2010.

Statistics on passengers given leave to enter the United Kingdom by country of nationality and purpose of journey are published annually in the series "Control of Immigration: Statistics United Kingdom". ### **Entry Clearances: Overseas Students**

**Frank Field:** To ask the Secretary of State for the Home Department how many Tier 4 student applications are pending in each consulate in the Indian sub-continent as a result of the suspension of processing; how many dependants are included in such applications; whether such applications will be considered against the criteria in force at the time of their application or under the new criteria; and whether applicants enrolled in education institutions which have subsequently had their licence to sponsor suspended or revoked will be refused a visa. [317851]

**Reply from Phil Woolas:** The suspension of tier 4 student visa applications in North India, Bangladesh and Nepal on 1 February means that we are not accepting any new applications in this category. No applications, including those from dependents, are therefore pending as a result of the suspension.

Applications submitted before 1 February are being processed as normal against the criteria in force at the time of their application.

The suspension will be lifted in North India from 1 March for tier 4 students intending to undertake higher education courses (foundation degree, undergraduate, postgraduate)

Applicants intending to study at educational institutions which have had their sponsor licence subsequently revoked will not meet the requirements for entry and will be refused a visa. In cases where the sponsor licence has been suspended, a decision on the visa application will be deferred until a decision is made on whether to revoke or re-instate the licence.

### **Immigration: Deportation**

**Baroness Warsi:** To ask Her Majesty's Government how many foreign national prisoners were deported in each of the last three years. [HL1871]

Reply from Lord West of Spithead: Published figures for the UK Border Agency show that in 2007 over 4,200 foreign national prisoners were removed or deported, in 2008 almost 5,400 were removed or deported and in quarters 1-3 of 2009 3,890 were removed or deported. ### Immigration: Yarl's Wood

**Lord Hylton:** To ask Her Majesty's Government what assessment they have made of the cause of the recent hunger strike at Yarl's Wood Detention Centre; how many people were arrested; how many suffered injuries; and how many were locked down within the Centre. [HL2010]

**Reply from Lord West of Spithead:** A passive protest was undertaken by some of the residents of Yarl's Wood Immigration Removal Centre over the weekend of 6 to 7 February which was resolved on Monday 8 February.

No arrests were made although four women were detained by Bedford Police under immigration administrative powers. The incident was resolved without any use of force.

One woman sustained a minor cut to her finger for which medical treatment was given.

In total, 47 women were involved in the disturbance, in three different parts of the centre.

The incident is subject to a management review.

### Asylum Seekers

**Baroness Warsi:** To ask Her Majesty's Government how many asylum cases they are dealing with; and how many of them are legacy cases. [HL1857]

Reply from Lord West of Spithead: In 2008 asylum intake was 25,935.

Published figures show that at the end of September 2009 there were 9,300 asylum applications (excluding dependents) awaiting an initial decision.

Information on asylum applications is published annually in the Control of Immigration: Statistics United Kingdom bulletin and on a quarterly basis in the Control of Immigration Quarterly Statistical Summary.

### **Asylum Seekers: Deportation**

**Baroness Warsi:** To ask Her Majesty's Government further to the Written Answer by Lord West of Spithead on 15 December 2009 (WA 192), how many of the 9,275 failed asylum seekers have now been removed. [HL1723]

**Reply from Lord West of Spithead:** Of the 9,275 unsuccessful removals of failed asylum seekers for the period 1 April 2008 to 30 November 2009, 4,303 have since been successfully removed from the UK (2,754 in financial year 2008-09, and 1,549 in financial year 2009-10 to 5 February). These figures do not constitute part of National Statistics as they are based on internal management information. The information has not been quality assured under National Statistics protocols and should be treated as provisional and subject to change.

**Baroness Warsi:** To ask Her Majesty's Government further to the Written Answer by Lord West of Spithead on 3 December 2009 (WA 63), how much money was spent on removing failed asylum seekers in each of the last three years. [HL1728]

**Reply from Lord West of Spithead:** It is not possible to provide a definitive figure on how much money is spent on removing failed asylum seekers. As I previously explained in my answer of 3 December 2009 (WA 63), due to the many different factors which may or may not be involved in the cost of a removal, we are unable to disaggregate the specific costs and any attempt to do so would incur disproportionate cost.

### Immigration: Fraud

**Daniel Kawczynski:** To ask the Secretary of State for the Home Department how many foreign-born nationals have been permitted to retain (a) their UK citizenship and (b) indefinite leave to remain subsequent to their documentation being found to be fraudulent in each year since 2005. [317731]

**Reply from Phil Woolas:** The information requested as to how many were permitted to retain citizenship since 2005 could be obtained by the detailed examination of individual records only at disproportionate cost. Although no one has been deprived of British citizenship, on the basis that that status was acquired on the basis of fraud, since 2005, the UK Border Agency has recently implemented a new deprivation policy and are pursuing deprivation action in a number of cases.

As regards indefinite leave to remain, a person who obtains (or seeks to obtain) leave to remain by deception is liable to removal under section 10 of the Immigration and Asylum Act 1999. We do not however have records for those that have been identified as using deception but have none the less been allowed to retain their indefinite leave to remain, as these could be obtained by the detailed examination of individual records only at disproportionate cost.

#### **Human Trafficking: Victims**

**Jim Cunningham:** To ask the Secretary of State for Justice what recent steps his Department has taken to support victims of human trafficking. [316986]

**Reply from Maria Eagle:** From 2003-09 we invested £5.8 million in the Poppy Project to provide specialist support to women trafficked into sexual exploitation only. Over the current and next financial year we have invested an additional £3.9 million in the provision of specialist support to victims of all forms of human trafficking, including victims of sexual exploitation, domestic servitude and forced labour. This includes as a minimum: safe accommodation; advocacy; access to counselling; access to legal advice and interpretative services.

A National Referral Mechanism (NRM) has been put in place to systematically identify victims and refer them to specialist support. Identified victims are granted an extendable 45-day recovery and reflection period in which to consider their options and access specialist support services, and one-year temporary residency permits in certain circumstances.

A victim's information leaflet, produced in October 2009 is now available in a range of languages. The leaflet provides information for victims on the support available to them, their options and legal rights.

# **Westminster Early Day Motions**

**Diane Abbott (890) Asylum Seeker Support** – That this House is concerned by the low level of support provided for asylum seekers; notes that the current level is below subsistence; further notes that a single 25-year-old adult seeking asylum receives £35.13 a week which is 55 per cent. of income support and which equates to just £5 per day; is further concerned at the level of destitution faced by asylum seekers as a result of this low level of support; believes that this policy drives asylum seekers into social exclusion rather than alleviates them from it; recognises that this is a punitive measure and not a form of welfare designed to allow asylum seekers adequately to subsist during an application; and urges the Government to consider raising the asylum support subsistence payment to a minimum of £45 a week, representing 70 per cent. of income support, for single adults.

**John McDonnell (919) Hunger strike at Yarl's Wood immigration removal centre** – That this House notes that women detained in Yarl's Wood Immigration Removal Centre have been on hunger strike since 5 February 2010 in protest against being detained for up to two years; condemns the detention of victims of rape and other torture, of mothers separated from their children and anyone who does not face imminent removal; believes that such detention flouts international conventions and UK immigration rules; requests

that HM Inspector of Prisons urgently carries out an independent investigation into reports of violence, mistreatment and racist abuse from guards, being kettled for over five hours in a hallway, denied access to toilets and water and locked out in the freezing cold, which women have made to their lawyers, the media and supporters, including the All African Women's Group and Black Women's Rape Action Project; and calls for a moratorium on all removals and deportations of the women who took part in the hunger strike pending the results of that investigation.

## **Westminster Petition**

#### **Bristol Refugee Rights**

The Petition of supporters of Bristol Refugee Rights and others, Declares that Britain has an international obligation to provide sanctuary to people fleeing conflict or persecution; declares that three quarters of those seeking safety here are refused protection, but that many cannot go back to their home country; further declares that people in this situation are not allowed to work or claim benefits, and frequently become destitute rather than go back to countries where they would be in real danger; further declares that the Petitioners believe that such people deserve to be treated fairly, humanely and with dignity.

The Petitioners therefore request that the House of Commons calls on the Government to grant temporary protection to people who cannot return to their countries of origin; to end the threat and use of destitution as a tool of Government policy against refused asylum seekers; and to allow asylum seekers, including those whose application has been refused, the right to work if they have not been given a decision and/or they cannot leave the UK after six months. # Observations from the Secretary of State for the Home Department, received on Monday 22 February 2010:

The United Kingdom has a long and proud tradition of providing protection to those who need it and considers all protection claims carefully, on their individual merits, and in accordance with our legal obligations. All asylum claims are considered on their individual merits in accordance with the 1951 United Nations Convention Relating to the Status of Refugees and the European Convention on Human Rights, against the background of the latest accurate, objective, sourced and up-to-date information on asylum seekers' countries of origin produced by the UK Border Agency Country of Origin Information Service.

Asylum and human rights applicants that are found to be in need of protection are granted it. Those found not to be in need of protection have a right of appeal to the independent appellate authorities. In this way we ensure that we provide protection to those asylum seekers who need it. Where a decision has been made that a person does not require international protection, and there are no remaining rights of appeal or obstacles to their return, unsuccessful asylum seekers are expected to return voluntarily to their country of origin. Return and reintegration assistance is available through the International Organization for Migration.

The Government do not have a policy of destitution. The asylum support policy is properly balanced. No person who has sought protection need be destitute whilst they have a valid reason to be here. Asylum seekers who need support to avoid destitution are given it from the time they arrive in the UK until their claim is fully determined (appeal rights exhausted). Support takes the form of accommodation or subsistence or both.

## **Westminster Debate**

#### Privilege

**Andrew Dismore:** ... The Joint Committee on Human Rights met on 9 February to discuss a draft report on the Equality and Human Rights Commission. It emerged at the start of the meeting that Trevor Phillips, the chair of the EHRC, had recently spoken to at least three members of the Committee about its consideration of the draft report and the publication of written evidence with the report. In our view, these discussions could constitute a contempt of both Houses in that they may have been an attempt to influence the views of certain members of the Committee shortly before it considered a draft report directly relevant to Mr. Phillips in his role as chair of the commission. We therefore recommended that the matter should be subject to investigation by the privileges Committees of both Houses, and so I ask the House to refer the matter in accordance with my motion. ...

These reserved teachers must be appointed for their fitness and competence to teach

religious education according to the tenets of the relevant faith; they may account for up to a fifth of all the teaching staff and may include the head teacher. In these schools such religious criteria cannot be applied to any other teaching posts.

Specifically I have established the Scottish Working Group on Unacceptable Behaviour which brings together voluntary and non-governmental organisations working in this area.

The members of the Working Group have been supporting the redevelopment of the on-line anti-sectarian resource Sectarianism: Don't Give It, Don't Take It and are helping to shape a programme of activity to tackle abusive behaviour, including sectarianism, in football.

**Reply from Lord Bach:** The ethnicity of parties involved in a reported incident is not collected centrally. This information will not often be collected locally with reports submitted not always identifying parties involved in an alleged incident.

While ethnicity data is not always collected, information that is reported will be regularly scrutinised locally. This would include any issues regarding the victimisation of a particular group such as Gypsy, Traveller and Roma prisoners. We don't request that this information is reported centrally and to collate these data would require examination of every individual report submitted.

#### Anti-Semitism

**Chris Huhne:** To ask the Secretary of State for the Home Department (1) pursuant to the answer of 29 January 2010, *Official Report*, column 1127W, on anti-Semitism, whether figures on occurrences of anti-Semitism have been added to the annual data requirements for police community safety figures; [317145]

(2) with reference to the answer of 18 March 2009, *Official Report*, column 1154W, on anti-Semitism, whether the five data requirements of hate crime have been added to the annual police community safety figures; and what data has been collected on anti-Semitic incidents. [317103]

**Reply from Alan Johnson:** The Annual Data Requirement (ADR) has not yet been extended to cover crime data disaggregated by the five hate crime strands. The situation is being resolved in order that this data can be collected as part of the ADR from April 2011. This is the next occasion in the annual data cycle that this will be possible. The extension to the ADR will not enable us to disaggregate the data on racist offences in order that we can identify specific data on anti-Semitic crimes.

The ACPO National Community Tension Team (NCTT) has been collating data on anti-Semitic crimes since April 2008. The data are collated as an intelligence document and has not been published previously. We are seeking publication of this data at the earliest opportunity in order that indicative figures on anti-Semitic hate crime for the year 2009-10 can be made available.

Since becoming the cross-Government champion, the Minister has overseen the progress of the Internet Hate Crime Action Plan. This is part of the wider Cross Governmental Hate Crime Action Plan. Work on this plan has included the creation of an online reporting mechanism for hate crime on the internet.

**Reply from Jim Knight:** The administration of Jobcentre Plus is a matter for the Chief Executive of Jobcentre Plus, Darra Singh. I have asked him to provide the hon. Member with the information requested.

Letter from Darra Singh, dated 24 February 2010:

The Secretary of State has asked me to reply to your question asking how many complaints of racism have been made by Jobcentre Plus staff against other Jobcentre Plus staff in each of the last five years, broken down by smallest geographical area for which information is available. This is something that falls within the responsibilities delegated to me as Chief Executive of Jobcentre Plus.

The Department does not maintain any automated data to capture the volumes of formal complaints from current or former staff relating to race discrimination. Although Jobcentre Plus retains clerical information on official written complaints from existing or former members of staff; this data does not identify where complaints relate specifically to any allegations of racism.

Although formal investigations into allegations of harassment, bullying and discrimination are handled through our Department for Work and Pensions Human Resources Investigation Service, some complaints may be addressed separately through local management investigations and there is no available data to provide the requested information in full.

I am, therefore, unable to provide a more detailed reply.

#### **Forced Marriage**

**Mr. Evans:** To ask the Secretary of State for the Home Department (1) what steps his Department is taking to reduce the incidence of vulnerable people being forced to marry against their will as a result of a financial agreement between family members and a foreign national; [317260]

(2) what estimate he has made of the number of vulnerable people who have been forced to marry against their will as a result of a financial agreement between their family members and a foreign national seeking UK citizenship. [317261]

Mr. Alan Campbell: The Forced Marriage Unit (FMU) provides confidential information and assistance to potential victims of forced marriage, those who have already been forced to marry and concerned professionals. The FMU also works with partners both in the UK and overseas, to ensure that appropriate action is taken to prevent forced marriage taking place.

In the last two years over 1,600 incidences of suspected forced marriage were reported in each year to the FMU. Forced marriage is, by its nature, an underground practice and therefore detailed statistics on the scale of the problem and patterns of abuse are not fully known. While the FMU are aware of some of the key motivators for forcing a person to marry and have seen cases where both these issues appear to be a factor among those with learning and physical disabilities we do not collect specific data on the motivators as it is not always possible to clearly identify one particular cause.

However, data on the number of suspected incidences of forced marriage that involved a person with learning and or physical difficulties have been collected since August 2009. From August 2009 to the end of January 2010 at least 18 cases involving people with learning difficulties and seven cases involving people with physical difficulties were reported to the FMU.

In July last year the FMU published revised Multi-agency Practice Guidelines which provide step by step guidance for frontline professionals on how to deal with cases of forced marriage including cases that may involve children and adults with support needs.

The FMU are also funding research to look at the prevalence of forced marriage among those with learning disabilities. One of the objectives of the research will be to examine the motivations for forcing people with learning difficulties into marriage.

### Travelling People: Caravan Sites

**Robert Neill:** To ask the Secretary of State for Communities and Local Government with reference to the oral answer by the Parliamentary Under-Secretary of State of 14 July 2009, *Official Report*, column 69WH, on Travellers, what his Department's definition of (*a*) fairness and (*b*) equality is in relation to planning applications for sites for Gypsy and Traveller caravans. [317605]

**Reply from Shahid Malik:** Fairness and equality, in relation for the planning applications for Gypsy and Traveller sites, means that the law is applied equally to Gypsies and Travellers and to those of the settled community; any proposal for development must be considered purely on its planning merits taking account of all relevant planning matters.

**Robert Neill:** To ask the Secretary of State for Communities and Local Government what guidance (*a*) his Department and (*b*) the Planning Inspectorate has issued on the length of time a (i) traveller and (ii) demonstration encampment may be in place before it is deemed permanent for planning purposes; and how long temporary encampments may be in place before becoming rateable for (A) council tax and (B) business rate purposes. [317805]

**Reply from Shahid Malik:** The Planning Inspectorate has issued guidance on the length of time a (i) Traveller or (ii) a demonstration encampment may be in place before it is deemed permanent or authorised. The guidance issued by the Planning Inspectorate is in the form of the Inspectors Handbook, which covers professional planning matters dealt with by Inspectors. Annex E of ODPM Planning Circular 01/2006 'Planning for Gypsy and Traveller sites' states that planning permission may not be required for any development if the use of the land has been established over a period of time without valid planning enforcement action have been taken by the local authority.

No guidance has been issued by the Department for Communities and Local Government or the Planning Inspectorate on the length of time a temporary encampment may be in place before becoming rateable for council tax or business rates. No minimum period is defined by statute. It is established rating law that a transitory occupation of land does not amount to rateable occupation. Whether the necessary permanence of occupation has been established for liability to arise will depend on the facts in each case.

A Traveller<sup>(1)</sup> or demonstration<sup>(2)</sup> encampment can become permanent, and authorised, for planning purposes through the express grant of planning permission for such a use, unencumbered by a condition limiting its use to a specified period, or by the imposition or removal of an appropriate condition attached to an existing planning permission by the formal process set out in s.73 and 73 A of the Town and Country Planning Act 1990. The only other means by which a use of land can become lawful is where it continues, uninterrupted and in essentially the same form, for a period of 10 years and the evidence exists to prove that this has occurred, on the balance of probabilities, such that a Certificate of Lawful Development under s.191 of the Town and Country Planning Act 1990 can be granted. In a similar way a use can become immune from enforcement action under S.171B of the 1990 Act after a period of 10 years, if a local planning authority has not taken enforcement action before that time.

**Robert Neill:** To ask the Secretary of State for Communities and Local Government whether unmet need for traveller sites is a material consideration in the planning process when considering a retrospective application of the development of an unauthorised traveller site. [317879]

**Reply from Shahid Malik:** ODPM Circular 2001-06 Planning for Gypsy and Traveller Caravan Sites confirms that unmet need for Gypsy and Traveller sites is one of several material considerations which decision makers should take into account when determining planning applications. The material considerations relevant to a retrospective application for the development are no different for those submitted prospectively.
