# Immigration and Asylum

### **Holyrood Parliamentary Questions**

#### Immigration

**George Foulkes (Lothians) (Lab):** To ask the Scottish Executive what discussions it has had with the UK Government regarding different immigration criteria for Scotland and what response it has received. (S3W-36440)

**Reply from Fiona Hyslop:** The Scottish Government has responded to the UK Government's consultation on how the mechanism for its proposed cap on immigration should operate. Our opposition to an annual limit on immigration is based on the potentially serious economic consequences for Scotland.

## Immigration and Asylum Holyrood Parliamentary Questions (continued)

**Reply from Fiona Hyslop:** The Council of Economic Advisers recommended that the Scottish Government undertake more research to better understand migration and to explore the factors affecting the decisions of both immigrants and emigrants. The Scottish Government accepted this recommendation, and we have undertaken an in-house review of research and statistical evidence to update our understanding of migration and emigration.

#### Asylum Seekers

**Johann Lamont (Glasgow Pollok) (Lab):** To ask the Scottish Executive whether it has sought information on how many children of asylum seekers were detained at Dungavel Immigration Removal Centre between January and August 2010 and, if so, what response it received. (S3W-36230)

**Reply from Michael Russell:** Unfortunately, the UK Border Agency does not provide statistical information on a month-by-month basis. However, it has published reports for the first two quarters of 2010 which are available on the UKBA website at:

http://rds.homeoffice.gov.uk/rds/immigration-asylum-publications.html.

According to these reports a total of 25 children entered Dungavel detention centre before the end to the overnight detention of children in May 2010. However, they do not specify if the children were those of asylum seeking families.

2 (April 201 to June 2010)	5

These figures are not subject to independent checks and therefore may not be wholly accurate. Some detainees may be recorded more than once, for example the person may have been detained on more than one separate occasion in the time period shown, such as a person who has left detention, but has subsequently been re-detained.

**Johann Lamont (Glasgow Pollok) (Lab):** To ask the Scottish Executive whether it has sought information on how many children of asylum seekers initially registered in Scotland were detained in removal centres in England between January and August 2010 and, if so, what response it received. (S3W-36231)

**Reply from Michael Russell:** This information is not collected by the UK Border Agency.

Christina McKelvie (Central Scotland) (SNP): To ask the Scottish Executive whether it is satisfied that dawn raids on asylum seeker families have ended. (S3W-36404)

**Reply from Alex Neil:** This government has made very clear its opposition to dawn raids and to the enforced removal and detention of children. The Minister for Culture and External Affairs, Fiona Hyslop, wrote to Damian Green, the UK Government's Minister for Immigration, on 9 September 2010 asking for urgent clarification of the UK Government position and urging him not to renege on the promise to end child detention. We will continue to pursue this issue with UK Government ministers until they deliver on this commitment.

**Christina McKelvie (Central Scotland) (SNP):** To ask the Scottish Executive whether it will enhance the assistance that it gives to asylum seekers and, if so, how. (S3W-36405)

**Reply from Alex Neil:** Asylum support (accommodation and cash support) for asylum seekers is a matter for the UK Border Agency. However, through the Race, Religion and Refugee Integration Funding Stream the Scottish Government has provided £5.6 million for the period 2008-11 to improve the lives of minority ethnic and faith communities in Scotland including refugees and asylum seekers, migrant workers and gypsies/travellers.

No decisions have been made regarding funding post 2011 which will be subject to the spending review.

### **Westminster Parliamentary Questions**

#### **People Trafficking**

**Lord Hylton:** To ask Her Majesty's Government what steps they are taking to raise awareness of human trafficking into and within the United Kingdom, to increase reporting and to gain evidence usable in prosecutions.[HL2063]

**Reply from the Minister of State, Home Office (Baroness Neville-Jones):** Within law enforcement agencies, awareness of human trafficking is being raised through mainstream police training courses and by the introduction of mandatory e-learning for all UK Border Agency staff below grade seven level.

In addition, it has been decided that 18 October will be the UK Anti-Slavery Day which will provide a focus for non-government organisations to undertake awareness-raising campaigns and encourage people to become actively involved in the campaign against this crime.

The Government keep legislation under constant review to ensure that it is fit for purpose. The Crown Prosecution Service (CPS) will be holding a consultation with victims of trafficking to discuss experiences of the criminal justice system and to identify possible measures to improve levels of engagement with the criminal justice system. This will lead to the publication of a public policy statement to explain how cases of human trafficking are prosecuted and encourage victims to support criminal proceedings.

**Baroness Thornton:** To ask Her Majesty's Government why they refused to sign the new draft European Union directive on human trafficking.[HL2073]

**Reply from Baroness Neville-Jones:** The Government decided not to opt in to the directive at the outset, but to review the position once the directive has been agreed. We still have the option of applying to opt in later.

While the directive will help to improve anti-trafficking efforts across the EU, it will make little practical difference to the way the UK fights trafficking. The UK is already bound by the Council of Europe Convention on Action Against Trafficking in Human Beings, which contains similar provisions on non-prosecution of victims.

The UK has a strong record in the fight against trafficking and already complies in both legislation and practice with most of what is required by the draft directive.

### **Parliamentary Question**

#### **Forced Marriages**

**Lord Lester of Herne Hill:** To ask Her Majesty's Government what is their assessment of the effect of the increase in the minimum age at which the spouse of a British citizen may be sponsored for entry into the United Kingdom on the length of time those in forced marriages remain against their will in foreign countries.[HL1961]

**Reply from the Minister of State, Home Office (Baroness Neville-Jones):** The minimum age at which someone can sponsor a spouse to come to the UK or be sponsored as a spouse was raised from 18 to 21 via a change to the Immigration Rules on 27 November 2008.

There is no full or reliable data available on the numbers of British citizens kept overseas against their will following a forced marriage.

Therefore we cannot assess whether the increase in the marriage visa age has had any impact on the length of time British citizens are kept overseas against their will following a forced marriage.

A strategic decision was taken to raise the marriage visa age to 21 to provide an opportunity for individuals to develop maturity and life skills which may allow them to resist the pressure of being forced into a marriage and provides an opportunity to complete education. It aims to delay sponsorship and allow the victim an opportunity to seek help and advice.
