Westminster Ministerial Statement

Immigration Rules

The Minister for Immigration (Damian Green): On 28 June 2010 the Home Secretary set out our proposals for an annual limit on the number of non-EU economic migrants admitted into the UK to live and work, including an interim limit for the tier 1 (general) and tier 2 (general) categories of the points-based-system.

On the same date we laid a Statement of Changes in Immigration Rules (HC 59) to implement the interim limit for the tier 1 (general) category, the category for highly skilled workers who do not require a job offer before coming to the UK.

In the case of tier 2 (general), the category for sponsored skilled workers with a job offer, the interim limit will be applied by limiting the number of certificates of sponsorship which licensed tier 2 (general) sponsors are authorised to issue. We previously considered that this does not require changes to the immigration rules. However, subsequent legal decisions have made the position less clear. For the avoidance of doubt, I am laying

changes today which make explicit provision for the Secretary of State to limit both the number of certificates of sponsorship that may be assigned to points based system sponsors overall during any particular period, and the number of certificates of sponsorship that may be assigned to individual sponsors.

As the Home Secretary set out in her statement on 28 June 2010, the total number of certificates of sponsorship that sponsors are authorised to issue under tier 2 (general) will be set at a level that achieves a reduction of 1,300 in the number of migrants admitted under this category in the equivalent period a year previously. The tier 2 interim limit will not apply to intra-company transferees, ministers of religion or to elite sportspeople, nor will it apply to dependants of tier 2 migrants.

The UK Border Agency's sponsor management team has already contacted sponsors in connection with the implementation of this interim limit, and will be writing to each sponsor individually to advise them of how the interim limit affects their allocation of certificates of sponsorship.

Westminster Parliamentary Questions

Entry Clearances: Overseas Students

Laura Sandys: To ask the Secretary of State for the Home Department (1) how many pages of guidance the UK Border Agency has issued to licensed sponsors in the last 24 months; [5120]

(2) how many institutions have had their licences revoked since the roll-out of tier 4 of the points-based immigration system; and how many of these were (a) Highly Trusted Sponsors, (b) accredited by the British Council and (c) inspected by Ofsted. [5121]

Reply from Damian Green: In the last two years the UK Border Agency has issued 1,501 pages of guidance to licensed sponsors covering tiers 2, 4 and 5. This will include reissue of guidance on specific tiers. At present the tier 2 and 5 guidance stands at 83 pages and the tier 4 guidance at 70 pages.

As at 30 June 2010, 47 sponsors have had their tier 4 licence revoked since 31 March 2009. Of these none held a Highly Trusted Sponsor licence, five were accredited by the British Council and none was inspected by Ofsted.

Laura Sandys: To ask the Secretary of State for the Home Department how many illegal migrants identified in the last 12 months, who initially entered the UK through the student visa system, had been sponsored by Highly Trusted Sponsors. [5123]

Reply from Damian Green: The number of illegal migrants identified in the last 12 months, who initially entered through the student visa system and who are now being sponsored by a Highly Trusted Sponsor is nil. The Highly Trusted Sponsor scheme came into force on 6 April 2010.

Lord Roberts of Llandudno: To ask Her Majesty's Government whether they will produce information packs in European languages about life in the United Kingdom, to be made available to prospective migrant workers in the European Union.[HL615]

Reply from the Minister of State, Home Office (Baroness Neville-Jones): There are no plans to produce any information packs for prospective migrant workers from the European Union.

Work Permits

John Mann: To ask the Secretary of State for the Home Department how many work permits were issued in 2009; and how much revenue her Department obtained as a result. [6904]

Reply from Damian Green: In 2009, there were 9,985 work permits issued and the revenue generated was £883,300. The work permit scheme closed for new applications in November 2008 and was replaced by Tiers 2 and 5 of the Points Based System. Under these Tiers, licensed sponsors issue Certificates of Sponsorship (CoS) not work permits. Sponsors pay UKBA a fee for each CoS they issue. In 2009, sponsors issued 54,630 Certificates of Sponsorship under Tier 2 and the total revenue was £11,429,100.

Worker Registration Scheme

Lord Roberts of Llandudno: To ask Her Majesty's Government whether nationals of the A8 countries will enjoy the same freedoms and rights in the United Kingdom as other European Union nationals after the end of the worker registration scheme on 30 April 2011.[HL98]

To ask Her Majesty's Government whether nationals of the A2 countries will enjoy the same freedoms and rights in the United Kingdom as other European Union nationals after the end of the worker registration scheme on 31 December 2011.[HL99]

Reply from the Minister of State, Home Office (Baroness Neville-Jones): Under the terms of the accession treaty, transitional measures relating to labour market access for nationals of member states that acceded on one May 2004 must end by 30 April 2011. The worker registration scheme must cease to apply to nationals of those countries from that date. When the scheme ends they will enjoy the same rights as other European Union nationals in terms of their freedom to take employment in the United Kingdom. Nationals of Bulgaria and Romania are not subject to the worker registration scheme and are instead subject to separate work authorisation requirements. These restrictions will continue until 31 December 2011, and under EU law may, in the event of a serious disturbance to the labour market, be extended until 31 December 2013. The Government will apply transitional controls as a matter of course in the future for all new EU member states.

Immigration Controls

Wayne David: To ask the Secretary of State for the Home Department what plans she has for an annual limit on the number of immigrants to the UK. [4924]

Reply from Damian Green: On 28 June the Government launched a 12 week consultation with businesses and other interested sectors on our plans for implementing annual limits on non-EU economic migration. At the same time, my right hon. Friend the Home Secretary commissioned the independent Migration Advisory Committee to advise the Government on the level at which the first annual limit should be set. In order to prevent a surge of applications while we consult, we introduced an interim limit on the General routes of Tiers one and two of the Points Based System and raised the pass mark for all new Tier one (General) applicants to ensure that those coming through the route are the most valuable to the UK.

Immigration Controls: English Language

Fiona Mactaggart: To ask the Secretary of State for the Home Department what steps the UK Border Agency plans to take to publicise the new English language requirement for those making immigration applications as spouses and partners. [4799]

Reply from Damian Green: On 9 June 2010, *Official Report*, column 11WS, my right hon. Friend the Home Secretary announced a new language requirement for those seeking entry to the UK as either a spouse or civil partner, fiancé(e) or proposed civil partner, unmarried partner or same sex partner of a British citizen or someone who is present and settled in the UK.

The announcement on 9 June received extensive publicity both in the UK and overseas. Information about the new policy for those making immigration applications is currently available on the UK Border Agency website. A further publicity campaign is planned.

Visas

Lord Laird: To ask Her Majesty's Government whether they will consider seeking authorisation from the European Commission to extend the transitional arrangements for visa restrictions on Bulgarians and Romanians for two years beyond 2011 because of recent changes in unemployment in the United Kingdom, particularly amongst young people, and long-term patterns in the labour market.[HL729]

Reply from the Minister of State, Home Office (Baroness Neville-Jones): The United Kingdom may, under the terms of the accession treaty, extend the labour market restrictions currently applied to nationals of Bulgaria and Romania beyond 2011 until the end of 2013, in the event of a serious disturbance to the labour market. The Government will assess the labour market case for extending the restrictions during the course of next year and notify the European Commission if it decides to extend the restrictions.

The Government will apply transitional controls as a matter of course in the future for all new EU member states.

Entry Clearances: Married People

Tom Greatrex: To ask the Secretary of State for the Home Department whether the proposed cap on immigration will include those applying for spouse visas. [5828]

Reply from Damian Green: The proposed limit announced by the Home Secretary on 28 June applies to economic migration routes only-Tier one and Tier two of the Points-Based System. We are consulting on whether the dependant spouses of Tier one and Tier two migrants should be included in the limit. The limit will not include those applying for other spouse visas, although we intend to review all other immigration routes in due course.

Immigration Controls: English Language

Fiona Mactaggart: To ask the Secretary of State for the Home Department what documents people making immigration applications as spouses and partners will be required to show to demonstrate that they have reached the A1 standard in the English language (a) in the UK and (b) when applying for entry clearance abroad. [4803]

Reply from Damian Green: On 9 June, my right hon. Friend the Home Secretary announced a new language requirement for those seeking entry to the UK as either a spouse or civil partner, fiancé(e) or proposed civil partner, unmarried partner or same sex partner of a British citizen or someone who is present and settled in the UK.

Spouses and partners both in the UK and when applying for entry clearance abroad will need to demonstrate competence in English language speaking and listening at a basic level (Common European Framework of Reference, level A1). A spouse or partner will need to provide evidence to the UK Border Agency with their visa application that they have passed an English language test to this standard with one of the UK Border Agency's approved test providers. Details of acceptable qualifications, approved test providers and documentary evidence to be submitted with an application will be published on the UK Border Agency website at the earliest opportunity.

Fiona Mactaggart: To ask the Secretary of State for the Home Department what representations she has received on the adequacy of teaching and examination facilities for the English language A1 standard examination for immigration purposes; what discussions she has had on the subject; and if she will make a statement. [4804]

Reply from Damian Green: The Government have received no formal representations on the adequacy of teaching and examination facilities for the A1 standard English language examination for immigration purposes.

Tony Lloyd: To ask the Secretary of State for the Home Department what the average time taken to process applications for (a) post-study work visas, (b) indefinite leave to remain based on long-term residency, (c) certificate of approval for marriage and (d) leave to remain was in the latest period for which figures are available. Reply from Damian Green: The average processing times are as follows:

Reply from Damian Green: The total number of people who have been (a) granted and (b) refused entry clearance in each of the financial years from 2001-02 to 2008-09 can be found in the published annual Entry Clearance Statistics on our website: www.ukba.homeoffice.gov.uk/visas.

Reliable statistics for previous years is not available. The number of people granted and refused entry clearance in FY 2009-10 was 2,015,670 and 444,622, respectively⁽¹⁾.

Caroline Lucas: To ask the Secretary of State for the Home Department whether a cost-benefit analysis to the UK economy of the presence of overseas students who obtain visas to study at English language schools will be included in her Department's review of the points-based immigration system. Reply from Damian Green: As the Home Secretary has indicated, the Government will be reviewing the non-economic immigration routes with a view to bringing forward proposals in due course. I intend to undertake a thorough evaluation of the student system, including English language schools. The aim of that work will be to ensure that the right balance is struck between providing a user-friendly route for bona fide students and education providers and keeping out those who would seek to abuse the student system. The work will also take into account the Government's overall objective to reduce net migration to the tens of thousands by the end of the parliamentary term.

Entry Clearances: Overseas Students

Simon Kirby: To ask the Secretary of State for the Home Department how many overseas students were awaiting a decision on their application for a visa to study in the UK at the latest date for which figures are available; and if she will make a statement. [5143]

Reply from Damian Green: Our records show that, as of 31 March 2010, there were 28,610 student visa applicants who were awaiting a decision on their applications.

Simon Kirby: To ask the Secretary of State for the Home Department what the terms of reference are of the ministerial review of the points-based immigration system rules applied to visa application forms for overseas students wishing to study in the UK. [5145]

Reply from Damian Green: As the Home Secretary has indicated, the Government will be reviewing the non-economic immigration routes with a view to bringing forward proposals for parliamentary consideration in due course. I intend to undertake a thorough evaluation of the student system. The aim of that work will be to ensure that the right balance is struck between providing a user-friendly route for bona fide students and education providers and keeping out those who would seek to abuse the student system. The work will also take into account the Government's overall objective to reduce net migration to the tens of thousands by the end of the parliamentary term.

Entry Clearances: Overseas Students

Laura Sandys: To ask the Secretary of State for the Home Department what research her Department has (a) commissioned and (b) evaluated on a link between competence in the English language and the likelihood of overstaying following the issue of a student visa. [6235]

Reply from Damian Green: The Government will be reviewing the non-economic immigration routes with a view to bringing forward proposals in due course, and this will include detailed consideration of the student routes. The UK Border Agency has analysed information on levels of abuse based on nationality, and on students not enrolling on courses or discontinuing study as part of tier four review undertaken earlier this year. As tier four of the points-based system was only launched just over a year ago, on 31 March 2009, many of the visas issued under the new student route have not yet expired and consequently no specific research has yet been commissioned or evaluated on the links between overstaying and competence in the English language.

I have asked for a thorough evaluation of the student system to be undertaken in the coming months. The aim of that work will be to ensure that the right balance is struck between providing a user-friendly route for bona fide students and education providers and keeping out those who would seek to abuse the student system.

Refugee and Migrant Justice

Lord Hylton: To ask Her Majesty's Government how the former clients of Refugee and Migrant Justice will receive continuity of legal advice and representation. [HL878]

Reply from the Minister of State, Ministry of Justice (Lord McNally): The Legal Services Commission (LSC) is working closely with the administrator and others to ensure that urgent arrangements are made so that clients continue to receive the advice they need. The LSC has experience of handling the transfer of work when a provider leaves the market and is satisfied that there is adequate capacity to absorb the extra workload. Although some initial disruption is unfortunately inevitable, every effort will be made to minimise this. The LSC is making urgent arrangements for other providers to take on RMJ cases that require prompt advice—for example, clients held in detention.

Lord Hylton: To ask Her Majesty's Government what assessment they have made of the ability of other providers of legal services to absorb the caseload of Refugee and Migrant Justice. [HL879]

Reply from Lord McNally: The Legal Services Commission (LSC) has recently run a tender exercise for asylum and immigration contracts from October 2010. There has been significant long-term interest in the work from organisations, both not-for-profit organisations and private solicitor firms.

Ongoing cases for Refugee and Migrant Justice's clients are currently in the process of being reallocated to other immigration providers who can progress their cases. The LSC is also working with immigration providers to ensure continued availability of services for clients detained at immigration removal centres.

Asylum

Stella Creasy: To ask the Secretary of State for the Home Department what information her Department holds on the number of claimants for asylum advised by Refugee and Migrant Justice before it went into administration; and what assessment her Department has made of the effects of that administration on the (a) time taken to complete claims and (b) costs to the public purse of processing the claims of those persons. [8152]

Reply from Damian Green: In each case where the UK Border Agency is notified by an individual applicant's legal representative of their details, these are recorded on our caseworking database. UK Border Agency internal management information shows that, at the beginning of July, Refugee and Migrant Justice (RMJ) were on the database representing more than 10,000 asylum applicants, of which fewer than half are recorded as being active cases. We are waiting to be advised of RMJ's final estimates of numbers of clients by the Legal Services Commission as RMJ's administrators manage the transfer of cases to other representatives. The UK Border Agency, with the Legal Services Commission, is working to ensure prompt access to alternative legal representation for all applicants as well as to ensure that the impact of what has happened to RMJ, in terms of both cost and effect on individual cases, is minimised.

Denis MacShane: To ask the Secretary of State for the Home Department what funds have been provided to Maxim Bakiyev following his application for asylum in the UK. [7039]

Reply from Damian Green: It is not Home Office policy to comment on individual cases.

Phil Woolas: To ask the Secretary of State for the Home Department what the reasons are for the time taken to publish Compass programme contract notices relating to the commissioning of services for asylum seekers. [8266]

Immigration and Asylum Westminster Parliamentary Questions (continued)

Damian Green: The original timetable for the COMPASS programme was to publish the invitation to tender for new asylum accommodation services in the summer of 2010.

Given the recent change of Government and the size of the contracts involved it has been agreed to delay the issue of the formal tender document until new ministers have had the opportunity to review the current plans and the strategy, to ensure best value.

Asylum Seekers

Lord Hylton: To ask Her Majesty's Government, further to the Written Answer by Baroness Neville-Jones on 28 June (WA 241-2), what is the usual interval between the ending of Section 4 support for persons granted leave to remain as a result of an appeal or change of circumstances and the beginning of normal benefits should the person not be able immediately to find work; and whether they will reduce the interval.[HL917]

Reply from the Parliamentary Under-Secretary of State, Department for Work and Pensions (Lord Freud): An application for benefits can be made where a person or family on support is given permission to stay. From that point, they are no longer a person subject to immigration control. The support provided under Section 4 is taken into account as income and deducted from any weekly benefit entitlement.

Asylum: Legal Aid and Assistance

Catherine McKinnell: To ask the Secretary of State for the Home Department if she will postpone decisions on applications for asylum in all cases where the applicants were receiving legal aid and assistance from Refugee and Migrant Justice until arrangements have been made for alternative legal aid and assistance to be provided to them; and if she will make a statement. [5086]

Reply from Damian Green: While the UK Border Agency will take every care to ensure that former Refugee and Migrant Justice clients are not unreasonably affected and will treat individual cases sensitively, we are unable to give a blanket assurance that no adverse immigration decisions will be taken on their former clients until a new legal representative has been appointed.

Reply from the Minister of State, Ministry of Justice (Lord McNally): The Legal Services Commission (LSC) is working closely with the administrator and others to ensure that urgent arrangements are made so that clients continue to receive the advice they need. The LSC has experience of handling the transfer of work when a provider leaves the market and is satisfied that there is adequate capacity to absorb the extra workload. Although some initial disruption is unfortunately inevitable, every effort will be made to minimise this. The LSC is making urgent arrangements for other providers to take on RMJ cases that require prompt advice; for example, clients held in detention.

Lord Jones of Cheltenham: To ask Her Majesty's Government what is their estimate of the cost to public funds of the closure of Refugee and Migrant Justice.[HL927]

Reply from Lord McNally: Where any provider ceases to have a legal aid contract for whatever reason, the LSC will make an assessment of any potential financial issues in the individual circumstances. This will include payments on account made, claims to be billed and whether, for example, the provider will be continuing to conclude cases for existing clients.

The LSC is working closely with the administrators and others to ensure that urgent arrangements are made so that clients continue to receive a good quality service and that cases are transferred to other providers where necessary. The LSC has agreed payment of £280,000 for the work to transfer RMJ clients' files. The LSC is also working with the administrators to confirm the correct payments to be made to RMJ. This assessment will take several weeks to be concluded. In the mean time, they have agreed an advance payment of £70,000 against any payment for work in progress, plus a contingency of £20,000 for this work.

Asylum: Children

Phil Woolas: To ask the Secretary of State for the Home Department when her Department plans to publish its response to the consultation on unaccompanied asylum-seeking children. [8268]

Reply from Damian Green: The Government last issued a consultation paper regarding unaccompanied asylum seeking children in February 2007: 'Planning Better Outcomes and Support for Unaccompanied Asylum Seeking Children'. A formal response was published in January 2008 entitled 'Better Outcomes: The Way Forward-Improving the Care of Unaccompanied Asylum Seeking Children'.

Although not pursuing a formal consultation, the UK Border Agency is in regular and frequent discussion with its partners on improvements to policy and process around dealing with unaccompanied asylum-seeking children. For example, a number of children's charities and refugee groups have recently been asked to review proposed amendments to the Processing an Asylum Application from a Child instruction to reflect changes in policy to remove some unaccompanied children to their country of origin where adequate reception arrangements are in place. In circumstances like this, comments and recommendations from partners will be factored into the revised instruction rather than being the subject of a formal response to consultation.

Reply from the Minister of State, Home Office (Baroness Neville-Jones): The UK signed the Council of Europe Convention on Action against Trafficking in Human Beings in March 2007, ratified it in December 2008, and implemented it from 1 April 2009. At the centre of the convention is a duty to meet minimum standards concerning the identification and protection of victims of trafficking called the national referral mechanism (NRM). To meet this obligation a government-led, multi-agency framework was created to help identify and support victims.

The coalition Government are currently reviewing monitoring arrangements. The responsible Minister of State in the Home Office has offered to write to the noble Lord when the review is complete.

Baroness Gould of Potternewton: To ask Her Majesty's Government what is their timetable for implementing the Equality Act 2010. [HL502]

Reply from the Minister of State, Home Office (Baroness Neville-Jones): The provisions in the Equality Act will come into force at different times to allow time for the people and organisations affected by the new laws to prepare for them. The first wave of implementation will go ahead to the planned October timetable following the publication of the first commencement order in Parliament this week. This will pave the way for much-needed simplification of discrimination law and the implementation of landmark provisions to protect disabled people from discrimination and to tackle the gender pay gap.

The Government have made clear that a key priority as we support economic recovery is to remove unnecessary burdens on business. By simplifying discrimination law, the Equality Act is an important part of our efforts to deliver on this commitment. The Government are looking at how the rest of the Act can be implemented in the best way for business and will make an announcement in due course.

Police: Stop and Search

Lord Ouseley: To ask Her Majesty's Government what action they propose to address the proportion of police stop and searches of black and Asian people. [HL658]

To ask Her Majesty's Government what assessment they have made of the reasons for the increased rates of black people being stopped and searched by the police compared to white people.[HL659]

To ask Her Majesty's Government whether they have assessed the likely consequences for race relations and equality, especially police/community relations, if the different proportions of police stop and searches of black people and white people continues.[HL660]

To ask Her Majesty's Government what advice and guidance applies to the use of stop and search by police; and whether there is specific advice on how to avoid biased or unjustified stops.[HL661]

Reply from the Minister of State, Home Office (Baroness Neville-Jones): The Government share the concerns about disproportionality in the use of stop-and-search powers. We are working with the police service to help ensure that stop-and-search powers are used appropriately. There is, however, no single cause of disproportionality. It is important, therefore, to look at levels of disproportionality, and any specific demographic or other factors, in individual forces.

The National Policing Improvement Agency (NPIA) has developed Next Steps, a diagnostic tool to ensure that a force's use of stop and search is not driven by other unjustified factors such as discrimination or stereotyping. NPIA will support forces to implement Next Steps and will target forces with high levels of disproportionality. We are about to start the roll out of Next Steps in Dorset, Merseyside and one borough of the Metropolitan Police.

Detailed guidance on the appropriate use of stop-and-search powers are contained in the Police and Criminal Evidence Act 1984 Code of Practice A. This includes the fundamental principles governing stop and search, which are that the powers must be used fairly, responsibly, with respect for people being searched and without unlawful discrimination. In 2005 the national Stop and Search Manual was published jointly by the Home Office, the Association of Chief Police Officers and the Association of Police Authorities.

The manual gives further detailed good practice, training packages and supervision techniques and looks at what should be done to address issues around the disproportionate use of stop-and-search powers.

In addition to this, police forces have their own operational advice and guidance which will address local stop-and-search and community issues.

David Amess: To ask the Secretary of State for Business, Innovation and Skills (1) pursuant to the answer of 24 June 2010, *Official Report*, columns 314-15, on higher education: anti-Semitism, when he plans to meet representatives of the Jewish community and the higher education sector; if he will place in the Library a copy of the agenda of that meeting; and if he will make a statement; [5379]

(2) what his policy is on the continuance of the higher education sub-group of the cross-Government working group on anti-Semitism; what discussions he has had with ministerial colleagues about this group since his appointment; and if he will make a statement; [5584]

(3) what guidance his Department has issued to higher education institutions on combating (a) anti-Semitism, (b) stereotyping of the Jewish community and (c) violent extremism; what discussions his Department has had with the Jewish community on the issue; and if he will make a statement. [5585]

Reply from David Willetts: The meeting with Jewish community and higher education stakeholders is in the process of being arranged and I anticipate that it will involve broad discussions on anti-Semitism and the implications for the higher education sector, including the future of the BIS Anti-Semitism and Higher Education Group. A formal agenda has not yet been agreed for this meeting but I would be happy to place a copy in the Library when it is available. I have held no discussions with ministerial colleagues about this group.

The former Department for Innovation, Universities and Skills provided updated and revised guidance to higher education institutions on 'Promoting Good Campus Relations, Fostering Shared Values and Preventing Violent Extremism in Universities and Higher Education Colleges', available here:

This provided detailed guidance to help institutions address issues concerning violent extremism, applicable to any form this might take on campus. The Department has not issued any guidance about the stereotyping of any community. The sector itself has also produced guidance which offers institutions practical strategies to deal with instances of hate crimes and intolerance on campus, including anti-Semitism.

There is no place for racism of any form, including anti-Semitism, in higher education. Universities have the primary responsibility for ensuring that their students are not subject to threatening or abusive behaviour on campus and have access to a strong legislative framework and guidance to help them deal effectively with instances of intolerance, racism and harassment in their institutions. Government would expect them to vigorously tackle these issues when they arise and report criminal attacks to the police when they occur on campus, or support students to do so.

As experienced civil servants these officials have undertaken work in a number other posts across Government in the past.

David Amess: To ask the Secretary of State for Business, Innovation and Skills what files his Department holds on (a) the higher education sub-group of the cross-government working group on anti-Semitism, (b) the cross-government working group on anti-Semitism, (c) the All Party Parliamentary Inquiry into anti-Semitism and (d) countering anti-Semitism in higher education; and if he will make a statement. [5587]

Reply from David Willetts: The Department holds the necessary records on each of (a), (b), (c) and (d) to enable officials to provide the appropriate policy support to Ministers.

Government would expect them to vigorously tackle these issues when they arise and report criminal attacks to the police when they occur on campus, or support students to do so. I have received correspondence on this issue, and I have had no discussions so far with representatives of the Jewish community. However, I am due to meet with representatives of the Jewish community and the HE sector to discuss anti-Semitism and higher education.

Reply from Jeremy Browne: Combating all forms of racism, including anti-Semitism, remains an important part of the Government's human rights agenda. We condemn all instances of violence and discrimination against individuals and groups because of their race, faith or belief. The Foreign and Commonwealth Office's overseas missions have a responsibility to monitor and raise human rights in their host countries and routinely raise our concerns with host governments. Where possible our embassies take action on individual cases where persecution or discrimination has occurred and lobby for changes in discriminatory practices and laws. The Government also support the All Party Parliamentary Group against anti-Semitism and their work on tackling anti-Semitism across Europe and encourages MEPs to get involved in tackling anti-Semitism in their own countries. We will continue to promote these issues within the EU, the UN, the Organisation for Security and Co-operation in Europe and other multilateral fora.

The total costs can be divided into two categories: policing costs, which will be met by the state from existing policing budgets, and non-policing costs, which will be split between the Catholic Church and the Government. Discussions are under way to finalise these costs and to agree the appropriate levels of contribution from the Government and the Catholic Bishops' Conferences of England and Wales, and of Scotland.

David Amess: To ask the Secretary of State for Foreign and Commonwealth Affairs what progress has been made on the visit to the UK of Pope Benedict XVI; what recent discussions he has had with his Vatican counterpart on the visit; and if he will make a statement. [5518]

Reply from Henry Bellingham: My right hon. Friend the Foreign Secretary has not met his Vatican counterpart to discuss the Papal Visit. However, a delegation from the Holy See visited the UK from 21 to 24 June and held discussions with Government officials and representatives of the Catholic Church on preparations for the visit. These included details of the programme and organisation of the various events involved, in addition to accommodation, travel and practical arrangements for the Papal delegation. Our embassy to the Holy See is in close touch with the Vatican over arrangements for the visit.

Jim Dobbin (483) Ethnic group question in the 2011 census - That this House has regard to the historic and enduring value of information gathered by the decennial National Census; believes the ethnic group question, first introduced in 1991, represented a milestone in understanding and embracing the diversity of the United Kingdom; notes the primary purpose of the ethnic group question is to enable organisations to monitor equal opportunities and anti-discrimination policies and to allocate government resources more effectively; further notes that the development of the ethnic group question for the 2011 Census is interlinked with that of the newly introduced national identity question; further notes that in extensive consultation with key users of Census data 92 per cent. of respondents expressed support for requirement for information on population ethnicity; and consequently urges the Government to maintain a considered framework for Census questions that form an important part of a balanced policy of improving race relations and to resist calls to drop questions regarding ethnic and national identity.
