# **Holyrood Parliamentary Motion**

**S3M-7911 Hugh O'Donnell: Cuts to Scottish Refugee Council Advice Budgets**— That the Parliament is seriously concerned by reports that the UK Border Agency (UKBA) proposes to cut advice funding to the Scottish Refugee Council (SRC) by as much as 62%; considers that the people using these services are some of the most vulnerable people in Scotland, often without recourse to any public funds or services; believes that this cut would be inappropriate, and calls on the UKBA to reconsider its current proposals before it damages what is considered the vital work being carried out by the SRC and other agencies working with refugees and asylum seekers.

# Westminster Parliamentary Questions

### Immigration

**Jeremy Corbyn:** To ask the Secretary of State for the Home Department how many immigration legacy cases were *(a)* lodged and *(b)* dealt with in each of the last 24 months; and what the outcome of each was. [37738]

**Reply from Damian Green** [holding answer 3 February 2011]: Cases dealt with under the "legacy" programme are asylum cases that were lodged with the agency on or prior to 5 March 2007 therefore no new legacy cases were lodged in the last 24 months. In response to part (b) of the question, the agency provides regular updates on performance, including a breakdown into grants, removals and "other" cases such as duplicates or errors, to the Home Affairs Select Committee and is due to report in the spring. On 1 November the agency reported to the Home Affairs Select Committee that it had concluded 334,500 cases.

### **Immigration Controls**

**Julian Sturdy:** To ask the Secretary of State for the Home Department what steps she is taking to increase levels of immigration control at border entry points. [38326]

**Reply from Damian Green:** We are continually strengthening and modernising our border controls, to improve our ability to prevent those who do not qualify for entry to the UK from doing so, while continuing to welcome those who wish to travel to the UK legitimately to visit, work or study. Measures we have already taken include maintaining the strength of our visa regimes; maintaining immigration liaison officers at airports overseas and the juxtaposed immigration controls in France and Belgium; as well as the continued development of e-borders and evolution of the points based system. We will also create a dedicated border police command, as part of the new National Crime Agency, to enhance national security, improve immigration controls and crack down on the trafficking of people, weapons and drugs.

**Priti Patel:** To ask the Secretary of State for the Home Department what measures are in place at each port in the UK to detect (*a*) illegal immigrants and (*b*) prohibited items from entering the UK. [38913]

**Reply from Damian Green:** UK Border Agency (UKBA) officers carry out detection duties at ports and airports across the UK and at our juxtaposed controls in France and Belgium. Officers have at their disposal hi-tech search equipment.

Specially trained officers deploy an array of search techniques including the use of body detection dogs, carbon dioxide detectors and heartbeat monitors as well as visual searches to find those seeking to enter the UK clandestinely

UK Border Agency officers work at the frontier to detect and disrupt smuggling of a wide range of goods. UKBA take a targeted risk-based approach to intervention that is intelligence led and use a variety of detection technologies to scan and examine baggage, vehicles and freight. This includes up-to-date x-ray and trace detection technology coupled with the use of detector dogs.

### **Migrant Workers**

**Richard Fuller:** To ask the Secretary of State for the Home Department how many visas under Tier 5 (religious workers) of the points-based visa scheme have been granted to applicants in each of the last three years. [39746]

**Reply from Damian Green:** Tier 5 of the points-based system (PBS) was introduced on 27 November 2008 to cover entry clearance visas for temporary workers and youth mobility. The following table shows the number of entry clearance visas issued under the Tier 5 (religious workers) category from 2008 to Quarter 3 2010.

Figures on entry clearance visas issued by category are published quarterly in table 1.1 of Control of Immigration: Quarterly Statistical Summary available from the Home Office's Research, Development and Statistics website at:

**Emma Reynolds:** To ask the Secretary of State for the Home Department how many students from outside the European Economic Area were *(a)* admitted into the UK on study visas and *(b)* granted post-study work visas in 2009-10. [38360]

**Reply from Damian Green:** The latest available information is given in the following table. The table shows statistics for a) student admissions (excluding dependants and student visitors) in 2009 and b) entry clearance visas issued and grants of leave to remain in the United Kingdom under the tier 1-post study route (excluding dependants) 2009 to Q3 2010.

### **Entry Clearances: Overseas Students**

**Tom Greatrex:** To ask the Secretary of State for the Home Department what assessment she has made of the effect of proposed reforms to the immigration system on the number of non-EU students applying to (*a*) all UK universities and (*b*) universities in (i) England, (ii) Scotland, (iii) Wales and (iv) Northern Ireland. [39369]

**William Bain:** To ask the Secretary of State for the Home Department what assessment she has made of the effects of her proposed restrictions on the number of student visas on levels of income of universities with courses attracting overseas students in (*a*) Scotland, (*b*) England, (*c*) Wales and (*d*) Northern Ireland in each of the next four years. [39550]

**Reply from Damian Green:** A consultation on the student immigration system closed on 31 January 2011. The consultation sought the views of all respondents on the effect of the proposals. The results of the consultation and an impact assessment will be published in due course.

#### **Immigration:** Appeals

**Priti Patel:** To ask the Secretary of State for the Home Department what the length of time was of the 20 longest-running immigration appeals cases concerning a single individual. [38906]

**Reply from Damian Green:** The Home Department does not record statistics on the individual time scales of all appeals.

The longest-running immigration appeals cases are cases that proceed through the court system to the Court of Appeal and the Supreme Court. There are no time limits for cases to be heard or judgments to be handed down at these courts. The length of time an appeal takes may be extended further should it be referred to the Court of Justice of the European Union. For the first two quarters of 2010-11

70,300 immigration appeals were received by the Tribunal Service and during the same period 73 appeals proceeded to the Court of Appeal, while four were determined at the Supreme Court.

#### Illegal Immigrants: Asylum

**Priti Patel:** To ask the Secretary of State for the Home Department what the average cost of processing a case involving (*a*) an illegal immigrant and (*b*) an asylum seeker whose application for asylum is refused was in each year for which figures are available. [38916]

**Reply from Damian Green:** The UK Border Agency has not previously collected these data, but since I became Minister for Immigration, I have asked the agency to show a greater focus on productivity and these, or similar, data will be more readily available in the future.

**Priti Patel:** To ask the Secretary of State for the Home Department how many (*a*) illegal immigrants and (*b*) asylum seekers whose application for asylum was refused have been allowed to remain in the UK by (i) ministerial or other administrative decision, (ii) as a consequence of an appeal to a tribunal and (iii) as a result of an appeal through the courts made predominantly, entirely or partly on human rights grounds. [38918]

**Reply from Damian Green:** We have interpreted illegal immigrants to mean individuals who have been served papers as immigration offenders, and refused asylum seekers to mean failed asylum seekers. Refused individuals who have been granted leave to remain by the Government, has been interpreted as individuals granted humanitarian protection or discretionary leave.

#### Asylum

**Priti Patel:** To ask the Secretary of State for the Home Department how many immigrants who have entered the UK illegally claimed asylum following detection in each year for which figures are available; how many of those were granted asylum; how many of those were refused permission to remain in the UK and asked to leave the UK; and how many left the UK in each year. [38911]

**Reply from Damian Green:** In answering this question we have interpreted illegal immigrants as individuals who have been served papers as immigration offenders, prior to claiming asylum. The information requested is shown in the following table:

#### Asylum

**Tom Brake:** To ask the Secretary of State for the Home Department what the maximum period of detention is for a stateless person in an immigration detention centre. [38756]

**Reply from Damian Green:** Immigration Act powers of detention are not time limited. However, detention must be kept to the minimum period reasonably necessary for the purpose for which it was authorised and must not be unduly prolonged. The length of those periods will vary between individual cases depending on their particular circumstances. Where a person seeks to frustrate their removal from the UK their detention may be prolonged as a consequence; the courts have upheld this position.

**Tom Brake:** To ask the Secretary of State for the Home Department how many people classified as stateless were held in immigration detention centres on the most recent date for which figures are available. [38758]

**Reply from Damian Green:** As at 30 September 2010, the latest date for which National Statistics have been published, five people (figure rounded to the nearest five) classified as stateless were detained solely under Immigration Act powers, in UK Border Agency Immigration Removal Centres and Short Term Holding Facilities. The Home Office publishes National Statistics on the number of persons detained solely under Immigration Act powers on a quarterly and annual basis which are available from the Library of the House and from the Home Office's Research, Development and Statistics website at: www.homeoffice.gov.uk/rds/immigration-asylum-stats.html

**Kate Hoey:** To ask the Secretary of State for the Home Department whether the UK Border Agency unit dealing with older unresolved asylum cases is on schedule to resolve all such cases by its target date of summer 2011. [38759]

**Reply from Damian Green:** The agency provides regular updates on performance, including a breakdown into grants, removals and "other" cases such as duplicates or errors, to the Home Affairs Select Committee and is next due to report in the spring. On 1 November the agency reported to the Home Affairs Select Committee that it had concluded 334,500 cases and is on track to conclude the legacy backlog by summer 2011.

### Asylum Seekers

**Lord Roberts of Llandudno:** To ask Her Majesty's Government what medical help is available to asylum seekers in the United Kingdom.[HL6629]

**Reply from the Minister of State, Home Office (Baroness Neville-Jones):** Under National Health Service (NHS) regulations, anyone who has made a formal application for asylum in the UK is eligible for both primary and secondary NHS treatment free of charge until a final decision is made on their claim and any appeal rights have been exhausted.

**Lord Roberts of Llandudno:** To ask Her Majesty's Government what medical help is available to asylum seekers due for deportation from the United Kingdom.[HL6630]

**Reply from Baroness Neville-Jones:** Asylum seekers are not removed until their case has been finally determined and it has been decided that they are not in need of protection. Failed asylum seekers whose removal is pending can access primary health care free of charge but may be charged for some secondary healthcare.

### **People Trafficking**

**Baroness Doocey:** To ask Her Majesty's Government how many children have been identified as potential victims of trafficking by UK Border Agency staff assigned to controls at Eurostar terminals in France and Belgium.[HL6514]

**Reply from The Minister of State, Home Office (Baroness Neville-Jones):** UK Border Agency Staff at the Eurostar terminals in France and Belgium do not record potential victims of trafficking. Cases of potential child trafficking are immediately reported to the French, Belgian authorities or the police authorities to take action.

**Baroness Doocey:** To ask Her Majesty's Government what assessment they have made of the work of the Metropolitan Police's Paladin team, who safeguard children at London entry ports; and whether they plan to replicate such police units across the United Kingdom.[HL6515]

**Reply from Baroness Neville-Jones:** The Government are committed to safeguarding trafficked children and combating this terrible crime. Whilst the Government have not carried out a formal assessment of the work of the Paladin team, the Association of Chief Police Officers (ACPO) have conducted an internal study of the Paladin model and how it works. The decision on whether to replicate it is an operational matter for the police.

**Baroness Doocey:** To ask Her Majesty's Government what safeguards will be in place in United Kingdom ports in the lead up to and during the London Olympic and Paralympic Games to prevent children being trafficked.[HL6516]

**Reply from Baroness Neville-Jones:** The UK Border Agency works closely with the Serious Organised Crime Agency (SOCA), the Child Exploitation and Online Protection Centre (CEOP), social services and the police to safeguard the welfare of children arriving into the UK. All frontline border force officers are trained to identify any children deemed at risk. We will continue to work collaboratively with our partners to protect children from being trafficked into the UK.

These safeguards will continue to apply in the lead up to and during the Olympic and Paralympic Games.

#### Sectarianism

**Bill Butler (Glasgow Anniesland) (Lab):** To ask the Scottish Executive how many antisectarianism projects it has funded from the Race, Religion and Refugee Integration Fund since 2008, broken down by (a) project and (b) amount. (S3W-39060)

**Reply from Fergus Ewing:** The Scottish Government funds a wide range of organisations to deliver projects to tackle sectarianism and all forms of religious intolerance. These include work focusing on schools, communities, the workplace, football supporters and adult offenders:

#### Anti-Semitism

**David Amess:** To ask the Secretary of State for Foreign and Commonwealth Affairs what recent reports he has received from the Co-ordination Forum for Countering anti-Semitism on the level of anti-Semitism worldwide; and if he will make a statement. [38035]

**Reply from Mr Jeremy Browne:** We have received no direct reports from the Coordination Forum for Countering anti-Semitism. The Community Security Trust (CST), a British charity focused on protecting the Jewish community, contributes to the forum and published their nationwide 2010 Anti-Semitic Incidents Report on 3 February 2011 which will be circulated to the Government and the Police.

The UK is committed to fighting racial discrimination and intolerance. Combating all forms of racism remains an important part of the Government's human rights policy. The Foreign and Commonwealth Office's overseas missions have a responsibility to monitor and raise human rights in their host countries and routinely raise our concerns with host Governments. Where possible our embassies take action on individual cases where persecution or discrimination has occurred and lobby for changes in discriminatory practices and laws.

We have also recently published the Government's first progress update report on our work to take forward the recommendations of the 2006 All-Party Parliamentary Inquiry into Anti-Semitism.
