## Immigration and Asylum

### Holyrood Parliamentary Motions

**S4M-01091 Patrick Harvie: Disparities in Asylum Appeal Success Rates**—That the Parliament notes with concern the response by the UK Government's Ministry of Justice to a freedom of information request by Dr Nick Gill of the University of Exeter that shows that significant disparities exist between the success rates of asylum appeals held in the various hearing centres around the UK and that the success rate in Glasgow is 22% compared with 44% at Taylor House in London; further notes that comparison with data previously released shows that the disparities appear to be increasing; would welcome research into the reasons for these disparities in order to discover whether there are barriers to justice that need to be addressed, and notes that a proposal for such research has the support of the Red Cross, the Refugee Council and Bail for Immigration Detainees.

**S4M-01088 Alison Johnstone: UK Anti-Slavery Day**—That Parliament notes that the annual UK Anti-Slavery Day will be on 18 October 2011 and that, to coincide with the European Anti-Trafficking Day, it will be now held on this day every year; welcomes

campaigners' efforts to raise awareness of the many people in the UK and around the world who, despite the abolition of the transatlantic slave trade over 200 years ago, continue to be trapped in what it considers to be modern slavery; regrets that, according to ECPAT UK, there are still child victims of trafficking in the UK; supports ECPAT UK's guardianship campaign in its call for a system of guardianship for child victims of trafficking; considers that modern slavery exists in various forms including bonded and child labour, forced marriage and trafficking; considers that ending modern slavery will require coordinated efforts from individuals and governmental and non-governmental organisations; understands that, in March 2011, in response to a petition signed by over 47,000 people, the UK Government opted-in to a EU directive on tackling human trafficking; further understands that EU law on human trafficking is designed to bolster current international anti-trafficking efforts by ensuring cooperation and common standards across member states for the prosecution of traffickers and the protection of victims, and calls on the Scottish Government to continue to tackle this form of exploitation of men, women and children and for it to provide support for the victims.

## Westminster Parliamentary Questions

### Forced Marriage

**Lord Avebury:** To ask Her Majesty's Government what amendments they intend to make to the Immigration Rules in the light of the Supreme Court judgment in R (on the application of Quila and another) v Secretary of State for the Home Department; R (on the application of Bibi and another) v Secretary of State for the Home Department [2011] UKSC 45; what instructions are being given to immigration officers and presenting officers on how to deal with new applications by spouses, partners and fiancés under the age of 21, pending applications, and those applications that have been refused and that may or may not be subject to appeal by such applicants; and what new proposals they have for preventing forced marriages. [HL12623]

**Reply from the Minister of State, Home Office (Lord Henley):** The Government are giving careful consideration to the Supreme Court's judgment and are preparing revised instructions for UK Border Agency staff. Further information on the implications of the judgment will be made available to applicants affected by the ruling via the UK Border Agency website very shortly.

There is no place in British society for the practice of forced marriage. It is a breach of human rights and a form of violence against the victims. The Prime Minister has announced that, in England and Wales, the breach of forced marriage protection orders will be criminalised and there will be a consultation on making forcing someone to marry an offence in its own right.

### Overseas Workers

**Michael Connarty:** To ask the Secretary of State for the Home Department if she will make it her policy to maintain visa arrangements which permit overseas domestic workers to change employer. [76147]

**Reply from Damian Green:** The Government's recent consultation document "Employment—Related Settlement, Tier 5 and Overseas Domestic Workers" set out a number of proposals for reform of the overseas domestic worker provisions, which include making protections more appropriate, should the route be retained.

### Right of Abode

**Sheila Gilmore:** To ask the Secretary of State for the Home Department (1) how many applications for right of residence in the UK her Department has rejected where the applicant is both an A2 national and defines their employment status as self-employed on the basis that her Department believes the applicant is not genuinely self-employed in each of the last three years; [76131]

(2) how many applications for right of residence in the UK her Department has (a) received, (b) approved and (c) rejected where the applicant is both an A2 national and defines their employment status as self-employed in each of the last three years. [76132]

**Reply from Damian Green:** The information is shown in the following table:

The UK Border Agency (UKBA) is unable to advise how many applications were rejected on the grounds that the applicant was not believed to be genuinely self-employed. This data is not held in a reportable format on the Case Information Database (CID).

Consequently, in order to provide this information we would need to undertake a manual case by case search of records, which would exceed the cost threshold.

### Immigrants: Detainees

**Julian Huppert:** To ask the Secretary of State for the Home Department how many pregnant women were detained for immigration purposes in 2010-11; and how many of them were released in the late stages of pregnancy because their pregnancy meant that they were not able to fly. [76621]

**Reply from Damian Green:** If a pregnant woman chooses to inform the UK Border Agency of her condition, the detail would be held on her medical file which is confidential between patient and doctor. The UK Border Agency does not hold such information centrally.

The UK Border Agency's published guidance makes clear that pregnant women should not normally be detained. The exceptions to this general position are where removal is imminent and medical advice does not suggest confinement before the due removal date or, for pregnant women of less than 24 weeks gestation, at Yarl's Wood as part of a fast-track asylum process.

**Julian Huppert:** To ask the Secretary of State for the Home Department how many women detained for immigration purposes were (a) deported and (b) released in 2010-11; and how long each such woman was detained for. [76664]

**Reply from Damian Green:** Published information on detention relates to those people held in detention, solely under Immigration Act powers in immigration removal centres and short-term holding facilities. This excludes those in police cells, Prison Service establishments, short-term holding rooms at ports and airports (for less than 24 hours), and those recorded as detained under both criminal and immigration powers and their dependants.

### Detention Centres: Children

**Keith Vaz:** To ask the Secretary of State for the Home Department how many children have been held in detention at pre-departure accommodation Cedars since it opened. [75650]

**Reply from Damian Green:** The latest published figures show that no children have been held in the pre-departure accommodation at Cedars between when it opened on 17 August 2011 and 31 August 2011.

Since 25 November 2010, each month the Home Office has published a table specifically showing how many children entered immigration removal centres and short-term holding facilities. This excludes those in police cells, Prison Service establishments and short-term holding rooms at ports and airports (for less than 24 hours), those recorded as detained under both criminal and immigration powers and their dependants. From 29 September 2011, when figures for August were published, this table has included Cedars pre-departure accommodation.

The Home Office publishes monthly, quarterly and annual statistics on the number of children entering detention, solely under Immigration Act powers. Children entering detention figures relating to September 2011 will be published on 27 October 2011 and will be available from the Library of the House and from the Home Office Science, research and statistics web pages at: <http://www.homeoffice.gov.uk/science-research/research-statistics/migration/migration-statistics/>

**Keith Vaz:** To ask the Secretary of State for the Home Department how many children are being held in each immigration detention facility; and what the reason for the detention is in each case. [75677]

**Reply from Damian Green:** The latest published figures show that no children were being held in detention, solely under Immigration Act powers in immigration removal centres and short term holding facilities as at 30 June 2011. This excludes those in police cells, Prison Service establishments and short-term holding rooms at ports and airports (for less than 24 hours), those recorded as detained under both criminal and immigration powers and their dependants.

Quarterly figures published on children in detention are taken as a snapshot on the last day of each quarter. Additionally figures are published on children entering detention on a monthly basis.

The Home Office publishes quarterly and annual statistics on the number of children in detention, solely under Immigration Act powers. Children in detention figures as at 30 September 2011 will be published on 24 November 2011 and will be available from the Library of the House and from the Home Office Science, research and statistics webpages at: <http://www.homeoffice.gov.uk/science-research/research-statistics/migration/migration-statistics1/>

### Detention Centres: Suicide

**Shabana Mahmood:** To ask the Secretary of State for the Home Department what measures are in place to support those who are held in detention centres who are considered to be at risk of suicide. [76654]

**Reply from Damian Green:** Each Immigration removal centre has a comprehensive self harm reduction strategy in place to support detainees who are deemed to be at risk of suicide or self-harm. The procedures, Assessment Care in Detention and Teamwork (ACDT), provide a holistic approach to suicide and self-harm prevention within the broader context of decency, safety, and the concept of a healthy centre. It also brings existing policy in line with similar changes implemented by the Ministry of Justice.

The ACDT process starts as soon as an individual has been identified as being at risk. It involves an initial risk assessment and assessment interview conducted by specially trained individuals. A specific care map tailored to the issues faced by the individual is produced to ensure provision of multi-disciplinary support, including input from both health care professionals and staff at the centre. The ACDT document is reviewed at regular intervals to ensure the correct support is provided while the individual is thought to be at risk.

### Restraint Equipment: Detainees

**Shabana Mahmood:** To ask the Secretary of State for the Home Department what steps she is taking to review the techniques used to restrain detainees on aircraft. [76049]

**Reply from Damian Green:** The UK Border Agency formally asked the National Tactical Response Group of the National Offender Management Service to conduct a review of the current restraint techniques being used by escort officers including those used during removals.

Officials expect to receive an interim report on the review in November 2011.

**Shabana Mahmood:** To ask the Secretary of State for the Home Department how many detainees have been injured while being restrained during deportation from the UK in (a) the 12 months period ending on 1 September 2011 and (b) each of the previous five years. [76050]

**Reply from Damian Green:** Escort officers are trained in the use of control and restraint techniques, which are used only as a matter of last resort when all other alternatives of persuading a person to comply with their removal from the UK have failed or they need to be controlled for safety reasons.

The use of restraint is legitimate and lawful so long as its use is justified, proportionate and de-escalated at the earliest opportunity when the individual has complied. Escort officers are required to submit a report each time force has been used to restrain a detainee while being removed. However separate records are not held on injuries sustained. This could be determined only by examination of each use of force or incident report submitted at disproportionate cost.

The "Kristallnacht" pogrom is usually seen as the symbolic beginning of the Holocaust. On 9 November each year the UNITED network organises a European-wide campaign to commemorate the past and to protest against contemporary forms of fascism and antisemitism.
