Westminster Parliamentary Questions

British Citizenship

Lord Marlesford: To ask Her Majesty's Government in what circumstances the granting of United Kingdom residency or citizenship is required to have the recommendation of more than one official of the UK Border Agency.[HL13209]

Reply from the Minister of State, Home Office (Lord Henley): The settlement cases that require authorisation by a senior officer include: proposed grants of settlement where the applicant has a criminal conviction; proposed grants of residence where there is a positive result on internal security checks; proposals to grant settlement outside the immigration rules; proposed grants of settlement in employment route and long residence cases where there has been a break in continuous residence that exceeds the permitted limits; and cases where it is proposed to conduct a marriage interview in order to assess whether a relationship is genuine before settlement is conferred.

Immigration Controls

Pete Wishart: To ask the Secretary of State for the Home Department how many failed applicants under the Highly-Skilled Migrants programme have subsequently been deported; and what the average cost of completing deportation proceedings against such people was in the latest period for which figures are available. [80341]

Reply from Damian Green: The Highly-Skilled Migrants programme ran from January 2002 to March 2008. 485 failed applicants to the programme have been removed from the UK.

The UK Border Agency (UKBA) is unable to provide an average cost of completing deportation proceeding as there are many variables, including: whether the person makes a voluntary or supervised departure; whether the person has to be detained in order to facilitate their removal; whether they have to be escorted; whether we have to apply for a travel document for their return; whether they are accompanied by dependants, and if so how many; the destination to which they are being returned; legal challenges.

Immigrants: Families

Rehman Chishti: To ask the Secretary of State for Justice what discussions he has had with the Secretary of State for the Home Department on the application of Article 8 of the European Court of Human Rights by courts and tribunals in immigration and deportation matters; and if he will introduce legislation to reverse the effects of the decision of the House of Lords in Huang [2007] UKHL 11. [80564]

Reply from Kenneth Clarke: In the Home Office's recent consultation on family migration, the Home Secretary sought views on how a proper balance should be struck between the individual's right to respect for a private and family life and the wider public interest in protecting the public and controlling immigration. On 4 October the Home Secretary made clear her intention to revise the Immigration Rules to reinforce the public interest, in relation to cases engaging Article 8 of the European Convention on Human Rights, in respect of foreign nationals convicted of a criminal offence or who have breached our immigration laws being removed from the UK.

Immigration: Students

Lord Clement-Jones: To ask Her Majesty's Government what evaluation they have made of the impact of the new student visa rules on the intake of overseas students in United Kingdom universities for the academic year 2011-12.

Reply from the Minister of State, Home Office (Lord Henley): My Lords, the Government's impact assessment concludes that the student visa reforms will have no impact on the number of visas issued to international students to attend UK universities either in the academic year 2011-12 or in subsequent years.

Lord Clement-Jones: My Lords, that shows that the impact assessment must be flawed. The early indications are that they are being heavily impacted, particularly from India, where the number of students is 20 per cent to 50 per cent down, as a result probably of the withdrawal of the post-study work route visa. Will the Government reconsider their policy before treating students as economic migrants and irreparable damage is done both to the finances and the reputation of UK universities?

Reply from Lord Henley: My Lords, I do not accept what my noble friend had to say, and I would refer him to the comments made by Universities UK about the reforms, saying that they will allow British universities to remain at the forefront of international student recruitment. I also refer my noble friend to the latest figures for non-EU university student applications for the 2012 academic year which are mostly for medical, dentistry, veterinary and Oxbridge courses, and those show an 8.8 per cent rise.

Baroness Prashar: My Lords, does the Minister agree that the Government should introduce a transitional measure for those students already in the UK whose colleges closed either as a result of action taken by the UK Border Agency or because many private and public sector providers voluntarily relinquished their licence because the system became too burdensome? It is estimated that there are some 5,000 internal students with no course, no sponsor and the majority have lost their fees. Would it not be more humane and less damaging for the reputation of the UK if those already here could retain their current visas and work entitlements while moving to an alternative sponsor? This would avoid students, particularly those from poor countries, staying here illegally.

Reply from Lord Henley: My Lords, we want to make sure that we continue to have high-quality students coming to the UK, and that is why I am very grateful for the support of Universities UK for the reforms that we are proposing. What we do not want are bogus students coming over for what might be called rather dubious or possibly non-existent institutions. As I have made clear, what we have done certainly has the support of Universities UK and will benefit universities in the UK, although it might not benefit what I would describe as the somewhat dubious institutions that have been acting in this field. We want to clamp down on the abuses of the immigration system that have crept in here. ...

Visas

Lord Laird: To ask Her Majesty's Government how many private sector providers are highly trusted sponsors (HTS) for general purposes, how many have A and B rating, how many confirmations of acceptance for studies for non-European Union nationals non-HTS

providers are permitted to assign from 21 April 2011-25 April 2012 in total; and what that figure is expected to be for the following year.[HL13221]

Reply from the Minister of State, Home Office (Lord Henley): There are three separate levels of sponsor status; highly trusted (HTS), A rated or B rated. As at 9 November 2011, there are 990 private sector providers with HTS; 494 are A rated and 88 are B rated.

A rated and B rated sponsors have assigned 33,676 confirmation of acceptance for studies (CAS) from their active allocation. We do not make forecasts on the numbers of CASs that private sector non-HTS providers will assign in future years. The figures provided are based on local management information. This information has not been quality assured under National Statistics protocols and should be treated as provisional.

Illegal Immigrants: Employment

Shabana Mahmood: To ask the Secretary of State for the Home Department what steps she is taking to ensure businesses are aware of the penalties for employing illegal immigrants. [79775]

Reply from Damian Green: The UK Border Agency (UKBA) works closely with other Government partners, such as HM Revenue and Customs (HMRC), and trade bodies to provide business to business communications, targeting employers with enforcement messaging about illegal working operations and civil penalties. For example, during 2010 we completed a large number of employer awareness sessions, working jointly with HMRC, reaching more than 5,700 delegates. The Comprehensive Guidance for Employers on preventing illegal working and the shorter Summary Guidance were updated last year and widely publicised. Both documents include clear guidance on the level of civil penalties to be levied on employers found to be employing workers illegally.

UKBA enforcement teams complete educational visits to employers and the agency works closely with employer organisations to raise awareness of the civil penalty regime.

National and regional media are regularly used to highlight successful enforcement and immigration crime operations, including details of the penalties faced by employers who break the rules. The agency uses online channels to promote operations, publish names of non-compliant employers and provide guidance on preventing illegal working. This information is provided through the UK Border Agency website, social media channels such as Twitter, and partner channels such as Businesslink.gov.uk. and Direct Gov.

Asylum

Pete Wishart: To ask the Secretary of State for the Home Department how many unsuccessful asylum seekers deported from the UK were refused entry on arrival at the country of their origin and subsequently returned to the UK in each of the last 24 months. [80340]

Reply from Damian Green: The UK Border Agency does not record this information on the Case Information Database (CID). To obtain this information would require a case by case search.

Asylum

Jim Cunningham: To ask the Secretary of State for the Home Department how many asylum claims are outstanding; and from which countries the applicants in those cases came. [81311]

Reply from Damian Green: The number of asylum applications made since April 2006 pending an initial decision or further review, excluding dependants, as at 31 August 2011 was 10,810. Of these 10,810 asylum cases, 5,655 were pending an initial decision and 5,155 were pending further review. A copy of the table disaggregated by country of nationality will be placed in the Library of the House. Total figures for the number of asylum applications awaiting an initial decision or further review are published monthly in monthly asylum statistics. Immigration: Detention Centres

The Lord Bishop of Ripon and Leeds: To ask Her Majesty's Government what steps they are taking to ensure that residents are able to fulfil their religious obligations through making financial gifts in those immigration removal centres which are seeking to remove the use of cash from their premises. [HL13273]

Reply from the Minister of State, Home Office (Lord Henley): Cashless systems in the UK Border Agency's immigration removal centres provide detainees with an account into which their money is paid on arrival. Donations made to them and any earnings are credited to their accounts, and purchases are debited. Detainees may also make arrangements for money to be transferred to other people or organisations from their accounts. The account balance is paid to the individual in cash when they are discharged from detention.

If detainees wish to make donations as part of their religious obligations, they may make arrangements for money to be transferred from their accounts to the organisation of their choice.

Detention Centres: Children

Lisa Nandy: To ask the Secretary of State for the Home Department with reference to her speech of 16 December 2010, what progress she has made on her proposal to end the detention of children for immigration purposes. [80666]

Reply from Damian Green: In December 2010 the Government published their plans for ending detention of children in a way which protects the welfare of children while ensuring that families with no right to remain in the country leave the UK.

On 1 March 2011 the UK Border Agency rolled out a new family returns process to

achieve this. This process gives families every opportunity to leave without the need for enforcement action and offers financial or practical assistance where appropriate. Where families choose not to co-operate, the UK Border Agency will take steps to ensure that they leave. In every case the Border Agency must submit a tailored family returns plan to a new independent Family Returns Panel comprising safeguarding and medical experts who advise on how the welfare of the children can best be safeguarded during the return.

Return plans may include a strictly time-limited stay in new family-friendly pre-departure accommodation, Cedars, where Barnardo's provide welfare and support services to help families prepare for their return. This is used as a last resort.

Tinsley House immigration removal centre remains in use for families intercepted at the border who are being held while arrangements are made for their immediate return and, in rare cases, for criminal and other high risk families who cannot be safely accommodated in pre-departure accommodation.

As set out on 16 December 2010, families may be held at ports for up to 24 hours to determine whether they should be admitted to the country or removed on a return flight.

Deportation: Complaints

Pete Wishart: To ask the Secretary of State for the Home Department how many (a) complaints and (b) claims have been made by (i) males and (ii) females of each nationality in each age group against her Department and its agencies and contractors as a result of alleged injuries and assaults sustained during the enforcement of deportation orders in each of the last five years; and what the location was of each alleged incident. [80336]

Reply from Damian Green: Complaints made by individuals detained in immigration removal centres or being removed from the UK have been centrally collated since December 2008. Information prior to this date is not available. The question has been interpreted as relating to the number of complaints and claims made that an incident allegedly took place during the removal process. All complaints are investigated and where there is an allegation of assault, the matter is referred to the police.

The number of complaints where an individual has alleged assault during an enforced removal are shown in the following table.

Anti-Semitism

Mr Hain: To ask the Secretary of State for Wales what steps her Department has taken to combat anti-Semitism since July 2010; and if she will make a statement. [80582]

Mr David Jones: The Government are committed to confronting anti-Semitism wherever it is found. Policy on tackling anti-Semitism across the UK is co-ordinated by the Department for Communities and Local Government through the cross-Government working group on anti-Semitism. This Group meets on a quarterly basis and includes representatives from the Community Security Trust, the Board of Deputies of British Jews and the Jewish Leadership Council.
