Holyrood Parliamentary Questions

British Citizenship

Iain Gray: To ask the Scottish Executive how many and what percentage of its posts require the jobholder to have British citizenship. (S4W-04041)

Reply from John Swinney: Under the Civil Service Nationality Rules, certain posts where the nature of the work requires special allegiance to the Crown can be deemed to be reserved for UK nationals. There are no posts within the Scottish Government which are reserved for UK Nationals.

The Civil Service Nationality Rules govern eligibility for employment in the UK Civil Service on the grounds of nationality and must be followed in our recruitment and appointment procedures. There are no posts within the Scottish Government which are reserved for UK Nationals, and this has been the case since Devolution in 1999.

What this means is that normally only those people who are nationals of the UK, European Economic Area (EEA), Commonwealth Countries and Dependant Territories can work within the UK Civil Service, including the Scottish Government. Certain family members of EEA nationals who themselves don't meet the nationality rules may be eligible to join the civil service if the EEA national has triggered his or her freedom of movement rights under EC law.

Human Trafficking

Drew Smith: To ask the First Minister what action the Scottish Government is taking to tackle human trafficking. (S4F-00316)

Reply from tThe First Minister (Alex Salmond): Human trafficking is an abhorrent crime and the Scottish Government is committed to making further progress in tackling the criminals who engage in it. The recent report from Helena Kennedy's Equality and Human Rights Commission acknowledges that the Scottish Government has taken important steps in recent years in anti-trafficking and helpfully sets out recommendations for further action.

We have provided additional funding of £4 million over a two-year period from 2009 to 2011 to the Scottish Crime and Drug Enforcement Agency to boost capacity to tackle organised crime and, within that, provide Scotland's first dedicated expert resource to build the intelligence necessary to support and improve human trafficking investigation.

Drew Smith: I thank the First Minister for that answer, particularly in the light, as Helena Kennedy says in her report, of the Glasgow 2014 Commonwealth games. There is some urgency around ensuring that our approach to human trafficking is correct, and Baroness Kennedy raises a number of concerns about the interaction between police and the United Kingdom Border Agency, the low awareness of trafficking in Scotland, the definition in law where two offences exist for the same crime, lack of intelligence, lack of prosecution expertise and lack of services for victims.

Does the First Minister take the view that there is a case for a review of the legislation in this area and will he ask the Cabinet Secretary for Parliament and Government Strategy to bring forward an early debate so that parties across the chamber can discuss this very important issue in more detail?

Reply from the First Minister: I shall speak to the business manager to allow that to happen. Let me quote the words of Baroness Kennedy in a letter to the Cabinet Secretary for Justice: "In conducting this Inquiry I have learnt not only how seriously you and Alex take the horrifying practice of human trafficking but, in particular, of your personal determination to eradicate it in Scotland. I would also

like to reiterate my appreciation for the consistently helpful input and cooperation that you and your Justice Directorate have given to me and my team in conducting this Inquiry.”

Given the enthusiasm with which we co-operated in the conduct of the inquiry, the member can be absolutely certain that we will pursue its welcome recommendations to fruition.

Westminster Parliamentary Questions

British Nationality

Graham Evans: To ask the Secretary of State for the Home Department whether she has received any applications to reduce the normal time period required for UK naturalisation in each of the last three years; and how many have (a) been received and (b) been successful. [83328]

Reply from Damian Green: No statistical information is available which would record any requests made by applicants for naturalisation as British citizens to reduce the required residence periods.

The Secretary of State for the Home Department, my right hon. Friend the Member for Maidenhead (Mrs May), does have discretion over absences from the United Kingdom during the qualifying residence period. Discretion is also available to waive the residence requirements under schedule 1 sections 1(3) and 4(d) of the British Nationality Act 1981 when applicants are applying on the basis of Crown or designated service.

However, no discretion is available to waive the requirement to have been physically present in the United Kingdom at the beginning of the residential qualifying period.

The use of discretion is part of the consideration process.

No statistical information is available to record the use of discretion during the consideration process.

Jeremy Corbyn: To ask the Secretary of State for the Home Department what criteria she uses for immigration files placed in the controlled archive. [81286]

Reply from Damian Green: The controlled archive is a hold for those cases where the case resolution directorate (CRD) had tried to establish contact with the applicant through the current set of processes and has been unsuccessful. All checks to establish the applicant's whereabouts have been made and all information on case information database (CID) for the applicant is correct.

When deciding whether to place a case file in the controlled archive, internal electronic records and the case papers must be checked thoroughly to ensure that all steps have been taken to contact the applicant. All cases are subjected to checks against watchlists and the police national computer before being placed in the controlled archive.

Jeremy Corbyn: To ask the Secretary of State for the Home Department how often immigration cases in the controlled archive are checked; what databases are used to carry out such checks; and how many staff perform such checks. [81288]

Reply from Damian Green: The Case Assurance and Audit Unit are responsible for ongoing management of the controlled archive and active management of cases which could not be fully concluded due to a barrier, the unit consists of 126 staff.

Each case is reviewed on a six monthly basis and a range of internal Home Office and external data bases are available.

The Controlled Archive is a hold for those cases where the Case Resolution Directorate (CRD) had tried to establish contact with the applicant through the current set of processes and has been unsuccessful and all checks to establish the applicant's whereabouts have been made and all information on Case Information Database (CID) for the applicant is correct.

When deciding whether to place a case file in the Controlled Archive, electronic records (ASYS, CID), and the case papers must be checked thoroughly to ensure that all steps have been taken to contact the applicant. All cases are subjected to checks against the Police National computer and Warning Index before being placed in the controlled archive. Lord Avebury To ask Her Majesty's Government how many asylum cases are under consideration by the Criminal Cases Directorate; of these, how many relate to persons arrested on entry to the United Kingdom; and how many of those in turn relate to persons convicted under Section 2 of the Asylum and Immigration (Treatment of Claims etc.) Act 2004 for not having a travel document at the time an application for leave or asylum was made. [HL13713]

The Minister of State, Home Office (Lord Henley): There are 323 asylum cases under consideration by the Criminal Casework Directorate as of 24 November 2011. It would incur a disproportionate cost to obtain a breakdown relating to persons arrested on entry and convicted for the lack of a travel document.

Keith Vaz: To ask the Secretary of State for the Home Department how many cases considered by the UK Border Agency's Case Assurance and Audit Unit have resulted in an individual being (a) removed and (b) granted indefinite leave to remain in each month since July 2011. [79435]

Reply from Damian Green: From July 2011 to October 2011 the UK Border Agency's Case Assurance and Audit Unit have considered (a) 1,074 cases which have resulted in a removal of an individual (b) 829 cases leading to a grant of indefinite leave (c) 1,906 cases which have resulted in a grant of temporary leave:

Pete Wishart: To ask the Secretary of State for the Home Department (1) whether the UK Border Agency has any plans to review its policy on the time of day at which it visits homes for the removal of failed asylum seekers and illegal immigrants; [82091]

(2) if she will place in the Library a copy of the guidance provided to immigration officers undertaking home visits; [82092]

(3) whether guidance is provided to immigration officers on the time of day a visit should take place to a home where a child is resident. [82093]

Reply from Damian Green: The UK Border Agency has clear guidance on the considerations that need to be made when planning an enforcement visit, including the time the visit should take place.

Guidance for the timing of operational enforcement visits to residential addresses is set out in chapters 31, 45 and 61 of the Enforcement Instructions and Guidance which is available for public viewing on the UK Border Agency website at the link below: www.ukba.homeoffice.gov.uk/policyandlaw/guidance/enforcement/

Where enforcement action is being considered to ensure the return of a family with children, an individually tailored return plan will be referred to the independent Family Returns Panel. Enforcement visits will only take place when the Family Returns Panel has advised on the most appropriate time of day to secure the return of the family, while having regard to the welfare of the children.

The timing of visit for cases falling outside of the family returns process is determined and also recorded in the risk assessment that is carried out for each visit. Visits should not normally take place either very late at night or very early in the morning unless operational planning indicates that a visit would be frustrated if

carried out at a different time. All existing policy and guidance relating to the timing of enforcement visits is regularly reviewed as part of a programme of nationwide unannounced assurance currently being rolled out by the UK Border Agency's Professional Standards for Enforcement team (PSE).

Reply from Damian Green: One child who was resident in Scotland prior to their removal was in pre-departure accommodation in November 2011.

No other child from Scotland has been in these facilities in the last 12 months.

Pete Wishart: To ask the Secretary of State for the Home Department how many children resident in Scotland have been moved to Yarl's Wood immigration removal centre since May 2010. [82045]

Reply from Damian Green: Since May 2010 no children resident in Scotland have been moved to Yarl's Wood.

Equality Act 2010

Lord Avebury: To ask Her Majesty's Government which persons or organisations within the United Kingdom opposed the bringing into force of Section 9(5)(a) of the Equality Act 2010, as claimed in a statement by Mr Hoggan to the United Nations Committee on the Elimination of Racial Discrimination on 24 August.[HL13474]

Reply from Baroness Verma: The statement made by the UK delegation to the United Nations Committee on the Elimination of Racial Discrimination did not refer to specific persons or organisations but related to the fact that, in the UK Government's view, there is no consensus of opinion in the UK with regards to the need for legislative protection against caste discrimination, even among those communities potentially most affected by it. For example, the Minister for Equalities, Lynne Featherstone, together with various government officials, attended an independent meeting on 15 March chaired by Lord Dholakia, at which the issue of caste legislation was discussed. At that meeting a number of participants spoke to oppose the bringing into force of Section 9(5)(a) of the Equality Act 2010. However, this was an independent meeting organised by concerned groups and individuals to lobby the Government on the issue, and no government record of who participated or spoke exists.

Equality

Lord Stoddart of Swindon: To ask Her Majesty's Government, further to the answer by Lord McNally on 16 November (*Official Report*, col. 683), whether the "tipping point" criterion constitutes discrimination against white men from the ethnic majority and undermines their human rights; and whether they will explain how the choice will be made between women and ethnic minorities and among the ethnic minorities themselves.[HL13645]

Reply from the Minister of State, Ministry of Justice (Lord McNally): The application of the "tipping point" provisions contained within the Equality Act 2010 does not constitute discrimination against any applicant.

The Ministry of Justice has recently published a consultation, which includes the proposal that the appointments process should be amended to enable the utilisation of the Equality Act 2010 positive action provisions where the merits of the candidates are essentially indistinguishable. This proposal retains the fundamental principle that judicial appointments should always be made on merit. However, where at the end of the selection process two candidates are essentially indistinguishable, then any of the eight protected characteristics could be applied to decide who to select for appointment.

Stewart Maxwell (West Scotland) (Scottish National Party): To ask the Scottish Executive whether it will provide a breakdown of recorded religious hate crimes in 2010-11 expressed as the number of incidents per 1,000 members of each religious affiliation. (S4W-04247)

Reply from Roseanna Cunningham: The report *Religiously Aggravated Offending in Scotland 2010-11* was published on 18 November 2011 and presented information on the number of religious aggravation charges (from Section 74 of the Criminal Justice (Scotland) Act 2003) that were reported to the Crown Office and Procurator Fiscal Service (COPFS) by the police in 2010-11. This report only presented information about the nature of the religious belief that was targeted through the offensive conduct and not about the religious affiliation of the victims of incidents.

COPFS in 2010-11 for conduct which was derogatory to each religious affiliation, and the number of charges per 1,000 members of each, as recorded in the 2001 census.

James Kelly: To ask the Scottish Executive what work it has carried out since 2007 to promote the use of anti-sectarian education resources to teachers. (S4W-03238)

James Kelly: To ask the Scottish Executive what guidance it has provided to local authorities since 2007 for schools to teach about sectarianism. (S4W-03244)

Reply from Roseanna Cunningham: Curriculum for Excellence, the national curriculum for Scottish schools, aims to provide the right environment to enable young people to develop as informed and responsible citizens. Curriculum for Excellence challenges schools to develop children and young people as responsible citizens who show respect for others; who can understand different beliefs and cultures, and who are developing informed, ethical views of complex issues.

Curriculum for Excellence also challenges schools to support the health and wellbeing of their pupils. Learning through health and wellbeing promotes confidence, independent thinking and positive attitudes. It supports children and young people to develop respect for others, to acknowledge diversity and to understand that it is everyone's responsibility to challenge discrimination.

Anti-sectarian education plays a really important role in all of this. Many different curriculum areas can be involved.

Since 2007 the Scottish Government has provided funding to a wide range of organisations to deliver projects to tackle sectarianism and all forms of religious intolerance across all aspects of Scottish society. A number of these organisations have offered support to schools and local authorities.

Education Scotland, a Scottish Government agency, is the national body responsible for supporting quality and improvement in learning and teaching from early years to adult and community learning in Scotland.

In 2007 Education Scotland, the then HMIE, published a report: Count us in Promoting Understanding and Combating Sectarianism Practical Examples from Primary, Secondary and Special Schools which aims to promote inclusive practices. The booklet brings together some examples of successful practice in promoting mutual understanding and combating sectarianism. It offers guidance on good practice and examples of resources to combat sectarianism. The report can be found at: <http://www.hmie.gov.uk/documents/publication/cuipepss.html>.

Education Scotland, and previously HMIE, will comment and publish reports on schools which are of good practice or where areas for improvement are identified in regard to sectarianism and twinning approaches where appropriate.

The Education Scotland website also offers lesson plans, resources and aspects of good practice in teaching and learning with regards to tackling sectarianism.

As part of the work being taken forward in Scotland to tackle sectarianism we will work with partners to support use of sectarianism as a context for learning which inspires and engages young people.

Reply from Roseanna Cunningham: The Ministerial Delivery Group on Tackling Sectarianism was an initiative of a previous administration, when an administration changes at the end of a parliamentary term, all Cabinet Sub-Committees, Ministerial and Delivery Groups cease to exist. The Scottish Government has consistently championed work to tackle sectarianism through funding organisations like Sense Over Sectarianism, Nil By Mouth, the Iona Community, Show Racism the Red Card, Show Bigotry the Red Card and YouthLink Scotland to develop resources and deliver specific projects and initiatives to tackle sectarianism. During the period of the last administration we expanded the range of work being delivered from being largely focussed on school age children and young people, to also include work aimed at adults and supported the development of resources to tackle sectarianism in the workplace and work to tackle sectarianism among adult prisoners. This work continues and in the 2011-12 financial year alone we will be providing £527,000 to such organisations to work in communities, schools, workplaces and prisons to prevent abusive sectarian behaviour from occurring.

In 2007 Education Scotland, the then HMIE, published a report: Count us in Promoting Understanding and Combating Sectarianism Practical Examples from Primary, Secondary and Special Schools which aims to promote inclusive practices. The booklet brings together some examples of successful practice in promoting mutual understanding and combating sectarianism. It offers guidance on good practice and examples of resources to combat sectarianism. The report can be found at <http://www.hmie.gov.uk/documents/publication/cuipess.html>. Education Scotland is building on this work by developing work in schools using the Curriculum for Excellence and, over the next few months, they will be aiming to find good practice, to help improve resources to support teaching and learning, and to support and encourage discussion across the country about how we can eradicate sectarianism through education from cradle to grave. This is a very positive step in ensuring that educational tools and approaches to tackling sectarianism are robust and fit for purpose.

The Joint Action Group – including representation from the Scottish Football Association, the Scottish Premier League, the Scottish Football League, Celtic Football Club, Rangers Football Club, Strathclyde Police and the Scottish Government – has worked in partnership to develop and deliver measures to tackle alcohol misuse, violence and sectarian bigotry associated with football. This work is also ongoing. We have introduced the Offensive Behaviour at Football and Threatening Communications and Threatening Communications (Scotland) Bill to stamp out offensive behaviour at football.

Racism and Religious Hatred Holyrood Parliamentary Questions (continued)

On 23 November I announced unprecedented funding of £9 million over the next three years to tackle sectarianism in all its forms and to deliver wide-ranging initiatives and projects across the country. I also announced that we are making up to £60,000 available in the current financial year to allow the Scottish Community Development Centre (SCDC) and Voluntary Action Fund (VAF) to pilot work in seven locations across Scotland to test the impact and effectiveness of working directly with communities to develop tailored solutions to the sectarian problems they experience, and support the delivery of those solutions.

We also published an analysis of religiously aggravated offences – Section 74 of the Criminal Justice (Scotland) Act 2003 – covering a one year period from 1 April 2010 to 31 March 2011 on 18 November and are committed to undertaking year-on-year analysis of this aggravation so that this data can be analysed along with other available evidence currently available to map out and better target initiatives as well as informing the development of future work.

In addition I have formed, and will chair, a Ministerial Group on Tackling Sectarianism which will include the Minister for Learning and Skills; Minister for Local Government and Planning; and Minister for Sport; and Cabinet Secretary for Culture and External Affairs. This group will work together to coordinate all of the Scottish Government's activities on tackling sectarianism and ensure that all portfolios are contributing to this agenda.
