## **Holyrood Parliamentary Motions**

**S4M-02634 Humza Yousaf: Concern at Evictions in Glasgow**—That the Parliament raises serious concern at the decision to evict 140 asylum seekers and refugees in Glasgow; recognises that many of these families come from war-torn conflict zones that would be unsafe to return to; understands that, if evicted, families will be left with no home and no access to work or benefits; believes that compassion must be shown to the most vulnerable in society, and considers that organisations such as the Fire Brigades Union Scotland have given fantastic support with their generous donations to enable the families to remain housed in the short term.

## **Westminster Parliamentary Questions**

#### **UK Border Force**

**Chris Bryant:** To ask the Secretary of State for the Home Department what operational responsibilities she proposes will be shared between the National Border Command and the UK Border Force. [101064]

**Reply from Damian Green:** The Border Policing Command (BPC) (as part of the National Crime Agency—NCA) and Border Force will work closely together and will play vital roles in the Government's approach to delivering increased security at the border. Border Force will be responsible for entry controls and customs functions at the border. The Border Policing Command will take the lead in delivering better, more joined up enforcement activity across all agencies operating in and around the border, including Border Force.

Border Force will be responsible for sharing intelligence with the BPC. This will enable the BPC to deliver a single, comprehensive picture of the threats to public safety and security at the border. The BPC will be responsible for tasking and coordinating Border Force assets (alongside wider NCA, UK Border Agency, law enforcement and other partner assets) to carry out separate or joint operations relating to border security.

These data will include some students who have not yet entered the country and some who have subsequently left the country. Individuals could be counted more than once within the data.

#### Refugees: Asylum

**Mike Wood:** To ask the Secretary of State for the Home Department in what circumstances a stateless person would be expected to provide a passport when making an application for asylum in the UK. [103628]

**Reply from Damian Green:** All applicants for asylum are expected to provide documents relating to their identity, nationality or country of habitual residence in so far as it is reasonable for them to do so. However, it is recognised that in some circumstances this will not be possible.

### Asylum

**Jon Cruddas:** To ask the Secretary of State for the Home Department why the UK Border Agency does not recognise asylum seekers from non-Arab ethnic groups from Darfur as members of such groups; and what assessment she has made of the likelihood of non-Arab Darfuri asylum seekers returned from the UK to Sudan being at risk of detention and torture. [103654]

**Reply from Damian Green:** Each asylum and human rights claim is considered on its individual merits in accordance with the UK Border Agency's obligations under the 1951 UN Refugee Convention and the European Convention on Human Rights. Claimants who meet the definition of a refugee in the 1951 convention are granted asylum. If they do not qualify for asylum, but there are other circumstances that make them particularly vulnerable and engage the UK Border Agency's obligations under the European Convention on Human Rights, they are granted humanitarian protection or discretionary leave. If their application is refused, they have a right of appeal to the courts. In this way the UK Border Agency ensures that it provides protection to those who need it.

Asylum claims by Sudanese nationals are dealt with in the same way as claims from every other country of origin. This includes assessment of nationality and, where appropriate, ethnicity, using information provided by the claimants themselves, relevant case law and objective country of origin information.

**Jon Cruddas:** To ask the Secretary of State for the Home Department what assessment she has made of the likelihood of the ethnicity of the 15 non-Arab Sudanese in detention at Campsfield facility and 13 at the Dover facility making them subject to detention and torture if returned to Sudan. [103655]

**Reply from Damian Green:** The UK Border Agency carefully considers all applications on their individual merits, and will offer protection to those who genuinely need it. Those who are found not to have a right to be here are expected to leave voluntarily. If they fail to do so, the UK Border Agency will seek to remove them.

The UK Border Agency only enforces the return of individuals whom it is satisfied have no right to be in the United Kingdom and who do not leave voluntarily.

#### Human Trafficking

Anas Sarwar: To ask the Secretary of State for Justice (1) how many prosecutions for human trafficking in Scotland in 2011 led to successful convictions and how many of those convicted were given a custodial sentence; [103479]

(2) how many prosecutions for human trafficking led to successful convictions in England and Wales in 2010-11 and how many of those convicted were given a custodial sentence. [103480]

Reply from Crispin Blunt: The number of defendants proceeded against at magistrates courts, found guilty and sentenced to immediate custody at all courts for human trafficking offences in England and Wales in 2010 (latest available) can be viewed in the table.

Court proceedings figures given in the table relate to persons for whom these offences were the principal offences for which they were dealt with. When a defendant has been found guilty of two or more offences it is the offence for which the heaviest penalty is imposed. Where the same disposal is imposed for two or more offences, the offence selected is the offence for which the statutory maximum penalty is the most severe.

Court proceedings data for Scotland are not held by the Ministry of Justice. Information for Scotland is a matter for the Scottish Executive.

Annual court proceedings data for England and Wales for 2011 are planned for publication on 24 May 2012.

# Westminster Early Day Motion

**Chris Bryant (2964) Statement of Changes in Immigration Rules** – That this House supports most elements of the Statement of Changes in Immigration Rules HC 1888, a copy of which was laid before this House on 15 March 2012, for instance the provisions that close the Tier 1 (Post-Study Work) category and introduce the Tier 1 (Graduate Entrepreneur) category and that amend the settlement regime; expects that the annual limits for 2012-13 and 2013-14 for Tier 1 of the Points-Based System will not make any appreciable difference to the Government's declared net migration targets, but is concerned that the proposed changes to the categories for overseas domestic workers in private households as they affect diplomats and others may lead to an increase in illegal trafficking and virtual domestic slavery; and therefore calls on the Government to allow a debate on the Statement of Changes as soon as possible. http://www.parliament.uk/edm/2010-12/2964

#### **Governance and Communities**

**Mark McDonald:** To ask the Scottish Executive how it supports the rights of minority ethnic groups in the workplace. (S4W-06451)

**Reply from Nicola Sturgeon:** Employment legislation which provides for the rights of employees, including ethnic minorities, is a reserved matter. Equality legislation is also largely reserved and the protection from discrimination for ethnic minorities and other protected characteristics is provided for through the Equality Act 2010. Scottish Ministers are responsible for specific duties to enable the better performance of the public sector equality duty in the Equality Act 2010. Within these proposed specific duties are requirements in relation to impact assessment, and gathering and using employment information. These duties are currently under consideration by the Scottish Parliament.

In relation to specific work around employment and employability, the Scottish Government continues to seek to address issues facing ethnic minorities. This includes funding the Glasgow Works project which supported and helped implement the Glasgow Works Ethnic Minority Policy Group Action Plan. In 2012-15, we are also funding the STUC"s One Workplace project, which aims to promote equality and tackle racism in the work place by building the capacity of Scottish trades unions to work effectively with public, private and voluntary sector employees on equality issues.

**Mark McDonald:** To ask the Scottish Executive what research is being done into the working conditions of minority ethnic groups. (S4W-06452)

**Reply from Nicola Sturgeon:** The Scottish Government does not currently have any commissioned research projects on this topic, but has considered the available evidence on the broader issue of employment outcomes for the full range of ethnic minority groups in Scotland.

Scottish Government analysts are also engaged in a Joseph Rowntree Foundation research programme on poverty and ethnicity in the UK. Within this, JRF seeks to explore the impact of informal workplace practices and culture on workplace experiences of people with different ethnic identities, and on deprivation. The main aim is to provide insight into what action could be taken to

address the level of in-work poverty experienced by people from different ethnic minority groups. The Scottish Government awaits the findings of this work with interest.

# **Westminster Parliamentary Questions**

### Human Rights: Religion

**Karl McCartney:** To ask the Minister for Women and Equalities if she will bring forward legislative proposals to protect workers who choose to wear a visible cross or crucifix. [104122]

**Lynne Featherstone:** There is nothing in domestic law that denies people the right to wear visibly a religious symbol such as a cross or crucifix while at work. Employers need to have proportionate and legitimate reasons—for instance in order to comply with health and safety requirements—if they want to restrict their employees from openly wearing any religious item.

We believe that domestic law already strikes the right balance between the rights of employees to manifest their faith and that of employers to place legitimate and appropriate restrictions on that freedom. There are no current plans to change the law in this respect.

**Reply from Lynne Featherstone:** Within Great Britain, anti-discrimination provisions contained in the Equality Act 2010 are intended to provide equal protection to all religions and religious or philosophical beliefs. No assessment has been made by Government of the effectiveness of these provisions in relation to any specific religion or belief.

# **Holyrood Parliamentary Question**

**Kezia Dugdale**: To ask the Scottish Executive how many reported incidents of racism in the last year for which figures are available involved an online element. (S4W-06348)

**Reply from Kenny MacAskill:** Information held centrally on the number of racist incidents recorded by the police cannot identify whether the incident involved an online element.

The 2012-13 Scottish Crime and Justice Survey, however, includes a new section on harassment. This will provide an estimate of how many people have been insulted, pestered or intimidated in the last 12 months by anybody who is not a member of their household. The survey will also establish whether there was any racial motive for the harassment and the means by which individuals were harassed, including (as separate categories) via texts or e-mail, or in writing via the internet, such as a social networking site. Subject to sample sizes, results will be available from November 2013 and will cover the adult (16 and over) population only.

**Reply from Lynne Featherstone:** Information on the number of people charged under the Female Genital Mutilation Act 2003 is not centrally held. There had been no prosecutions under the Female Genital Mutilation Act 2003 in England and Wales, from its introduction in March 2004 up to the end of 2010.

Research suggests that there may be a number of barriers to prosecution, including pressure from the family or wider community to remain silent. Multiagency practice guidelines on handling cases of female genital mutilation were

#### Listed Places of Worship Grant Scheme

**Helen Goodman:** To ask the Secretary of State for Culture, Olympics, Media and Sport what assistance he is planning to provide to owners of listed buildings who are not eligible for the listed places of worship grant scheme, following the changes to VAT charged on approved alterations. [103974]

**Reply from John Penrose:** English Heritage provides a wide range of advice and support to owners of listed buildings and their various associations; details are available on their website.

Financially, Governments have not historically provided support (apart from churches through the Listed Places of Worship scheme) for repairs or maintenance of listed buildings, which have long been VAT-able at the same rate as non-listed structures.

Instead, owners of listed buildings used to enjoy a VAT exemption for alterations (such as loft extensions or new conservatories) while everybody else had to pay VAT for the same work on an unlisted property. This created a perverse incentive for listed building owners to alter and modernise their properties rather than maintain the rare or beautiful old structure which was, of course, the reason why it was listed in the first place.

The Budget puts these anomalies right. We have no plans to spend any more taxpayers' money by recreating them in some other way.

**Dan Jarvis:** To ask the Secretary of State for Culture, Olympics, Media and Sport how he plans to extend the listed places of worship grant scheme; and how much it will cost to extend the scheme in the next financial year. [103975]

**Reply from John Penrose:** We will be extending the assistance provided by the Listed Places of Worship Scheme to ensure that alterations are also eligible for support. We have already begun consulting a range of organisations, both faith groups and heritage protection organisations, on the details of these changes.
