Immigration: Foreign University Students

Lord Hannay of Chiswick: To ask Her Majesty's Government what consideration they have given to the benefits to the United Kingdom of ceasing to classify foreign university students as economic migrants.

Reply from the Minister of State, Home Office (Lord Henley): My Lords, the United Kingdom uses the internationally agreed definition of the migrant, which is someone who comes here for over 12 months. It is right that students staying for that period are counted because during their stay they are part of the resident population. It would damage public confidence in statistics to discount them.

Lord Hannay of Chiswick: ... The main reason he has given in replies to earlier questions-he has just given it again-for not changing our present practice of classifying students for policy purposes in the net migration figures is the existence of a UN guideline to the effect that anyone who stays for a year is a migrant. Can he confirm that the guideline does not have the force of international law, is therefore not binding on the British Government and, further, is not applied in the calculation of net migration figures for policy purposes by our main competitors in the higher education sector-the US, Canada and Australia? Is it not about time that the Government ceased to handicap the most rapidly growing and most promising invisible export sector we have?

Reply from Lord Henley: My Lords, I fail to understand what the noble Lord and Universities UK are getting at in their objections to us applying proper statistics as agreed by international convention, which is what we follow. If the noble Lord is suggesting that by changing the way we count the statistics, we will make life easier for universities, again I fail to understand him. I do not see why they are discouraging undergraduates from coming to this country. All we require of the students is that they show an ability to speak English and that they have an offer of a place at a university in the United Kingdom. The statistics simply do not come into it, so fiddling with them would discourage students because it would imply that probably the only subject they ought to come here to study would be statistics.

Lord Eden of Winton: Can my noble friend assure the House that nothing is being done now that would in any way damage or reduce the substantial economic benefit that bona fide foreign students bring to this country, in particular to our universities, colleges and academies where the English language is taught? It is important that this should continue unabated.

Reply from Lord Henley: My Lords, I totally agree with my noble friend, and we want to continue to encourage them to come here. I do not see why changing the statistics is going to discourage them. We have, in fact, seen an increase in the number of students who come to reputable and proper universities, and a reduction in the number of those who come to bogus colleges and schools, who come here not to learn but to work.

Nicholas Soames: To ask the Secretary of State for the Home Department how many non-EU students were reported to her Department by educational institutions due to (*a*) poor attendance and (*b*) other concerns about their genuineness. [114868]

Reply from Damian Green: Tier 4 sponsors use the online Sponsor Management System to report on student activity. Sponsors select one of a number of categories when reporting.

The number of reports by sponsors using the category which most closely equates to poor attendance, "Student has missed 10 expected contacts without

Immigration

Lord Morrow: To ask Her Majesty's Government whether the UK Border Agency is monitored to ensure compliance with all statutory rules when interviewing potential illegal immigrants, particularly with regard to interviews of children and vulnerable adults, when a social worker or person of similar standing is required to be present.[HL1029]

Reply from the Minister of State, Home Office (Lord Henley): Oversight of the UK Border Agency's compliance with all statutory duties and operational policy, including those relating to children and vulnerable adults, is governed on various levels throughout the business. The Independent Chief Inspector of Borders and Immigration works to ensure independent scrutiny of the work of the UK Border Agency and the Border Force, providing confidence and assurance as to their effectiveness and efficiency.

The chief inspector is completely independent of the UK Border Agency and Border Force and reports directly to the Home Secretary. Full detail on the role of the chief inspector can be found at: <u>http://icinspector.independent.gov.uk/</u>.

Within the UK Border Agency there are various mechanisms for monitoring compliance. Both the UK Border Agency and Border Force conduct national assurance programmes, to ensure compliance with policies and processes against comprehensive quality assurance frameworks and operational guidance. Management assurance measures are also in place to check whether the standards are met. Expert advice and quality assurance on any case involving children, including those cases where vulnerable adults form part of a family unit is available through the safeguarding co-ordinators network and the Office of the Children's Champion within the UK Border Agency.

EU: Bulgaria and Romania

Lord Laird: To ask Her Majesty's Government under what circumstances the transitional restrictions currently applied to Bulgarian and Romanian nationals can be extended beyond 2013; and whether they will propose within the European Union that the transitional rules be reviewed and time extended.[HL1128]

Reply from the Minister of State, Home Office (Lord Henley): The Protocol to the Treaty on the Accession of Bulgaria and Romania to the European Union provides that transitional measures on the freedom of movement of persons may be applied for a maximum period of seven years. The existing restrictions cannot, therefore, be extended beyond the end of 2013 under the terms of the treaty.

Asylum

Nic Dakin: To ask the Secretary of State for the Home Department what steps she has taken to ensure that (*a*) failed asylum seekers and (*b*) refugees have access to adequate accommodation, food and other essential items whilst in the UK. [113575]

Reply from Damian Green: The support available to failed asylum seekers under section 4 of the Immigration and Asylum Act 1999 includes the provision of accommodation and a weekly allowance to obtain food and other essential items. Refugees can access the mainstream benefits system on the same terms as British citizens and other permanent residents.

Asylum

Cathy Jamieson: To ask the Secretary of State for the Home Department how many legacy asylum cases for each country of origin remain unresolved; and when she expects these cases to be resolved. [113672]

Reply from Damian Green: The UK Border Agency provides regular updates to the Home Affairs Committee on the cases in its Case Assurance and Audit Committee. The latest update was sent to the Committee in May 2012.

The additional information you have requested about legacy asylum cases for each country of origin is not readily available or quality assured. However, the top 10 nationalities have been sourced from local management information; this is not a national statistic:

- 1. China
- 2. India
- 3. Pakistan
- 4. Afghanistan
- 5. Sri Lanka
- 6. Iraq
- 7. Nigeria
- 8. Turkey
- 9. Zimbabwe

10. Iran.

The Casework and Assurance Audit Unit will resolve these legacy cases as barriers are lifted.

Asylum: Children

Nic Dakin: To ask the Secretary of State for the Home Department what steps she is taking to ensure that children do not become destitute as a result of having financial support withdrawn in the event of a failed application for asylum. [113574]

Reply from Damian Green: Support is not withdrawn in the circumstances described. Asylum seekers with children are supported by the UK Border Agency under section 95 of the Immigration and Asylum Act 1999. Eligibility to this support lasts until they leave the United Kingdom or they are granted leave to remain and can access the mainstream benefits system. Unaccompanied asylum seeking children are supported by local authorities irrespective of their immigration status.

Nic Dakin: To ask the Secretary of State for the Home Department whether her Department monitors the numbers of all asylum-seeking and migrant children living in poverty. [113576]

Reply from Damian Green: There are no such monitoring arrangements. All

asylum seeking children have access to support if they need it. The support is provided by the UK Border Agency if they are with their parents or by local authorities if they are unaccompanied. Other migrant children have to satisfy the immigration rules in order to enter the United Kingdom, including requirements that their families can support them without recourse to public funds. The Children Acts also act as a safeguard in circumstances where the child's welfare is at risk.

Westminster Early Day Motion

David Ward (335) Family immigration rules – That this House recognises the important economic and cultural benefits of immigration; notes that the Government's plans to increase the income threshold at which UK citizens can bring a spouse to the country to $\pounds 18,600$ ($\pounds 27,200$ with three children) will deprive many residents of towns like Bradford, where 21 per cent of households have incomes under $\pounds 15,000$ per year, of the right to a family life; believes that the right to a family life should not be contingent on earnings; further notes several reports from the Independent Chief Inspector of Borders and Immigration which call into question the quality of decision making on family immigration cases; and therefore calls for the Government to review its plans both to increase the income threshold at which UK citizens can bring a spouse to the country to $\pounds 18,600$ ($\pounds 27,200$ with three children) and to remove the right of appeal against the refusal of family visitor visas.

Unemployment: Ethnic Groups

Stephen Timms: To ask the Minister for the Cabinet Office what his most recent estimate is of the level of unemployment among young black men. [114804]

Reply from Nick Hurd : The information requested falls within the responsibility of the UK Statistics Authority. I have asked the authority to reply.

Letter from Stephen Penneck, dated July 2012:

Estimates of unemployment come from the Labour Force Survey (LFS). For the period January-March 2012 it is estimated that there were 28,000 unemployed men aged 16 to 24 inclusive who reported their ethnicity as Black. This is an unemployment rate of 50 per cent.

As with any sample survey, estimates from the LFS are subject to a margin of

uncertainty. It is estimated that the true value is likely to lie between 18,000 and 38,000.

Employment Schemes: Ethnic Groups

Stephen Timms: To ask the Secretary of State for Work and Pensions what steps he plans to take to ensure that the Work Programme achieves equitable outcomes for black and minority ethnic participants. [114806]

Chris Grayling: Work Programme providers deliver personalised support, tailored to the individual needs of participants. The Department monitors the characteristics, including ethnicity, of participants referred to the Work Programme on an ongoing basis, and Work Programme providers are bound through the terms of their contract to prevent unlawful discrimination and promote equality of opportunity in respect of ethnicity.

Furthermore DWP has commissioned a consortium led by the Institute for Employment Studies (IES) to undertake an independent evaluation of the Work Programme. Evaluation work started in autumn 2011 and will conclude in 2014. This evaluation will consider the effectiveness of the programme for different types of participants, including black and minority ethnic participants.

Toby Perkins: To ask the Secretary of State for Work and Pensions what steps he has

taken to ensure that the new enterprise allowance attracts black or minority ethnic participants; and how he plans to monitor the success of those steps. [114861]

Reply from Chris Grayling: The new enterprise allowance is a voluntary scheme which is open to all jobseeker's allowance claimants from 26-weeks unemployment. All eligible claimants are informed about the scheme by Jobcentre Plus and, therefore, steps to attract specific groups are not required. Participants are self selecting and all claimants that express an interest are referred to a local mentoring partnership to have their business idea assessed. Take up of the scheme is reported each quarter via the official statistics published here: http://statistics.dwp.gov.uk/asd/asd1/pwp/pwp_gbw_may12.pdf

Toby Perkins: To ask the Secretary of State for Work and Pensions how many of the successful applicants for the new enterprise allowance are of black or minority ethnic origin. [114862]

Religious Groups: Discrimination

Lord Janner of Braunstone: To ask Her Majesty's Government what action they are taking to ensure that minority faiths in the United Kingdom are protected against discrimination, especially by radical groups.[HL1050]

Reply from Baroness Verma: Under the Equality Act 2010, which this Government brought into force, there is protection against discrimination, harassment and victimisation for a range of characteristics, including religion or belief. These provisions apply equally to all religions and beliefs; there is no difference in the way that they protect those of minority faiths or those with no religion or belief. Specific criminal offences exist under Part three and Part 3A of the Public Order Act 1986 with regard to stirring up hatred on the grounds of race or religion. There are separate racially and religiously aggravated offences under Sections 28-32 of the Crime and Disorder Act 1998 and Section 39 of the Antiterrorism, Crime and Security Act 2001. There are also powers to increase the sentence for any offence aggravated by hostility towards race and religion under Sections 145 and 146 of the Criminal Justice Act 2003. The courts have not hesitated to use their general powers to reflect aggravating and mitigating factors to increase the minimum term in individual cases.

Racial Discrimination: EU Action

Kate Green: To ask the Minister for Women and Equalities what assessment she has made of the effect of the proposed repeal of the good relations duty in section 3 of the Equality Act 2006 on the UK's compliance with EU framework decision 2008/913/JHA on combating racism and xenophobia; and if she will make a statement. [114083]

Reply from Lynne Featherstone: The Equality and Human Rights Commission's duty to promote understanding of the importance of good relations between groups is contained in section 10 of the Equality Act 2006. The repeal of section 10 will not impact on the UK's compliance with EU Framework Decision 2008/913/JHA on combating racism and xenophobia. The UK fulfils its obligations under the Framework Decision through the criminal law, principally the provisions on incitement to racial hatred contained in the Public Order Act 1986. Further, the Equality and Human Rights Commission's most valuable work in the area of good relations can continue to be carried out under its existing equality and human rights duties at section 8 and section 9 of the Equality Act 2006, so the separate good relations duty set out in section 10 is unnecessary.
