### Holyrood Parliamentary Question

#### Human Trafficking

**Anne McTaggart (Glasgow) (Scottish Labour):** To ask the Scottish Government what steps it is taking to train medical professionals to identify signs of human trafficking. (S4O-01323)

**Reply from Alex Neil:** The Scottish Government issued guidance to health boards in June 2012 for healthcare staff on human trafficking, which encompasses how to identify and respond to victims of trafficking. The guidance, and covering CEL letter 19(2012), can be accessed on the Scotland's Health on the Web website. It is for health boards, supported where appropriate by NHS Education for Scotland (NES), to provide the educational and training support to enable their staff to access relevant training and continuing professional

Development opportunities. NES has been asked to develop training resources to assist healthcare staff develop the knowledge and skills to respond sensitively on trafficking, and will align this with health boards' ongoing work on gender-based violence.
