### **Holyrood Parliamentary Motion**

**S4M-04334 Christina McKelvie: Stop Refugee Destitution**—That the Parliament welcomes the launch of the Scottish Refugee Council and the Refugee Survival Trust's campaign, Stop Refugee Destitution, which aims to prevent people who are seeking sanctuary in Scotland from experiencing destitution; believes that destitution arises because of what it considers to be inhumane and uncompassionate actions by the UK Border Agency (UKBA); is concerned at what it believes are UKBA's many failings, which, it considers, have led to one-in-four asylum seekers in Scotland experiencing destitution; believes that these are ultimately a result of poor policy decisions made by UK administrations, both past and present; wishes the campaign well when it is launched at the Tron Theatre; hopes that the organisers are s uccessful in raising awareness of

what it views as an abhorrent situation, and encourages people to sign the Stop Refugee Destitution petition.
