#### **Immigration Controls**

**Keith Vaz:** To ask the Secretary of State for the Home Department what the average waiting time is for sponsor licence applications to be decided. [145855]

**Reply from Mark Harper**: Based on the difference between application prepared date and the application despatch date in (Q4) 1 October 2012 to 31 December 2012, the average length of time taken to process a sponsor licence application was 17 calendar days.

(1) The figure quoted has been derived from management information and is therefore provisional and subject to change.

(2) Figure relates to sponsorship licence applications from organisations.

(3) Figure relates to applications logged in the period from 1 October to 31 December 2012.

(4) Processing time based on average number of calendar days between application logged and despatch dates.

#### Immigration

**Duncan Hames:** To ask the Secretary of State for the Home Department how many applications for elderly dependent relatives from non-EEA countries to obtain leave to stay in the UK UK Border Agency have (*a*) received, (*b*) granted, (*c*) refused and (*d*) not processed since July 2012. [144651]

**Reply from Mark Harper**: The immigration rules governing the settlement (indefinite leave) of adult dependent relatives changed in July 2012. This route is now only accessible to applicants applying from outside the UK.

The latest published figures for July to December 2012 on applications from outside the UK, and grants issued and refusals outside the UK, of entry clearance visas providing settlement (indefinite leave) to dependants (other than children or partners, of those who were settled in the UK or British citizens), are given in the following table. Published statistics do not separately identify entry clearance visas not processed.

**Gregory Campbell:** To ask the Secretary of State for the Home Department how many applications to sponsor a non-EEA national spouse to settle in the UK have failed to meet the minimum financial income requirement introduced in July 2012. [146811]

**Reply from Mark Harper:** The latest published figures for 2012 on decisions, grants and refusals for entry clearance visa applications (from outside the UK) and for extensions of stay (from inside the UK) for non-EEA partners, potentially leading to settlement (indefinite leave), are given in the following tables:

#### **Romanians and Bulgarians (Benefits)**

**Frank Field**: To ask the Secretary of State for Work and Pensions if he will make a statement on what actions the Government are planning to restrict welfare to newcomers from Bulgaria and Romania from 1 January next year.

**Reply from the Secretary of State for Work and Pensions (Mr Iain Duncan Smith):** ... Between 1997 and 2010, net migration to the UK was some 2.2 million people—larger than the city of Birmingham. Interestingly, from 2004 to 2010, 1.1 million European economic area nationals registered to work in the UK. After the prediction of what was likely to happen, the scope of the problem is far greater than anything the Labour party wanted to tell the public. Most of all, I congratulate my right hon. Friend the Home Secretary and her team in the coalition for having begun the process of reducing net migration to Britain for the first time in a long time.

... people must pass the habitual residence test, introduced by the previous Government, before being entitled to claim income-related benefits. The current system was put in place in 2004 and has basically two elements—a legal right to reside and an assessment of factual evidence of habitual residence. As we know, EU citizens have the right to live in another member state as long as they are a qualified person, which basically means a worker, self-employed person, jobseeker, self-sufficient person or student. Tax credits have, I am afraid, been open to abuse outside that system from day one because the rules allow anybody from within the European economic area to claim self-employed status and receive full entitlement immediately. The Government are trying to wrestle with that problem, and I will return to it.

We are currently facing—not for the first time—a legal challenge from the European Commission because our habitual residence test states that people must prove they live in the UK habitually before they get access to benefits. It seems strange to me that anyone should be surprised that a habitual residence test requires that a person should live in the UK habitually, but we sometimes live in that George Orwellian political language world, which the Commission seems to foster with great alacrity.

... under the EU co-ordination rules, benefits under the main categories of social security are exportable—that is, payable elsewhere in the European economic area. So that we clear up the confusion, let me say that that includes, notably, child benefit, for example, and has for a while. We therefore pay child benefit to children who live in other EU states when their parents are working here. That causes a lot of concern, and quite legitimately so. When both parents work but in different countries, the EU rules apparently determine who has primary

responsibility for paying, but any difference in entitlement is netted off. So, for example, if someone comes from Poland and works over here, the child support that we pay here is netted out against what they might have received had they been paid in Poland, and the net amount is therefore paid across. That is the existing rule. The UK system is obviously more generous, and that is why it pays people in a sense to be here, getting those benefits.

I recognise there are some real issues here. ... The Government are concerned that, although some protections are in place, they are not enough. ...

The reality is that we are trying, for example, to figure out the rules that allow us to prevent individuals from staying in the UK for only a short time before claiming benefits—a rule that existed under the last Government. We are looking at the tests about accommodation and the length of time people spend here. We want to look at things such the leasing arrangements they have for their housing and over what length of time, and even at challenging the narrow and short-term definition of "habitual" used by the European Court of Justice. In other words, we are trying to lock people out from coming here solely for the purpose of claiming benefits....

#### **Higher Education: Foreign Students**

**Lord Laird:** To ask Her Majesty's Government what restrictions apply to non-European Union students who have graduated from British universities staying in the United Kingdom if they obtain employment or seek post-graduate opportunities; and whether they take into account the number of United Kingdom nationals who graduate from British universities who are seeking to enter the labour market in assessing the appropriateness of those restrictions.[HL5769]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach):** In April 2012, the Government closed the tier 1 (Post-Study Work) route, which allowed all international graduates to remain in the UK labour market for two years after graduation and to have unrestricted access to the labour market during that period. In closing this route, the Government had regard to the state of the labour market for graduates, both UK and international. Non-EEA graduates may however remain in the UK on completion of their studies, in order to work, in one of the following ways:

those with an offer of an approved graduate-level job from an employer licensed by the UK Border Agency, paying at least £20,000, can be sponsored by the employer for leave to remain in tier 2 of the points-based system. These jobs are not subject to the annual limit of 20,700 on tier 2 visas and the employer does not have to carry out a resident labour market test; the graduate entrepreneur route allows higher education institutions to sponsor students to remain in the UK to pursue their entrepreneurial activities for up to two years. There is a limit of 1,000 places on the scheme. From April this year there will be a further 1,000 places specifically for MBA graduates who are sponsored to stay on after their studies to pursue business activities; those wishing to undertake a temporary period of professional training to supplement their qualification (such as pharmacy), before pursuing a career overseas, can do so under defined schemes in tier 5 of the points-based system. Tier 5 also offers defined schemes for internships and work experience; orfrom April this year, international students successfully completing a PhD at a UK higher education institution will be able to stay in the UK for one year to look for skilled work or set up as an entrepreneur.

#### **Schools: Immigration**

**Kevin Brennan:** To ask the Secretary of State for Education what estimate he has made of the potential effect of inward migration from Romania and Bulgaria on the number of primary school pupils from 2014. [144762]

**Reply from David Laws**: No separate estimate has been made of the effect of immigration from Romania and Bulgaria on the number of primary school pupils in England. The Department's national pupil projections are based on population projections from the Office for National Statistics (ONS), which take into account net migration from European Union accession countries including Romania and Bulgaria.

**Tobias Ellwood:** To ask the Secretary of State for Education under what responsibility local authorities are placed to confirm that parents applying for school places for their children who are immigrants from *(a)* other EU member states and *(b)* other countries are present in the UK lawfully. [145082]

**Reply from David Laws:** Local authorities are responsible for co-ordinating the school admission arrangements for all state funded schools within their area. Parents are asked by local authorities to complete a common application form (CAF), which enables them to express a preference for a place at any state funded school. The CAF can seek personal details such as name, address and the name, address and date of birth of the child. Where a local authority has concerns about an individual's access to public benefits, including education, they may refer the matter to the UK Border Agency.

**Kevin Brennan:** To ask the Secretary of State for Education what account his Department has taken of the Department for Communities and Local Government's estimates of inward migration from Romania and Bulgaria in the School Capacity Census. [144761]

**Reply from David Laws**: The School Capacity Collection is an annual survey through which local authorities provide information on school places and pupil forecasts to the Department for Education. The forecasts that local authorities provide to the Department factor in a range of local demographic considerations, including inward migration, and will be informed by data from ONS.

#### Deportation

**Daniel Kawczynski:** To ask the Secretary of State for the Home Department how much has been spent on returning (*a*) illegal migrants by nationality and (*b*) victims of trafficking to countries (i) within the EU and (ii) outside the EU in each of the last five years; and how many people were returned in each such category in each such year. [144708]

**Reply from Mark Harper:** The costs of removing illegal migrants and victims of trafficking are included within an aggregate cost of removing all foreign nationals from the United Kingdom. A detailed costing of the specified categories could be provided only at disproportionate cost.

**Mary Creagh:** To ask the Secretary of State for Environment, Food and Rural Affairs what tests the Food Standards Agency is conducting to ensure that food in the public sector food supply chain labelled as halal does not contain pork DNA. [142097]

# Other Westminster Parliamentary Questions (continued)

**Reply from David Heath:** It is the responsibility of all food businesses to ensure that the food they sell is what it says it is and that consumers are not misled. DEFRA's food authenticity programme develops and validates methods to detect the presence of pork in foods. These methodologies are made available as standard operating procedures to support testing by public analysts and industry.

The Food Standards Agency delegates responsibility to local authorities for enforcing food safety legislation in food premises, covering the food supply chain from food manufacturing, processing, packing, distribution and storage through to catering and retail, including in the public sector.

There are no specific regulations governing the sale and labelling of halal or kosher meat. However, if meat is labelled as such, this must not mislead the consumer. Certification is provided by private organisations.

The Government's unit for engaging faith communities at DCLG will be hosting discussions between DEFRA, the Food Standards Agency and representatives of kosher and halal organisations this month. These discussions will cover how the Government is responding to the recently reported contamination of meat products through its testing programme and the approaches being used to detect contamination.
