Female Genital Mutilation

Jenny Marra: To ask the Scottish Government what its strategy is for tackling female genital mutilation. (S4W-16502)

Reply from Michael Matheson: Female genital mutilation (FGM) is addressed under the violence against women policy area and will be included in the violence against women strategy currently being developed. The FGM strand of this strategy will focus on prevention through awareness raising, supporting victims, empowerment of women and girls, community engagement, multi-agency action and enforcement.

Appropriate action plans for FGM prevention, pathways for safeguarding children, protocols for referral and sharing of information will be strengthened in the new strategy and reviewed regularly.

Jenny Marra: To ask the Scottish Government how it encourages the police to identify that female genital mutilation has taken place. (S4W-16503)

Reply from Michael Matheson: The Scottish Government is represented on Police Scotland's Honour Based Violence Working Group which co-ordinates work on female genital mutilation (FGM) in addition to other forms of honour based violence. Officials work closely with the police to provide advice and share information and participate in the development of documents such as the Police Scotland action plan and fact sheet on FGM.

Jenny Marra: To ask the Scottish Government what discussions it has had since July 2012 with (a) the police, (b) the NHS, (c) COSLA, (d) the Home Office, (e) social work departments and (f) support organisations regarding female genital mutilation. (S4W-16504)

Reply from Michael Matheson: The Scottish Government has engaged on an ongoing basis since July 2012 with organisations, individuals and groups of people from the communities affected by female genital mutilation (FGM), to raise awareness of the harm caused by FGM, along with awareness about the law and the government's position. The Scottish Government works closely with police, voluntary organisations, health professionals, social services and education departments, to share good practice and promote awareness across Scotland for the prevention of FGM, officials also liaise with Westminster colleagues on a regular basis.

Officials are members of Police Scotland's Honour Based Violence Working

Group and the Scottish Government promotes collaborative working with minority ethnic women's organisations such as Saheliya, Dignity Alert Research Forum and Shakti Women's Aid as well as voluntary and community groups and encourages links with relevant statutory bodies such as the police, health, social services and education to ensure that issues around FGM remain in focus.

The Scottish Government submitted written evidence to the House of Commons International Development Committee's inquiry into violence against women and girls with regards to the Scottish Government's position on FGM in Scotland.

Jenny Marra: To ask the Scottish Government how much funding it is allocating in 2012-13 to tackle female genital mutilation. (S4W-16505)

Reply from Michael Matheson: In 2012, Saheliya was allocated £225,390 from the Violence Against Women Fund to tackle female genital mutilation (FGM) over the period 2012-15, and will receive a further £137,000 from the Third Sector Early Intervention Fund during 2013-15 for work with minority ethnic young women, including FGM.

Jenny Marra: To ask the Scottish Government how many (a) women and (b) girls in Scotland are estimated to (i) have experienced or (ii) be at risk of genital mutilation. (S4W-16506)

Reply from Michael Matheson: It has been estimated that 3,000 women and girls are at risk in Scotland. This figure for Scotland is a pro rata projection based on research by FORWARD in England and Wales in 2007. According to the 2001 Census data, there were 2,946 women between the ages of 0 to 49 living in Scotland and born in one of the 29 countries in which female genital mutilation (FGM) is reported to be a traditional practice.

We are currently considering data that might help us more accurately estimate the prevalence of FGM in Scotland. The numbers from the 2011 Census (when available later this year) are likely to be significantly higher, as is demonstrated by the increase over time in numbers of births registered in Scotland to mothers who were born in one of these countries (from 120 births in 2001 to 656 births in 2011).

Jenny Marra: To ask the Scottish Government what guidance is available to the (a) police and (b) NHS to (i) identify and (ii) help women and girls who have experienced genital mutilation. (S4W-16508)

Reply from Michael Matheson: The guidance available for police officers includes the Honour Based Violence, Forced Marriage and Female Genital Mutilation Standard Operating Procedures document which provides officers with the necessary understanding and skills to deal appropriately and consistently with hepatitis B virus incidents including female genital mutilation. They also receive regular training and a fact sheet has been prepared for Police Scotland's intranet. NHS guidance available for health workers includes: NHS Scotland - Perineal Repair after Childbirth 2008, a procedure and standards tool to support practice development; The Royal College of Obstetricians and Gynaecologists has guidelines available on Female Genital Mutilation and Its Management and the

Jenny Marra: To ask the Scottish Government what action is taken by the (a) police and (b) NHS when a woman or girl is identified as having experienced genital mutilation. (S4W-16509)

Reply from Michael Matheson: If an incident of female genital mutilation (FGM) is reported, the police will carry out a thorough investigation and report the case to the Procurator Fiscal for the appropriate action.

Midwives, along with other health professionals such as doctors, nurses and health visitors, can play a crucial role in eradicating FGM because women from practicing communities are likely to use health services during pregnancy or for other health reasons. If women are identified as being victims of FGM, the NHS in Scotland offers all available assistance to ensure positive health outcomes for the women affected.

Jenny Marra: To ask the Scottish Government what (a) positions and (b) specific units there are in the (i) police and (ii) NHS to help prevent female genital mutilation. (S4W-16510)

Reply from Michael Matheson: Police Scotland has a dedicated officer who will coordinate all actions against female genital mutilation (FGM) nationally. FGM is addressed by the Honour Based Violence Working Group chaired by a Detective Chief Superintendent. Victims of FGM can access NHS services such as the genital anomaly surgical service and the specialist midwife for asylum seekers and refugees provided by NHS Greater Glasgow and Clyde.

Jenny Marra: To ask the Scottish Government how it raises awareness about female genital mutilation in communities where it is considered that the practice is likely to occur. (S4W-16511)

Reply from Michael Matheson: A number of methods are used to raise awareness and encourage the reporting of female genital mutilation (FGM) including engaging with individuals and minority ethnic women's organisations such as Dignity Alert Research Forum, Saheliya and Shakti Women's Aid which provide services to women who come from communities affected by FGM.

The Scottish Government awarded Saheliya £225,000 from the Violence Against Women Fund for the period 2012–15 to support and empower women from communities affected by FGM in order to increase their confidence to reject the practice. The government also works in partnership with other voluntary organisations, social services, education departments and the police to support victims and engage with communities for the prevention of FGM.
