### Holyrood Parliamentary Motion

**S4M-08135 Christina McKelvie: Hidden in Plain Sight**—That the Parliament welcomes the publication of the Anti-Trafficking Monitoring Group report, *Hidden in plain sight: Three years on: updated analysis of UK measures to protect trafficked persons*; understands that the report examines progress made by the UK Government in combatting trafficking in human beings since the publication of the Anti-Trafficking Monitoring Group's first report, *Wrong Kind of Victim?*; notes that the Anti-Trafficking Monitoring Group was established in May 2009 to coincide with the coming into force of the Council of Europe Convention on Action against Trafficking in Human Beings in the UK and that the group monitors the UK Government's implementation of the convention and examines all types of trafficking, including internal trafficking and the trafficking of British nationals; believes that the report is a welcome addition to the fight against human trafficking, and hopes that the UK Government will take note of some of the recommendations in the report.

### Westminster Parliamentary Questions

#### Crime: Migrants

**Lord Touhig:** To ask Her Majesty's Government how many victims in the United Kingdom in 2012–13 of (1) violent crime, (2) sexual assault, and (3) female genital mutilation were (a) illegal migrants, (b) non-European Economic Area short-term visitors, and (c) non-European Economic Area temporary migrants. [HL2491]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach):** I regret that the information requested is not available from the police recorded crime data collected by the Home Office. The migration status of victims of crime is not identified in the information that the Home Office receives from the police.

#### Health Services: Foreign Nationals

**Helen Jones:** To ask the Secretary of State for Health how many people treated for injuries related to (a) female genital mutilation and (b) domestic violence in 2012-13 were in the UK (i) illegally and (ii) as short-term visitors at the time of their treatment; and what provision he plans to make for such cases under the proposed new charging scheme for NHS treatment. [172516]

**Reply from Jane Ellison:** Although the Health and Social Care Information Centre collects hospital episode statistics, there is currently no central coding of domestic violence or female genital mutilation in respect of healthcare or treatments, nor do these contain information about the patient's residency, nationality or migration status.

The Department is considering responses to its recent consultation "Sustaining services, ensuring fairness: A consultation on migrant access and their financial contribution to NHS provision in England" and will respond shortly.

#### Immigration

**Lord Roberts of Llandudno:** To ask Her Majesty's Government, under their proposals for landlords to check tenants' immigration status, what provisions will be made for those legally resident in the United Kingdom, including United Kingdom citizens, who for any reason do not have the correct documentation to prove their citizenship. [HL2695]

To ask Her Majesty's Government, under their proposals for landlords to check tenants' immigration status, whether legislative provision will be made for people residing in the United Kingdom whose immigration status is legitimate but under consideration. [HL2696]

To ask Her Majesty's Government according to what criteria they will choose the region in which landlord checks on immigration status will be piloted. [HL2697]

To ask Her Majesty's Government what assessment they have made of a recent survey by the Residential Landlords Association concerning the performance of further documentary checks on proposed tenants in order to establish their immigration status. [HL2698]

To ask Her Majesty's Government, under their proposals for landlords to check tenants' immigration status, whether steps will be taken to ensure the compliance of landlords with data protection provisions regarding the handling of and saving of personal information. [HL2699]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach) (Con):** The Government consulted on the landlords proposals in detail between July and August. Our response was published on 10 October.

## Immigration and Asylum Westminster Parliamentary Questions (continued)

Having consulted closely with housing charities, local authorities and the private rented sector, we are proposing to allow tenants to use a broad range of commonly available documents, such as benefits letters, in addition to passports as a means of satisfying the required checks.

For lawful migrants, the Government will allow those who are applying for an extension of leave to retain their biometric residence permit as evidence of lawful status; we will also provide a landlords checking service which will allow landlords to quickly confirm the immigration status of a prospective tenant without relevant documentation; foreign nationals who have live applications with the Home Office will also be able to obtain a verification certificate that they can use with landlords. The Bill allows for a phased implementation of the landlords checking requirement. The selection of an appropriate model or region is under consideration — relevant criteria would include the nature of the housing stock, size of the population, as well as the ability to establish a clear boundary.

We understand that the Residential Landlords Association has conducted two surveys of their members in relation to these proposals. The first survey found many landlords opposed to or concerned by the proposals. A further survey of members undertaken in July and August, however, showed that the majority already check passports; nearly half seek evidence of employment and that a wide range of documents are seen by some landlords. The survey also showed that the majority of respondents, nearly 90 percent, agreed with the need for some form of checks on tenants, albeit largely in relation to creditworthiness.

Landlords and their agents are already under a legal obligation to handle, store and dispose of personal consumer information sensibly and securely and are obliged to abide by the principles of the Data Protection Act 1998.

### Entry Clearances: Overseas Students

**Julian Huppert:** To ask the Secretary of State for the Home Department what steps she is taking to ensure that students applying for visas for study in the UK are not unreasonably affected by fluctuations in foreign exchange rates. [171257]

**Reply from Mark Harper:** Students are required to demonstrate that they have sufficient funds available to meet their living costs while they are in the UK. The precise amounts that they must have available are set out in the Immigration Rules. Where the funds are in one or more foreign currencies, the applicant must have the specified level of funds when converted to pound sterling using the spot exchange rate which appears on [www.oanda.com](http://www.oanda.com) for the 28-day period up to the date of application. Students may therefore check for themselves whether their funds are sufficient to meet the visa requirements, taking into account daily exchange rates, before submitting an application.

### Illegal Immigrants: Employment

**Stephen Barclay:** To ask the Secretary of State for the Home Department what the average fine currently imposed on rogue businesses employing illegal immigrants is; and how many rogue businesses have been subject to a maximum penalty fine in each of the last three years. [172080]

**Reply from Mark Harper:** Between 29 February 2008 and 30 September 2013 the average value of a civil penalty served on an employer was £9,123.

The information relating to businesses subject to a maximum penalty in each of the last three years is in the following table:

The maximum civil penalty per illegal worker is £10,000. The size of the civil penalty depends on the type of eligibility checks that the employer has made on its workers, the number of times the Home Office has issued a warning or imposed a civil penalty on the employer, and the extent to which the employer has co-operated with us.

The figures are based on civil penalties served to employers within the UK for employing illegal migrant workers under section 15 of the Immigration, Asylum and Nationality Act 2006, at the initial stage of the civil penalty process.

Following receipt of a civil penalty, employers have the right to submit grounds of objection against the imposition of the penalty within 28 days and lodge an appeal against the penalty decision to a county court. Therefore penalties may subsequently be reduced, cancelled or re-issued at the objection and appeal stages.

### Asylum

**Jeremy Corbyn:** To ask the Secretary of State for the Home Department how many legacy asylum applications are still outstanding; how many have been resolved in each of the last 12 months; and how many staff are allocated to this task. [168341]

**Reply from Mark Harper** [*holding answer 12 September 2013*]: The Home Office provides quarterly updates to the Home Affairs Select Committee on the progress of the Legacy cohort of cases under consideration by the Older Live Cases Unit (formerly the Case Audit and Assurance Unit). This is the ring fenced cohort of older asylum cases that was passed to CAAU when the Case Resolution Directorate closed in March 2011.

Table A was included in the letter from David Wood and Sarah Rapson to the right hon. Member for Leicester East (Keith Vaz), Chair of the Committee on 10 July 2013 as Annex A.

We expect to provide a further update of this data to the Home Affairs Select Committee when it next considers the work of the Older Live Cases Unit in October 2013. We will take this opportunity to provide a more comprehensive breakdown of the conclusions by month.

### Asylum: Finance

**Sarah Teather:** To ask the Secretary of State for the Home Department (1) if she will provide information on using the Azure card in languages other than English; [170039] (2) how much unspent money was recouped from Azure cards in each of the last three years for which records are available. [170050]

**Reply from Mark Harper:** The Azure card is issued to failed asylum seekers supported under the provisions of section 4 of the Immigration and Asylum Act 1999.

Home Office officials are looking at ways of providing information about the card in languages other than English. Funding is already provided to voluntary sector organisations to advise asylum seekers and failed asylum seekers about the support available to them.

The card can be used at supermarkets to buy food and other essential items to the value of £35.39 per week. Unless the person has children only £5 can be carried over on the card into the following week. Any unspent excess over the £5 limit is returned to the Home Office.

**Reply from Mark Harper:** The estimated average direct annual cost of holding a person in our immigration detention facilities for 2013-14 is £37,230.

### Human Trafficking

**Lord McConnell of Glenscorrodale:** To ask Her Majesty's Government what discussions have taken place with the devolved administrations in relation to action and policy to protect child victims of human trafficking. [HL2670]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach):** The UK Government works closely with the devolved administrations to tackle human trafficking. The Welsh Minister for Local Government and Government Business, Scottish Cabinet Secretary for Justice and Northern Ireland Minister of Justice sit on the Inter-Departmental Ministerial Group (IDMG) on human trafficking which provides direction and oversight on the UK's efforts to tackle human trafficking.

Across the UK officials work closely to ensure there is a shared understanding of the scale of the problem and the nature of the threat. Officials from the devolved administrations are also represented on the Home Office-led Human Trafficking Officials Strategy Board and the Joint Strategic Group on Human Trafficking, which meet at official level, to shape and inform the UK response including on child trafficking.

**Lord McConnell of Glenscorrodale:** To ask Her Majesty's Government how they will ensure that guidelines and legislation relating to human slavery and the trafficking of children work effectively across the whole United Kingdom. [HL2671]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach):** The Inter-Departmental Ministerial Group (IDMG) on human trafficking brings together UK Government Ministers and ministers from the Northern Ireland Executive, Scottish Government and Welsh Assembly Government. The Group provide direction and oversight on the UK's efforts to tackle human trafficking, including of children.

The work of the IDMG ensures a common awareness of the nature of the problem and a shared understanding of measures developed in response.

### Human Trafficking: Prosecutions

**Emily Thornberry:** To ask the Attorney-General how many human trafficking-flagged cases have been (a) referred to the Crown Prosecution Service (CPS) for a charging decision, (b) subject to a decision by the CPS to take no further action, (c) subject to a CPS decision to be cautioned, (d) prosecuted, (e) prosecuted successfully and (f) prosecuted successfully where the defendant contested the charge in each of the last five years. [172354]

**Reply from the Solicitor-General:** The Crown Prosecution Service (CPS) maintains a central record of the numbers of cases involving human trafficking by way of a database monitoring flag applied to the electronic case record. Collection of this information commenced from 1 April 2010.

The following table shows the number of human trafficking flagged cases referred to the CPS for a pre-charge decision (PCD) and the number of suspects where a decision to charge, take no further action or to issue an out of court disposal, including a caution, was made:

**Naomi Long:** To ask the secretary of State for the Home Department how many residence permits have been granted to persons conclusively recognised as victims of trafficking by the National Referral Mechanism in (a) the UK and (b) Northern Ireland in each year since its implementation; and how many of those permits were issued due to the victim's personal circumstances. [166857]

**Reply from Mark Harper:** The information requested can be found in Table 1 which shows the number of individuals who were conclusively found to be victims of trafficking and who were granted some form of leave. This includes grants of asylum, humanitarian protection and discretionary leave.

#### Female Genital Mutilation

**Lord Judd:** To ask Her Majesty's Government what estimate they have made of the number of female genital mutilation operations carried out in the United Kingdom in each of the last three years.[HL2609]

**Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach):** Due to the hidden nature of the crime, it is difficult to estimate accurately how many girls and women have been subjected to female genital mutilation (FGM). A 2007 study carried out by the Foundation for Women's Health Research and Development (FORWARD) and based on 2001 census data estimated that:

- Over 20,000 girls under the age of 15 could be at high risk of FGM in England and Wales each year;
- Nearly 66,000 women in England and Wales are living with the consequences of FGM.

The Home Office announced in July 2013 that it is part funding a new study into the prevalence of FGM in England and Wales.
