UK Parliament Ministerial Statement and Questions

Romanian and Bulgarian Accession

Yvette Cooper (Normanton, Pontefract and Castleford): To ask the Home Secretary if she will make a statement on Romanian and Bulgarian accession.

Reply from he Secretary of State for the Home Department (Mrs Theresa May): In June 2005, the previous Government signed accession treaties with Romania and Bulgaria, and in doing so they granted all Romanians and Bulgarians the right to come to Britain. The treaties came into effect in 2007, and as a result the seven-year transitional controls relating to free movement will end on 1 January 2014. From that date, Romanians and Bulgarians will have the right to largely unrestricted free movement across Europe.

Unlike the previous Government, who chose not to apply the transitional controls for countries such as Poland and Hungary in 2004, this Government are doing everything we can to ensure that we are prepared for this latest extension in EU free movement rights. First, we are making use of the full seven years available to us to impose

transitional controls, something the Labour party failed to do in 2004, which meant that Britain was the only major economy in Europe to grant full access to its labour market to millions of Poles, Hungarians and others.

Secondly, we are tightening the European immigration regulations to ensure that we do not gold-plate EU free movement rules. We are therefore amending the regulations to create a statutory presumption that a European's right to reside here ends after six months unless they can prove that they are actively seeking work and stand a real chance of finding it.

Thirdly, we are taking action to limit the pull factors that attract people to come to Britain. My right hon. Friend the Secretary of State for Work and Pensions is introducing a threemonth delay before a European jobseeker can claim benefits and a new minimum earnings threshold to ensure that EU nationals are genuinely working in the UK before they can access benefits. He is also developing a tougher six-month test to assess whether benefit claimants have a genuine chance of finding work. That will apply to all EU nationals who come here to look for work and those who have already worked here. Those changes will come into effect as soon as possible in the new year. My right hon. Friend the Secretary of State for Health is ensuring that, wherever possible, the NHS claims back the cost of treating Europeans from their home country. My right hon. Friend the Secretary of State for Communities and Local Government will issue new statutory guidance to ensure that local authorities set a residency requirement, or a minimum period of residence in a community, before a person gualifies for social housing.

Fourthly, we are ensuring that there is a full and proper operational response to the challenges brought by that extension in free movement. We are working with the police, local authorities and other agencies to identify Europeans who are rough-sleeping and not exercising their treaty right to be in the UK. Where appropriate, those people will be removed. We are also changing the European immigration regulations to introduce a 12-month bar on their return to Britain, unless they can prove that they have a proper reason to be here.

Fifthly, I have lobbied other member states in the Council of Ministers about the abuse of free movement, and there is a growing coalition of support for change. In April this year, Germany, Austria and the Netherlands, along with Britain, wrote to the European presidency and the Commission to make the case for change. Although I am pleased that the European Commission has at long last admitted that there is a problem, it is still refusing to do anything meaningful about it.

Those are the measures we are taking to prepare us for the extension of free movement in January, but in the long term there is much more we need to do.

The evaluation for Operation Vaken, of which the ad vans were one element, was published on 31 October 2013 and copies were placed in the library of both Houses. The separate pilot activity in reporting centres in Hounslow and Glasgow will not be repeated in its current form.

Immigration: Registered Travellers

Viscount Colville of Culross: To ask Her Majesty's Government why non-European Union citizens who are resident in the United Kingdom are not allowed to register for the new registered traveller scheme; and how that compares with the conditions for registration (1) by such citizens for the old iris recognition immigration scheme and (2) by non-European Union citizens who are not resident in the United Kingdom. [HL3563]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Registered Traveller was launched in September 2013, as a pilot scheme with a small cohort of potential applicants so that Border Force can test the processes. The cohort for the Registered Traveller pilot consists of those non EEA nationals who were registered for IRIS. The pilot scheme does not currently include those non EEA nationals who are resident in the UK, but does include those non EEA nationals who are visitors and not resident in the UK.

This initial approach allows for comprehensive testing and evaluation of the processes and systems, including the IT. The evaluation of the pilot will inform the criteria for the next cohort to be included on the scheme.

Health Services: Overseas Students

Roger Godsiff: To ask the Secretary of State for Health what assessment she has made of the potential administrative cost to the NHS of charging international students for their treatment. [176228]

Reply from Jane Ellison: The Immigration Bill, currently before Parliament, proposes to introduce a requirement for non-European economic area (EEA) temporary migrants, coming to the United Kingdom for more than six months, to pay an annual health surcharge with their visa application fee. This includes international students.

The estimated administration cost to the national health service in England for the total number of estimated non-EEA migrants who will be covered by the health surcharge is £0.3 million per year. International students represent approximately 300,000 out of a total of around 500,000 visas granted to non-EEA temporary migrants. This was published in the Home Office impact assessment, a copy of which has been placed in the Library.

Detainee Custody Officers who are employed as overseas escorts are accredited by Home Office Immigration Enforcement in accordance with Detention Services Order 4/2011 which is available at:

Reply from the Solicitor-General: The Crown Prosecution Service (CPS) uses a "double flag" when prosecuting cases of human trafficking involving victims under 18. The double flag involves using both the Human Trafficking Monitoring Flag to identify the number of defendants prosecuted for these offences, and the Child

Abuse Flag to distinguish cases where the victim was under 18 at the time of the commission of the offence.

Human Trafficking

Louise Ellman: To ask the Secretary of State for the Home Department if she will (*a*) create the position of anti-slavery commissioner and (*b*) take other steps to increase the number of convictions for human trafficking. [177029]

Reply from James Brokenshire: The proposed draft Modern Slavery Bill will include provisions on the appointment of an Anti-Slavery Commissioner. The planned Commissioner will play a key role in strengthening the efforts of law enforcement agencies in the UK to secure more modern slavery and human trafficking investigations, prosecutions and convictions. The exact nature of this role is still being developed and will be further reviewed following pre-legislative scrutiny of the Bill.

The proposed Modern Slavery Bill will also: increase the maximum sentence available on human trafficking and modern slavery offences from 14 years to life imprisonment; include the offences in the extended determinate sentences regime; and introduce civil orders to restrict the movement of perpetrators.

Revised guidance on effective investigation and prosecution of offences will be issued shortly by the Director of Public Prosecutions.

Roma Communities

Baroness Scotland of Asthal: To ask Her Majesty's Government what is their estimate of the size of the Roma community in the United Kingdom; and what is being done to access European Union funds to facilitate Roma integration. [HL3495]

Reply from the Parliamentary Under-Secretary of State, Department for Communities and Local Government (Baroness Stowell of Beeston) (Con): There are no reliable estimates of the size of the Roma community in the United Kingdom. Statistics on the ethnic origin of the UK's population are derived from the 2011 census, which did not separately identify Roma. The regulations governing the EU structural funds for 2014-2020 are currently being negotiated in Brussels. We expect them to be finalised and adopted this autumn. Member States will then be able to submit proposals for Partnership Agreements and Operational Programmes to the European Commission setting out their spending plans. Our investment priorities in the UK will relate to the priorities of our Growth Programme, including employment and social inclusion. Each Local Enterprise Partnership is leading on the development of an EU structural funds investment strategy, and in doing so will work with a broad range of economic, social and environmental partners, including businesses and civil society.

Scottish Parliament Parliamentary Motion

S4M-08419 Stewart Maxwell: Universities UK Guidance on Gender Segregation at Scottish Institutes of Higher Education—That the Parliament is dismayed that Universities UK has issued guidance to higher education institutions in Scotland indicating that it is acceptable to separate attendees at meetings by gender; believes that this breaks the spirit of equalities legislation and is reminiscent of the separate but equal doctrine in United States law, which justified segregation; is disturbed that the religious beliefs of some speakers are thought to trump the rights of women; does not believe that allowing audiences to mix at university events curtails freedom of speech in any way, and considers that if segregation is enforced by gender then the case against segregation by race, religion, sexual orientation and disability has been profoundly weakened.

Education: Black and Ethnic Minorities

Lord Storey: To ask Her Majesty's Government what plans they have to target provision for pupils from black and minority ethnic backgrounds who may be underperforming at school or college.[HL3528]

Reply from the Parliamentary Under-Secretary of State for Schools (Lord Nash) (Con): The Government supports an education system which enables all pupils, regardless of their background or ethnicity, to fulfil their potential, attain high quality and rigorous education qualifications and have choices for their future lives.

Schools lead the way in driving up the attainment of all pupils, including underperforming groups. The Government is supporting schools by, for example, introducing a pupil premium to raise attainment amongst deprived pupils and narrow the attainment gap between these pupils and their peers. The premium will represent £2.5 billion of additional funding in financial year 2014-15. We have also introduced a new secondary school accountability system, replacing the current arrangements which create a perverse incentive for schools to focus overly on pupils near the GCSE grades C and D borderline, at the expense of other pupils. Once our reforms are in place, schools will rightly be accountable for the academic progress of all their pupils equally. Similarly, Ofsted will also consider how well schools are meeting the needs of all their pupils, by looking at the data on all groups and individuals (including for attainment, progression, behaviour and attendance), with a particular emphasis on the most disadvantaged.

Shona Robison: The Scottish Government is committed to promoting a multifaith and multi-cultural society based on mutual trust, respect and understanding. The Scottish Government funded the Scottish Working Group on Religion and Belief Relations to write and publish Belief in Dialogue: Religion and Belief Relations in Scotland Good Practice Guide (2011), which provides guidance (including examples of successful activities) in bringing together people of different faiths and beliefs to develop and engage in dialogue and relationship building.

We have also allocated over £1 million (2012-2015) to support faith-based projects to create, among other things, opportunities for the development of interfaith and cross-cultural awareness and understanding, including raising awareness of the dietary needs of some people because of their religious beliefs.

Other Scottish Parliament and Government Parliamentary Questions (continued)

In school education, religious and moral education enables children and young people to explore the world's major religions and to develop their own beliefs and values. Through Curriculum for Excellence, from the early years to level four, the experience and outcomes for religious and moral education include strands that enable children and young people to develop their knowledge and understanding of a variety of practices and traditions associated with world religions, including dietary requirements.

Female Genital Mutilation

Lord Berkeley of Knighton: To ask Her Majesty's Government why there have been no prosecutions for female genital mutilation.

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): My Lords, there are many barriers to prosecuting cases of female genital mutilation. Evidence suggests that the young age of the victims, and pressure from family and the wider community, lead to many cases going unreported. However, I am greatly encouraged by the commitment of the police and the Crown Prosecution Service to overcome these barriers, and by the Director of Public Prosecution's assessment that it is only a matter of time before a perpetrator is brought to justice.

Lord Berkeley of Knighton: My Lords, it is welcome news that there is very likely to be a prosecution, but we have to put this in the context that this practice has been illegal for more than a decade, an estimated 60,000 women in this country have suffered this

barbaric practice and 30,000 young children may be at risk of it. I fear that we may be dealing with a cultural tradition. I know that this is a very difficult and sensitive subject, but there is no supporting medical or religious evidence for this practice. Therefore, we have to assume that we have perhaps been afraid of offending at the temple of cultural diversity. If at this very moment, for that reason, a woman is descending on some young girl with a razor blade to slice off her external genitalia, we have to ask ourselves: is this a price worth paying for cultural diversity?

Reply from Lord Taylor of Holbeach: Although this is a highly sensitive issue, I do not see that as the source of conflict. This is essentially a hearts and minds issue. The noble Lord identified that correctly. However, there is no lack of determination as far as the Government are concerned. My colleague in the Home Office, Norman Baker, is having a meeting on 5 December with the Crown Prosecution Service. The Health Minister, Jane Ellison, is having a meeting on Monday to see how her department can deal with this. I have to tell the noble Lord that he has grossly underestimated the legislative background to this. FGM has been illegal since 1985.
