#### **UK Parliament Questions**

#### **British Nationality**

**Richard Fuller:** To ask the Secretary of State for the Home Department pursuant to the answer of 20 November 2013, *Official Report*, column 908W, on British nationality, how many of the 814 cases in 2012-13 that were concluded after 12 months were concluded (a) between 12 and 18, (b) between 18 and 24 and (c) after more than 24 months; and of those cases that took longer than 24 months to conclude, how long each such case took. [187921]

**Reply from James Brokenshire:** The information requested is shown in the following table.

Our reporting system counts 24 months from the date the report is completed.

Other decisions will now come within that reporting period; therefore it is not possible to isolate the original 249 cases reported on.

Reflects cases decided in the financial year.

#### **Immigration**

**Lord Roberts of Llandudno:** To ask Her Majesty's Government what forms of appeal would be available to someone who has been deprived of their citizenship under the current proposals in the Immigration Bill.[HL5153]

To ask Her Majesty's Government whether, under the proposed reforms relating to the residence test applicable to those eligible for legal aid, legal aid would be available to someone who had been deprived of their citizenship under the amendment to section 40(4) of the British Nationality Act 1981 currently being considered as part of the Immigration Bill, were that deprivation to take place while the individual was outside the United Kingdom.[HL5154]

Reply from The Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Any individual who is deprived of their citizenship including cases where action is taken under the provisions set out in the Bill, has a full right of appeal against the Secretary of State's decision. Where the Secretary of State certifies that her decision to deprive the individual of citizenship has been taken wholly or partly in reliance on information which should not be made public in the interests of national security, or in the interests of the relationship between the UK and another country or because it is otherwise not in the public interest to release the information, any appeal will be to the Special Immigration Appeals Commission (SIAC). If the decision is not so certified, any appeal will be to the Immigration & Asylum Chamber (First Tier).

In both cases there is the opportunity for onward challenge to the Upper Tribunal or the Court of Appeal or other higher courts.

Where an individual is outside the UK when they are served with the deprivation decision, they must bring their appeal from outside the UK.

Legal aid reform will not substantively alter the current position of immigration applicants. Where the appeal against the deprivation of citizenship is to the Immigration and Asylum Chamber, legal aid is not currently available unless the applicant is an asylum claimant. This will be unchanged by the proposed reform.

As set out in Transforming Legal Aid; Next Steps, the proposed residence test would not apply in certain categories of case which broadly relate to an individual's liberty, where the individual is particularly vulnerable or where the case relates to the protection of children. This includes proceedings before the SIAC, which will not be subject to the residence test, even where the appeal is brought from outside the UK.

**Baroness Smith of Basildon:** To ask Her Majesty's Government on how many occasions United Kingdom immigration officials have stopped and questioned individuals in-country, away from ports and borders, in each of the last five years.[HL5212]

**Reply from Lord Taylor of Holbeach:** The following table lists Enforcement visit encounters from January 2009 to September 2013.

These figures relate to all individuals encountered on any type of enforcement operation conducted in the United Kingdom, other than those conducted at ports and borders.

Whilst conducting enforcement operations, our officers will invite individuals to answer questions about their immigration status to those where there are reasonable grounds to suspect that they are immigration offenders. In accordance with Home Office guidance, our officers will record all individuals encountered, both offenders and non-offenders.

These figures do not relate to number of unique individuals as a person may have been encountered on one or more occasions.

#### **Immigration**

Baroness Hamwee: To ask Her Majesty's Government, in the light of the statement on the UK Border Agency website regarding the financial requirement applying to a person wishing to come to, or stay in, the United Kingdom as the partner of a British citizen or settled person that "you will be exempt from the new financial requirement if your sponsor receives a specified disability-related benefit or carer's allowance in the United Kingdom. You will need to show that your sponsor can maintain and accommodate you without access to public funds", why Incapacity Benefit or Employment Support Allowance do not qualify for exemption; and what benefits do qualify. [HL5349]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The benefits which exempt an applicant from the new financial requirement for sponsoring a spouse or partner and dependent children of non-European Economic Area nationality to settle in the UK under the family Immigration Rules include: Disability Living Allowance, Severe Disablement Allowance, Industrial Injuries Disablement Benefit, Attendance Allowance, Carer's Allowance, Personal Independence Payment, Armed Forces Independence Payment, Guaranteed Income Payment under the Armed Forces Compensation Scheme, Constant Attendance Allowance, Mobility Supplement and War Disablement Pension under the War Pensions Scheme.

Incapacity Benefit and Employment Support Allowance are not included in the list of specified benefits because they are not paid solely as a result of an individual's disability or responsibility for a person in receipt of a disability-related benefit.

#### **Immigration Bill**

**Lord Hylton:** To ask Her Majesty's Government why clause 18 of the Immigration Bill would enable the Secretary of State to impose a financial penalty on a landlord, without recourse to a court, and give that Minister discretion as to the amount of the penalty; and what precedent, if any, there is for such authority.[HL5434]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The provisions in the Immigration Bill relating to landlords are modelled closely on the existing civil penalty scheme for employers of illegal workers in the Immigration and Asylum Act 2006. Under the proposed scheme, a

landlord will face a civil financial penalty for letting property to an illegal migrant if they have failed to comply with specified document checks. This civil scheme is distinct from criminal prosecution involving bringing a case to court, and the Bill does not create a criminal offence for landlords. The scheme incorporates important safeguards to ensure the arrangements are transparent and to protect the rights of landlords. The maximum level of penalty is specified at £3,000 on the face of the Bill (clauses 18 and 33), and may only be adjusted by affirmative resolution order. Penalties will operate in accordance with a scale set out in a statutory code of practice under clause 27, and landlords will have a right to object to the Secretary of State against a penalty (clause 24) and then to appeal to the civil courts (clause 25) on the grounds that they are not liable to the penalty, have established an excuse, or the level of penalty is too high.

#### **Immigration Bill**

**Lord Hylton:** To ask Her Majesty's Government whether the Home Office consulted the Department for Education and the Charity Commission about the impact of the Immigration Bill on charities; and if not, why not.[HL5318]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): During the development of the Immigration Bill there have been and continue to be many discussions across government departments including with Department for Education. Furthermore, several of the key elements in the Bill were subject to public consultation including proposals relating to migrant access to health, private rented accommodation, illegal working and family migration. A significant proportion of respondents were charities. There were also further discussions with individual charities that had an interest in specific parts of the Bill. It has not therefore been necessary to consult directly with the Charity Commission, which was able to participate in the public consultations along with any other organisation which wished to do so.

#### **Immigration Bill**

**Lord Hylton:** To ask Her Majesty's Government whether the impact of the current Immigration Bill is consistent with their existing policies to prevent the trafficking of persons.[HL5433]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Tackling modern slavery and human trafficking is a priority for this Government. The National Crime Agency leads the fight against organised criminals involved in the trafficking of persons. We are strengthening our response through the Modern Slavery Bill and the publication of an action plan, later this year, which will set out a complementary range of non-legislative activities.

The Immigration Bill will ensure that potential victims of trafficking are adequately protected by ensuring that there is no adverse impact on vulnerable groups. There are exemptions from the duty on landlords to check immigration status for hostels and refuges where victims of trafficking are housed. The regulations setting out who will pay the immigration health charge will also contain appropriate exemptions for victims of trafficking.

The Immigration Bill makes it more likely that those who are not here legally, including victims of trafficking, come to the notice of authorities. This policy will

work and complement other measures being taken to combat trafficking, facilitation, rogue landlords and gangmasters.

#### **Visas**

**Lord Hylton:** To ask Her Majesty's Government whether they will adjust minimum income requirements for persons settled in the United Kingdom to sponsor family members to enter or remain in the United Kingdom to equate with the Living Wage and regional variations of it.[HL5431]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The Government has no plans to adjust the minimum income threshold for spouse or partner visa applications to equate with the Living Wage or regional variations of it. The level of the income threshold, which was set in the light of advice from the independent Migration Advisory Committee, reflects the level of income at which a couple, once settled in the UK, generally cannot access income-related benefits.

The income threshold therefore prevents family migrants becoming a burden on the taxpayer and helps to ensure that they are well enough supported to integrate effectively in British society.

#### **Entry Clearances**

**David Hanson:** To ask the Secretary of State for the Home Department how many people who (a) successfully and (b) unsuccessfully applied for permission to enter the UK were described as self-employed in each year since 2010. [187824]

**Reply from James Brokenshire:** The available information on grants and refusals of entry clearance visas for the calendar years 2010-12 and for each of the first three quarters of 2013 are published in the Department's quarterly release Immigration Statistics. The latest edition is available from the Library of the House and from gov.uk at the following link:

#### **NHS: Foreign Workers**

**David Simpson:** To ask the Secretary of State for the Home Department what plans she has to ease visa or work permit restrictions for doctors and other medical staff from outside the UK wanting to work in UK hospitals. [187821]

**Reply from James Brokenshire:** The Government recognises the valuable contribution doctors from overseas make to our health service. There are several immigration routes available to doctors and there is no reason why those who are needed to fill gaps and who have a job offer from a UK sponsor cannot come.

Several roles for doctors, including emergency medicine, are on the shortage occupation list, which means they qualify for a visa under the Tier 2 (skilled work) route. For other roles not on the list, overseas doctors can be sponsored to work in the UK if it is not possible to fill the role from the resident labour market.

Doctors who graduate from UK medical schools can undertake foundation training in Tier 4 of the Points-Based System and then progress into Tier 2 with no need for a resident labour market test.

#### **Health Services: Foreign Nationals**

**Meg Hillier:** To ask the Secretary of State for Health what his policy is on retaining access to free diagnosis and treatment for every resident in England for all the diseases included in Schedule 1 of the National Health Service (Charges to Overseas Visitors) Regulations 2011. [187447]

**Reply from Jane Ellison:** Diagnosis and treatment of infectious diseases will remain free for people who are ordinarily resident in England.

Current exemptions that exist with regard to infectious diseases and sexually transmitted infections are integral to protecting the public's health. Therefore there are no planned changes to the exemptions listed in relation to treatment for the diseases stated in Schedule 1 of the National Health Service (Charges to Overseas Visitors) Regulations 2011.

We are currently working with NHS (England) and Public Health (England) to consider which diagnosis and treatment services (excluding the above) will become chargeable to visitors and migrants, there are no planned changes to individuals who are ordinarily resident in England. The outcome of this work will be published in due course.

#### **Employment: Migrants**

**Lord Taylor of Warwick:** To ask Her Majesty's Government what plans they have to help into employment female migrants who may lack the skills required to be economically active.[HL5125]

Reply from The Parliamentary Under-Secretary of State, Department for Work and Pensions (Lord Freud): Support for the unemployed is a priority for this Government. We provide funding to enable unemployed people to take up education and training which helps them develop the skills they need for employment.

Eligibility criteria for public funding are set out in the Skills Funding Agency's Funding Rules. Details are available at:

Unemployed learners will be eligible for full funded skills training if they are claimants of Jobseeker's Allowance, Employment and Support Allowance (in the Work Related Activity Group) and those on Universal Credit mandated to training by their Jobcentre adviser. Skills providers may also provide fully funded training to unemployed people on other benefits where this will help the learner gain the skills they need for employment.

**Lord Hylton:** To ask Her Majesty's Government how many unaccompanied asylumseeking children arrived in the United Kingdom in each of the last three years; and what proportion were subsequently joined by their parents or next of kin.[HL5320]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord

**Taylor of Holbeach):** The Home Office publishes statistics on asylum applications from unaccompanied asylum seeking children in tables as\_08 and as\_08\_q (Asylum data tables Volume 2) of Immigration Statistics. A copy of the latest release Immigration Statistics July-September 2013 is available from:

<u>september-2013</u> and the Library of the House. Data for Q4 2013 will be available from 27 February 2014.

As announced in Immigration Statistics January-March 2013, an internal review in 2012 of unaccompanied and asylum seeking children and age dispute data highlighted issues in the consistency of the definitions used to produce the previously published figures. The definitions were subsequently refined and reproduced for 2012 and the following quarters of 2013. While the data published using the previous definition provides the best available guide to historical trends for the years 2006 to 2012, comparison with latest figures based on the revised definition are not recommended. It is planned that future releases of Immigration Statistics will include figures for 2006 to 2011 using the new definition.

Figures for the number of unaccompanied children who are subsequently joined by their parents or next of kin are not routinely collected by the Home Office.

**Lord Roberts of Llandudno:** To ask Her Majesty's Government what form their financial support to asylum seekers takes; and whether they have plans to reform it.[HL5401] To ask Her Majesty's Government what, if any, benefits are available to asylum seekers to enable them to travel on public transport.[HL5402]

**Reply from Lord Taylor of Holbeach:** Destitute asylum seekers are provided with a cash allowance which they are free to use as they choose. The Home Office also provides travel tickets for certain appointments, including asylum interviews, appeal hearings and attendance at immigration reporting centres.

#### **Immigration and Asylum Act 2002**

**Lord Hylton:** To ask Her Majesty's Government how many appeals against (1) refusal of refugee status, (2) human rights claims, or (3) claims for humanitarian protection, have been made from outside the United Kingdom since the coming into force of the Immigration and Asylum Act 2002; and how many of each were successful.[HL5317]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Since 2007, our records show that 114 appeals have been lodged from outside the United Kingdom against a certified refusal of refugee status and/ or refusals of claims for humanitarian protection. One of these appeals is recorded as being successful.

#### Notes

- i. A breakdown for the full period requested is not available due to the way that this information was recorded on our internal database prior to 2007.
- ii. We are unable to break down figures that specifically relate to refusals of refugee status and refusals of humanitarian protection.
- iii. We are unable to provide information on how many appeals against human rights claims have been lodged from outside of the United Kingdom as the information is not recorded centrally in one system in a way that allows us to extract the information requested.
- iv. All figures given are based on internal management information and are subject to change.
- v. Figures provided are up to 30th September 2013.

#### **Asylum Seekers**

**Lord Hylton:** To ask Her Majesty's Government what was the total number of asylum applications that were undecided after 12 months, on the most recent date for which figures are available.[HL5448]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): At the end of November 2013, 4,886 asylum applications were pending an initial decision after 12 months. Of these, 3,634 were for main applicants. The figures provided are a subset of latest published statistics for applications received for asylum since April 2006 and published by the Home Office on a monthly basis. **Reply from James Brokenshire:** The Home Office has been consulting with the Refugee Council and Maternity Action with a view to updating the guidance. The Refugee Council and Maternity Action sent a response to the proposed revision of the guidance in January and this is now being considered.

**Lord Roberts of Llandudno:** To ask Her Majesty's Government, further to the Written Answer by Lord Taylor of Holbeach on 7 January (WA 276), why the system of gathering data on the medical welfare of those detained for immigration purposes was changed.[HL4840]

To ask Her Majesty's Government, further to the Written Answer by Lord Taylor of Holbeach on 7 January (WA 276), what was the system for gathering data on the medical welfare of those detained for immigration purposes before 2012; and what is the system now.[HL4841]

To ask Her Majesty's Government, further to the Written Answer by Lord Taylor of Holbeach on 7 January (WA 276), how information relating to self harm would be (1) gathered, and (2) made publicly accessible, other than in response to Freedom of Information Act 2000 requests.[HL4842]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Management information relating to individuals placed on Assessment Care in Detention and Teamwork monitoring, or individuals requiring medical attention as a result of self harm, is part of data collated for internal performance monitoring. The data collation process was changed in 2012 to avoid duplication and to improve and rationalise data quality.

Prior to 2012 data was collated centrally by month. After 2012 changes were made to the reporting frequency, data periods covered, and categories of data collected.

Information on the number of incidents of self harm is management information and does not form part of published statistics. There are no plans to change this.

#### **Immigration Removal Centres: Restraint**

**Baroness Stern:** To ask Her Majesty's Government what action they have taken about the use of restraints at Harmondsworth Immigration Removal Centre in the light of the report by the HM Chief Inspector of Prisons that two elderly men were handcuffed in "an excessive and unacceptable manner", one of whom died shortly after the removal of handcuffs and the other, an 84-year-old who had been declared unfit for detention, died whilst still handcuffed. [HL5445]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Unnecessary use of restraints is unacceptable. Following these incidents an investigation was carried out and a number of changes have been made to ensure proper risk assessments are carried out (by contractors) in a timely way. Firm instructions have been issued making clear that restraint should only happen where absolutely necessary.

In the case of the 84 year old man, the use of restraint was completely unjustified

and such action must not be repeated in similar circumstances. The independent Prisons and Probation Ombudsman is investigating the circumstances of the death. The Home Office will carefully consider the findings of the Ombudsman's report.

#### **Helmets: Sikhs**

**John Spellar:** To ask the Secretary of State for Work and Pensions what plans he has to extend to industrial premises the exemption for Sikhs from requirements to wear safety helmets on construction sites. [185731]

**Reply from Mike Penning:** As the law currently stands, turban-wearing Sikhs are exempt from wearing head protection in a high hazard industry, construction, but may be required to wear it in lower hazard workplaces.

I am seeking to table an amendment to the De-regulation Bill, which is currently before Parliament, to extend this exemption to all workplaces, including industrial premises. The amendment will also extend the limitation on liability for employers to any work situation where a turban-wearing Sikh chooses not to wear head protection. There may be very limited exceptions, such as for specific roles in the emergency services or armed forces. The Health and Safety Executive is currently consulting on the proposals.

Reply from the Parliamentary Under-Secretary of State, Department of Health (Earl Howe) (Con): NHS England advises that it is currently undergoing a refresh of its equality and diversity data, which includes all grades. To this end, all its staff have been asked to update their information including, if they are willing to

do so, self-classifying their ethnicity, in keeping with provisions of the Equality Act 2010. The completion rate of the refresh currently exceeds 80% and is scheduled to be concluded by 31 March 2014.

In line with Cabinet Office guidance we do not publish details about individuals' protected characteristics. Given the small numbers of Board members we could not disclose the results of our monitoring, or NHS England's monitoring, without infringing the rights of the individuals concerned. Our data is included in broader data on appointments by ethnic minority background, role, and body, which have been published by the Commissioner for Public Appointments in the Annual Survey of Ministerial Appointments and Reappointments to the Boards of Public Bodies Regulated by the Commissioner for Public Appointments. **Lord Boateng:** To ask Her Majesty's Government, further to the answer by Earl Howe on 10 February (HL Deb, col 406), when the strategy on the career progression of black and minority ethnic nurses will be completed; and whether it will be published.[HL5438]

To ask Her Majesty's Government what assessment they have made of the impact of institutional racism in the wider representation of black and minority ethnic nurses amongst executive directors of nursing in the National Health Service.[HL5439]

To ask Her Majesty's Government what is the membership of the Chief Nursing Officers Black and Minority Ethnic Advisory Group; how many times it met in 2011, 2012 and 2013; and whether its reports are circulated to (1) ministers, and (2) NHS England Board Members.[HL5441]

Reply from the Parliamentary Under-Secretary of State, Department of Health (Earl Howe): The Chair of the Chief Nursing Officers (CNO) Black and Minority Ethnic (BME) Advisory Group has set up a BME Leadership Strategy Group to develop a BME Leadership Strategy. It plans to publish and implement the strategy later this year. The strategy has a strong focus on support and development for BME staff with the aim to improve services and workplaces that are equitable where everyone feels that they count.

Workforce diversity across all occupations and grades in the National Health Service is a priority. This is not about quotas but it is fundamentally about bringing the best resources to leadership, culture, innovation, ethics and behaviour, thus creating a workforce that has shared values represented by a wide range of perspectives.

To help the NHS perform well on equality, and build on its considerable achievements, the NHS Equality and Diversity Council, working with the NHS, designed an Equality Delivery System for the NHS which was formally launched in November 2011. Following an evaluation, a refresh of the Equality Delivery System for the NHS, known as "EDS2" was published in November 2013.

The EDS2 toolkit is designed to support NHS commissioners and providers to deliver better outcomes for all patients and communities. It does so by asking NHS organisations to monitor their equality performance jointly with their patients, communities and staff, in regard to each of the nine characteristics given protection under the Equality Act 2010, including race (ethnic or national origins). The CNO BME Advisory Group consists of 25 core members and 65 affiliated members representing Senior Nurses and Midwives in the NHS and independent

organisations, and educationalists. The Group meets bi-monthly (6 times a year) and has done since its establishment in 2001. The CNO attends some of the meetings herself and minutes of meetings are sent to the CNO; they are not sent to Ministers. Key outcomes and actions are fed back to the NHS Equality and Diversity Council meetings, the Nurse Leadership Programme Board and internal Executive meetings.

**Jackie Baillie:** To ask the Scottish Government what community awareness raising and prevention work is undertaken with women from cultures that practice female genital mutilation. (S4W-19523)

**Reply from Shona Robison:** A number of methods are used to raise awareness and encourage the reporting of female genital mutilation (FGM) including engaging with individuals and minority ethnic women's organisations such as Dignity Alert Research Forum (DARF), Saheliya and Shakti Women's Aid, all of who provide services to women who come from communities affected by FGM.

The Government also works in partnership with health professionals, voluntary organisations, social services, education departments and the police to support victims, engage with communities for the prevention of FGM, and to share good practice and promote awareness across Scotland for the prevention of FGM.

Scottish Government is providing funding to the Scottish Refugee Council and the Women's Support Project, to carry out a project to produce a baseline of information which will inform work to tackle female genital mutilation. We will be looking closely at all findings and recommendations from that report (due for publication September 2014) to ensure that what we are doing and what we are developing meets our shared objective of tackling FGM.

FGM is addressed within the violence against women policy area and will be

included in the Violence Against Women Strategy that is currently being developed and scheduled for publication summer 2014.

#### **Female Genital Mutilation**

**Jackie Baillie:** To ask the Scottish Government what the (a) prevalence and (b) severity is of female genital mutilation. (S4W-19520)

**Reply from Shona Robison:** (a) It has been estimated that 3,000 women and girls are at risk in Scotland. This figure for Scotland is a pro rata projection based on research by FORWARD in England and Wales in 2007.

According to the 2001 Census data, there were 2,946 women between the ages of 0-49 living in Scotland and born in one of the 29 countries in which female genital mutilation (FGM) is reported to be a traditional practice. We will consider data from the 2011 Census which is scheduled for release in the first part of 2014, and that will allow a more-up to date prevalence estimate of FGM to be calculated. However initial data from the census shows that the number of people resident in Scotland who were born in Africa has more than doubled since the 2001 Census (from 22,049 to 46,742), and so the number of women and girls estimated to have undergone FGM is also likely to have increased.

That does not mean that all those women who were born in a country where FGM is prevalent have been abused in this way, only that they may be at risk.

(b) FGM is defined by the World Health Organisation as 'all procedures that involve partial or total removal of the external female genitalia, or other injury to the female genital organs for non-medical reasons'. The Scottish Government does not hold any information on severity of such 'procedures' carried out.

We strongly support the action plan that the Director of Public Prosecutions has published with a view to bringing a successful prosecution for female genital mutilation.

**Margot James:** What steps [is the Department for Health] taking to tackle female genital mutilation. [902631]

Reply from the Parliamentary Under-Secretary of State for Health (Jane Ellison): We recently announced that all NHS acute hospitals must provide information on patients who have undergone female genital mutilation, but that is just one element of a wider-ranging programme of work that is under way in order, most importantly, to improve the way in which we care for girls and women who have undergone FGM and to follow up on, respond to and prevent FGM. I will make further announcements in due course.

**Margot James:** I congratulate my hon. Friend on all the work she has done to combat this abhorrent crime since she entered Parliament. Will she confirm that the data reported to her Department will be used to mount educational campaigns to stamp out FGM in the vicinity of hospitals reporting patients who have been abused in this way?

**Reply from Jane Ellison:** We anticipate that we will be able to share the data collected with all appropriate Government Departments and partner organisations. On local education campaigns, I see no reason why requests to access the data would not be approved. We want to build a proper national picture of what is going on with FGM so that we can do all we can both to care for victims and to stamp out this abuse.

**John Cryer:** On the issue of widening education, could the Minister encourage her colleagues at the Department for Education to write to schools to raise awareness of this abhorrent practice?

**Reply from Jane Ellison:** Fahma Mohamed, the brilliant young woman who has led the campaign on this, will meet the Education Secretary today and there is a

lot of work under way across all Government Departments. There was recently a cross-Government declaration on the things that are going on to stamp out FGM and to care for its victims. The hon. That the proposed project will raise awareness about socio-cultural, ethnic-legal, sexual health and clinical implications of FGM.

**Helen Jones:** To ask the Secretary of State for Health what use his Department plans to make of information on female genital mutilation reported by acute hospitals after September 2014. [188442]

**Reply from Jane Ellison:** Data collection is the first stage of a wider ranging programme of work in development to improve the way in which the national health service will respond to the health needs of girls and women who have suffered female genital mutilation (FGM) and actively support prevention.

Further announcements on the collection and use of FGM information will be made in due course.
