### **UK Parliament Ministerial Statement**

#### **Vulnerable Persons Relocation Scheme (Syria)**

The Minister for Security and Immigration (James Brokenshire): Our country has a proud history of granting protection to those who need it. We are still all too conscious of the appalling scenes of violence and suffering which are occurring every day in Syria. The greatest contribution we can make is to work to end the conflict altogether and we continue to seek a peaceful settlement that enables a political transition and an end to

violence. We are the second largest bilateral donor to the Syrian relief effort and have provided £600 million so far.

As the Home Secretary outlined to the House of Commons on 29 January 2014, Official Report, column 863, while the greatest need is in the region and the United Kingdom can make the largest impact there, we have launched the Syrian vulnerable persons relocation (VPR) scheme to provide protection in this country to particularly vulnerable refugees who are at grave risk. Since that point, we have been working closely with the United Nations High Commissioner for Refugees (UNHCR) to identify those who are most vulnerable.

I am pleased to report that we expect the first group of Syrians to arrive as part of the VPR scheme today, just eight weeks after the Home Secretary's announcement. During this time, we have been working in close collaboration with the UNHCR, the International Organisation for Migration and local authority services to ensure that the particular needs of the beneficiaries, with their extreme vulnerabilities, will be met. Given the absolute primacy of safeguarding the UK's security, appropriate checks have also been conducted before bringing Syrians displaced by the conflict to the UK. We expect the next arrivals in April. Those admitted under the VPR scheme will be granted five years' humanitarian protection with all the rights and benefits that go with that status, including access to public funds, access to the labour market and the possibility of family reunion. We believe that the VPR scheme will make a real difference to the lives of some of the most vulnerable Syrians displaced by the conflict by giving them protection and support in the LIK

I have agreed a ministerial authorisation (Equality (Syria—Entry clearance outside the immigration rules) Authorisation 2014) to allow differentiation in favour of Syrian nationals whom we want to bring to the UK under the VPR scheme.

This authorisation will remain in force until revoked.

#### **Immigration Bill**

**Baroness Lister of Burtersett:** To ask Her Majesty's Government what research has been undertaken on the potential health impacts of the proposed changes in the Immigration Bill on vulnerable migrants, including pregnant women and children.[HL5957]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The Government's assessment of the potential impact of the health provisions in the Immigration Bill on vulnerable groups is set out in the Home Office response to its public consultation Controlling Immigration — Regulating Migrant Access to Health Services in the UK and the Policy Equality Statement contained therein. #### **Immigration Bill**

**Baroness Lister of Burtersett:** To ask Her Majesty's Government how they plan to monitor who is chargeable for NHS care under clause 33 of the Immigration Bill; and what is the expected cost of administering such a system in the National Health Service.[HL5958]

Reply from the Parliamentary Under-Secretary of State, Department of Health (Earl Howe): Clause 33 of the Immigration Bill gives provision for the introduction of the health surcharge on individuals subject to immigration control. We anticipate that this surcharge will be introduced for individuals seeking leave to enter or remain on visas of between six months and five years' duration.

The Department is working closely with the Home Office to ensure that information on the individuals who have paid the health surcharge is easily available to providers of National Health Service healthcare. An individual having paid the health surcharge will then generally be entitled to access all NHS services free at the point of delivery as per any United Kingdom or European Economic Area national resident here. Eligibility will be demonstrated by the possession of a biometric residence permit and an automatically-created NHS record, which will identify that the individual has paid the surcharge and therefore is not to be subject to further charges, except where a resident pays charges.

The additional administrative burden on the NHS of identifying those who have paid the surcharge, and thus of verifying their entitlement to healthcare which is free at the point of delivery, should be minimal. The Department is working with the Health and Social Care Information Centre to include new data fields on the NHS Spine that will be populated with an individual's immigration status and surcharge validity automatically.

The Department will be publishing a costed implementation plan for the NHS Cost Recovery Programme soon.

#### **Visas**

**Lord Willis of Knaresborough:** To ask Her Majesty's Government what visa arrangements are made to allow academics from non-European Union countries who are invited to lecture or take part in research on a short-term basis to enter the United Kingdom; and whether those arrangements apply to their immediate family members.[HL6117]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Academics can use the academic visitor route to carry out unpaid research for up to 12 months provided they are on sabbatical leave from their overseas academic institution. Academics can also speak at conferences provided it is a not for profit venture.

Academics can use the permitted paid engagement visitor route to give paid lectures for up to 1 month. They must be invited by a UK Higher Education Institution or a UK research or arts based organisation.

Family members can apply as general visitors, or child visitors in the case of children under 18 years, to accompany the main visitor to the UK. They would be allowed to stay in the UK for up to 6 months, or 12 months where they are accompanying an academic visitor.

Academics who are employed to carry out paid research in the UK can do so under the Tier 5 Government Authorised Exchange route for up to 24 months. They must be sponsored by a UK Higher Education Institution. Their dependents can stay with them and have the right to work.

**Lord Avebury:** To ask Her Majesty's Government how many applications have been received by United Kingdom entry clearance posts for adult dependant settlement visas from 31 July 2012, to the latest convenient date; and how many such visas were granted over the same period.[HL6119]

Reply from Lord Taylor of Holbeach: The information requested on entry

clearance applications for adult dependent relative settlement visas is not available and could only be obtained at disproportionate cost by the examination of a significant number of individual case records.

The Home Office publishes quarterly statistics on entry clearance visa applications and resolutions (issued, refused, withdrawn and lapsed) by category in table be\_01\_q (Before Entry tables volume 2) within the 'Immigration Statistics' release. A copy of the latest release, 'Immigration Statistics September – December 2013' is available from the Library of the House and from:

Within the table be\_01\_q, data relating to adult dependent relatives of a British Citizen in the UK or a settled person in the UK are included in the category 'Family: Other (for immediate settlement)' but cannot be identified separately.

The Home Office is reviewing the collection of data relating to adult dependent relative settlement visas. Data are being developed and, subject to resolving any data quality/recording issues, it is planned to begin publishing data specifically relating to adult dependent relative settlement visas later this year.

A manual review of the available management information to identify adult dependent relative applications granted in the period from 1 November 2012 to 30 September 2013 indicates that 34 settlement visas were issued in that period to an adult dependent relative under Appendix FM to the Immigration Rules. This information is provisional and subject to change. Corresponding information on applications is not available.

### **Immigrants**

**Frank Field:** To ask the Secretary of State for the Home Department with reference to the Assistance for the Voluntary Return and Reintegration of Returnees project, what the countries of origin of the 1,470 irregular migrants were; what assistance will be provided to the 30 victims of human trafficking from EU countries; how it will provide reintegration assistance to the 75 returning vulnerable migrants; and if she will make a statement. [190276]

**Reply from James Brokenshire**: For many illegal migrants, the UK remains a primary destination country and some of those this programme will assist might otherwise arrive in the UK.

This project will make a positive and significant contribution to Greece's comprehensive management of migration by facilitating the safe returns and reintegration of migrants in their countries of origin. The project will also raise awareness of the real dangers associated with illegal migration and of the advantages of returning home voluntarily, with support.

We will keep the effectiveness of this project under review.

**Frank Field:** To ask the Secretary of State for the Home Department what the nature and purpose is of the Government-funded Assistance for the Voluntary Return and Reintegration of Returnees project being implemented by the International Organisation for Migration in co-operation with the Greek Government; how that project will assist irregular migrants to return to their countries of origin; and how the project will help identified victims of human trafficking from EU countries. ### **Migrant Domestic Workers**

**Baroness Cox:** To ask Her Majesty's Government whether they plan to permit migrant domestic workers to change employers without breaching the immigration rules.[HL5840]

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): The overseas domestic worker route was reformed in April 2012 to restore it to the original purpose, which is to enable domestic workers to accompany their overseas employer on a visit to the UK.

The Government is carefully considering all of the recommendations made in the report of the Modern Slavery Bill Evidence Review which included reference to considering reinstating the right to change employer.

### **Entry Clearances: Overseas Students**

**Nicholas Soames:** To ask the Secretary of State for the Home Department what estimate she has made of the change in the number of non-EU students issued visas to study at UK universities in the last five years. [191829]

**Reply from James Brokenshire**:Since 2010 we have made common sense reforms to our student visa system, cutting out abuse whilst ensuring that we continue to attract talented international students to our world class universities.

Available figures of applications for visas for study using sponsor acceptances at UK universities during the last four years (2010 to 2013) show that there has been an increase in each year, rising by 7% from 156,629 in 2012 to 167,995 in 2013 and for students sponsored by the Russell Group of universities this rose by 11%. ### **Asylum: Syria**

**Keith Vaz:** To ask the Secretary of State for the Home Department how many (a) children and (b) adults have been granted asylum in the UK under the Vulnerable Person Relocation Scheme from Syria. [192532]

Reply from James Brokenshire: The first Syrians relocated under the Vulnerable Persons Relocation (VPR) scheme arrived into the UK on 25 March 2014. The scheme prioritises women and children at risk or in need of medical care, and survivors of torture and violence; given the particular vulnerability of these individuals, it has been essential to work with partners including UNHCR and local authorities to ensure that the support, services and accommodation they need are

in place before they arrive in the UK. We expect the scheme to support several hundred people over the next three years.

#### **Detention Centres**

**Keith Vaz:** To ask the Secretary of State for the Home Department how many people are allocated to each room in immigration detention centres. [192293]

Reply rom James Brokenshire: Rooms in Immigration Removal Centres are generally shared by two or three occupants, although there are also single occupancy and some larger rooms, which can accommodate up to eight detainees. The largest room capacity is a 12-bed first-night unit in Dungavel, Scotland. In order to be used as sleeping accommodation, rooms must be certified in accordance with Detention Services Order 4/2003 by the Secretary of State, that the lighting, heating and ventilation are adequate for health. #### Census

**Clare Adamson:** To ask the Scottish Government what arrangements are being made for future censuses in Scotland. (S4W-20348)

**Reply from Fiona Hyslop:** National Records of Scotland (NRS) has today announced that it intends to focus on planning for a census in 2021 which will be primarily online, while offering alternative modes of completion where necessary. It also aims to make best use of technology and administrative data in its design, building on the online approach used successfully in the 2011 census.

This follows on from the Beyond 2011 programme of work in Scotland to review the options for providing population statistics. The review focused on two options:

- an online census option carried out every 10 years supplemented by the use of administrative data to produce annual population estimates in intervening years.
- an administrative data option using administrative data already held by government and annual surveys.

The decision to focus plans on a census in 2021 in Scotland was based on a variety of evidence, including results from research, stakeholder engagement, a user consultation and international experience. A final decision will be taken in 2016 on the basis of the business case. A programme of consultation and engagement will continue by NRS to understand user requirements and shape the design of the 2021 census. The findings from Beyond 2011 to date will be incorporated into the programme of work. Further research will be carried out to enable greater use of administrative data and surveys in the future.

#### **Female Genital Mutilation**

**Mr Simon Burns:** To ask the Attorney-General what steps the Crown Prosecution Service is taking to better prosecute cases involving female genital mutilation. [192572]

Reply from the Solicitor-General: The Crown Prosecution Service (CPS) is taking a leading role in tackling female genital mutilation (FGM). The Director of Public Prosecutions (DPP) announced the first ever prosecution under the Female Genital Mutilation Act 2003 on 21 March 2014. The first defendant is charged with carrying out FGM and the second defendant is charged with intentionally encouraging an offence of FGM and aiding, abetting, counselling or procuring an offence of FGM.

The CPS has worked closely with the police, other Government Departments and third sector organisations to put a robust framework in place to support reporting and the effective investigation and prosecution of FGM. The CPS has published action plans in 2012 and 2013 which have led to much closer joint working between the police and CPS. Lead prosecutors have been appointed for each CPS area and they have led on agreeing protocols with every local police force setting out the arrangements for investigating and prosecuting FGM locally. A joint CPS/police national training event has been held recently. The DPP and I have written to Ministers in the Home Office, Ministry of Justice and Department of Health with a paper identifying possible ways in which the criminal law could be strengthened. The DPP and I attended a Ministers' meeting recently to consider cross-government action against FGM.

#### **Female Genital Mutilation**

**Luciana Berger:** To ask the Secretary of State for Health if he plans to provide services to support midwives reporting cases of female genital mutilation. [193253]

**Reply from Jane Ellison:** The Government published the guidance 'Multi-Agency Practice Guidelines: Female Genital Mutilation' on 24 February 2011, which provides advice to health professionals on when they should report cases under section 47 of the 1989 Children Act.

Guidance is also available from various, professional bodies, for example, the General Medical Council and the Royal College of Midwives. In addition, the National Society for the Prevention of Cruelty to Children female genital mutilation (FGM) helpline, co-funded by the Home Office, is a resource for health professionals and young people with concerns about safeguarding issues.

The Department is also working with NHS England, Health Education England and the Royal Colleges to develop materials and training to support national health service staff including midwives to better identify and support girls at risk of female genital mutilation. Further announcements on this work will be made in due course.

**Keith Vaz:** To ask the Secretary of State for Health how many women and girls received NHS treatment in each foundation trust area after having undergone a female genital mutilation procedure in each of the last three years. [193323]

**Reply from Jane Ellison:** Information on female genital mutilation (FGM) is not currently collected centrally in the Department.

However, from April, all (foundation and non-foundation) national health service acute hospitals will report to the Department on the prevalence of female genital mutilation within their patient population, including the total number of patients who have undergone FGM or been treated for FGM (for example, de-infibulation). This information will be returned to the Department every month with compliance on this required by September.
