## **UK Parliament Questions**

#### **Entry Clearances**

**George Galloway:** To ask the Secretary of State for the Home Department (1) for what reasons there are differential rates for visas for dependents of British citizens coming from non-EU countries and visas for dependents of EU non-British citizens domiciled in Britain; [193115]

(2) if she will abolish the differential rates for visas paid by British and EU non-British citizens living in the UK for dependents outside the EU and make the cost of all such visas the same as the EU rate. [193116]

Reply from James Brokenshire: Dependants of British citizens from non-EU countries who wish to enter the UK are required to apply for entry under the immigration rules. In line with its legislative powers, the Home Office sets immigration and nationality fees to reflect the administrative cost of processing an application as well as benefits and entitlements that may accrue if an applicant is successful. These fees apply to foreign national family members of British citizens applying for entry under the immigration rules. The Home Office believes that it is right that those who use and benefit most from the immigration system contribute to its running costs. The rights of EU nationals to live and work in other European Union member states, and to be accompanied by their non-EU family members, are set out in European Union law, in directive 2004/38/EC ("the free movement directive"), by which all EU member states are bound. The free movement directive does not cover the rights of EU citizens living in their country of nationality, so it does not apply to British nationals living in the UK. The free movement directive requires member states to issue entry clearance visas to non-EU family members of EU nationals free of charge.

#### **Overseas Students**

**Nicholas Soames:** To ask the Secretary of State for the Home Department what steps her Department is taking to record the departure of non-EU students as they leave the UK at the end of their studies. [191828]

**Reply from James Brokenshire:** The Office for National Statistics long-term international migration data include estimates of the numbers of students leaving the UK. At the request of the Home Office and other migration statistics users, the ONS has improved its methodology with an aim to identify emigrants who had originally arrived as students. This has assisted in assessing the contribution of students to overall net migration. It is estimated that 49,000 non-EU migrants, who had previously immigrated for study, had emigrated from the UK in the year ending September 2013. HM Government has made a commitment to reintroduce exit checks. By 2015, we will have checks in place on those who leave the UK by scheduled international air, sea and rail services. Introducing exit checks will improve our ability to confirm departure and to identify those who have failed to leave the UK when they should have done so.

**Sarah Teather:** To ask the Secretary of State for the Home Department how many asylum applicants receiving support under section 4 of the Immigration and Asylum Act 1999 have been receiving support for more than (*a*) two years, (*b*) four years and (*c*)six years; and if she will make a statement. [193593]

**Reply from James Brokenshire:** Data specific to your request can be found in the following table.

**Reply from James Brokenshire:** There are no immediate plans to change the support rates provided to destitute asylum seekers.

#### **Asylum: Pregnant Women**

**Diane Abbott:** To ask the Secretary of State for the Home Department with reference to the report by the Refugee Council, When Maternity Doesn't Matter, what steps her Department has taken to reform the dispersal policy of the former UK Border Agency. [193461]

**Reply from James Brokenshire:** The report covers procedures for accommodating pregnant asylum seekers who are destitute. The Home Office has been consulting about changes to these procedures and is considering some detailed suggestions by the Refugee Council and Maternity Action. Once that is completed we will move towards finalising and publishing revised guidance on the procedures.

#### Illegal Immigrants: Employment

**Bob Ainsworth:** To ask the Secretary of State for the Home Department what measures her Department has introduced in the last year to reduce the number of businesses employing illegal immigrants. [193823]

**Reply from James Brokenshire:** Employers have a duty to ensure that their employees have the right to work in the UK, and this duty has been underpinned by a civil penalty scheme since 2008. The Government is taking measures to ensure a tougher response to employers who use illegal labour, while simplifying arrangements for legitimate businesses to conduct right to work checks.

To deter employers from using illegal workers, the Home Office is doubling the maximum penalty to £20,000. The Government is also using the current Immigration Bill to make it easier to enforce unpaid civil penalties in the civil courts. In addition, with the creation of the new Immigration Enforcement Directorate last year, there has been a 47% increase in illegal working enforcement operations and a corresponding increase in civil penalties imposed, with 1,862 penalties served in 2013-14 (to the end of February) compared to 1,270 in 2012-13. We are also ensuring greater collaboration across Government

to increase our "enforcement reach" and the range of sanctions that can be brought to bear against rogue employers who exploit illegal workers.

#### Illegal Immigrants: Employment

**David Hanson:** To ask the Secretary of State for the Home Department how many fines levied under the Immigration (Employment of Adults Subject to Immigration Control) (Maximum Penalty) Order 2008 of a value of (*a*) up to £1000, (*b*) between £1000 and £2000, (*c*) between £2000 and £5000 and (*d*) between £5000 and £10000 remained unpaid. [194135]

**Reply from James Brokenshire:** Information on how many fines levied under the Immigration (Employment of Adults Subject to Immigration Control) (Maximum Penalty) Order 2008 of a value of (a) up to £1,000, (b) between £1,000 and £2,000, (c) between £2,000 and £5,000 and (d) £5,000 and £10,000 remained unpaid, is not recorded in a format compatible with National Statistics protocols. Data constraints on electronic records mean that the Home Office would have to examine in detail a large number of individual case files in order to ascertain the information required. The cost of producing the data linking civil penalties issued to our accounting system for civil penalties which remain unpaid by value would be at a disproportionate cost to the Home Office.

However, the Home Office has collected £30.6 million in fines through the life of the regime and the current total value of outstanding collectable debt is £14.6 million.

The Home Office is using the Immigration Bill to make it easier to enforce civil penalty debts in the courts and is incorporating debt recovery best practice from across Government Departments, with earlier initiation of legal proceedings for debt recovery if required.

#### Illegal Immigrants: Employment

**Christopher Chope:** To ask the Secretary of State for the Home Department what her most recent estimate is of the number of illegal immigrants employed in the UK; and what change there has been in this number since May 2010. [192961]

**Reply from James Brokenshire**: HM Government has not made any estimate of the number of illegal migrants currently employed in the UK. Given the clandestine nature of illegal migrants, any estimation is, by definition, extremely difficult and prone to considerable uncertainty.

However, the Government takes illegal immigration very seriously and is focusing on measures to ensure that illegal migrants cannot live, work or abuse benefits and services in the UK. The Immigration Bill will prevent illegal migrants from accessing and abusing public services. It will also strengthen our existing arrangements to prevent illegal working, by making it easier to enforce penalties on employers found to be employing illegal workers; reform the removals and appeals system, making it simpler to remove those with no right to be in the UK; and end the abuse of Article 8 of the ECHR—the right to respect for private and family life. Parallel changes to secondary legislation will also double the maximum penalty for employing an illegal worker and strengthen the scheme as a whole, including by simplifying the checks employers must perform.

**Sarah Teather:** To ask the Secretary of State for the Home Department how many people held in immigration removal centres and who refused food or fluids have been transferred to prisons since May 2013. [193784]

**Reply from James Brokenshire:** No persons held in immigration removal centres have been transferred to prisons since May 2013 due to refusal of food or fluids.

#### Deportation

**David Hanson:** To ask the Secretary of State for the Home Department how many serious misconduct complaints related to the use of control and restraint during enforced removal were referred to the Professional Standards Unit in each year since 2010. [193473]

**Reply from James Brokenshire:** Complaints made by, or on behalf of, detainees are managed in accordance with Detention Services Order 3/2011. All allegations of serious misconduct are referred to the Home Office Professional Standards Unit (PSU) for investigation. These include allegations made against staff who work in the detention estate or who are engaged in escorting work.

Data on the number of complaints referred to the PSU is not recorded. Only data of those complaints where PSU have agreed to investigate are recorded. The number investigated relating to the use of control and restraint during enforced removal is detailed as follows:

2010: 42

2011: 30

2012: 39

2013: 19.

These figures are based on management information, which is subject to change, and does not form part of our publicised statistics.

#### **Human Trafficking**

**Jake Berry:** To ask the Secretary of State for Foreign and Commonwealth Affairs what role the UK's embassies and consulates play in preventing human trafficking in source countries. [193547]

**Reply from Hugo Swire:** Britain's diplomatic missions implement a Human Trafficking Strategy overseas, on behalf of her Majesty's Government. They work with foreign governments in source and transit countries to build their capacity to disrupt and tackle human trafficking. They support local investigators to increase prosecutions for human trafficking offences and conduct awareness raising projects. They contribute to the UK's and international efforts to combat trafficking by ensuring that UK interests are effectively represented bilaterally and in multilateral fora including the EU and the UN. Our missions also address the root causes of human trafficking through the Department for International Development's work in the world's poorest countries.

#### Human Trafficking: Victim Support Schemes

**Frank Field:** To ask the Secretary of State for the Home Department how many survivors of human trafficking who have been placed in shelters funded by the Government through the Salvation Army received support from the government victim care contract specialist support providers to develop a move-on strategy in *(a)* 2012 and *(b)* 2013; how many of these victims were (i) men and (ii) women; how many (A) men and (B) women are still receiving such support; and if she will make a statement. [191305]

**Reply from Karen Bradley:** Support to develop a move-on strategy is offered to all victims supported under the Government victim-care contract. The number of victims who have received Government-funded support are given as follows.

#### Human Trafficking: Repatriation

**Frank Field:** To ask the Secretary of State for the Home Department how many (*a*) men and (*b*) women who are victims of human trafficking are nationals of non-EEA countries have received return and reintegration assistance through the Assisted Voluntary Returns for Irregular Migrants programme since April 2011; and how much was so made available to those trafficked from (i) inside and (ii) outside the EU. [191303]

**Reply from Karen Bradley:** 16 victims of trafficking (one male, 15 female) have received financial assistance under the programme since April 2011.

While the Assisted Voluntary Return for Irregular Migrants (AVRIM) programme does not normally include financial assistance, a discretionary sum of up to £1000 is provided for specified vulnerable cases, and this includes victims of trafficking. Assisted Voluntary Return is only available to non-EEA nationals and the support is not dependent upon whether the individual has arrived from inside or outside the EU.

The figures provided are sourced from a Home Office management information system which is not quality assured under National Statistics protocols and is

subject to change due to internal data quality checking. Figures provided from this source do not constitute part of National Statistics and should be treated as provisional.

**Reply from the Parliamentary Under-Secretary of State for Schools (Lord Nash):** The Government firmly believes in the importance of Religious Education (RE). To help maintain progress in improving RE teaching, we are establishing a subject expert group on RE chaired by Dave Francis from RE:ONLINE. By working with schools to clarify the key challenges in teaching RE, the expert group will help to ensure that support and resources are available for high quality RE teaching. In addition, as part of reforms to non-EBacc subjects, Ofqual is considering how it could improve the content and rigour of the Religious Studies GCSE.

S4M-09591 Anne McTaggart: African and Caribbean Women's Association Report on Sickle Cell Disorder—That the Parliament recognises the work of the African and Caribbean Women's Association on raising awareness of sickle cell disorder (SCD) in communities in Glasgow and across Scotland; recognises that SCD is an inherited condition that affects one in every 2,500 children born in the UK; understands that sickle cell traits have been identified in as many as one in 10 people of African and Caribbean descent and that over 6,000 adults in the UK have SCD; notes the calls for a universal antenatal and newborn screening programme to be implemented across Scotland in order to identify new cases at the earliest stage, for NHS staff to be provided with comprehensive training on the specific needs of people with the condition and for health and social care providers to be appropriately resourced to treat SCD as a lifelong condition; notes the findings of the report by the African and Caribbean Women's Association, which calls for greater awareness of the condition among GPs, the Scottish Ambulance Service and accident and emergency staff, and further notes the view that support for people with SCD should be delivered in partnership between the Scottish Government, local authorities and the NHS.

**Helen Jones:** To ask the Secretary of State for the Home Department how many people have been arrested for breach of a forced marriage protection order in each year since such orders came into force. [193700]

**Reply from Norman Baker:** The information requested is not collected centrally by the Home Office.

Powers of arrest for breach of a forced marriage protection order are currently issued by the civil courts. Arrests for civil offences are not covered by the Home Office arrest collection.

Breach of a forced marriage protection order will become an offence when section 120 of the Anti-social Behaviour, Crime and Policing Act 2014 comes into force in summer 2014.

#### **Female Genital Mutilation**

**Emily Thornberry:** To ask the Attorney-General what steps he is taking to ensure that victims of female genital mutilation whose cases go to trial have access to the full range of support and special measures that are available to victims of other sexual offences. [193653]

**Reply from the Solicitor-General:** The Crown Prosecution Service (CPS) recognises that appropriate support is vital to ensure that victims of female genital mutilation (FGM) are able to give their evidence effectively in court. The CPS legal guidance advises prosecutors that in all cases of FGM they must ensure that the complainant is aware of the special measures that can be applied for at court, and that applications are made in time. For all child witnesses there is a presumption that they will give their evidence in chief by recorded interview and any further

evidence by live link unless the court is satisfied that this will not improve the quality of the child's evidence. Adult victims of FGM are also eligible for special measures on the grounds that they are likely to be intimidated witnesses in relation to testifying at court. However it is a matter for the court to grant the application.

**Emily Thornberry:** To ask the Attorney-General if he will make it his policy to introduce the option of anonymity for victims of female genital mutilation in court trials. [193654]

**Reply from the Solicitor-General:** The Crown Prosecution Service recognises that more needs to be done to encourage victims of female genital mutilation (FGM) to come forward. The Director of Public Prosecutions (DPP) has said that the introduction of anonymity for victims of FGM should be considered to encourage more victims to come forward as, given the very personal nature of the offence, very few do so. However, any change of law on anonymity is a matter for the Ministry of Justice.

#### Female Genital Mutilation

**Lord Blencathra:** To ask Her Majesty's Government whether they will instruct the Crown Prosecution Service to bring prosecutions relating to all cases of female genital mutilation reported in London since 2009.[HL6240]

**Reply from the Advocate-General for Scotland (Lord Wallace of Tankerness) (LD):** The Crown Prosecution Service (CPS) is committed to tackling cases of female genital mutilation (FGM), however it can only prosecute cases referred to it by the police which meet both of the tests outlined in the Code for Crown Prosecutors.

The Code sets out a two stage test which must be applied when deciding whether a case should be prosecuted. The first stage is the evidential test which requires prosecutors to be satisfied that there is sufficient evidence to provide a realistic prospect of conviction. If the evidential stage of the test is met prosecutors must then go on to identify the relevant public interest factors tending for and against the prosecution in order to form an overall assessment of whether a prosecution is in the public interest.

#### Sharia Law

Lord Pearson of Rannoch: To ask Her Majesty's Government what is their assessment of the Law Society's practice note on drawing up wills which are compliant with Sharia law.[HL6320]

**Reply from the Minister of State, Ministry of Justice (Lord Faulks) (Con):** Sharia law has no jurisdiction in England and Wales and the Government has no intention to change this position.

The Law Society's practice note gives guidance to solicitors preparing wills under the law of England and Wales. It is a fundamental principle of this law that testators are, by making a valid will, able to leave their property to whomsoever they wish, subject only to the Inheritance (Provision for Family and Dependants) Act 1975. The practice note does not and cannot change the law.

**Lord Bradshaw:** To ask Her Majesty's Government, in the light of the guidelines issued by the Law Society on 13 March on making wills "Sharia compliant", what steps they are taking to prevent the escalation of the problem identified by the Law Society. [HL6394]

Reply from Lord Faulks: Sharia law has no jurisdiction in England and Wales

and the Government has no intention to change this position.

The Government also has no intention of changing the fundamental principle of the law of succession in England and Wales that testators are, by making a valid will, able to leave their property to whomsoever they wish, subject only to the Inheritance (Provision for Family and Dependants) Act 1975.

We encourage people to make wills by providing a relatively straightforward legal framework that keeps the formalities to a minimum and enables wills to be made quickly and inexpensively; and are considering what further steps we can take to raise awareness of the importance of making a will and to make the process simpler. **Lord Taylor of Warwick:** To ask Her Majesty's Government what steps they are taking to prevent the selective abortion of girls in ethnic communities.[HL6199]

**Reply from the Parliamentary Under-Secretary of State, Department of Health (Earl Howe):** Abortion on the grounds of gender alone is illegal. The 1967 Abortion Act states that two practitioners have to be "of the opinion, formed in good faith" that the woman has grounds for an abortion according to the criteria set out in that Act.

The Chief Medical Officer for England has written twice (on 23 February 2012 and 22 November 2013) to all practitioners reminding them of their responsibilities under the Abortion Act.
