### **Immigration**

John Finnie: To ask the Scottish Government, in light of the potential impact on communities in Scotland, what discussions it has had with the UK Government about Home Office immigration compliance and enforcement teams that operate in Scotland. (S4W-20349)

Reply from Humza Yousaf: The Scottish Government has not had specific discussions with the Home Office about the immigration and compliance teams that operate in Scotland. However, Scottish Ministers and Scottish Government officials regularly communicate with the Home Office, and raise issues of concern to communities in Scotland through these communications, including discussions on the issue of immigration.

### **Immigration**

**John Finnie:** To ask the Scottish Government whether it provides facilities to Home Office immigration compliance and enforcement teams that operate in Scotland and, if so, where these are located. (S4W-20354)

**Reply from Humza Yousaf:** The Scottish Government does not provide facilities to Home Office immigration compliance and enforcement teams. Home Office immigration enforcement can request from Police Scotland, with 72 hours' notice, use of custody facilities where these may be required for an operation.

The location of these custody facilities is dependent upon where the operation is to take place. Home Office Immigration Enforcement utilise custody suites as directed by Police Scotland.

### **Immigration**

**John Finnie:** To ask the Scottish Government whether Home Office immigration compliance and enforcement teams that operate in Scotland can access the (a) staffing and (b) other resources of Police Scotland. (S4W-20357)

Reply from Humza Yousaf: There is joint working between Home Office immigration enforcement and the Border Policing Command within Police Scotland's Specialist Crime Division, the focus of which has been to protect vulnerable people and identify those foreign national offenders who are causing harm to communities. At present Police Scotland have one officer seconded to Home Office immigration enforcement. There is one Home Office immigration enforcement officer embedded within Specialist Crime Division and two officers embedded within key custody suites to ensure the appropriate checks on detainees are being carried out.

### **Community Relations**

**Robert Neill:** To ask the Secretary of State for Communities and Local Government pursuant to the answer of 3 March 2014, *Official Report*, column 694W, on polling stations, what assessment he has made of the effect of foreign language translation by local authorities on integration of non-English speakers into their communities. [190554]

**Reply from Brandon Lewis:** In March 2013, my Department published new guidance for local authorities outlining how councils should stop translating into foreign languages. As outlined in the written ministerial statement of 12 March 2013, *Official Report*, column 5WS, such translation weakens integration;

discourages communities from learning English; undermines rather than strengthens equality goals; harms community relations; and is an expensive waste of taxpayers' money at a time when councils need to be making sensible savings. It is disappointing that councils like Tower Hamlets have disregarded that guidance, and reflects broader issues with the dysfunctional governance and divisive practices of the council.

I would add that in light of previous instances of electoral fraud, including impersonation in polling stations, postal voting irregularities and allegations of improper influence, Ministers in this Department have concerns about the practice of allowing foreign language translators/interpreters inside polling stations. The privacy of the ballot must be protected and voters inside a polling station should not be subject to any pressure or influence to vote in a particular way. In that context, the integrity of the ballot box and of the local democratic process requires independent and transparent scrutiny in polling stations by polling agents, council staff, the police and, indeed, passing members of the public who are also voting. This is undermined by polling room administration being conducted in foreign languages.

### **Immigration**

**George Galloway:** To ask the Secretary of State for the Home Department what estimate she has made of the number of workers made unemployed, or displaced, as a result of immigration from countries outside the EU in the last year. [191003]

**Reply from James Brokenshire:** The Government commissioned the Migration Advisory Committee (MAC) to "research the labour market, social and public service impacts of non-EEA migration; and to advise on the use of such evidence in cost-benefit analyses of migration policy decisions".

The MAC's report published in 2012 called "Analysis of the Impact of Migration", available at:

https://www.gov.uk/government/uploads/system/uploads/attachment\_data/file/257 235/analysis-of-the-impacts.pdf suggested that "between 1995 and 2010 an additional 100 non-EU migrants were associated with a reduction in employment of 23 native workers".

This report is a comprehensive review of the evidence around the displacement effect of migrants on UK native employment and builds on the MAC 2012 report. In addition, a report on the "Employment and Occupational skill levels among UK and foreign nationals" available at:

https://www.gov.uk/government/uploads/system/uploads/attachment\_data/file/282 503/occ108.pdf finds that over most of the last decade, employment levels in the UK rose faster among foreign nationals than among UK nationals. However, this pattern has reversed, and over the last year around 90% of employment growth was accounted for by UK nationals.

**Mark Hendrick:** To ask the Secretary of State for the Home Department how many immigration reconsideration cases have been outsourced to Capita Business Services; what payment Capita Business Services receives to process these cases; which country these cases are processed in; and what targets she has set Capita Business Services for that work. [196177]

**Reply from James Brokenshire:** Capita has been contracted to deliver contact management and casework services for the Home Office. The initial target is for 50,000 casework outcomes to be delivered, which includes responding to requests for reconsideration.

Disclosure of payment information would result in commercially sensitive information being placed in the public domain and could jeopardise the effective use of public money by undermining further contractual negotiations.

Capita process all of work under this contract in the United Kingdom.

Capita are currently delivering a phased mobilisation of casework services in a model office environment, to build up capacity and refine processes. The contract requires Capita to deliver the first 50,000 casework outcomes within nine months of completing model office and moving into full delivery under the contract.

### **Student Visas**

**Jason McCartney:** What progress [the Secretary of State for the Home Department] has made on reducing abuse of the student visa system. [903695]

Reply from the Minister for Security and Immigration (James Brokenshire): The Government have overhauled the student visa route with a range of measures to combat abuse, while continuing to attract the brightest and best students to UK's world-class universities. Our reforms have resulted in 700 education providers being removed as sponsors to bring students into the UK. The total number of tier 4 student visas has fallen by a third since 2010, while visa applications from university students continue to increase.

**Jason McCartney:** I welcome the clampdown on abuses of the student visa system, but will the Minister assure the House that our world-class universities, including my local award-winning university, Huddersfield university, where overseas students come from more than 120 countries, will still be allowed to grow their courses with these students from around the globe? ...

**Reply from James Brokenshire:** ... there has been abuse of the student visa system and we are tackling this while placing no limit on the number of genuine international students, whom we welcome to our world-class universities.

**Nick Raynsford:** Although it is quite right that action should be taken against bogus colleges, does the Minister accept that both the tone and the nature of some of the Government's actions have created an impression, widely understood by very reputable higher education institutions, that it is now less easy for able students from many parts of the world, including the Indian sub-continent, to gain access to courses here for legitimate study?

Reply from James Brokenshire: I do not accept that. I note that the Higher Education Funding Council for England published a report on 10 April indicating that student entrants were up. We continue to work with colleagues across Government. It is notable that we have seen new entrants from key markets including China, Malaysia and Hong Kong. We very much welcome international students to study at our fantastic universities.

[903703] **Nicholas Soames:** Does my hon. Friend accept that although of course we warmly welcome students from all over the world to our excellent universities, they must leave when they are meant to do so? May I suggest that he encourages the universities themselves to play a greater part in seeing to it that that happens?

**Reply from James Brokenshire:** I agree with my right hon. Friend. There has been abuse of the system, with people coming to this country not to study, but to work. We have worked closely with the universities sector, and there has been a

successful pilot with one university to encourage universities to see that students do leave at the end of their studies. We will continue to roll that out, as well as working with immigration enforcement to see that those who are not entitled to be here do leave.

Pete Wishart: Has the Minister seen the comments from Anton Muscatelli, the principal of Glasgow university, who says that this Government are in effect saying to international students, "Don't come here, we're closed for business, closed for education"? I know that the Home Office—I hear the Home Secretary saying this—always thinks it knows better than the Scottish academic and university community, but will the Minister at least acknowledge that we have a bit of an issue with this?

**Reply from James Brokenshire:** There is no limit on the number of students who can legitimately come to this country to study. When the hon. Gentleman looks at the statistics and the information, he will see that the number of visa applications coming to universities has gone up by 7%. We continue to underline that this country welcomes students to our world-class universities in Scotland and in the rest of the United Kingdom.

### **Entry Clearances**

**David Hanson:** To ask the Secretary of State for the Home Department what assessment she has made of the number of people who have overstayed their approved visa to be in the UK by (a) up to six months, (b) six months to one year, (c) more than one year and (d) more than three years as at 31 March 2014. [194952]

**Reply from James Brokenshire:** It is not possible to accurately quantify the number of immigration offenders in the UK as, by their very nature, those that deliberately evade immigration control to enter and stay in the country illegally are not officially recorded until they come to light and are arrested.

The Immigration Bill will provide new powers to implement exit checks, which the last Labour Government scrapped in 1998. This will allow the Home Office to screen those who leave the UK to identify threats and persons of interest to Border Force, immigration enforcement and other law enforcement bodies, and to enable an appropriate response.

The Home Office continues to prevent abuse, pursue offenders and increase compliance with immigration law—our immigration compliance and enforcement teams across the UK target illegal migrants who have no right to live and work in the community.

The Immigration Bill will stop migrants using public services to which they are not entitled, reduce the factors which encourage people to come to the UK and make it easier to remove people who should not be here.

**Chris Ruane:** To ask the Secretary of State for the Home Department what the average time is between the expiry of a visa and *(a)* the person voluntarily leaving the country and *(b)* the forcible removal of the visa holder. [196067]

Reply from James Brokenshire: The information requested is not available.

**Margaret Beckett:** To ask the Secretary of State for the Home Department how many family visit visa applications to the UK were made between June 2013 and December 2013; and how many such applications were (a) granted, (b) refused, (c) withdrawn, (d) lapsed and (e) given the right to appeal. [196070]

**Reply from James Brokenshire:** From the 1 of June until the 31 of December 2013 there were 149,995 applications for family visit visas. Of those applications:

111,990 were issued

37,370 were refused

65 were lapsed

330 were withdrawn

4,570 were given the right to appeal

These figures are based upon management information, and have been rounded to the nearest five. Until the 24 June 2013, any family visit visa that was refused was given a right of appeal against that decision. The numbers above reflect this change to appeal rights.

**Ian Lucas:** To ask the Secretary of State for the Home Department what criteria are used to decide in which countries to have UK consular and visa offices. [196075]

Reply from James Brokenshire: Decisions regarding the location of our visa application centres, and the places in which the applications are decided, are based on a number of different factors, including geography, security issues, distribution of demand, political and economic impacts, as well as the financial cost. The Home Office uses commercial partners to help run its network of visa application centres, which are the customer-facing end of the service. Under new contracts which came into effect on 1 April 2014, we will have 340 visa application points in 142 countries around the world. Applications submitted at visa application centres are then sent to one of our 32 decision-making hubs for consideration.

On the consular side, the Foreign and Commonwealth Office (FCO) supports British nationals through the diplomatic network of 220 posts around the world, in 170 countries. They also have a network of 230 honorary consuls who provide support in places where the UK is not otherwise represented. Having consular partners present in countries where the UK is not represented ensures British nationals have immediate access to assistance. There are only three countries in the world where there is no in country consular representation by the UK or any of our main consular partners (EU, Australia, Canada, US or New Zealand).

These are Palau, Sao Tome & Principe and Tuvalu. In these cases, UK Travel Advice instructs British nationals to seek assistance when needed through the nearest country with British diplomatic representation: Philippines, Angola and Fiji respectively. The FCO currently advise against all travel to Syria and warn British nationals who travel there that the FCO will not be able to provide them with any assistance. The FCO also advise against all but essential travel to Iran and advise British nationals to seek assistance from any EU member state present in the country.

### **Entry Clearances**

**Adam Afriyie:** To ask the Secretary of State for the Home Department what assessment she has made of the contribution of the *(a)* Tier 1 (Entrepreneur) visa route and *(b)* Tier 1 (Investor) visa route on economic growth. [193286]

**Reply from James Brokenshire:** The Migration Advisory Committee (MAC) advises the Government on economic issues relating to migration.

On 1 July 2013 the MAC published a "Report on the economic and labour market impacts of tier 1 entrepreneur and investor migrants to the UK" which it had commissioned from the Migration Observatory. The report made a number of findings, although it concluded that it was too early to make a full assessment of the economic contribution of the two routes without further research. More recently, on 25 February 2014 the MAC published its own report, "Tier 1 (Investor) route: investment thresholds and economic benefits" in response to a Government commission. The MAC concluded that the direct investment required by the route is of little or no benefit, but there is some benefit from indirect spending by investors and their families in the UK (although this is difficult to quantify). ### **Illegal Immigrants: Employment**

**David Hanson:** To ask the Secretary of State for the Home Department how many individual prosecutions for employing an illegal worker under the Immigration, Asylum and Nationality Act 2006 have been (a) brought and (b) successful in each year since 2010. [192793]

**Reply from James Brokenshire:** Employers have a responsibility to check that their employees have the right to work in the United Kingdom and this duty is underpinned by criminal and civil sanctions.

The Home Office only holds data on individual prosecutions on its national operations database from 2012.

- (a) Five employers were charged in 2012 and five employers were charged in 2013 for an offence of knowingly employing illegal workers under section 21 of the Immigration, Asylum and Nationality Act 2006.
- 1. The figures quoted have been derived from management information and are therefore provisional and subject to change. This information has not been quality assured under National Statistics protocols.
- 2. Figures relate to employers charged (offence recorded as IAN 2006 S21) between 1 January 2012 and 31 December 2013 recorded on the national operations database (NODMMX).
- 3. Figures relate to individuals who may have been charged for more than one offence under section 21.
- 4. Figures rounded to nearest five. In compliance with legislation such as the Data Protection Act 1998 and principle 5 of the Code of Practice for Official Statistics, we are required to preserve the confidentiality of the data we collect, process and disseminate. In order to prevent the disclosure of personal information counts of individuals are rounded to the nearest multiple of five.

- (b) Under section 21 of the Immigration, Asylum and Nationality Act 2006, fewer than five employers were successfully prosecuted in 2012 and five employers were successfully prosecuted in 2013.

**David Hanson:** To ask the Secretary of State for the Home Department how many maximum fines have been levied under the Immigration (Employment of Adults, Subject to Immigration Control) (Maximum Penalty) Order 2008 in each year since it was enacted. [193753]

**Reply from James Brokenshire:** The maximum penalty of £10,000 has been levied with regards to 22 employers. The breakdown of employers levied with the maximum penalty for each financial year is shown in the table.

Please note the figures are for penalties levied against employers at the initial decision stage and may relate to more than one worker. A penalty may be reduced for a number of reasons, including if it was a first visit to the business; if the employer co-operated with the visit; or if the employer can provide evidence that a partial check has been undertaken. We propose to tighten and clarify the use of mitigating factors in the calculation of civil penalties with an increased focus on employer co-operation with the Home office.

Reply from James Brokenshire: Enforcement operations against illegal working

have increased significantly, with a 47% increase in 2013 compared to 2012. The administration of the penalty scheme and administrative debt recovery processes have been reviewed, including with Cabinet Office input and are being streamlined and further improved.

The information on the number of civil penalties levied is provided in the following table. Data has been provided from £2,500 upwards as this is the minimum penalty value that is levied in line with the published penalty calculation framework. The table includes values of £10,000 upwards to account for multiple workers per penalty. Please note the figures are for penalties levied at the initial decision stage which may be reduced, cancelled, increased or reissued at the objection or appeal stage.

### **Illegal Immigrants: Employment**

**David Hanson:** To ask the Secretary of State for the Home Department what total amount of fines has been (a) levied and (b) collected under the Immigration, Asylum and Nationality Act 2006 for employment of illegal workers in each year since 2010. [192805]

**Reply from James Brokenshire:** The civil penalty scheme to prevent illegal working was introduced in the Immigration Asylum and Nationality Act 2006 (2006 Act), and came into effect in February 2008.

Before 2010, the average value of penalties collected under the scheme was 14%. Since 2010, the average value of penalties collected has been 45%. The information requested is in the following table. The figures are based on the number of civil penalties served at visited business addresses.

Please note the figures are for penalties levied at the initial decision stage which may be reduced, cancelled, increased or reissued at the objection or appeal stage.

Please also note that the collection figures are not cohort based statistics and therefore do not represent payment against penalties issued in a particular year.

**Andrew Turner:** To ask the Secretary of State for the Home Department (1) how many rejections of asylum seekers, by country of origin, there have been in each of the last five years; [196228]

(2) how many asylum seekers there were, by country of origin, in each of the last five years; [196226]

(3) how many asylum seekers, by country of origin, have been waiting for a decision on their application for asylum for (a) one and (b) more than five years. [196227]

**Reply from James Brokenshire:** Figures for asylum applications for main applicants, by nationality, from 2009 to 2013 are published in Table as\_01 (Asylum data tables Volume 1) in the release Immigration Statistics.

The number of asylum applications from main applicants pending an initial decision, by nationality, for (a) more than one year and (b) more than five years, as at the end of 2013, can be found in the table, "Asylum application from main applicants pending an initial decision as at 31 December 2013" which I will place in the House Library.

These figures are a subset of those also published in Table as\_01 (Asylum data tables Volume 1) of the release Immigration Statistics.

Figures for asylum applications from main applicants refused a grant of asylum, humanitarian protection, discretionary leave or other grants of leave, at initial decision, by nationality, from 2009 to 2013 are published in Table as\_01 (Asylum data tables Volume 1) of the release Immigration Statistics.

**Frank Field:** To ask the Secretary of State for the Home Department what her Department's total budget for assisted voluntary returns projects is for the current financial year, and what has been the total budget for such projects in each of the last five years. [196222]

**Reply from James Brokenshire:** The information requested is shown below.

The figures quoted relate to the UK Assisted Voluntary Return Programme, and the Assisted Voluntary Return and Reintegration Programmes operated in Greece and Turkey.

The figures for years 2009-10 to 2013-14 relate to actual spend and the figures for 2014-15 are projected spend.

The Home Office also receives funding from the European Union for the UK Assisted Voluntary Return programme. ### **Deportation: Children**

**Sarah Teather:** To ask the Secretary of State for the Home Department how many unaccompanied migrant children have been forcibly removed to another country in each of the last five years. [193591]

Reply from James Brokenshire: No unaccompanied child under the age of 18 can be forcibly removed from the UK unless adequate care and reception arrangements are in place in their country of origin. The difficulty of setting up suitable reception arrangements has meant that, with the exception of transfers to other European Union countries under the Dublin Regulations<sup>1</sup>, the Home Office does not routinely enforce the return of unaccompanied children to any country. The majority of unaccompanied children whose asylum claims are rejected are granted temporary leave which is reviewed when they reach 17 and a half years of age. We believe that the vast majority of enforced returns of unaccompanied children undertaken between 2006 and 2010 were transfers under the Dublin Regulations.

<sup>1</sup> The Dublin Regulation EC No. 343/2003 is a binding measure of European Community law to determine which State should be responsible for examining an application for asylum made within the EU territory.

### **Advocacy: Children**

**Alex Cunningham:** To ask the Secretary of State for the Home Department (1) when she plans to publish the terms of reference for the trial advocate scheme; [196473]

- (2) if her Department will consider extending the trial advocate scheme to unaccompanied children; [196474]
- (3) whether the pilot scheme for advocates will be independent of local authorities; [196475]
- (4) what powers advocates will have during the pilot advocate scheme; [196476]
- (5) when the pilot advocate scheme will begin. [196477]

**Reply from Karen Bradley:** In January 2014 the Home Office announced proposals to trial specialist, independent advocates for trafficked children which is due to begin this summer. This trial forms part of the Government's work to eradicate modern day slavery and as such there are no plans for this trial to be extended to unaccompanied children.

The child trafficking advocate will be fully independent from the local authority, but will need to work with the existing structures around the child trafficking victim, such as children's services, education, criminal justice system and immigration system. The advocate role is intended to deliver the best outcomes for children. The advocate's role will include the following activities but this is not an

exhaustive list and we expect the advocate to respond to the specific needs of the child:

being a consistent point of contact for the child trafficking victim;

assisting the local authority to assess the needs of the child trafficking victim as a victim of trafficking, thereby promoting the safety and wellbeing of the child trafficking victim (in particular in light of the risk of re-trafficking);

making recommendations for referrals to other services (e.g. mental health services) to ensure the child trafficking victim receives educational, medical, practical and legal support they need and deserve;

accompanying the child trafficking victim to certain meetings—e.g. with an immigration lawyer;

supporting the child trafficking victim in any age assessment process;

supporting the child trafficking victim in overcoming language and cultural barriers; supporting witnesses through the criminal justice system;

supporting looked after children and children in need through the care system, in particular in safety planning, age assessment and future planning;

assisting the local authority to plan for the child trafficking victim's future and receive any compensation that they may be entitled to;

helping prevent the child trafficking victim from facing further exploitation or harm from traffickers (and the risks of going missing);

providing advice on immigration, criminal justice and welfare matters to the child trafficking victim and arranging effective legal representation;

involvement in the key decisions relating to the child trafficking victim (but final decisions would remain the responsibility of the local authority or Home Office, where relevant).

The Home Office is commissioning an independent evaluation of the trial which will report six months after the trial commences. The evaluation will include the terms of reference for the trial.

### **Human Trafficking (Labour Exploitation)**

**David Heath:** What steps [the Secretary of State for the Home Department] has taken to prevent human trafficking for purposes of labour exploitation. [903687]

Reply from the Parliamentary Under-Secretary of State for the Home Department (Karen Bradley): My right hon. Friend the Home Secretary has set out in detail much of the work that the Government are doing to tackle human trafficking and slavery. To better tackle labour exploitation, we have moved the Gangmasters Licensing Authority to the Home Office to strengthen its links with law enforcement agencies.

**David Heath:** ... I know ... how effective the Gangmasters Licensing Authority is. It is particularly effective because it focuses its attention on the areas with the highest risk of criminality and exploitation, rather than on lower-risk areas. ...

...will she also consider the status of the GLA's board members, now that it is in her remit? Will she, first, upgrade the status of the sole representative for human trafficking on the board from delegate status to full status ...?

**Reply from Karen Bradley:** That is also an interesting suggestion that I will look into, although I cannot promise where we will get to.

Charlie Elphicke: When I visited the migrant camps at Calais with the deputy mayor of Calais, every person there said that they had paid traffickers to get there, putting them in danger of labour exploitation in the UK. Will Home Office Ministers consider supporting a joint initiative by Dover and Calais for the French police to clear those camps and

repatriate people or process their asylum claims, as the case may be?

**Reply from Karen Bradley:** ... We work closely with our counterparts in the French police to deal with this issue, and my hon. Friend makes an important point. Many victims of modern slavery that I have met came into the country willingly but illegally, because they felt they were coming for a better life. They have been exploited; that is not right and we need to stamp that out.

**Reply from Karen Bradley:** The requested information on the gender of potential victims and the regions in which they were found in January 2014 was provided in the answer of 7 April 2014, *Official Report*, columns 114-15W, on human trafficking: victim support schemes. However, this data was provided in a number of separate tables. The information was not withheld and is provided below in an alternative format, giving the same data broken down by individual case, in one table.

The victim care contract does not require support providers to maintain any form of formal contact after the recovery and reflection period. However, some survivors do maintain informal contact with their support provider. All support providers will work with victims throughout their support period to help them move on from the service. We are looking at what more we can do to help victims reintegrate effectively.

#### **Human Trafficking**

Angie Bray: To ask the Secretary of State for the Home Department what the nationality and gender was of each suspected victim of trafficking referred to the Trafficking Victim Support Scheme operated by the Salvation Army in February 2014; in which (a) region and (b) county each of the suspected victims was found; which agency referred each person to the scheme; in which town the shelter in which they were placed was for the relevant period; and what contact has been made with each victim to ensure they are not re-trafficked. [196685]

Reply from Karen Bradley: In February 2014, there were 126 referrals to the Government-funded support service for adult victims of human trafficking in England and Wales administered by the Salvation Army. In the interests of victim safety, only the region in which the victim was encountered is provided, and not which town they were placed in. Once an individual receives a Conclusive Grounds decision, they will be given tailored support to safely return home or

integrate in the UK. Once they exit the service, no formal mechanisms exist to maintain contact.

### **Human Trafficking: Children**

**Angie Bray:** To ask the Secretary of State for the Home Department what criteria were used to select organisations or local authorities to pilot the advocacy scheme for trafficked children; how that scheme was commissioned; when such schemes will start in which location and for what duration; and if she will make a statement. [196686]

**Reply from Karen Bradley:** The Modern Slavery Bill will enable us to strengthen our response to human trafficking and modern slavery for both adults and children. We announced in January our intention to trial specialist independent advocates for victims of child trafficking.

23 local authorities have agreed to participate in the trial: Greater Manchester including Manchester City, Stockport, Tameside, Oldham, Rochdale, Bury, Bolton, Wigan, Salford, Trafford; West Midlands including, Birmingham, Coventry, Dudley, Sandwell, Solihull, Walsall, Wolverhampton; Croydon; Derbyshire; Kent; Lancashire; Oxfordshire; and West Sussex.

These local authorities represent a wide demographic range as well as major transport hubs and asylum screening units. These areas also have the highest rates of trafficking referrals to the National Referral Mechanism or are areas where we are aware of a high number of trafficking investigations by law enforcement agencies.

We remain committed to trialling this approach. We are currently considering bids from a number of voluntary and community services organisations that were identified as potential providers of the advocacy service because of the particular expertise they hold. We will announce the outcome of the process in due course.

Reply from the Minister for Crime Prevention (Norman Baker): The coalition welcomed the joint royal colleges' report published last November. The Government is committed to eradicating female genital mutilation and is taking

action in each of the areas recommended in the report. As part of our strategy, eight Departments have signed a cross-government declaration reaffirming our commitment to protecting current and future generations of girls from this abuse, and each Department is doing what it can to eradicate the practice in the UK.

**Gavin Shuker:** Given that the Minister accepts that both strong political leadership and joint working are essential to tackle the problem, will he give me an assurance that he has met the Secretary of State for Education to discuss the matter?

**Reply from Norman Baker:** I have certainly been in correspondence with the Education Secretary, and I have met on more than one occasion the relevant Education Minister. The hon. Gentleman will know that the Education Secretary has now written to schools, which is a very helpful development.

**Lyn Brown:** I am a little concerned to hear that answer, given that the Minister talked about good co-operation across all Departments. Given that the survey quoted by the National Society for the Prevention of Cruelty to Children reports that one in six teachers are unaware that FGM is a crime and that 68% are unaware of any guidance from the Government on what to do if they suspect a pupil is at risk, can the Minister assure the House that he will meet the Secretary of State for Education, discuss this very important issue and report back to the House on what agreements they make on how to tackle this despicable crime?

Reply from Norman Baker: I agree with the hon. Lady that it is a despicable crime. That is why we take it so seriously not just in the Home Office but across Government. I refer her to the cross-government agreement I mentioned in my original answer, which has been signed by eight Departments, including by the Under-Secretary of State for Education, the hon. Member for Crewe and Nantwich (Mr Timpson), on behalf of the Department for Education. We are in regular contact on these matters across Departments and will continue to be so.

**Margot James:** I welcome my hon. Friend's commitment to interdepartmental working and a multi-agency approach, but does he not agree that until more perpetrators are brought before our courts and convicted, the elders and parents in the communities in which these atrocities take place will not take the law seriously?

Reply from Norman Baker: It is a matter of some regret, in my view, that there have been no successful prosecutions since the practice was outlawed in 1985. I am delighted that there are now two cases pending, although obviously I cannot comment on matters before the courts. What I can say is that in my view there is certainly a willingness on the part of police forces, the Director of Public Prosecutions and others to ensure that where the crime is perpetrated, those responsible are brought to justice. The DPP wrote to me and the Minister for Policing, Criminal Justice and Victims earlier this year with a suggestion for a particular change that might be enacted to try to make prosecutions more likely and more successful. We are looking at that suggestion now.
