UK Parliament Questions

Asylum: Albania

Lord Storey: To ask Her Majesty's Government what information and personal data are provided to the Albanian authorities on unaccompanied asylum-seeking children from Albania making asylum claims in the United Kingdom; and whether such children are informed or asked to consent to the transfer of such information and personal data before they are transferred.[HL1515]

To ask Her Majesty's Government, in respect of how many Albanian asylum seekers claiming to be children, information was sought from the Albanian authorities leading to the identification of 23 individuals who were suspected of providing incorrect information about their age and the establishment of Operation Coldspell in December 2013.[HL1516]

Immigration and Asylum UK Parliament Questions (continued)

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Tavlor of Holbeach): The Government has a legal duty to endeavour to trace the families of unaccompanied asylum seeking children and to take into account their best interests. In response to safeguarding concerns arising from reports that Albanian adults were falsely claiming to be children, and in order to facilitate the family tracing process, the Home Office piloted a process in late 2013 whereby information relevant to family tracing and confirming identity was obtained from the Albanian authorities in respect of 215 individuals. In all of these cases, the asylum claims had been refused and the Albanian authorities had not been the alleged actor of persecution. The piloted process became business as usual with effect from 29 January 2014. Checks are only conducted under this process if such a step will not jeopardise the safety of the child and their family. The Albanian authorities are provided with the names, dates of birth, identity numbers, places of birth, addresses and contact numbers for the child and their parents. Published Home Office guidance stipulates that the child should be informed shortly after point of claim for asylum that the Home Office will take appropriate steps to endeavour to trace their families.

Reply from Baroness Northover: The Home Office does not collect the information that has been requested. However, domestic workers who are abused or exploited, regardless of their immigration status, can receive care and support in the UK.

Officials have had some contact with Argyll and Bute Council, in relation to the Minister for Housing and Welfare's visit to the Gypsy/Traveller site at Lochgilphead in May 2014.

Reply from Margaret Burgess: Local authorities are responsible for decisions regarding the provision of Gypsy/Traveller sites in their area, including any decision to close a Gypsy/Traveller site. The Scottish Government is not directly involved in assessing the impact of such a closure. However, a local authority has to consider the accommodation needs of Gypsy/Travellers as part of a Housing Need and Demand Assessment and when developing its local housing strategy and development plan. Each local housing strategy goes through a review process, with input from Scottish Government officials, and comments are provided as appropriate. These comments can cover Gypsy/Traveller site provision.

Reply from Lord Wallace of Saltaire: The Government is committed to access to Higher Education (HE) based on talent and potential, irrespective of background. Promoting equal opportunities is taken very seriously and we have put in place a strong legal framework which protects the rights of people not to be discriminated against, through the Equality Act 2010.

Whilst universities are independent and autonomous organisations, responsible for their own admissions decisions, the Equality Act places clear duties and responsibilities on them to ensure that students with protected characteristics do not face discrimination or less favourable treatment whilst applying to, and studying in, higher education.

Scottish Parliament Motion

S4M-10819 Ken Macintosh: Spike in Antisemitic Incidents in Scotland-That the Parliament condemns the recent reported spike in antisemitic incidents in Scotland, many of them under the pretext of political protest against the conflict in Gaza; understands that the Scottish Council of Jewish Communities (SCoJeC) has received as many reports of antisemitic incidents in a single week as during the whole of 2013; is appalled to learn that many members of the Jewish community have said that they do not feel safe wearing a kippah or Star of David or speaking Hebrew in the street and that a number have said that they no longer feel welcome in Scotland and are actively considering moving elsewhere; is shocked that the participant in SCoJeC's Being Jewish in Scotland project who two years ago said "Scotland is a darn good place to be a Jew" now says that she "feels alienated and no longer Scottish first then Jewish. Feel Jewish only." and that she "has to be very guarded when speaking to people"; welcomes police assurances that they are taking the situation very seriously; urges all victims of hate crime always to report all incidents to the police, and calls on the Scottish Government, local authorities, trades unions and all other public bodies to condemn all forms of antisemitism in whatever guise it may appear.

British Veterinary Association (Meetings)

Alex Johnstone: Has the cabinet secretary or his officials had specific talks regarding concerns about ritual slaughter? As a result, does he intend to bring forward any proposals to include labelling information on Scottish meat on whether stunning took place prior to slaughter?

Reply from the Cabinet Secretary for Rural Affairs and the Environment (Richard Lochhead): We have been looking at the issue in recent weeks and months. The religious slaughter of animals for food is a difficult, sensitive and complex issue. We must be very careful with regard to any debate about labelling and take on board the view of Scotland's faith communities.

It is widely accepted that animals should be stunned before slaughter to properly safeguard their welfare, but we must recognise the importance that Jewish and Muslim communities in particular attach to being supplied with meat from animals that are slaughtered in accordance with their religious beliefs.

I understand that the European Union is contemplating looking at the issue, and I will ensure that Scotland has a voice in those discussions.

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Taylor of Holbeach): Our longer term focus has not changed. Prevention remains at the heart of our work to tackle and eradicate Female Genital Mutilation in the UK. The new FGM unit is being set up to drive a step change in nationwide

Female Genital Mutilation

Baroness Tonge: To ask Her Majesty's Government what representations they have made to governments in countries where female genital mutilation (FGM) is practised; and what steps they have taken to verify reports that ISIS is introducing compulsory FGM in areas they control.[HL1581]

Reply from Lord Popat: The Government is playing a key role in supporting and strengthening the international movement to end female genital mutilation (FGM) worldwide, within a generation. Given that the vast majority of communities who practise FGM are found in 29 countries clustered in West Africa, Egypt, Sudan and the Horn of Africa and that change must come from within affected communities, we have sought to support the existing African-led movement to end FGM, and build upon the success of the Africa Group 2012 UN resolution that banned the practice.

It is in this spirit that the Prime Minister, my right honourable friend the Member for Witney (Mr Cameron), convened the first global summit on ending FGM and child, early and forced marriage (CEFM) on 22 July 2014. The Girl Summit brought together 650 participants from 50 affected countries. It resulted in 32 countries signing the Summit Charter and private and public financial pledges of \$88 million to end CEFM and \$7million for FGM. Ministers and senior officials worked with all countries affected by FGM, including countries where it is practised by diaspora communities, in advance of the Summit to encourage them to develop new commitments to end FGM. This is in addition to the UK's flagship programme of £35 million over 5 years to support African countries to end FGM, and an additional £12 million commitment in Sudan.

Reports that the Islamic State in Iraq and the Levant (ISIS) is introducing compulsory FGM in areas they control remain unconfirmed. Staff at our Embassy in Iraq have spoken to the Head of UN Human Rights Office, the Head of UN Women, and the UN Assistance Mission for Iraq, all of whom were unable to confirm the reports. We also remain in contact with the United Nations International Children's Emergency Fund (UNICEF). On balance, we conclude that the threat, while a serious matter, is not new. We continue to follow developments as closely as possible.
