Scottish Parliament Motion

S4M-11447 Kevin Stewart: Home Secretary Withholding Information—That the Parliament believes that it is unacceptable for the Home Secretary to take the stance that the UK Border Force only engages with UK MPs on the basis that immigration is a reserved matter; considers that the Scottish Parliament is an equally important elected body as the UK Parliament and that the withholding of information is undemocratic; believes that this is obstructing MSPs, the elected representatives of the people of Scotland, from being able to represent their constituents effectively, and calls on the Home Office to make the necessary information available for all elected members to act for their electorate, regardless of where power currently lies.

Immigration and Asylum (continued) UK Parliament Questions

Mediterranean: Refugees and Migrants

Lord Roberts of Llandudno: To ask Her Majesty's Government what plans they have to restore migrant search and rescue facilities in the Mediterranean.

Reply from the Parliamentary Under-Secretary of State, Home Office (Lord Bates): My Lords, the UK has had no involvement in Mare Nostrum, the Italian search and rescue operation in the Mediterranean. Given that search and rescue is a competence of individual member states, the Government have no plans to call for the restoration or replacement of Mare Nostrum. Instead, we will continue to work with the EU and with countries of origin and transit to address the causes of illegal migration and combat people smugglers and traffickers.

Lord Roberts of Llandudno: Does the Minister agree with Amnesty International, which says that stopping search and rescue in the Mediterranean is causing the loss of thousands of lives? How many men, women and children need to drown before the Government change their policy?

Reply from Lord Bates: I reiterate that we are talking about the Italian Government. It is their decision, which they have taken. We all share a concern about the situation and the safety of people in the Mediterranean. We need to take a long, hard look at the organised crime gangs who are trafficking people, pushing them out to sea with very little protection, in unseaworthy vessels, and giving them the telephone number of the Italian coastguard. That is the regrettable and appalling thing about this whole situation. ...

Lord Anderson of Swansea: My Lords, it is surely immoral not to rescue those in peril of drowning if we have the capability to do so. Yet at the same time we need a coherent and ordered immigration policy, and cannot offer an open door to anyone who reaches our shores. Has an effort been made to tackle this matter at source by reaching deals with the riparian countries on the south of the Mediterranean, to pay them to destroy the ships and prosecute the traffickers? At least then we can try to deal with this matter at source.

Reply from Lord Bates: I agree with the noble Lord that it would indeed be immoral and, of course, not to help someone in distress would be in contravention of our obligations under the UN convention on safety of life at sea. ...

Lord Avebury: My Lords, does my noble friend note the comment made by the UN special rapporteur on migrant rights that it is appalling to bank on a rise in the number in people who drown acting as a deterrent? Does he think that the EU views a steep rise in the number of people killed with complacency, if not with satisfaction, because more people are drowning and acting as a deterrent?

Reply from Lord Bates: It is certainly not the case to say that the Government have been passive on this. My right honourable friend the Home Secretary had meetings with her Italian counterparts last month, and will meet them again this month. We have extended our offers of support and of course we have looked at the countries from which most of these migrants are coming, namely Syria and Ethiopia. We are putting large sums of money—£700 million in the first instance, £360 million in the second—to try and help people to give themselves a proper life at home. ...

Lord Elystan-Morgan: Can the Minister recollect that last Thursday he gave me a very forthright answer to a question as to what the attitude of the commander of a British naval vessel would be if he was aware that there was a refugee ship in peril within range of his ship? I was told indeed that he would most certainly lend all assistance in accordance with the law of the sea and the highest traditions of the Royal Navy. In the light of that most honest answer, what is the point of giving any impression on the part of the Government that we are gibbing in relation to search and rescue?

Reply from Lord Bates: The noble Lord is absolutely right that we need to be

clear. There is a grave information message we need to get out here that of course there is no change in our humanitarian obligation. The only thing which is changing is that we are putting more money and resource behind it, but those obligations from a humanitarian point of view remain, in the proud tradition of this country and of seafarers.

Baroness Hussein-Ece: My Lords, my noble friend the Minister mentioned the increase in refugees from, for example, countries such as Syria. In statements that I have seen, Ministers have said that we encourage those people to stay in their own country. The surrounding countries have taken millions and millions of refugees. Turkey took 250,000 Syrian refugees in one week, more than the EU has done in four years. Is it not time that we stepped up to the plate and set an example, and not let people drown in this way?

Reply from Lord Bates: That is so, and we have introduced the Syrian vulnerable persons relocation scheme, which is taking some of those—not enough—but of course the EU can do more. We are donating additional funds into that area but there needs to be more done to tackle the instability which is the cause of migration in the first place.

Entry Clearances: West Africa

Joan Ruddock [211471] To ask the Secretary of State for the Home Department, what visa arrangements are being made for citizens of Liberia, Sierra Leone and Guinea whose visas are expiring or expired and whose return flights have been cancelled by the relevant airlines.

Reply from James Brokenshire: The World Health Organisation (WHO) recommends that there should not be a general ban on international travel or trade to the countries affected by ebola. This is consistent with the position of the Foreign and Commonwealth Office, whose advice for British nationals is that travel for essential reasons should continue. Nationals from Guinea, Liberia and Sierra Leone whose flights have been cancelled but whose visas are expiring or expired are therefore expected to re-arrange their flights and leave the UK at the earliest opportunity.

However, the Government is monitoring the situation closely.

Migration

Lord Kilclooney [HL2524] To ask Her Majesty's Government what are the most recent annual figures for (1) emigrants departing the United Kingdom, and (2) immigrants arriving in the United Kingdom; and how many of those immigrants were non-EU citizens.

Reply from Lord Wallace of Saltaire: The information requested falls within the responsibility of the UK Statistics Authority. I have asked the Authority to reply. Nick Vaughan, Director, National Accounts & Economic Statistics, Office for National Statistics ... Estimates of Long-Term International Migration (LTIM) are produced by the ONS primarily based on data from the International Passenger Survey (IPS), with adjustments made for asylum seekers, people whose intentions change with regard to their length of stay, and migration to and from Northern Ireland. LTIM estimates are based on the United Nations definition of a long-term international migrant, that is, someone who changes their country of usual residence for a period of at least one year.

The most recent provisional estimates of annual LTIM are for the year ending

March 2014. These show that 316,000 emigrants left the UK, with a margin of error of +/- 20,000, and 560,000 immigrants arrived in the UK, with a margin of error of +/- 31,000. Provisional estimates for the number of non-EU citizens who arrived in the UK for the same period was 265,000, with a margin of error of +/- 19,000.

The most recent final estimates for immigration and emigration (LTIM) are for 2012. These show that 321,000 emigrants left the UK, with a margin of error of +/-20,000, and 498,000 immigrants arrived in the UK, with a margin of error of +/-27,000. The number of non-EU citizens who arrived in 2012 was estimated to be 260,000, with a margin of error of +/-17,000.

The margin of error refers to the 95 per cent confidence interval around the estimate, and is a standard measure of the uncertainty associated with making inferences from a sample survey.

Please note that final LTIM estimates for 2013 and provisional estimates for the year ending June 2014 will be published on 27 November 2014.

Immigration Controls

Frank Field [211431] To ask the Secretary of State for the Home Department, what change there was in the number of passengers refused entry at port and subsequently deported from 2009 to 2010; and what assessment she has made of the reasons for that change.

Reply from James Brokenshire: A total of 18,276 people were refused entry at port and subsequently departed in 2010 compared with 29,162 in 2009.

The number of people refused entry at port and subsequently departed has decreased since the beginning of the data series in 2004. The overall falls are likely to be due to a combination of factors, including: tighter screening of passengers prior to travel including upstream interventions by RALON; performance of carriers on their checks made in support of the Carrier's liability requirements; effectiveness of visa regimes including the imposition of new visa regimes; for example, South African nationals have been required to have a visa for any length or type of visit to the UK since July 2009.

In the past couple of years, the figures have shown small levels of fluctuations. The number of passengers refused entry at port and who subsequently departed has increased by 3% in the year ending June 2014, to 14,671 from 14,247 for the previous 12 months.

Overseas Students

Adam Afriyie [211742] To ask the Secretary of State for the Home Department, what his policy is on excluding foreign university students from net immigration targets.

Reply from James Brokenshire: Net migration statistics are produced by the independent Office for National Statistics (ONS). In line with the internationally agreed UN definition, these statistics define a migrant as someone changing their normal place of residence for more than a year. This includes students in net migration in the same way as other migrants. Other countries, including the United States, Canada, Australia and New Zealand also include students in their net migration figures.

Net migration measures the difference between the number of peoplecoming the UK and the number leaving, so if students return home after their studies, their

impact on long-term net migration will be minimal. The ONS has recently improved its methodology so that it is possible to better identify students in the emigration flows to give a more accurate measure of the contribution of students to overall net migration. In the last year, 124,000 non-EU students came to Britain to stay for more than 12 months, and the ONS estimates that only 50,000 left the country.

All migrants who are in the UK for 12 months or more have an impact on our communities, infrastructure and public services. Changing the way we measure migration would not make any difference to our student migration policy. There is no cap on the number of students who can come to the UK, and the county remains open to the brightest and the best.

Mike Gapes [212157] To ask the Secretary of State for the Home Department, what guidance she has issued to the Referred Casework Unit on how to process compassionate compelling cases; and if she will make a statement.

Reply from James Brokenshire: Guidance available to Entry Clearance Officers and the Referred Casework Unit on exceptional circumstances and compassionate factors when considering family migration applications is available in the 'Family Life (as a Partner or Parent): 5-Year Routes' guidance which is published on Gov.uk at: https://www.gov.uk/government/publications/chapter-8-appendix-fm-family-members

The referred Casework Unit also consider ad hoc applications in other visa categories when referred by an Entry Clearance Manager overseas where there are compelling and compassionate circumstances and where there may be consideration given to a grant of leave to enter outside the rules.

Entry Clearances

Lord Laird [HL2130] To ask Her Majesty's Government how many applications from outside the United Kingdom for entry clearance visas for work, using certificates of sponsorship from employers, were made in the last four years; how many applications were made for extensions of stay for work using certificates of sponsorship from employers from within the United Kingdom in the same four years; and what were the top 20 employers overall making applications.

Reply from Lord Bates: The published figures related to numbers of certificates of sponsorship (CoS) used in applications, and are shown in table 1 below.

The latest Home Office immigration statistics, including those for CoS used in applications for entry clearance visas and for extensions of stay, are published in the release Immigration Statistics April – June 2014, tables cs_03 and cs_04 (Sponsorship), which is available from the Library of the House and on the Department's website at: https://www.gov.uk/government/collections/immigration-statistics-quarterly-release Sponsors do not make applications for visas or for extensions of stay. Entry Clearances

Mike Gapes [212156] To ask the Secretary of State for the Home Department, what the average time taken for her Department's Referred Casework Unit to review decisions of the Entry Clearance Manager in the last year; and if she will make a statement.

Reply from James Brokenshire: It is not a function of the Referred Casework Unit to review the decisions of Entry Clearance Managers. Where an Entry Clearance Manager refers an application to the Referred Casework Unit for decision, the Referred Casework Unit aims to provide a full response within an internal 15 working day service level agreement, unless further enquiries are needed. The requested data on performance against this service level agreement is not available through published statistics. However, locally held management information confirms that from the 1st April 2014 to 30th September 2014 over 99% of referrals were responded to within 15 working days.

Marriage of Convenience

Emily Thornberry [212437] To ask the Attorney General, how many prosecutions the Crown Prosecution Service has brought on breaches of immigration law arising from sham marriages in each of the last five financial years.

Reply from Robert Buckland: Offences of breaching immigration law may be prosecuted by way of Section 25 of the Immigration Act 1971 (assisting unlawful immigration to a European Union Member State) or by way of Section 1 of the Criminal Law Act (conspiracy).

The offence created by Section 25 of the Immigration Act 1971 encompasses both the offence of assisting illegal entry (whether by smuggling someone in a vehicle or by providing false documents for presentation at a port) or by assisting someone to remain by deception (for example, by entering into a sham marriage) which facilitate a breach of the immigration laws. Conspiracies to facilitate breaches of immigration law are charged by way of Section 1 of the Criminal Law Act 1977.

The records held by the Crown Prosecution Service (CPS) indicate the number of offences charged, in which a prosecution commenced at magistrates' courts for assisting unlawful immigration or conspiracy. However it is not possible to disaggregate which of these offences relate to sham marriages rather than other immigration law breaches without reviewing individual case files which would incur a disproportionate cost.

Reply from Lord Bates: The annual number of asylum appeals lodged and the percentage of asylum appeals determined that were successful for 2005 and 2008 are shown in the table attached.

Reply from James Brokenshire: Of the people granted Humanitarian Protection under the Vulnerable Persons Relocation Scheme up to the end of June 2014, 11 are Principal Applicants and 39 are dependant family members. Of these people 14 have been assessed as having serious medical needs.

Illegal Immigrants

Charlie Elphicke 211615] To ask the Secretary of State for the Home Department, what steps her Department is taking to deport illegal migrants to their home country.

Reply from James Brokenshire: We have recently legislated in the Immigration Act 2014 to make it harder for illegal migrants to remain in the country undetected and to encourage people to leave of their own accord. The provisions include implementing a penalty for those landlords who rent property to immigrants without leave in the UK, denying free access to most secondary healthcare in the UK to illegal immigrants, requiring banks to check against a database of known immigration offenders before opening accounts, introducing new powers to check the immigration status of applicants before issuing a driving licence and revoking the driving licences of those migrants who have overstayed, and introducing new powers to clamp down on those trying to gain immigration advantage by entering into a sham marriage or civil partnership.

We have also used the Immigration Act to streamline the process of enforcing the removal of illegal migrants when necessary. We have reduced the number of appeal rights from 17 to 4, and set out clearly in primary legislation the right balance on Article 8 rights, to prevent individuals from playing the system. We have also streamlined the process of serving immigration decisions to reduce bureaucracy and further accelerate the system.

We also introduced on 1 January 2014 new regulations allowing us to prevent the re-entry to the UK for up to 12 months of EEA nationals who are removed for failing to exercise treaty rights, unless they have a valid reason to be here.

These measures support and enhance our immigration enforcement capability, with teams operating on a targeted, risk-based approach across the country to detect and remove illegal migrants. This effort has also been given fresh impetus with the break-up of the UK Border Agency and the creation of a focused Immigration Enforcement operational command.

Reply from Karen Bradley: Details of the methodology used to develop the annual National Crime Agency Strategic Assessment of the Nature and Scale of Human Trafficking in the UK are set out in the report for 2013, published on 30 September 2014. If a person receives a negative Reasonable Grounds or negative Conclusive Decision, this means that they have been found not to be a victim of human trafficking for the purpose of the Council of Europe Convention Against Trafficking in Human Beings.

A human trafficker may, as an alternative, be charged and prosecuted for a different offence, such as prostitution or money laundering, which could incur a confiscation order. But this would not be recorded as a trafficking offence.

Paul Blomfield [212651] To ask Mr Chancellor of the Exchequer, what training is provided to national minimum wage inspectors to identify cases of trafficking.

Reply from David Gauke: The Government takes the enforcement of the National Minimum Wage very seriously. HM Revenue and Customs (HMRC) review every complaint that is referred to them by the Pay and Work Rights Helpline.

Within that obligation, HMRC work to priorities agreed with the Department for Business, Innovation and Skills (BIS). To identify sectors where non-payment of National Minimum Wage is more likely HMRC and BIS analyse numbers of complaints and incidences of non-compliance and take account of information from, for example, other Government Departments, Trade Union representatives and the Low Pay Commission . Using this information, and often in conjunction with other Government Departments, HMRC have undertaken targeted enforcement on areas such as the care sector, car washes and the retail sector, amongst others.

However, HMRC, including National Minimum Wage officials, undertake joint working with the police, Home Office and local authorities across the country. HMRC's collaboration has assisted in identifying instances of slavery and servitude in some of these operations.

Reply from Karen Bradley: Tackling Modern slavery is a priority for the National Crime Agency, which is committed to improving the co-ordination and coherence of intelligence gathering processes, working with law enforcement partners in the UK and abroad. For example, Europol helped facilitate the arrest of 90 people suspected of human trafficking as part of Operation Archimedes in September this year, and that is why the Government is seeking to rejoin the measure on 1 December. The Modern Slavery Strategy, which will be published shortly, will set out a number of measures to improve the way in which intelligence on modern slavery is gathered, analysed and shared with law enforcement partners.

The review team has visited 10 of the contracted service providers in England, Wales, Scotland and Northern Ireland. At each visit the team has taken the opportunity to meet victims and discuss their experiences. In addition the team has consulted other organisations that work closely with victims and provide additional services.

recent assessment her Department has made of the level of female genital mutilation in the UK; and if she will make a statement.

Reply from Norman Baker: The Coalition Government has part funded a new study by Equality Now and City University into the prevalence of female genital mutilation in England and Wales.

The interim report, published in July 2014, has estimated that approximately 60,000 girls aged 0-14 were born in England and Wales to mothers who had had FGM, and that approximately 103,000 women aged 15-49 and approximately 24,000 women aged 50 and over who have migrated to England and Wales are living with the consequences of FGM. In addition, approximately 10,000 girls aged under 15 who have migrated to England and Wales are likely to have suffered FGM. The full report, with data disaggregated to a local level, will be released in the new year.

In addition, since April 2014 NHS staff have been required to record in a patient's healthcare record whenever it is identified that the patient has

suffered FGM. This applies to all NHS clinicians and healthcare professionals across the NHS. The collection became mandatory on 1 September 2014. The first aggregated monthly data return from acute hospital providers in England, published by the Health and Social Care Information Centre, reported that in September 2014 there were 1,279 patients identified as having undergone FGM prior to the reporting period, who were still being actively seen or treated for FGM-related conditions or any other non-related condition, and 467 newly identified cases of FGM nationally.

Reply from Lord Bates: The Minister for Crime Prevention is chairing a cross government FGM roundtable meeting on 10 November, to which the National Policing Lead on Female Genital Mutilation, the Director of Public Prosecutions and other key stakeholders are invited. The meeting will take stock of progress in implementing the extensive package of announcements to tackle FGM made at the Girl Summit hosted by the PM on 22 July. This includes the recently published NHS statistics on cases of FGM and how they can be promoted, alongside new FGM prevalence data, part-funded by the Home Office and published by City University and Equality Now in July 2014. The roundtable will also review current progress on police and Crown Prosecution Service activity to tackle FGM.
