## UK Parliament Questions

### Translation Costs

**Dominic Raab:** What steps he is taking to reduce translation costs in the delivery of local services. [907332]

**Reply from the Secretary of State for Communities and Local Government (Eric Pickles):** My Department has issued crystal clear guidance to councils that they should cease translating into foreign languages. Translation is a waste of taxpayers' money and encourages segregation and division. Promoting English is the best way to ensure integration.

**Dominic Raab:** ... Does he agree that the enormous translation costs for public services that grew up under the previous Government were not just a huge waste of taxpayers' money, but sent a message that if someone moves here from abroad, they do not need to speak English or to integrate, and that has proved a major policy mistake?

**Reply from Eric Pickles:** Yes; the cost worked out at something like £140 million a year. It is not good enough to say, "Don't translate"; we must make a real effort to ensure that people can speak English. That is why my Department has invested £6 million in six programmes to deliver courses for more than 24,000 adults with the lowest levels of English. Those people are the most isolated because they are unable to speak English. The courses have been targeted principally towards Bangladeshi, Pakistani and Somali women.

**Chi Onwurah:** I recently met the profoundly deaf communities in my constituency through DeafLink, and they highlighted how isolated they felt because of the lack of British sign language translation services available when accessing services. What will the Secretary of State do to support them?

**Reply from Eric Pickles:** The hon. Lady makes a reasonable point: sign languages in English should be available. I shall look into the matter very carefully and, because she has made a reasonable point, respond to her.

### Police: Translation Services

**Jim Shannon** [223192] To ask the Secretary of State for the Home Department, what steps she is taking to reduce translation and interpretation costs in police forces.

**Reply from Mike Penning:** The provision of translation and interpretation services is an operational matter for the Chief Constable of each force in England and Wales. These services fall into one of the categories in which Police and Crime Commissioners and Chief Constables have agreed to move to standardise specifications of their requirements and to aggregate buying power to improve the value for money they obtain.

Under this Government, collaborative procurement of goods and services has delivered £200 million in savings for the taxpayer.

### Community Relations

**Lord Hylton** [HL4425] To ask Her Majesty's Government what assessment they have made of the existing policies of European Union states to promote the integration as citizens of all members of immigrant communities, across ethnic and religious boundaries; and whether they consider any such policies to be relevant to the United Kingdom.

**Reply from Lord Ahmad of Wimbledon:** The Government participates in exchanges of good practice on integration with other EU Member States at meetings of the EU network of National Contact Points on Integration. In relation to our domestic policies on integration, I refer the Noble Lord to the Written Ministerial Statement on Integration by my Rt Hon Friend the Secretary of State for Communities and Local Government on 18 December 2014, *Official Report*, column 110WS.

### Immigration

**Lord Marlesford** [HL4548] To ask Her Majesty's Government what arrangements are in place to accommodate immigrants arriving in the United Kingdom from Bulgaria and Romania who have no financial resources and nowhere to sleep.

**Reply from Lord Bates:** EU nationals who are not fulfilling the residency requirements set out in the Free Movement Directive, for example those who are begging or sleeping rough, and who have no right of residence in the UK should leave. Following changes this Government made from 1 January 2014, those who do not depart voluntarily can be administratively removed and barred from returning to the UK for 12 months unless they can show that they have a valid reason to return.

### Illegal Immigrants

**Lord Marlesford** [HL4547] To ask Her Majesty's Government what is the status of immigrants from (1) Bulgaria, and (2) Romania, who arrived in the United Kingdom illegally before January 2014; and what is the total number of such cases that have been detected.

**Reply from Lord Bates:** The previous Labour Government signed the EU Accession treaty with Romania and Bulgaria, which granted Romanians and Bulgarians a right of entry to the UK from 1 January 2007. From that date, Romanians and Bulgarians have been able to travel to the UK legally, though their access to the UK labour market was restricted under the transitional arrangements, which the present Government extended until 31 December 2013, the maximum possible period.

### Illegal Immigrants: Employment

**David Hanson** [222054] To ask the Secretary of State for the Home Department, how many companies were fined for employing illegal immigrants in each of the last five years.

**Reply from Mike Penning:** The information requested is in the following table. The figures are based on the number of civil penalties issued to individual employers during each of the last five complete financial years. This includes public and private limited companies, sole traders, partnerships and franchises.

The government is committed to taking effective action against employers of illegal workers. Illegal working drives illegal immigration which leads to exploitation of workers and is also linked to non payment of the national minimum wage, harmful working conditions and tax evasion. Illegal working also undercuts legitimate businesses and adversely impacts on the employment of people who are lawfully resident in the UK.

The government has therefore taken measures to strengthen our approach to rogue employers. In 2014, we doubled the maximum civil penalty that can be levied against an employer to £20,000 per illegal worker and we used the Immigration Act 2014 to make it easier to enforce unpaid penalties in the courts. We have also extended our enforcement reach by working more closely across government departments to identify where illegal working is taking place and to enforce a range of sanctions against employers of illegal workers.

### Asylum

**David Hanson** [221244] To ask the Secretary of State for the Home Department, how many asylum case work staff were employed in dealing with asylum claims in each year since 2010-11.

**Reply from Mike Penning:** The total number of asylum decision makers currently employed by UK Visas and Immigration is 416. In January 2014, we employed 309 decision makers and in April 2013 there were 345 decision makers employed. Prior to April 2013, this information is not held in a reportable format and to provide this information would only be possible at a disproportionate cost. The numbers provided have been taken from internal management information and as such are provisional and may be subject to change.

### Asylum

**David Hanson** [221261] To ask the Secretary of State for the Home Department, how many asylum seekers have been waiting for an initial decision on their claim for (a) six months or more and (b) one year or more.

**Reply from Mike Penning:** At the end of October 2014, 9,844 asylum applications from main applicants were pending initial decision for six months or more and, of those, 5,423 for one year or more.

The figures provided are a subset of latest published statistics for applications received for asylum since April 2006 and published by the Home Office on a monthly basis. The Home Office has robust plans in place and is working to ensure that straightforward asylum applications made before 1 April 2014 receive initial decisions by 31 March 2015 and straightforward asylum claims made after 1 April 2014 are decided within 6 months.

### Asylum: Scotland

*The following three questions all received the same answer.*

**Cathy Jamieson** [222152] To ask the Secretary of State for the Home Department, what steps she is taking to ensure that asylum seekers resident in Scotland are able to submit evidence on their claim to offices in Scotland.

**Cathy Jamieson** [222153] To ask the Secretary of State for the Home Department, what assessment she has made of the effect on asylum seekers in Scotland of the recent changes to rules which provide that evidence related to asylum claims must be submitted in Liverpool.

**Cathy Jamieson** [222154] To ask the Secretary of State for the Home Department, what representations she has received about the rule change which means that asylum seekers must submit claims in Liverpool.

**Reply from Mike Penning:** The changes to the further submissions process only apply to failed asylum seekers whose claims have already been carefully considered and refused and, where applicable, had any appeal against that decision rejected by an independent court. Asylum seekers who are yet to receive a decision on their claim are unaffected by the new arrangements. They are given every opportunity to disclose all relevant evidence and remain able to submit it by post or at offices in Scotland.

Home Office officials meet asylum partners on a regular basis through the National Asylum Stakeholders Forum (NASF) and several sub-groups of this forum. The Government is familiar with the range of views about the asylum system and how it is operated and these views were considered when developing this policy change. NASF were notified of the change in a letter dated 13 January and Home Office officials met partners on 22 January to discuss their concerns. We will continue to discuss these issues with partners and have scheduled forthcoming meetings for this purpose. We are not aware of any direct approach from Scottish stakeholders.

### Asylum: Middle East

**Lord Alton of Liverpool** [HL4384] To ask Her Majesty's Government, further to the reply by Baroness Northover on 13 January (HL Deb, col 652) and the Written Answer by Lord Bates on 21 January (HL4111) what is the difference between the 3,800 "Syrian nationals and their dependents" to whom they say they have given sanctuary and the 90 people whom they say were relocated to the United Kingdom under the Vulnerable Persons Relocation Scheme; what is meant by the phrase "given sanctuary"; how many of those given sanctuary were invited to the United Kingdom; how many came under their own steam; how many of the 3,800 Syrians have been given asylum or granted re-settlement; how many arrived in the United Kingdom before the present disturbances; and how many refugees in the United Kingdom are from Iraq or other parts of the Middle East region.

**Reply from Lord Bates:** The latest published figures show that between April 2011 and the end of September 2014, a total of 3,468 Syrians were granted protection in the United Kingdom. This number represents those people who have

claimed asylum in the United Kingdom, and includes those who have left Syria since the onset of the crisis, as well as those already residing in the United Kingdom who are unable to return safely. It is not possible to break the data down further to show how many people have arrived in the UK since the onset of the crisis, as opposed to those who were already residing in the UK.

The 90 people who were relocated under the Syrian Vulnerable Persons Relocation Scheme (VPRS) between March 2014 and end of September 2014 are in addition to the number quoted above. Potential beneficiaries of the scheme are referred to us from Lebanon, Jordan, Turkey, Iraq and Egypt by UNHCR on the basis of vulnerability.

The next set of asylum and VPRS statistics will be published on 26 February.

The phrase 'given sanctuary' is defined as those given protection by the United Kingdom. The table below shows the number of people from the Middle East who have been granted a form of protection or other leave after claiming asylum in the UK. It includes those granted asylum, discretionary leave, humanitarian protection, as well as other grants outside these three categories. The data also include dependents.

**Paul Blomfield** [221902] To ask the Secretary of State for the Home Department, with reference to the UK Human Trafficking Centre report, A strategic assessment on the nature and scale of human trafficking in 2012, published in August 2013, and the National Crime Agency strategic assessment, The nature and scale of human trafficking in 2013, published in September 2014, how many of the (a) 402 victims of trafficking in 2012 and (b) 594 victims of trafficking in 2013 who received a positive conclusive grounds decision from the National Referral Mechanism have subsequently claimed asylum in the UK; and if she will make a statement.

**Reply from Karen Bradley:** In 2012, 234 victims who received a positive

conclusive grounds decision claimed asylum; and in 2013, 220 victims who received a positive conclusive grounds decision claimed asylum.

**Reply from Karen Bradley:** The Government has accepted, in principle, all the recommendations set out in the National Referral Mechanism review report. Pilots will be established to test the core recommendations to ensure that our approach to identifying and supporting victims of modern slavery is robust and fit for purpose. Details of the pilots, including the terms of reference, will be published in due course.

**Paul Blomfield** [221879] To ask the Secretary of State for Justice, what damages were awarded to victims of trafficking in actions under existing civil torts since 2010.

**Paul Blomfield** [221883] To ask the Secretary of State for Justice, how many victims of trafficking have brought claims against their traffickers under existing civil torts in the last five years; and how many such claims have resulted in awards for damages.

**Reply from Mike Penning:** Modern slavery is an appalling crime that has no place in today's society. It is an affront not just to the dignity and humanity of the people crushed by it but to every one of us.

That's why the Government has introduced a Modern Slavery Bill, the first of its kind in Europe.

But we are clear that legislation is only part of the answer. We have also launched the Modern Slavery Strategy setting out co-ordinated action across government departments, agencies and law enforcement in the UK and internationally to tackle slavery.

We believe that the remedies available to victims of trafficking under the civil law of tort are adequate and effective. In addition to damages to compensate the victim for the harm he or she has suffered, the law also allows for aggravated or exemplary damages to be awarded depending on the circumstances of the case.

We are confident that the courts will award such damages wherever it is appropriate to do so.

### Human Trafficking

**Paul Blomfield** [221880] To ask the Secretary of State for Justice, how many cases of (a) trafficking for sexual exploitation, (b) trafficking for other exploitation and (c) forced labour, slavery and servitude (i) were prosecuted and (ii) resulted in convictions in 2013.

**Reply from Mike Penning:** The number of defendants proceeded against at magistrates' courts and found guilty at all courts of offences under Section 71 of the Coroners and Justice Act 2009 (relating to forced labour, slavery and servitude), Section 4 of the Asylum and Immigration (Treatment of Claimants etc) Act 2004 (relating to trafficking for other exploitation) and Section 57 and 59 of the Sexual Offences Act 2003 in England and Wales (relating to for sexual exploitation) from 2009 to 2013 can be viewed in the table.

Modern slavery is an appalling crime that has no place in today's society. It is an affront not just to the dignity and humanity of the people crushed by it but to every one of us.

That is why the Government has gone beyond the above legislation and introduced a Modern Slavery Bill, the first of its kind in Europe.

### Human Trafficking

**Paul Blomfield** [221908] To ask the Secretary of State for Justice, with reference to paragraph 6.3.11 of the National Referral Mechanism Review published in November 2014, if he will review the provision of legal aid to potential victims of human trafficking.

**Reply from Mike Penning:** Civil legal aid is currently available to help victims of human trafficking in relation to applications for leave to enter or remain in the UK, and also for claims for damages or under employment law brought by victims of human trafficking arising in connection with their exploitation.

My officials are working with the Home Office on implementation of the Review's recommendations.

### Human Trafficking

**Michael Connarty** : How many people have been convicted of human trafficking offences in the last four years. [907375]

**Reply from the Lord Chancellor and Secretary of State for Justice (Chris Grayling):** That question does not sit within the responsibilities of the Ministry of Justice; it is a question for the Home Office. However, I can inform the hon. Gentleman that between 2010 and 2013—the latest year for which figures are available in relation to human trafficking offences on an all-offences basis—the number of convictions increased by nearly 66%. The Government are committed to stamping out this abhorrent crime, building on the United Kingdom's strong track record of supporting victims and fighting the perpetrators.

**Michael Connarty:** I am sorry to learn that the Secretary of State for Justice thinks that convictions for trafficking are not really his responsibility. I should have thought that those at the Ministry of Justice were the very people to deal with them. In Scotland, the Minister for Justice takes responsibility for trafficking convictions there. My criticism of the new Modern Slavery Bill is that all the laws for which it provides are exactly the same as those that have operated up to this moment.

I do not know what "66%" means: 66% of nothing is nothing. We want to know why the Ministry of Justice did not argue for the new laws that Lord Judge and Peter Carter recommended to the Joint Committee that was set up to look into the issue.

**Reply from Chris Grayling:** In response to the hon. Gentleman's first point, I can tell him that it is a simple matter of fact in Government that this issue is looked after by the Home Office. As for his second point, I do not believe that any past Government have done more than the present Government to tackle human trafficking. Work is being done across Government and across the public sector to deal with a crime that we all believe is abhorrent, and that we all want to see

stamped out.

**Meg Hillier** : The Secretary of State says that the issue of human trafficking is not his responsibility, but the issue of convictions is, and one of the key challenges is gathering evidence. In my constituency, I often meet victims many years after the trafficking offences have been committed. The Home Office may be responsible for some of these matters, but what is the right hon. Gentleman's Department doing to improve the evidential chain and ensure that the evidence is there in court to secure convictions?

**Reply from Chris Grayling**: The securing of evidence to bring prosecutions to court is a matter for the police and the Crown Prosecution Service, but our Department will always do all that it can to facilitate their work. I expect our reforms of the court system to improve the process in both those organisations, but we depend on the very good work done by our police service and the Crown Prosecution Service to ensure that people are prosecuted.

### **Caste: Equality Act 2010**

**Lord Avebury:** To ask Her Majesty's Government what is the timetable for implementing the legislation to incorporate caste as a protected characteristic under the Equality Act 2010.

**Reply from Baroness Garden of Frognal:** My Lords, we have no immediate plans to incorporate caste into legislation. We are aware of the recent *Tirkey v Chandok* Employment Appeal Tribunal judgment and are considering its implications for discrimination law. The judgment opens the possibility of a legal remedy for claims of caste-associated discrimination under existing legislation, in the ethnic origins element of Section 9 of the Equality Act 2010. We note this potential protection and have always stated that we completely oppose caste discrimination.

**Lord Avebury:** My Lords, can my noble friend give an undertaking on behalf of the Government that, if they are re-elected in May, they will pursue this matter to completion, as recommended by the UN Committee on the Elimination of Racial Discrimination? As regards the tribunal case of *Tirkey* that she mentioned, have the Government considered the opinion of the EHRC that it is not binding on all future cases of caste discrimination and that an express provision in the Equality Act, which has already been decided by Parliament, is necessary for reasons of legal clarity?

**Reply from Baroness Garden of Frognal:** My Lords, I cannot make promises on behalf of a future Government not yet elected, but post-election, of course, the incoming Administration will need to consider how to discharge their legal obligations in respect of the outstanding duty to legislate. On my noble friend's second question, we of course take note of what the EHRC says, but I should make it clear to the House that this view was expressed by the commission in its submission on the *Tirkey* case and not part of the judicial decision.

**Baroness Thornton:** My Lords, it is almost two years since this House voted by a very large majority that caste should be considered for inclusion in the Equality Act 2010. As the noble Lord, Lord Avebury, has said, the recent employment tribunal judgment reinforces the point that caste discrimination is an issue coming before the courts and that clarity of the law is required. This issue cannot be ignored or sidelined, so what exactly is the Government's timetable for taking this forward after this terrible delay?

**Reply from Baroness Garden of Frognal:** My Lords, we are conscious of the delay in this matter. During the passage of the Enterprise and Regulatory Reform Act 2013, when the need for explicit caste legislation was debated extensively, it was generally acknowledged that a full public consultation should be undertaken, not least because there was no general consensus on even basic concepts, such as a workable definition of caste itself. Because of a number of delays, there is no

longer sufficient time before the election to put it through.

**Lord Deben:** My Lords, my noble friend will remember that in those debates this House specifically refused to support the Government's position and refused to accept the delay. We voted for a change in the law. We are now two years later and that change has not been implemented. The Government owe it to this House to say that they will implement it, and that any future Government made up of the two parties of this Government will also implement it.

**Reply from Baroness Garden of Frognal:** My Lords, I recognise the frustration around the Chamber over this matter. However, the debates during the final stages of the then Enterprise and Regulatory Reform Bill made clear that caste is a controversial and difficult issue, and that the Government would need to proceed carefully, involving public consultation. I believe that the *Tirkey v Chandok* case, which was unknown at the time those debates took place but which has potentially significant implications for the law in respect of caste and race discrimination, clearly illustrates the need for caution.

**Lord Harries of Pentregarth:** Does the Minister agree that it would be quite inadequate to leave issues of racial and gender equality to employment tribunals? What is different about caste discrimination, when the judge in the *Tirkey v Chandok* case said that his judgment applied only to the facts of that particular case, and did not make any ruling about caste in general?

**Reply from Baroness Garden of Frognal:** Indeed, my Lords, but the Employment Appeal Tribunal is an authoritative court and, for the time being at least, its judgment in that case is the law of the land. The EHRC intervened in the appeal and I imagine would wish to consider another intervention, if it thought that was necessary.

**Lord Cashman:** My Lords, all discrimination is difficult to deal with, but such procrastination is entirely unacceptable when more than 200 million people experience caste discrimination every single day. Therefore, will the Minister please report back the strength of feeling in this House that the procrastination is entirely unacceptable?

**Reply from Baroness Garden of Frognal:** I will, indeed, report back the frustration of this House but I come back to one of the difficulties, which is that there is no agreed definition of caste. Many cases which are in the pipeline could be brought under the ethnic origins discrimination legislation.

**Lynne Featherstone:** The UK Government takes all forms of hate crime very seriously. We deplore all attacks motivated by religion, race or sexuality. Everyone should be able to live their lives free from fear of targeted hostility, harassment or violence on the grounds of a particular characteristic.

The Government's action plan on hate crime brings together the activities of government departments that work with local agencies, voluntary organisations

and an independent advisory group to meet three main objectives to challenge attitudes and behaviours, increase the reporting of hate crime, and improve the operational response to it.

Our work includes encouraging anyone who is a victim of a hate crime or subject to religion or race-related abuse or attack to have the confidence to report it to the police so that the offenders can be dealt with appropriately. As part of this, we issued guidance in 2014 to police forces in England, Wales and Northern Ireland on dealing with hate crimes. This which includes advice on responding to incidents and how to monitor and deal with community tensions.

We have also worked with organisations, including Show Racism the Red Card, the Anne Frank Trust and the Jewish Museum to raise awareness of prejudice with children and young people, to prevent hate crime from happening in the first place.

A progress report was published in May 2014 and provides an overview of our achievements, which include working with football authorities to help drive racism and homophobia out of football, worked with organisations such as Show Racism the Red Card, the Anne Frank Trust and the Jewish Museum to raise awareness of prejudice with children and young people and supported the work of Tell MAMA to address anti-Muslim hatred. We have also seen the first conviction(s) for offences of stirring up hatred on the grounds of sexual orientation under Part 3A of the Public Order Act 1986 (as amended). The progress report also includes case study examples which demonstrate how work is being carried out locally. The report is available in the House of Commons Library.

**Reply from Lord Bates:** Part 3 and Part 3A of the Public Order Act 1986 (as amended by the Racial and Religious Hatred Act 2006 and Criminal Justice and Immigration Act 2008) cover a range of offences relating to inciting hatred on the grounds of race, religion and sexual orientation.

For offences under both parts of this legislation, the criminal threshold has to be met in order for a person to be found guilty. For racial hatred the threshold test is that the words or behaviour used have to be 'threatening', 'abusive' or 'insulting' and intend to stir up racial hatred or having regard to all the circumstances racial hatred is likely to be stirred up. For hatred on the grounds of religion and sexual orientation, the threshold test is different; the words or behaviour have to be 'threatening' and the person must intend thereby to stir up hatred on the grounds of religion or sexual orientation. This part of the Act also sets out a provision for the protection of freedom of expression.

The government has no current plans to make amendments to this legislation.

**Reply from Lord Bates:** The number of reported cases to the Forced Marriage Unit (FMU) each year does not reflect the full scale of the abuse, as many more cases go unreported. 82% of the reported number of 2013 cases involved female victims. The FMU operates across the whole of the UK, where support is provided to any individual of any nationality. It also operates overseas where consular assistance is provided to British nationals, including dual nationals.

The data held by the FMU cannot specifically be broken down to identify cases for advice or support relating to British girls sent abroad. To provide more detailed information on the figures for England, Scotland, Wales and Northern Ireland, would involve a disproportionate cost. We also have no plans to publish figures in this format in future years.

The consultation closed on 12 January and we are carefully considering the responses. We will announce the results of the consultation shortly.
