Scottish Parliament Motion

S4M-12265 Ken Macintosh: Restricted Access to Asylum in Scotland—That the Parliament condemns what it understands is the impending rule change by the Home Office that will further restrict access to the asylum process in Scotland; believes that the change will require asylum seekers whose applications have been refused to travel to Liverpool in person to submit any new evidence in support of their claim; notes the calls for an urgent review of this proposal; is concerned that it will apply regardless of where people live; understands that no support will be offered to help people meet it, unless exceptional circumstances, which are currently undefined, pertain; believes that the people affected are, by definition, without financial support; considers that the rule change will further restrict access to the asylum system; notes the existing restrictions in access that are experienced by newly-arrived asylum seekers across the country

including in the West Scotland region, who must travel to Croydon to register their claim, without support or recognition by the Home Office; believes that this new rule will not only have an adverse impact on new and refused asylum seekers but will further add to the barriers faced by women survivors of violence in accessing the asylum process, which requires them to disclose experiences of violence, sometimes despite their children being present, through often a male interpreter or interviewers who lack specific training, an issue which has been highlighted by the Protection Gap campaign; expresses doubts about the legality of the proposed change; notes the view that consideration should be given to abandoning it in light of its possible impact on refused asylum seekers, including the danger of increased destitution and greater vulnerability to exploitation, which could render asylum seekers, including women survivors of violence, unable to access any international protection, and notes the recommendation by the Smith Commission that the UK and Scottish governments should work together to explore the possibility of asylum seekers in Scotland being able to lodge both new and fresh asylum claims to the Home Office from where they reside.

UK Parliament Ministerial Statement

Immigration Detention

The Secretary of State for the Home Department (Theresa May): I have today commissioned an independent review into the Home Office policies and operating procedures that have an impact on immigration detainee welfare. Immigration detention plays a key role in helping to secure our borders and in maintaining effective immigration control.

The Government believe that those with no right to be in the UK should return to their home country and we will help those who wish to leave voluntarily. However, when people refuse to do so, we will seek to enforce their removal, which may involve detaining people for a period of time. But the wellbeing of those in our care is always a high priority and we are committed to treating all detainees with dignity and respect.

I want to ensure that the health and wellbeing of all those detained is safeguarded. Following the work I commissioned into the welfare of people with mental health difficulties in police custody, I believe it is necessary to undertake a comprehensive review of our policies and operating procedures to better understand the impact of detention on the welfare of those in immigration detention. The purpose of this wider-ranging review is to consider the appropriateness, and application, of current policies and practices concerning the health and wellbeing of vulnerable people in immigration detention, and those being escorted in the UK. I am committed to considering any emerging findings made by the review and to taking action where appropriate.

I have asked Stephen Shaw CBE, the former Prisons and Probation Ombudsman for England and Wales, and a widely respected expert in this field, to lead the review. The terms of reference can be found on the Home Office website and copies will be placed in the Libraries of both Houses.

British Nationality

Mike Hancock [223524] To ask the Secretary of State for the Home Department, how many people seeking British nationality have been waiting more than (a) nine months and (b) one year for their application to be processed having paid all due fees.

Reply from Karen Bradley: (a) between 9 – 12 months 369 people. (b) More than 12 months 487 people.

These figures are as of the end of September 2014, in line with the latest published data.

This compares with a peak in 2007-08 of 2592 people waiting between 9 and 12 months and 4166 people waiting more than 12 months.

Reply from James Brokenshire: According to internal management information, 138 people applied for an administrative review under paragraph 34M of Part 1 of the Immigration Rules between 20 October 2014 and 31 December 2014.

Paul Blomfield [223109] To ask the Secretary of State for the Home Department, how many people granted discretionary leave to remain in the last three years have subsequently been (a) granted and (b) refused a further grant of leave to remain.

Reply from Karen Bradley: In the three years up to September 2014, 101 people were granted further leave to remain following an initial grant of discretionary leave to remain, whilst 190 people were refused a further grant of leave to remain.

This applies to those individuals who were granted discretionary leave to remain between October 2011 and September 2014, and who during that period have received a decision on a subsequent application for further leave to remain. A grant of further leave to remain may include the following; a grant of asylum, humanitarian protection, discretionary leave, further leave as an unaccompanied asylum seeking child or leave to remain on the basis of an individual's private and/or family life.

Immigration: Scotland

Pamela Nash [219752] To ask the Secretary of State for the Home Department, how many unresolved (a) asylum and (b) immigration cases there were in each (i) parliamentary constituency and (ii) local authority area in Scotland since May 2010, up to the latest period for which figures are available in 2013.

Reply from Karen Bradley: The number of outstanding asylum and immigration cases recorded as associated with each Scottish parliamentary constituency can be found at Table 1 below. The number of outstanding cases recorded as associated with each Scottish local authority area can be found in Table 2. The figures that have been provided below relate to main applicants who have made

an immigration application or an asylum claim between 1 May 2010 - 31 December 2013, and whose claim was recorded as unresolved on 31 December 2013. For data protection purposes, cohorts of fewer than 10 people have been indicated with a *.

The data has been compiled by identifying the latest valid postcode on the Case Information Database (CID). For Scottish postcodes, this was then matched to the ONS Postcode database to associate it with a parliamentary constituency and local authority as far as possible. This postcode is the most recently recorded postcode for correspondence purposes and may not be represent the applicant's of place of residence or be the same postcode provided at the time of applying.

Sarah Teather [221183] To ask the Secretary of State for the Home Department, how many fresh applications for asylum have been (a) made and (b) accepted, in each of the last five years.

Reply from James Brokenshire: There were 905 fresh claims, from main applicants, for asylum in the United Kingdom in 2009, 1,621 in 2010, 969 in 2011, 849 in 2012 and 866 in 2013 (provisional figure). This data can be found at as_01 and as_01_q at

Asylum: Appeals

Mike Hancock [223525] To ask the Secretary of State for Justice, how many people who are currently waiting for appeals relating to asylum applications have been waiting over (a) one year and (b) two years.

Reply from Andrew Selous: The First-tier Tribunal (Immigration & Asylum Chamber) hears appeals against decisions to refuse a claim for asylum. The Upper Tribunal (Immigration & Asylum Chamber) hears appeals on a point of law against a First-tier Tribunal decision.

(a) As of 9 February 2015 case management records show there are 211 outstanding asylum appeals in the First-tier Tribunal and 121 outstanding asylum appeals in the Upper Tribunal that were received at least one year ago.

(b) Of these records, 55 First-tier Tribunal appeals and 83 Upper Tribunal appeals were received at least two years ago.

Only a tiny percentage of cases take more than a year, and when they do it is because they raise complex issues. Official statistics published on the 11 December 2014, available at <https://www.gov.uk/government/statistics/tribunals-and-gender-recognition-certificate-statistics-quarterly-july-to-september-2014> show that the average time taken to dispose of an asylum appeal within the First-tier Tribunal was 12 weeks between July and September 2014.

Asylum: Appeals

Sarah Teather [223220] To ask the Secretary of State for Justice, how many appeals against decisions (a) not to award and (b) to stop support provided under section 4 of the Immigration and Asylum Act 1999 there have been in each of the last five years.

Reply from Shailesh Vara: Appeals relating to Asylum Support are heard in the First-tier Tribunal Social Entitlement Chamber (Asylum Support) which is administered by HM Courts & Tribunals Service (HMCTS). The Ministry of Justice (MoJ) publishes official statistics on the operation of HMCTS which includes the number of Asylum Support appeals received in each of the last five years. These statistics are published on a quarterly basis and the most recent official statistical publication (covering the period up to the end of September 2014) can be found at: <https://www.gov.uk/government/collections/tribunals-statistics>.

HMCTS does not collate information on the volume of cases received broken down by decision type. This information could only be provided at a disproportionate cost by manually checking individual tribunal files for the period in question.

Asylum: Children

Sarah Teather [223221] To ask the Secretary of State for the Home Department, how many unaccompanied asylum-seeking children granted discretionary leave to remain were subject to an enforced removal after turning 18 in each of the last five years.

Reply from James Brokenshire: The Home Office does not return Unaccompanied Asylum Seeking Children (UASC) whose claims have been refused, unless adequate reception arrangements are in place in the country to which the child is to be returned. If adequate reception arrangements are absent, most unaccompanied children are granted UASC Leave (formally known as UASC discretionary leave) which usually lasts until their 18th birthday.

When a child passes the age of 18 and UASC Leave expires, they are no longer considered to be a UASC and are therefore required to take steps to voluntarily return or seek further leave to remain. If the individual does not seek to regularise their stay through further applications or leave is not granted they may be removed in accordance with the Immigration Rules and Published Home Office policy should they fail to leave voluntarily. The table below outlines the number of individuals removed in each of the last five years who had previously been granted discretionary leave to remain as an unaccompanied asylum-seeking child but has since passed the age of 18 and had not regularised their leave or left the UK voluntarily.

Asylum: Housing

Sarah Teather [223236] To ask the Secretary of State for the Home Department, how many asylum applicants receiving support under section 4 of the Immigration and Asylum Act 1999 have been receiving that support for more than (a) two, (b) four and (c) six years; and if she will make a statement.

Reply from Karen Bradley: The total number of main applicants supported under Section 4 is now well below the peak of 12,019 in the Quarter 3 of 2009, standing at 3,566 in the Quarter 3 of 2014.

The number of main asylum claimants receiving Section 4 support for more than two, four and six years is set out in the table below.

Asylum: Syria

The following two questions both received the same answer.

Tim Farron [221697] To ask the Secretary of State for the Home Department, how many local authorities have (a) applied for and (b) received funding from her Department for the purposes of resettling Syrian refugees; and what the total value was of that funding.

Tim Farron [221687] To ask the Secretary of State for the Home Department, what estimate she has made of the number of Syrian refugees resettled by local authorities in the UK to date.

Reply from James Brokenshire: A number of local authorities across the UK accept Syrian refugees under normal asylum procedures. Over 3,400 Syrians have been granted asylum or other forms of leave since the crisis in Syria began in 2011. Furthermore, Syrian asylum seekers who are not being accommodated by the Government, can choose to live in any local authority area.

In addition to this the Home Secretary launched the Syrian Vulnerable Persons Relocation (VPR) scheme last January to provide sanctuary for those displaced Syrians who are most at risk, particularly survivors of torture and violence, women and children at risk and those in need of medical care.

Following the launch of this scheme the Home Secretary wrote to the Chairman of the Local Government Association on 11 February 2014 encouraging local authority participation and this letter has been cascaded across local authorities. So far, three local authorities have received refugees under the scheme and we continue to engage closely with additional local authorities who have expressed an interest in participation. We therefore remain confident that we can continue to meet the needs of arrivals in the UK under the scheme as planned but we welcome further offers of support from other local authorities as the scheme progresses.

Full costs borne by the local authorities will not be known until the refugees have been in UK for a full 12 months. Costs will depend on the particular vulnerabilities of those brought to the UK, and we are keeping costs under close review.

Central government is responsible for the overall funding of the scheme, but we will recover costs wherever possible, including from international aid funding schemes and potential EU funding schemes. We have put forward proposals to obtain funding from the new EU Asylum, Migration and Integration Fund and are

hopeful of a positive outcome. The UK's National Programme is yet to be agreed and until this is signed off by the EU Commission, costs to the Home Office specifically will not be finalised.

Ninety people were relocated to the UK under the Syrian Vulnerable Persons Relocation (VPR) scheme between the first group of arrivals on 25 March and the end of September. This is the latest publicly available figure, as numbers are released as part of the Home Office official statistics each quarter. The number of arrivals under the scheme up to the end of December 2014 will be published on 26 February.

We have said that we expect the scheme to help several hundred people over three years, and we remain on track to deliver that commitment.

Andrew Smith [223425] To ask the Secretary of State for the Home Department, what plans her Department has to extend or renew the current service level agreement between her Department and the National Offender Management Service on the use of prisons to hold immigration detainees.

Reply from James Brokenshire: The current service level agreement between the Home Office and the National Offender Management Service (NOMS), which includes the use of prisons to hold immigration detainees, ends on 31 March 2015. The Home Office is in negotiation with NOMS to renew the agreement

Deportation

Lord Marlesford [HL4549] To ask Her Majesty's Government how many (1) Bulgarian, and (2) Romanian, passport holders are awaiting deportation from the United Kingdom.

Reply from Lord Bates: Most immigration offenders are removed under administrative or illegal entry powers from the UK and are not deported. Deportations are a specific subset of removals which are enforced either following a criminal conviction or when it is judged that a person's removal from the UK is conducive to the public good.

The question has been taken as meaning all enforced removals.

The table below shows the number of Romanian and Bulgarian nationals as of 30 January 2015 awaiting either removal or deportation as a combined total, with removal directions scheduled and set for removal.

Human Trafficking

Paul Blomfield [223156] To ask the Secretary of State for Justice, pursuant to the Answers of 2 February 2015 to Questions 221907 and 221908 if he will review the provision of legal aid to potential victims of human trafficking in advance of their referral to the UK national referral mechanism.

Shailesh Vara: Provision of legal aid to victims of human trafficking in immigration matters is an exception to the general removal of immigration matters from the scope of civil legal aid, and one that we have extended to all victims of modern slavery through the Modern Slavery Bill. Applicants are required to have engaged in the National Referral Mechanism (NRM) process, which also provides specialist accommodation and support, to the point that a positive reasonable grounds or conclusive determination has been made, in order to ensure that limited resources are made available in the cases parliament identified as justifying public support. A review of the NRM, published in November 2014, recommended a range of changes to the current system including changes to align the referral process and the reasonable grounds decision. The point of access to legal aid will be considered as part of our wider consideration and piloting of the NRM review recommendations.

Human Trafficking

Paul Blomfield [223158] To ask the Secretary of State for the Home Department, pursuant to the Answer of 2 February 2015 to Questions 221902, how many of the asylum claimants referred to in the Answer were granted leave to remain in the UK.

Reply from Karen Bradley: The answer of 2 February 2015 to Question 221902 stated that of the human trafficking victims who received positive conclusive grounds decisions in 2012 and 2013, 234 and 220 victims applied for asylum respectively.

This answer was based on Home Office internal management information extracted in June 2014. To answer the current question, the dataset has been fully refreshed, and updated to now include victims who have applied for asylum since June 2014.

As such, the latest data shows that of those who received positive conclusive grounds decisions in 2012 and 2013, 235 and 270 victims respectively have since applied for asylum.

Of the 235 victims of trafficking who received a positive conclusive grounds decision in 2012 and have since applied for asylum, 156 have been granted asylum.

Of the 270 victims of trafficking who received a positive conclusive grounds decision in 2013 and have since applied for asylum, 126 have been granted asylum.

Baroness Afshar [HL4503] To ask Her Majesty's Government what plans they have to introduce measures to help prevent Muslims born and bred in the United Kingdom from being labelled by their faith and excluded from the mainstream.

Reply from Lord Ahmad of Wimbledon: My right hon friend the Secretary of State for Communities and Local Government (Eric Pickles) made a Written Ministerial Statement on 18 December, *Official Report* Column 110WS, setting out the Government's work on integration. As the Statement notes since 2010 the Department for Communities and Local Government has spent £45 million on supporting integration projects. It also makes clear that we are rising to the challenges, championing what unites our country across class, colour and creed and making clear that Britain is a stronger nation because of its faith communities. We are also taking initiatives and supporting communities in addressing anti-Muslim hatred.

We are clear that British values are Muslim values and there are incredible and powerful examples of Muslim social action and charitable contributions made by Britain's Muslim communities. Britain has a proud track record of multi-faith cooperation and we are confident that our communities work together in strengthening society. This cannot be achieved by Government alone and local communities and faith leaders are in a unique position in working with Government in ensuring that no British citizen feels marginalised.

Recorded Religious Hate Crimes

Stewart Maxwell: To ask the Scottish Government whether it will provide a breakdown of recorded religious hate crimes in 2013-14 expressed as the number of incidents per 1,000 members of each religious affiliation, also broken down by incidents recorded under section (a) 74 of the Criminal Justice (Scotland) Act 2003 and (b) 1 of the Offensive Behaviour at Football and Threatening Communications (Scotland) Act 2012. (S4W-24173)

Reply from Michael Matheson: The reports titled Religiously Aggravated Offending in Scotland 2013-14 and Charges reported under the Offensive Behaviour at Football and Threatening Communications (Scotland) Act 2012 in 2013-14 were published on 13 June 2014 and presented information on the number of charges that were reported to the Crown Office and Procurator Fiscal Service (COPFS) by the police in 2013-14 under section 74 of the Criminal Justice (Scotland) Act 2003 and section 1 and section 6 of the Offensive Behaviour at Football and Threatening Communications (Scotland) Act 2012.

The following table shows religious aggravation charges that were reported to COPFS in 2013-14 for conduct which was derogatory to each religion under the two pieces of legislation. The final column presents the number of charges per 1,000 members of each, as recorded in the 2011 census.

It is important to note that reported charges only contain information about the nature of the offensive conduct and not about the religious affiliation of the victims of incidents. In 48% of charges, the victim of the conduct was a police officer (an increase from 40% in 2012-13), and in 11% of charges the victim was a worker (decreased from 12% in 2012-13). The occasions when religious abuse targeted people within the 'general community', and not a particular individual, represented 26% of all charges (a decrease from 34% in 2012-13).

This suggests that for many of the charges it is unlikely the accused knew the religious affiliation/belief of the victim at the time of incident, and that the attacks were more arbitrary in nature.

As a consequence this may lead to an under-reporting of the 'charges per 1,000 members' in the Protestant category.

Provided start-up funding to the Tell MAMA initiative to record incidents and support victims of anti-Muslim hatred;

Established a UK Srebrenica Memorial Day which recognises the fatal consequences of hatred and division;

Run social media workshops to build the capacity of community organisations to use social media effectively;

Held 8 integration roadshows with communities to find out what more Government can do to integrate communities and tackle anti-Muslim hatred. Further roadshows are planned throughout 2015;

Following the attacks in Paris, My Right Honourable Friend the Secretary of State for Communities and Local Government and I wrote on 16 January to mosques across England reassuring them of Government help if they experience anti-Muslim hatred. The Department has also assured faith and community leaders of its support to their commendable efforts to foster mutual understanding and shared respect;

Proactive engagement with the police to combat anti-Muslim hatred;

Initiated roundtable discussions with representatives of Muslim communities, including Imams and Muslim youth leaders;

Regular ministerial engagement and attendance at Muslim community events.

Lord Bates: The Government is clear that female genital mutilation (FGM) is a crime and it is child abuse. We will not tolerate a practice that can cause extreme and lifelong physical and psychological suffering to women and girls.

The Home Office has provided £100,000 through the FGM Community Engagement Initiative. The fund was open to organisations across all parts of the UK to bid for up to £10,000 to carry out community work to raise awareness of FGM amongst women already affected by FGM, young at-risk girls, as well as men in the community.

Other UK Parliament and Government Parliamentary Questions (continued)

The Government's specialist cross-Government FGM Unit launched on 5 December. The Unit will provide outreach support to local areas in England and Wales, act as a hub for effective practice, work with the police and develop cross-government policies on FGM.

The Unit does receive enquires from individuals and organisations in Scotland which are dealt with through appropriate consultation with partners in Scotland.

In 2013, the FMU gave advice or support related to a possible forced marriage in 1302 cases. Where the age was known, 15% of cases involved victims below 16 years and 25% involved victims aged 16-17. Where a victim is repatriated back to the UK, this is individually recorded on case notes.
