### **Scottish Parliament Questions**

### **Post-study Work Visas**

Roderick Campbell: To ask the Scottish Government what recent discussions it has had with the United Kingdom Government regarding the post-study work visa. (S4O-04493) Reply from the Cabinet Secretary for Education and Lifelong Learning (Angela Constance: This Government is committed to working with the UK Government, as recommended in the Smith report, to ensure that a post-study work route is put in place in Scotland. I welcome the recent backing for the

scheme by 100 figures from business and academia.

My colleague Humza Yousaf, the Minister for Europe and International Development, has twice written to Mr Brokenshire, who was previously the UK Minister for Immigration and Security and is now the Minister for Immigration, about the issue—most recently on 20 May, following the UK election. My colleague, Mr Matheson, the Cabinet Secretary for Justice, also raised the issue in a letter to the Home Secretary, Theresa May, on 15 May. I understand that officials are currently seeking a meeting to discuss the post-study work visa, among other matters.

In addition, Scottish Government and UK Government officials met on 23 January and again on 13 March to discuss a potential post-study work route.

**Roderick Campbell:** I thank the cabinet secretary for that comprehensive answer, which dealt with my supplementary question.

**Reply from Angela Constance:** I hope to reassure Mr Campbell and the rest of the chamber that we will continue to keep up the pressure. Colleagues may be aware that Humza Yousaf has established a new cross-party working group that includes representatives from across the chamber. We look forward to progressing the matter further.

### **UK Parliament Ministerial Statement**

#### Border Management (Calais)

... the ongoing situation in Calais serves as an important reminder of why EU member states need to work together to tackle the causes of illegal immigration in source and transit countries. We are already co-operating closely with the French to tackle the organised criminal gangs that facilitate the movement of migrants into and across Europe. UK and French law enforcement organisations have already had considerable success in dismantling criminal networks behind people trafficking and smuggling on both sides of the channel, resulting in the prosecution of 223 individuals ... ### **UK Parliament Questions**

#### **NHS: Immigration Rules**

**Lord Hunt of Kings Heath:** To ask Her Majesty's Government what their response is to the Royal College of Nursing report concerning the impact of immigration rules on the employment of foreign nurses within the National Health Service.

Reply from the Parliamentary Under-Secretary of State, Department of Health (Lord Prior of Brampton): My Lords, ensuring we have the right number of nurses is vital. That is why we are taking the issue of nursing recruitment seriously and have prioritised and invested in front-line staff, so there are over 8,600 more nurses on our wards. Health Education England's workforce plan for England for 2015-16 forecasts that, following further increases in the number of training commissions, the proposed levels for nurse training will deliver over

23,000 more nurses by 2019.

**Lord Hunt of Kings Heath:** My Lords, the noble Lord will know that the RCN report estimates that as a result of the migration rules around 7,000 nurses will be forced to leave the NHS because they do not reach the £35,000 per annum employment threshold. Despite the modest increase in the number of training places, is he confident that that gap can be filled, alongside dealing with the current recruitment crisis, the extra nurses needed for seven-day working, the extra nurses needed for improved patient-staff ratios and the Government's indication that they want to rule out the use of agency nurses in future? When will all those policies be adopted alongside the 7,000 reduction in overseas nurses?

**Reply from Lord Prior of Brampton:** My Lords, the Royal College of Nursing figure I saw was closer to 3,000 than 7,000, but in a sense that is not what is important. What is important is that over the long run we train our own nurses in this country. Although we recruit some exceptionally wonderful nurses from places such as the Philippines, it does not seem a good long-term strategy to rely on recruiting nurses, often from third-world, quite poor countries, so I am very pleased that we are going to train 23,000 new nurses over the next five years. That is the right answer to any short-term, temporary shortage.

Lord Fowler: My Lords, surely the central point is that we should review the policy of recruiting nurses from overseas, as I think my noble friend is indicating. Should we not in a bipartisan way now concentrate on training our own nurses in this country rather than permanently taking them from other countries, for example, in Africa, which often desperately need their care?

**Reply from Lord Prior of Brampton:** My Lords, I agree with my noble friend; it cannot be right for a rich country such as ours to recruit nurses from much poorer countries. ... the Philippines, for example, produces more nurses on a deliberate basis than it needs for itself, so that they can go overseas, usually for temporary periods, not permanently. Interestingly, over the last five years, the number of non-EU overseas nurses working in this country has reduced by 41%. ...

#### **Migrant Workers: Domestic Service**

The following two questions both received the same answer

**Baroness Cox** [HL313] To ask Her Majesty's Government whether anyone applying to enter the United Kingdom accompanying an employer on a Domestic Workers in a Private Household visa since 2009 has disclosed abuse perpetrated by their employer.

**Baroness Cox** [HL314] To ask Her Majesty's Government whether anyone entering the United Kingdom accompanying an employer on a Domestic Workers in a Private Household visa since 2009 has disclosed abuse perpetrated by their employer.

**Reply from Lord Bates:** The Home Office does not collect data on disclosures of abuse by applicants for, or those entering the United Kingdom on, domestic worker visas. However, disclosures of abuse perpetrated by employers do occur. Analysis of Home Office management information indicates that of the 1,623 trafficking cases which were confirmed between May 2009 and May 2015, 71 were linked to people who had previously been issued an overseas domestic worker visa. This includes the Domestic Workers in a Private Household visa and the Private Servants in a Diplomatic Household visa issued under the International Agreement category of Tier 5 of the Points Based System. The Government has asked James Ewins, an expert on modern slavery, to carry out an independent review of the overseas domestic worker visas, which will consider whether they are effective in protecting potential victims from abuse. Mr Ewins is due to report in July.

#### Migrant Workers: Domestic Service

**Baroness Cox** [HL395] To ask Her Majesty's Government how many people in the United Kingdom on overseas domestic worker visas have, since 2012, been granted a residence permit, including grants of discretionary leave to remain, following a positive conclusive grounds decision that they have been trafficked.

**Reply from Lord Bates:** A manual review of a significant number of applications would be needed in order to provide an accurate response and this would incur a disproportionate cost to the public purse. Therefore we are unable to confirm the number of individuals in the United Kingdom who have been issued residence permits following positive identification as a victim of Human Trafficking who held leave as a domestic worker since 2012.

#### **Immigration: EU Nationals**

**David Nutall** [2742] To ask the Minister for the Cabinet Office, how many citizens of other member states of the EU are resident in the UK.

**Reply from Rob Wilson:** The information requested falls within the responsibility of the UK Statistics Authority. I have asked the Authority to reply.

John Pullinger: The Office for National Statistics collects data on country of birth and nationality from the Annual Population Survey (APS). The APS comprises the Labour Force Survey (LFS) plus various sample boosts. The latest available data is for the period January to December 2013. There are two important issues to bear in mind when using this data:

As with any survey, estimates from the APS are subject to a margin of

uncertainty. A confidence interval has been provided against the estimate provided below.

• The APS is a household survey and therefore excludes people in most types of communal establishment (e.g hotels, boarding houses, hostels, mobile homes), and excludes students in educational accommodation who do not have a UK resident permit.

The number of EU nationals (not including British citizens) resident in the UK, between January and December 2013 (the latest year available) was 2,507,000, with a corresponding margin of uncertainty of  $\pm$ - 69,000<sup>1</sup>.

<sup>1</sup> This means that the number of EU nationals (not including British citizens) resident in households in the UK is within the range of 2,438,000 to 2,576,000 in 19 out of 20 possible survey samples drawn.

#### Visas

**David Winnick** [2953] To ask the Secretary of State for the Home Department, what her Department's practice is in cases in which hon. Members send further documentary evidence to UK Visas and Immigration on visitor's applications which have been refused after meeting constituents who are visa sponsors; whether that body considers that evidence as part of the original application; whether it is her Department's policy to give advice in all such cases that a new application should be made; and if she will make a statement.

**Reply from James Brokenshire:** An application to visit the UK can be reconsidered where representations are made that assert and provide evidence showing that the refusal contained a material error. Where representations contain new evidence that was not submitted with the original application, applicants should submit such evidence through a fresh application, which will then be considered on its own merit against the requirement of the Immigration Rules.

#### **Visas: Overseas Students**

**Lord Green of Deddington** [HL331] To ask Her Majesty's Government how many certificates of sponsorship were issued in respect of Scottish employers for students who switched from Tier 4 into Tier 2 in each of 2012, 2013 and 2014.

**Reply from Lord Bates:** The number of certificates of sponsorship used in each of the calendar years 2012, 2013 and 2014 by migrants to switch from Tier 4 into Tier 2 employment in Scotland, is set out at Table 1 below.

#### **Visas: Overseas Students**

Lord Green of Deddington [HL332] To ask Her Majesty's Government how many students from Scottish higher educational institutions were granted a Tier 1 Post-Study

Work visa in each year since 2009.

**Reply from Lord Bates:** It is not possible to provide data on the number of students from Scottish higher educational institutions who were granted a Tier 1 Post-Study Work visa for every year since 2009 because our records for Tier 1 Post-Study Work applications do not record the previous sponsoring institution in a format which can be used as the basis for a search.

It is however possible to provide data on the number of applicants who were granted a Tier 1 Post-Study Work visa while they were resident in Scotland. This data can be found below.

Year Total amount of grants issued to migrants resident in Scotland

2009 2374

2010 2648

2011 2999

2012 2249

Total 10270

It cannot be confirmed that these migrants had previously studied at Scottish higher educational institutions, for the reasons previously stated. The Tier 1 Post-Study work route was closed to new applications on 6 April 2012.

The figures provided relate to partners in the family immigration category.

Withdrawn and lapsed applications are not available in the published extensions data.

The Home Office publishes quarterly statistics on entry clearance visa decisions by category in table vi\_01\_q (Entry clearance visas tables volume 1) and extension of stay decisions in table ex\_01\_q within the 'Immigration Statistics' release. The published statistics do not distinguish between applications made and decided under the family Immigration Rules in force before and from 9 July 2012. Grants and other case resolutions do not necessarily correspond to an application made in the same period.

#### Asylum: Eritrea

**Baroness Hayter of Kentish Town** [HL451] To ask Her Majesty's Government how many requests for asylum from Eritreans have been granted over the last year, on a month by month basis.

**Reply from Lord Bates:** The table below shows the latest published number of nationals of Eritrea granted asylum and other form of protection in the UK, based on initial decisions for main applicants since January 2014.

#### Refugees: Yemen

**Louise Ellman** [3193] To ask the Secretary of State for the Home Department, how many Yemenis have been granted refugee leave since the beginning of the present political and military crisis in Yemen.

**Reply from James Brokenshire:** In the six months to the end of March 2015 there were 11 grants of asylum, humanitarian protection, discretionary leave or another form of protection, for Yemeni nationals.

#### **Refugees: Detainees**

**Frank Field** [2832] To ask the Secretary of State for the Home Department, what the Government's policy is on the detention of refugee women.

**Reply from James Brokenshire:** The Home Office will not routinely use immigration powers to detain individuals who have been granted refugee status, though may need to do so in specific circumstances, for example if the refugee has subsequently been convicted of committing a crime and deportation action is being taken against them. We would not seek to deport a refugee in such circumstances if they still faced a real risk of death, persecution or torture.

#### **Immigrants: Detainees**

**Caroline Lucas** [3223] To ask the Secretary of State for the Home Department, if she will commission an audit of reports submitted by healthcare professionals in Immigration Removal Centres under Detention Centre Rule 35 to maintain compliance with policy on the detention of victims of crime.

**Reply from James Brokenshire:** Rule 35 of the Detention Centre Rules 2001 requires doctors working in immigration removal centres to report to the Home

Office if they have concerns about the case of any particularly vulnerable detainee in order that the appropriateness of their continued detention can be reviewed.

A Home Office audit of Rule 35 compliance was undertaken in 2014 and a summary of the audit's findings will be published in due course.

#### Yarl's Wood Immigration Removal Centre

**Lord Hylton** [HL585] To ask Her Majesty's Government how many separate incidents of detainees self-harming and requiring medical treatment occurred at Yarl's Wood Immigration Removal Centre in 2013 and 2014 respectively.

**Reply from Lord Bates:** Information is collated on the number of incidents of selfharm requiring medical treatment at Yarl's Wood IRC. In 2013 there were 74 incidents and in 2014 there were 61.

These are the number of incidents of self-harm requiring medical attention; they do not necessarily equate to the number of detainees requiring medical attention as one individual may have received medical attention on more than one occasion.

The data quoted has been taken from management information only and has not been subject to the detailed checks that apply for national statistics publications. These figures are provisional and are subject to change.

### **Tinsley House Immigration Removal Centre**

**Caroline Lucas** [3178] To ask the Secretary of State for the Home Department, what measures she plans to take to implement the recommendations of the most recent report on Tinsley House Immigration Removal Centre by HM Chief Inspector of Prisons; and if she will conduct a review of the operation of (a) the families unit and (b) alternatives to detention at that centre.

**Reply from James Brokenshire:** HM Inspectorate of Prisons (HMIP) published their report of Tinsley House immigration removal centre (IRC) on their website on 28 May following the unannounced inspection.

The recommendations made are already under consideration. This includes the recommendation to reassess the role of the family unit and to consider alternatives to detention before holding families with children at the centre.

In line with the protocol agreed with HMIP, we will respond formally to the report with a service improvement plan (SIP) within two months of the report's publication. The SIP will be made public on HMIP's website.

On 9 February the Home Secretary announced an independent review of detainee welfare in immigration detention, led by the former prisons ombudsman Stephen Shaw. The review is expected to report in September and will seek to identify whether improvements can be made to safeguard the health and wellbeing of detainees across the immigration detention estate, short term holding facilities, and those being escorted in the UK.

The Government will publish the report by laying it before Parliament, alongside the Government's response to the recommendations.

#### **Tinsley House Immigration Removal Centre**

Caroline Lucas [3179] To ask the Secretary of State for the Home Department, how

many and what proportion of detainees sent to Tinsley House Immigration Removal Centre were assessed by a nurse upon arrival in the last 12 months.

**Reply from James Brokenshire:** The operating standards for immigration removal centres requires that all detainees are medically screened, to include an assessment for risk of self-harm/suicidal behaviour, within two hours of admission. Performance is reported on a monthly basis by the service provider. The on-site Home Office team also has the opportunity to view the induction records for individual detainees.

Her Majesty's Chief Inspector of Prisons conducted an inspection of Tinsley House between 1-12 December 2014 and found that all detainees were interviewed by a member of the health care team on reception and information was shared sensitively between escort and centre staff.

#### Deportation

**Chris Stephens** [2561] To ask the Secretary of State for the Home Department, what steps she takes to ensure compliance with the UK's international legal obligations on non-refoulement when deporting people to conflict affected countries.

**Reply from James Brokenshire:** In accordance with the Refugee Convention and our other international obligations, the UK carefully considers all asylum claims, so that no-one is returned to a country where they have a well-founded fear of persecution on account of their race, religion, nationality, membership of a social group or political opinion, or to a country where they would be at real risk of serious harm as a result, for example, of indiscriminate violence due to armed conflict. Those whose applications are rejected and whose appeal rights are exhausted are required to leave the UK and their removal will be enforced if they fail to do so.

#### Deportation

**Reply from James Brokenshire:** Where legally permissible we will deport foreign nationals to countries with the death penalty, provided the individual will not face the death penalty when they return.

#### Slavery

**Jeremy Lefroy** [3739] To ask the Secretary of State for the Home Department, what regulations have been made under section 50 of the Modern Slavery Act 2015 to identify and support victims of trafficking.

**Reply from Karen Bradley:** No regulations have been made under section 50 of the Modern Slavery Act 2015 to identify and support victims of trafficking. The Government will consider the introduction of regulations once the proposed changes to the National Referral Mechanism have been tested.

**Reply from James Brokenshire:** Initial medical triaging and assistance is carried out on board UK vessels deployed to the Mediterranean for search and rescue purposes. Migrants are then taken to a nearby port, as directed by the Italian authorities, where their needs can be more fully assessed and addressed by Italian authorities there.

The UK has regular discussions with other Member States about search and rescue in the Mediterranean.

Furthermore, the UK is also playing a leading role in pushing for comprehensive, long-term action through the EU and the UN to tackle the cause of illegal immigration and the organised trafficking gangs behind it, as well as increasing support and protection for those who need it North and East Africa. We are clear that the need to break the link between getting on a boat and achieving residence in Europe.

#### **Racial Discrimination**

**Lord Ouseley** [HL492] To ask Her Majesty's Government what assessment they have made of the actions and resources required to minimise the adverse effects and impact of institutional racism in society as a whole and in the Metropolitan Police Service, particularly in the light of the statement by the Commissioner for the Metropolitan Police that institutional racism remains a serious problem.

**Reply from Lord Bates:** The Government recognises that people from all communities want the police to fight crime while having confidence that their individual needs will be understood and respected.

The Metropolitan Police have worked hard to improve equality and diversity since the Stephen Lawrence Inquiry. The officer workforce is more representative in terms of gender and ethnicity than it has ever been. However, the Government is clear that there is more for all police forces to do.

Our reforms will allow for faster progress on equality and diversity. PCCs and the College of Policing will play a key role in ensuring improvements in forces. The College of Policing has published advice for forces on the use of more proactive, lawful approaches to the recruitment and progression of officers from currently under-represented groups, using positive action provisions in the Equality Act 2010.

New entry routes into policing such as direct entry and Police Now are also helping to improve the diversity of the police workforce. Police Now, a flagship Metropolitan Police scheme aimed at attracting top university graduates, which is supported by Home Office funding received over 2,200 applications, of which 48% were from women, and 19% were from people from Black or Minority Ethnic backgrounds. 79 individuals accepted provisional job offers. Of these, 16% are from a Black or Minority Ethnic background and 47% are women. This is in contrast to the current representation levels in the Metropolitan Police where only 11% of police officers are from a Black or Minority Ethnic background and 25% are women.

We have reformed the use of stop and search to ensure that the police use all such powers lawfully, in a targeted and intelligence-led way; and local communities must be able to hold the police to account for their use of the powers. All 43 forces in England and Wales, and the British Transport Police, signed up to the voluntary Best Use of Stop and Search Scheme.

In London, the Metropolitan Police Service (MPS) has introduced London residency criteria for police constable recruitment in 2014. Since its introduction MPS figures indicate that the proportion of black and other minority ethnic applicants is now reaching representative levels when compared with London's population.

place to counter the impact of Islamophobia and stigmatisation on young Muslims.

Reply from the Parliamentary Under-Secretary of State, Department for Communities and Local Government (Baroness Williams of Trafford): My Lords, this Government are committed to preventing anti-Muslim hatred and the stigmatisation of young Muslims. We are continuing the extensive community engagement of my predecessors to help to understand the concerns faced by Muslim communities, including working with the cross-government Anti-Muslim Hatred Working Group and Tell MAMA in order to record and monitor anti-Muslim hate crime.

**Baroness Afshar:** I think the Minister for her reply. Have the Government considered celebrating differences by marking occasions such as Eid al-Fitr and applauding actions such as those by Muslims in this month of Ramadan in forgoing eating all day in order to share an evening meal with those who cannot afford it? Could we have more celebration and less condemnation?

**Reply from Baroness Williams of Trafford:** My Lords, this Government and the Prime Minister himself have done extensive engagement in celebrating some of the occasions in communities of different faiths, in marking those occasions that are so important to them. In the Prime Minister's message for Ramadan, he talked—as indeed did my honourable friend Greg Clark in the other place—about the peaceful nature of Islam and the phenomenal contribution of Muslims to this country.

I have been one of the lucky recipients of several invitations to Big Iftars, and that coming together of different faiths has been a great success.

**Baroness Warsi:** My Lords, I pay tribute to the extensive relationship and engagement that my noble friend has with British Muslim communities, but is she aware of the Government's report on the review of Prevent and other reports that identify Islamophobia as a driver of radicalisation? In light of the Government's determined effort to defeat extremism, when can we expect to hear from them about the rising phenomenon of Islamophobia in a keynote speech? What is the Government's policy response to tackle it?

**Reply from Baroness Williams of Trafford:** My Lords, I return the compliment to my noble friend, who over the years has, not just in her words but in her actions, worked hard to tackle Islamophobia in this country. She has been a great support to me in some of the multifaith work that we have done. My noble friend makes a good point about the problems of the disaffection and isolation of young men. Those problems do not apply just to the Muslim community but can apply to young men and women in all areas of this country. The Government have put £8 million into supporting adults in learning English, which is a very good measure in terms of tackling the isolation and disaffection that young people may have. One of the projects that I visited in Rochdale was a Near Neighbours project, which has done phenomenal work in bringing together not just different faiths but different age groups and different aspects of the community. It has created some very peaceful outcomes in terms of that community's well-being.

**Baroness Hussein-Ece:** My Lords, amid reports that the Government have started to disengage with Muslim grass-roots communities, does the Minister think that it is helpful for the Prime Minister to say that some Muslims "quietly condone" radicalisation— apparently we are sitting at home, quietly condoning it? Or does the Minister agree with the Home Secretary's most senior counterterrorism adviser, Charles Farr, who was quoted in the *Telegraph* the other day saying that there is a danger of oversimplification, given that there are 2.7 million Muslims in the UK, and just a few hundred have joined Daesh—so-called ISIS? Who does the noble Baroness think is right?

Reply from Baroness Williams of Trafford: My Lords, I agree with both of them.

The Prime Minister is not saying that Muslims are a problem but that Islamic ideology is a problem that needs to be tackled, and Charles Farr was making a similar point.

Lord Singh of Wimbledon: My Lords, is the Minister aware that ever since 9/11 there has been a huge increase in the number of attacks on Sikhs and Sikh places of worship in cases of mistaken identity? The most recent case was a machete attack on a young Sikh dentist in south Wales, which was described on "Newsnight" as Islamophobia. Does the Minister agree that hate crime is hate crime against any community, and that it should be tackled even-handedly, irrespective of the size of the community?

**Reply from Baroness Williams of Trafford:** The noble Lord is absolutely right hate crime is hate crime.

**Lord Beecham:** My Lords, will the Government consider convening a meeting of the different faith communities to encourage collaboration around combating Islamophobia? Perhaps that could draw on the experience of the Community Security Trust, which works with both Jewish and Muslim communities to protect places of worship—a very good example of interfaith collaboration.

**Reply from Baroness Williams of Trafford:** My Lords, I have a long history of work with interfaith communities, which is well established back in my home area of Trafford. I am pleased to be able to tell the noble Lord that I am already engaging in that work.

because few places are in public ownership. Councillors are naturally reluctant to support approved sites as Travellers are always perceived as bad neighbours, even though we know that many of them cause little trouble. Could the Government use its national planning powers—or at least consider doing so—to provide a national network of halting and permanent sites, because that might enable such a network to happen?

**Reply from Margaret Burgess:** The Government's position is that decisions about the provision of Gypsy Traveller sites are best made by those who have local knowledge and accountability. A decision on whether to provide a Gypsy Traveller site is therefore one for the relevant local authority. Local authorities could choose to work together to create a national network of sites.

We funded Planning Aid for Scotland to carry out a project on planning and the Gypsy Traveller community. It has now produced guides for councillors and council officials on Gypsy Travellers and the planning system. Those are useful documents that have information on the Gypsy Traveller community and local authorities' legal duties.

**Colleen Fletcher** [2923] To ask the Secretary of State for the Home Department, what steps her Department is taking to prevent female genital mutilation in communities affected by that practice.

**Colleen Fletcher** [2924] To ask the Secretary of State for the Home Department, what programmes and projects her Department funds that carry out community engagement work to raise awareness of female genital mutilation.

**Reply from Karen Bradley:** Female genital mutilation (FGM) is child abuse. We will not tolerate a practice that can cause extreme and lifelong physical and psychological suffering to women and girls.

The Home Office has provided £100,000 through the FGM Community Engagement Initiative. The fund was open to organisations across all parts of the UK to bid for up to £10,000 to carry out community work to raise awareness of FGM amongst women already affected by FGM, young at-risk girls, as well as men in the community.

The Government's specialist Home Office-led FGM Unit launched on 5 December 2014. The Unit provides outreach support to local areas and communities in England and Wales, coordinates cross-Government activity, acts as a hub for effective practice and works with the police, voluntary and community sector, survivors and professionals to develop policies and practices to end FGM.

Additionally, through the Serious Crime Act 2015, we are introducing a new mandatory reporting duty which requires known cases of FGM to be reported to the police.

#### **Detainees: Death**

**Lord Ouseley** [HL429] To ask Her Majesty's Government, further to the Written Answer by Lord Faulks on 10 June (HL139), what assessment they have made of the report by the Institute for Race Relations, *Dying for Justice*, and in particular the finding that, between 1991 and 2014, over 500 deaths occurred in some form of custody, resulting in 10 verdicts of unlawful killing, five prosecutions, and no convictions.

**Reply from Lord Faulks:** Every death in custody is a tragedy. Each one is investigated independently by the Prisons and Probation Ombudsman or the Independent Police Complaints Commission, and is the subject of a coroner's

inquest. Every effort is made to learn lessons from these investigations, and the prevention of further deaths is a priority for police, prisons and immigration detention services.

The very small number of cases in which criminal offences are believed to have been committed are referred for further investigation by the police and/or to the Crown Prosecution Service, and where appropriate charges are brought. The final outcome in such cases is a matter for the courts.

The report by the Institute of Race Relations brings together information from a number of sources to highlight the particular issue of deaths of Black and Minority Ethnic people in custody. It describes 509 cases of 'suspicious' death, including large numbers of natural causes deaths as well as self-inflicted deaths and the ten cases that resulted in inquest findings of unlawful killing. These deaths occurred over a period of more than twenty years.

The report acknowledges some of the improvements that have been made during that period. It also reminds us of the enduring nature of many of the issues related to deaths in custody, particularly that the families of the deceased and others in the Black and Minority Ethnic community continue to lack confidence that appropriate action is being taken in response to such deaths. The Government is working to address this, for example through more effective liaison with families, as well as improvements to restraint techniques and training.

The Government announced in February 2014 that Lord Harris of Haringey would lead a review into self-inflicted deaths of 18-24 year olds in NOMS custody. The report will be published in due course.
