# Immigration and Asylum

## **Scottish Parliament Questions**

### Immigration and Asylum Act 1999

**Neil Findlay:** To ask the Scottish Government whether it has the power under section 101(7) of the Immigration and Asylum Act 1999 to halt widening of asylum dispersal in Scotland and whether it has any power in relation to companies alleged to be involved in mistreating asylum seekers in Scotland. (S4W-30572)

**Reply from Alex Neil:** Asylum is a matter reserved to the UK Government. The Scottish Government does not have powers in relation to companies holding Home Office contracts to provide services to asylum seekers in Scotland. The

Scottish Government is aware that the Home Office is exploring the widening of asylum dispersal in Scotland. As discussions are still at an early stage, the application of section 101(7) of the Immigration and Asylum Act 1999 has not yet been tested.

#### Asylum seekers

**Neil Findlay:** To ask the Scottish Government what (a) correspondence and (b) discussions it has had with the UK Government regarding the reported provision of inappropriate accommodation for asylum seekers in Scotland and whether it will publish any such correspondence. (S4W-30573)

**Reply from Alex Neil:** The Cabinet Secretary for Social Justice, Communities and Pensioners' Rights wrote to the Home Secretary about allegations of inappropriate accommodation provision for asylum seekers on 10 February and 8 March 2016. The UK Immigration Minister responded to the first of these letters on 11 March 2016. The Scottish Government has not had any discussions with the UK Government on this subject.

#### Syrian refugees

**Tavish Scott:** To ask the Scottish Government, further to the answer to question S4O-05277 by Humza Yousaf on 20 January 2016 (Official Report, c. 12), what discussions it has had with (a) Shetland Islands Council and (b) other local authorities regarding accepting refugees from Syria. (S4W-30512)

**Reply from Humza Yousaf:** The Scottish Government has not had discussions with Shetland Islands Council about accepting refugees from Syria. Local authorities currently liaise directly with the Home Office about acceptance of refugees. The Scottish Government is in regular dialogue with COSLA, which represents and supports local authorities considering participation in the Syrian Resettlement Programme.

## **Scottish Parliament Motions**

**S4M-16004 Patrick Harvie: Stop the Deportation of Glasgow Student, Lord Elias Mensah Apetsi**—That the Parliament expresses the most urgent concern for the University of Strathclyde student and NUS Scotland Asylum and Refugee Officer, Lord Elias Mensah Apetsi, who is currently being held in a detention centre following a deportation order, which appears to be the result of human error; understands that Mr Apetsi's previous appeal was successful, but that a recent application for leave to remain was submitted late through no fault on his part; recognises what it considers Mr Apetsi's significant contribution to student life through the student societies that he has established and other voluntary work; further expresses concern for his family, who are now separated from him and fearful for his safety, and urges the UK Government to immediately halt moves to deport him, accept the application for leave to remain and return him to his friends, family and colleagues.

#### S4M-16001 Hanzala Malik: University of Strathclyde Student Faces Deportation—

That the Parliament understands with concern that Lord Elias Mensah Apetsi, who is an award-winning student at the University of Strathclyde, is facing deportation to Ghana; notes reports that he was detained on 11 March 2016 after he reported to the Border and Immigration Agency as his application for leave to remain was not submitted on time because of human error; understands that he is being held at Gatwick and will be forced onto a plane on 22 March; believes that Lord, who fled Ghana 10 years ago, is in fear of his life and is scared about what will happen when he returns; considers it wrong that his life can be turned upside down in this manner and that he might be separated from his child, and urges the Home Office to reverse its decision and allow him to return immediately to his life and family in Glasgow.

#### Immigration

**Jim Cunningham** [31493] To ask Mr Chancellor of the Exchequer, what assessment his Department has made of the effect of immigration on the level of economic productivity over the last 10 years; and if he will make a statement.

**Reply from Greg Hands:** As noted in the 2012 report by the Migration Advisory Committee the empirical literature suggests that the impact of migration on productivity may be mixed and heavily dependent on the type of migrant coming to the UK. Migrants may increase productivity either through a simple 'batting average' effect if they work in higher productivity roles relative to the average for non-migrants, or through increasing the productivity of UK workers through greater specialisation and knowledge transfer.

**Jim Cunningham** [31494] To ask Mr Chancellor of the Exchequer, what estimate his Department has made of the effect of immigration on the UK's GDP in the last 10 years; and if he will make a statement.

**Reply from Greg Hands:** Analysis undertaken by the independent Migration Advisory Committee in 2012 shows that higher levels of net migration will, all else equal, increase the growth rate of the potential labour supply and therefore the rate of growth of overall GDP.

**Lord Renwick of Clifton** [HL6922] To ask Her Majesty's Government what assessment they have made of any discrepancy between the net migration numbers and the number of EU citizens registering for the first time for National Insurance in the UK.

**Reply from Lord Bridges of Headley:** The information requested falls within the responsibility of the UK Statistics Authority. I have asked the Authority to reply. ...

#### **Migrant Workers**

**Rupa Juq** [31467] To ask the Secretary of State for the Home Department, how many migrant workers have entered the UK on a non-EU Tier 2 migrant visa since 2010 (a) in total and (b) to work in each sector.

**Reply from James Brokenshire:** The latest available published data show 225,040 passengers were given leave to enter the United Kingdom under Tier 2 in the period January 2010 to June 2015 (excluding dependents).

The available published information regarding Tier 2 by industry type relates to Certificates of Sponsorship used in Tier 2 (Skilled work) visa applications. These data will differ from passengers given leave to enter because applicants may be unsuccessful or decide not to travel. The table below shows the total number of Tier 2 Certificates of Sponsorship used in visa applications, by industry type, in the period January 2010 to June 2015.

#### **Undocumented Migrants: Offenders**

**Anne Main** [31327] To ask the Secretary of State for the Home Department, how many people in immigration detention of each nationality have been convicted of a criminal offence in the UK.

**Reply from James Brokenshire:** As of December 2015 there were 1,274 foreign national offenders in immigration detention.

The Home Office does not provide nationality specific data. The data is withheld where disclosure would be likely to prejudice diplomatic relations between the UK and a foreign government and where its disclosure would be likely to prejudice the operation of immigration control.

#### **Refugees: Syria**

**Baroness Sheehan [HL6967]** To ask Her Majesty's Government how many refugees have been brought to the UK under the Syrian Vulnerable Persons scheme; how many of those refugees were children; and where within the UK those refugees have been dispersed.

**Reply from Lord Bates:** The Home Office is committed to publishing data in an orderly way as part of the regular quarterly Immigration Statistics, in line with the Code of Practice for Official Statistics. The next set of figures will be in the quarterly release on 26 May 2016 and will cover the period January – March 2016. Latest statistics published on 25 February 2016 confirms in 2015, a total of 1,194 people were resettled the Syrian Vulnerable Persons Resettlement Scheme (VPRS) including 1,085 who arrived in the last quarter of 2015. Of those resettled under the scheme in 2015, 605 were under 18 years old. Resettlement under the Syrian VPRS by local authorities is voluntary. It is a matter for each local authority to decide whether they want to publish the fact of their participation and the numbers of refugees they take.

### Asylum: Deportation [correction to answer given in October 2015]

**Lord Roberts of Llandudno** [HL2297] To ask Her Majesty's Government how many asylum seekers were deported from the United Kingdom in (1) 1990, (2) 2000, (3) 2010, and (4) 2014, on reaching the age of 18.

**Reply from Lord Bates:** The Home Office does not keep electronic records on removals going as far back as 2000. Records of removals on the Immigration Database only go back to 2006. In 2010, 778 failed asylum seekers were removed after reaching the age of 18. In 2014, 445 failed asylum seekers were removed after reaching the age of 18.

**Simon Danczuk** [904227] To ask the Secretary of State for the Home Department, what recent assessment he has made of the effectiveness of his Department's arrangements with local authorities for the settlement of asylum seekers.

**Reply from James Brokenshire:** The Home Office maintains an active partnership with local governments across the UK and funds Strategic Migration Partnerships to plan for the most appropriate voluntary agreements for the dispersal of asylum seekers, and the integration of Syrian refugees.

We continue to work closely with a wide range of local authorities to increase the number of areas that accommodate and support people seeking asylum and protection – every local authority is encouraged to contribute to ensure a reasonable spread across the whole of the UK.

**Lord Lansley** [HL6961] To ask Her Majesty's Government what proportion of asylum claims resolved after six months were found to be well-founded in the latest period for which the statistics are available.

**Reply from Lord Bates:** In 2015 there were a total of 10,199 asylum claims which were concluded six months or more after their initial application date. Of these, 4,620 claims were found to be entitled to a grant of asylum based on a well-founded fear of persecution.

Charlotte Leslie [31773] To ask the Secretary of State for the Home Department,

pursuant to the Answer of 25 February 2016 to Question 27389, what assessment her Department has made of the ability of failed asylum seekers to fund travel to their country of origin.

**Reply from James Brokenshire:** Migrants in the UK without permission, including those who have failed in a claim for asylum, are expected to leave the UK promptly and voluntarily. Those who need help purchasing a ticket or organising their travel can contact the Voluntary Return Service that came into effect on 1 January, who can provide assistance as appropriate. Subject to the bespoke needs of the individual or family, reintegration support in the country of origin may also be provided. Those individuals who do not leave voluntarily will be forcibly removed.

#### **Deportation: EU Nationals**

**Anne Main** [31329] To ask the Secretary of State for the Home Department, how many nationals of other EU member states are awaiting deportation from the UK.

**Reply from James Brokenshire:** The removal of foreign national offenders (FNOs) has been increasing year on year since 2010. In 2015, 5,602 FNOs were removed, the highest number in a year since records began in 2009.

As of December 2015, there were 4,217 EEA foreign national offenders awaiting deportation.

**Anne Main** [31404] To ask the Secretary of State for the Home Department, whether she has instructed the deportation of any nationals of other EU member states on public protection grounds in each of the last five years.

**Anne Main** [31475] To ask the Secretary of State for the Home Department, how many nationals of other EU member states who have served custodial sentences have been deported back to their country of nationality at the end of their sentence.

**Reply from James Brokenshire:** The Home Office seeks to deport EEA nationals or their family members on grounds of public policy or public security where that person's conduct represents a genuine, present and sufficiently serious threat affecting one of the fundamental interests of society.

The table below shows the number of EEA nationals deported on the basis of a criminal conviction, where their presence in the UK is not considered conducive to the public good.

### Human Trafficking

**Kate Osamor** [31363] To ask the Secretary of State for the Home Department, what recent steps she has taken to tackle human trafficking into the UK at source.

**Reply from Karen Bradley:** We are committed to tackling all forms of modern slavery, including human trafficking. The Government has secured commitment from other governments and institutions, including the UN, the Commonwealth and the EU, to tackle modern slavery. We have successfully lobbied for the establishment of the first ever UN Sustainable Development Goal to end modern slavery. We are also working bilaterally with priority countries to deepen law enforcement cooperation.

The Work in Freedom programme is helping to prevent trafficking of girls and women from South Asia. We have also supported the work of the Independent Anti-Slavery Commissioner, who has visited source countries and identified further opportunities for prevention activity. Our world-leading Transparency in Supply Chains provision in the Modern Slavery Act 2015 will encourage business to eradicate slavery from global supply chains.

#### The following two questions both received the same answer

**Paul Biomfield** [31872] To ask Mr Chancellor of the Exchequer, what training is provided to HM Revenue and Customs national minimum wage inspectors on identification and investigation of cases of human trafficking.

#### Slavery

**Paul Blomfield** [31878] To ask Mr Chancellor of the Exchequer, how many (a) enforcement actions have been undertaken by HM Revenue and Customs (HMRC) involving victims of modern slavery and (b) victims of modern slavery HMRC recovered national minimum wage arrears for in each of the last five years; and how much in national minimum wage arrears HMRC has recovered for victims of modern slavery in that period.

**Reply from David Gauke:** HM Revenue and Customs (HMRC) has developed a specific training package targeting Modern Slavery and Human Trafficking which is mandatory for all visiting officers. This training advises officers on the indicators to look for and the responses to take where exploitation is suspected.

HMRC participates in multi-agency investigations into cases of Modern Slavery where there are potential tax or National Minimum Wage (NMW) offences. Since February 2015, HMRC has opened 73 tax investigations in cases where Modern Slavery is suspected. HMRC does not collate specific data on any NMW arrears identified in cases involving Modern Slavery.

#### **Human Trafficking**

**Sarah Champion** [31936] To ask the Secretary of State for the Home Department, what steps the Government has taken to strengthen its data collection strategy to help combat human trafficking.

**Reply from Karen Bradley:** We are strengthening data collection on human trafficking and other forms of modern slavery in several ways. In the Modern Slavery Act we introduced a duty on named public authorities to notify the Home Office every time they have reasonable grounds to believe they have encountered a victim of modern slavery.

These notifications can be anonymous so that data is collected even if the potential victim does not want to engage with the authorities. We are reviewing the National Referral Mechanism form, so that it better captures key data about potential victims and perpetrators. Polaris and Unseen UK are working with other NGOs and law enforcement to launch an enhanced modern slavery helpline later this year which will capture more data and help to shine a light on the scale and nature of this appalling crime.

**Tasmina Ahmed-Sheikh (1290) Journeys to Europe Report** – That this House welcomes the report of the Overseas Development Institute, Journeys to Europe: the role of policy in migrant decision-making, published in February 2016, which recommends three key policies to lead to a better management of and response to the migration crisis in Europe; notes that these polices are to make journeys safer, to create a faster, fairer EU asylum system and, most importantly, to make the most of migration; calls on the Government to do all it can to publicly communicate the social and economic benefits of migration, to encourage circular migration and to invest in economic integration programmes for new arrivals; and further calls on the Government to work with the UK's friends in the EU to help make journeys to Europe safer, rather than to pursue its isolationist agenda in Europe.

**Danny Kinahan** [31196] To ask the Secretary of State for Business, Innovation and Skills, if he will take steps to tackle the lower expected offer rate to Asian, Black, Mixed and Other ethnic groups higher education applicants.

**Reply from Joseph Johnson:** My right hon. Friend the Prime Minister has set a goal of increasing by 20% the number of BME students in higher education by 2020. Entry rates for 18 year olds in each ethnic group increased in 2015,

reaching the highest recorded values for each group. Between 2009 and 2015, the entry rate for young people in the Black ethnic group increased by over 40 percent proportionally. The Government has introduced a number of policies, including those set out below, to achieve my right hon. Friend the Prime Minister's goal.

We recently announced that universities would be required to publish admissions and retention rate by gender, ethnic background and disadvantage. Greater transparency will expose where offer rates for students from the poorest and black and minority backgrounds are particularly low and help to encourage universities to take further action.

In addition, UCAS are consulting on making applications to university name-blind from 2017 to make sure that everyone, no matter what their background, is treated equally.

I have asked Universities UK to establish an expert advisory group on social mobility to provide further advice in this area.

**Reply from Nick Boles:** Ensuring people from black and minority ethnic (BME) backgrounds can find work and progress through the labour market is an important step in tackling economic inequality. The Government has embarked on an ambitious programme to increase opportunity in the labour market for all those from BME backgrounds. This includes increasing employment rates, improving access to universities and ensuring more people from BME backgrounds start an apprenticeship.

As part of this, my right hon. Friend the Secretary of State for Business, Innovation and Skills is chairing a new Inter-Ministerial Group tasked with improving opportunity and progression in the labour market for those from BME backgrounds. The Government has also asked Baroness Ruby McGregor-Smith to undertake a review into the obstacles faced by BME groups in the labour market, from recruitment through to the executive level. This will complement Sir John Parker's review considering BME representation at the very highest levels of business.
