Immigration

Shabana Mahmood [34453] To ask the Secretary of State for the Home Department, how many applications for discretionary leave to remain have been (a) received, (b) rejected and (c) treated as invalid in the latest period for which figures are available; and how many such applications were rejected owing to (i) failure to pay the fee and (ii) refusal of fee waiver.

Reply from James Brokenshire: Our records indicate that 12,656 (a) applications for further discretionary leave to remain were received from 1 January 2015 to 31 December 2015.

164 (b) were rejected for failure to pay the fee or Immigration Health Surcharge (IHS) and

175 (c) rejected as invalid.

Of the 164 rejections 55 (i) were rejected owing to failure to pay the application fee and 89 (ii) owing to refusal of a fee waiver. 20 were also rejected solely due to failure to pay the IHS.

Notes:

- The data relates to applications for Further Discretionary Leave to Remain.
- The 12,656 (a) applications were made by 12,430 people (due to repeat applications).
- The data provided is provisional management information that is subject to change. It has not been assured to the standard of Official Statistics.
- All of the statistics referred to in the answer come with necessary caveats about the accuracy of the data. The data provided to answer (b), (c), (i) and (ii) above has been drawn from manual records on the Home Office Case Information Database, which, as with any large scale recording system, is subject to possible human errors with data entry and processing.

Immigration: EEA Nationals

William Wragg [35279] To ask the Secretary of State for the Home Department, how many EEA nationals have moved to the UK since 1 February 2004 and (a) are now eligible for and (b) have been granted permanent residency status by virtue of being resident for at least five years.

Reply from James Brokenshire: European Economic Area (EEA) nationals have free movement rights in other Member States, but these rights are not unconditional. An EEA national does not gain the right of permanent residence merely by living in the UK; the right is only gained once they have exercised a Treaty right continuously for five years by working, being self-employed, self-sufficient or a student. EEA nationals who are not working or self-employed must have comprehensive sickness insurance and sufficient resources to support themselves and their families to avoid becoming a burden on the social assistance system.

EEA nationals with the right of permanent residence may apply for documentation confirming that right. The table below shows the number granted a document certifying permanent residence since 2006, when such documentation was introduced.

Immigration: Appeals

Lord Lester of Herne Hill [HL7970] To ask Her Majesty's Government why they propose to increase immigration and asylum chamber fees, and what assessment they have made of the likely impact of those increased fees on access to justice.

Reply from Lord Faulks: We're protecting the most vulnerable from any fee increase, including those who receive asylum support and cases involving children being supported or housed by a local authority. But it is also right that the taxpayer does not subsidise those who choose to challenge a decision made by the Home Office before the Tribunal.

We have a duty to the public to reduce the deficit and ensure sustainable funding for Her Majesty's Courts and Tribunal Service.

We have published a full impact assessment alongside the consultation document published on the Government website.

Visas: Overseas Students

The Marquess of Lothian [HL7934] To ask Her Majesty's Government, further to the Written Answer by Immigration Minister, James Brokenshire, on 14 March (HC29894), and in the light of the figures released by the Home Office on the number of non-EU students who had their visas curtailed in the three years to the end of December 2015 as part of their strategy to clamp down on immigration abuse, how many educational institutions were affected, and whether any of those educational institutions remain open to British and EU students.

Lord Ahmad of Wimbledon: It is not possible to run a report linking each curtailment decision to a specific educational institution. To provide the information requested would require a manual check of every curtailment in the cohort referenced which would incur a disproportionate cost.

The Immigration Rules allow for leave of an individual to be curtailed for a variety of reasons, not only as a result of an institution losing its sponsor licence but also, for example, is a student drops out of their course of study and is reported to the

Home Office by the sponsor. Sponsors have a number of reporting duties in respect of their students, and these can be found here: https://www.gov.uk/government/publications/sponsor-a-tier-4-student-guidance-for-educators

The Home Office does not close down educational institutions. The revocation of a Tier 4 sponsor licence means that an educational institution can no longer recruit non-EEA students under the Points Based System. The institution may, however, continue to operate and teach UK and EEA students. The Home Office does not routinely monitor educational institutions who do not hold a sponsor licence.

Refugees

Lord Ouseley [HL7926] To ask Her Majesty's Government how they are liaising with local public service providers to ensure that all incoming refugees as part of the refugee resettlement policy are appropriately assisted within local community cohesion programmes.

Reply with Lord Ahmad of Wimbledon: The Government and the Local Government Association continue to work closely with individual local authorities who are volunteering to take refugees.

Local authorities are required to provide refugees they resettle with a 12 month support package tailored to their individual needs which includes; accommodation, casework support and integration assistance, medical and social care needs and English language tuition. The first 12 months of a refugee's resettlement costs will be funded by central government from the Overseas Development Aid budget.

Prime Minister's Questions: Refugee children

Angus Robertson: Last week, the Prime Minister took issue when I mentioned unaccompanied Syrian refugee children in Europe and the Kindertransports of the 1930s. Since then, he has been written to by Sir Erich Reich, the chairman of the Association of Jewish Refugees' Kindertransport special interest group, who said: "The echoes of the past haunt many of my fellow Kinder and I whose fate similarly rested with members of the British parliament. I feel it is incumbent on us to once again demonstrate our compassion and human-kindness to provide sanctuary to those in need."

Why has it taken so long, and the threat of a parliamentary defeat, for the Prime Minister to begin changing his mind?

Reply from the Prime Minister: First, let me pay tribute to the gentleman mentioned by the right hon. Gentleman. Let us be clear that no country has done more than Britain to help when it comes to Syrian refugees. No country has raised more money, and only the United States has spent more money. I want us to proceed with as much support from across the House as we can. I think it is right to stick to the principle that we should not be encouraging people to make this dangerous journey. I think it is right to stick to the idea that we keep investing in the refugee camps and in neighbouring countries. I also think it is right not to take part in the EU relocation and resettlement schemes, which have been, in my view, a failure.

We are already taking child migrants in Europe with a direct family connection to the UK, and we will speed that up. I am also talking to Save the Children to see what more we can do, particularly with children who came here before the EU-Turkey deal was signed, because I say again that I do not want us to take steps that will encourage people to make this dangerous journey. Otherwise, our actions, however well-meaning they will be, could result in more people dying, rather than more people getting a good life.

Angus Robertson: Last week, I accused the Prime Minister of walking by on the other side when he stoutly defended his then policy, opposing further help for unaccompanied refugee children in Europe. If what we are hearing now is the beginnings of a U-turn, I very much welcome it, as I am sure do Members from all parts of the House. May I encourage him to think more about what can be done, given that the Kindertransport helped 10,000 children from Europe? Finally, may I ask him to take the opportunity to thank Lord Alf Dubs and all campaigners who have worked so hard for the UK to live up to the example and the spirit of the Kindertransport?

Reply from the Prime Minister: I certainly think that all those people deserve recognition for the work they have done to put this issue so squarely on the agenda, but let me just say again that I do reject the comparison with the Kindertransport. I do so for this reason: I would argue that what we are doing primarily—taking children from the region, taking vulnerable people from the camps, going to the neighbouring countries and taking people into our country, housing them, clothing them, feeding them and making sure they can have a good life here—is like the Kindertransport.

I think that to say that the Kindertransport is like taking children today from France, Germany or Italy—safe countries that are democracies—is an insult to those countries. But, as I have said, because of the steps we are taking, it will not be necessary to send the Dubs amendment back to the other place; the amendment does not now mention a number of people. We are going to go around the local authorities and see what more we can do, but let us stick to the principle that we should not be taking new arrivals to Europe.

Prime Minister's Questions: Refugee children

Edward Leigh: The Christian Yazidi and Shi'a children in Syria are suffering from genocide carried out by Daesh, and we should recognise it as such. May I urge the Prime Minister to do more to replicate the Kindertransport of the 1930s? That is what we are doing in taking children directly from the camps in Syria. If we were to take 16-year-olds from a safe environment in Europe, we would simply be causing more misery and encouraging the people traffickers.

Reply from the Prime Minister: My hon. Friend has asked me two questions. One is whether there is more we can do to label what has happened as genocide.

That has always been done under a legal definition, but there is a very strong case here for saying that it is genocide, and I hope that it will be portrayed and spoken of as such.

On the issue of the Kindertransport, I agree with my hon. Friend. We have an enormous amount of which we can be proud—the money that we have put into the camps, and the fact that we raised more in London on one day than any humanitarian conference has ever raised in the history of the world. We have a very strong record. We will do more for children who were already registered in Europe before the EU-Turkey deal, but the principle that we should try to cling to is that we should not do anything that encourages people to make the perilous journey. That has been the cornerstone of our policy and it should remain the case.

Refugees: Calais

The following two questions both received the same answer

Barry Sheerman [34219] To ask the Secretary of State for the Home Department, what recent estimate her Department has made of the number of children in Calais who are waiting to be reunited with their families in the UK.

Barry Sheerman [34220] To ask the Secretary of State for the Home Department, what the average length time taken to reunite stranded minors with their families in the UK once they have been identified in Calais has been in each of the last three years.

Reply from James Brokenshire: There is no official estimate of the number of children in Calais, this is primarily a matter for the French authorities. It is only possible to assess whether an individual has links to the UK that could enable a transfer on family unity grounds once they make an application for asylum in France.

Once an asylum claim is lodged in France the Dublin Regulation procedure requesting the UK to take charge of a child on family unity grounds takes place very quickly, often in a matter of weeks, subject to consideration of the evidence in each individual case. An average time is not available for each of the last three years.

Since February 2016 the UK has accepted 30 family reunification applications from minors in France of which 23 have already been transferred to the UK.

Asylum: Children

The following two questions both received the same answer

Lord Hylton [HL7890] To ask Her Majesty's Government why less than 30 of the 157 children at Calais and identified as eligible for family re-union have so far been admitted to the UK; and what plans they have to improve the processes for re-union.

Asylum: EU Law

Lord Hylton [HL7892] To ask Her Majesty's Government what assessment they have made of Amnesty International's report *Trapped in Greece: an avoidable refugee Crisis* of April 2016, in particular concerning the EU and the Dublin III Regulations on Family Reunion.

Reply from Lord Ahmad of Wimbledon: There is no official estimate of the

number of children in Calais; this is primarily a matter for the French authorities. It is only possible to assess whether an individual has links to the UK that could enable a transfer on family unity grounds once they make an application for asylum in France.

Once an asylum claim is lodged in another Member State, the Dublin Regulation procedure requesting the UK to take charge of a child on family unity grounds can take place very quickly, often in a matter of weeks, subject to consideration of the evidence in each individual case.

Since February 2016 the UK has accepted 30 requests from France under the Dublin Regulation to take charge of asylum seeking children on family grounds of which 23 have already been transferred to the UK. We are working closely with the French Government and NGOs, including on a joint communications campaign to inform migrants of their options and we provided a senior UK asylum official to the French Government who has put processes in place to support an efficient procedure.

Immigrants: Detainees

Lisa Cameron [35734] To ask the Secretary of State for Health, what steps he is taking to ensure that treatment is provided to detainees held in immigration removal centres who are (a) self-harming and (b) experiencing post-traumatic stress disorder.

Reply from Ben Gummer: People detained in immigration removal centres (IRCs) should receive an equivalent range and quality of treatment and services for their health needs as people in the community, according to their clinical needs.

Health care in IRCs in England is commissioned by NHS England, who only commission evidence-based treatments approved by the National Institute for Health and Care Excellence (NICE). NICE provides guidance on the treatment of people who self-harm, which healthcare professionals in IRCs are expected to take into account. NICE guidance is available at:

Robert Jenrick [36015] To ask the Secretary of State for the Home Department, what proportion of racially motivated attacks in England and Wales targeted Jews in each of the last five years.

Reply from Karen Bradley: The Home Office does not hold the requested information. The Home Office receive data on hate crimes recorded by the police in England and Wales for the five centrally monitored strands (race, religion, sexual orientation, disability and gender identity) but these data cannot be broken down by race or religion of the victim and cover all offences, not just "attacks". The most recently available data relate to the financial year 2014/15 and can be found at:

From April 2016, the Home Office will collect a breakdown of religion-based hate crime data from the police to help forces build community trust, target their resources and enable the public to better hold them to account. Reply from Robert Buckland: The Whilst the Crown Prosecution Service (CPS) does flag cases on its case management system that are identified as racial or religious hate crimes, it does not maintain a central record of prosecutions for offences specifically relating to anti-semitism. Such information could only be obtained through a manual search of records which would incur disproportionate cost.

anti-Semitic incident at King's College London on 19 January 2016; and whether any people have been prosecuted for their connection with that incident.

Reply from Joseph Johnson: There is no place in our society, including higher education, for bigotry, hatred and any form of racism such as anti-Semitism. We expect universities to act swiftly to investigate and address any anti-Semitic incidents reported to them. Responsibility for ensuring students do not face harassment, abuse or violence rests with individual institutions, as a clear part of their duties under the 2010 Equality Act.

In November I asked Universities UK to set up a task force to consider what more can be done to address harassment on campus, including on the basis of religion and belief. The Union of Jewish Students are part of the advisory group.

In relation to the event organised by the Kings College Israel Society, officials in my Department and in the Higher Education Funding Council for England asked Kings College what action they had taken in response, and I have met with the Principal to discuss this incident. It is completely unacceptable for legitimate free speech to be shut down on our universities campuses through intimidation and harassment and we will continue to fully support university leaders who take a strong stance on this.

Lord Patten [HL8001] To ask Her Majesty's Government what is their assessment of anti-semitism within bodies representing students in English universities.

Reply from Baroness Evants of Bowes Park: The Government is clear that there is absolutely no place in higher education or anywhere else in society for bigotry, hatred or any form of racism such as anti-Semitism.

Recent reports of anti-Semitism are extremely concerning and must be met with a decisive response. We expect all bodies with a role in English higher education to be absolutely clear in their opposition to racism in all its forms, and to have robust policies in place to tackle such hatred and support victims.

At the Government's request, Universities UK has set up a taskforce to examine what more can be done to tackle harassment and hate crime on campus, including anti-Semitism.

Attendance at the Forums is fluid to ensure Ministers can hear from a wide range of partners from a variety of backgrounds.

Reply from Karen Bradley: On 1 April the Government published updated multiagency guidance on female genital mutilation (FGM), which we have placed on a statutory footing for the first time. The guidance applies to all frontline professionals in England and Wales, and includes steps police and social services should take when a girl is identified as being at risk of FGM. The guidance will help increase awareness of FGM; improve compliance with good practice in order to afford victims of this terrible abuse the greatest possible protection. It will also help to support effective training of frontline professionals and a more effective multi-agency response. The guidance is available on GOV.uk

The Government has introduced FGM Protection Orders through the Serious Crime Act 2015 which can be used to protect a potential victim or other family member who may be at risk of FGM. Data released on 31 March 2016 shows that 32 FGMPOs were issued between their introduction in July 2015 and December 2015.

Female Genital Mutilation

Catherine West [35905] To ask the Secretary of State for the Home Department, how many cases of female genital mutilation have been reported in (a) London and (b) England and Wales in each of the last five years.

Reply from Karen Bradley: Female Genital Mutilation (FGM) is a crime and it is child abuse. We will not tolerate a practice that can cause extreme and lifelong physical and psychological suffering to women and girls.

The most recent NHS data published on 8 March shows that between October – December 2015 there were 1,316 newly identified cases of FGM within the NHS. A breakdown of this information by region is available at: www.hscic.gov.uk, as are earlier reports.

In addition, data released by the Ministry of Justice on 31 March shows that since their introduction in July 2015, 32 FGM Protection Orders were issued between July and December 2015.

A new mandatory reporting duty requiring regulated health and social care professionals and teachers to report known cases of FGM in under 18s to the police came into force on 31 October 2015. The duty will help increase the number of referrals to the police in order to deter perpetrators and in turn prevent this appalling crime from happening.
