Scottish Parliament Motion

S5M-00524 Christina McKelvie: World Refugee Day—That the Parliament welcomes 20 June 2016 as World Refugee Day; understands that the UN refugee agency, UNHCR, believes that now is the time to show world leaders that the public stands with refugees and will use the day to launch its petition, #WithRefugees, to send a message to governments that they must work together and do their fair share to help; notes that the petition also asks all governments to ensure that every refugee child gets an education, all refugee families have somewhere safe to live and that every refugee can work or learn new skills to make a positive contribution to their adopted community; recognises what it sees as the need for all to stand together to recognise the strength, courage, and resilience of millions of displaced peoples across the world, and believes that compassion must be at the forefront of how governments across the world work to support refugees.

Refugees: Children

Baroness Sheehan [HL487] To ask Her Majesty's Government, further to the remarks by Lord Bates on 21 March (HL Deb, col 2149), what evidence they have that allowing child refugees to sponsor relatives would "create a situation that encourages children to risk hazardous journeys to and across Europe".

Reply from Lord Ahmad of Wimbledon: There are a range of factors that affect migrants decisions to leave their countries and travel across Europe to seek asylum. The Government believes that allowing children to sponsor relatives would create further incentives for children to be encouraged, or even forced, to leave their family and risk hazardous journeys to the UK in order to act as sponsors.

Asylum

David Lammy [40155] To ask the Secretary of State for the Home Department, how many asylum seekers who were granted refugee status were not provided with a (a) biometric residence permit and (b) National Insurance number by her Department before their 28-day asylum support ceased in the latest period for which figures are available.

Reply from James Brokenshire: If an asylum seeker is granted refugee status written confirmation that there are no longer any restrictions on them living and working in the UK is posted to them. A Biometric Residence Permit and National Insurance number is also sent, which can then be used as evidence of their immigration status and in support of any application for benefits.

Statistics on the number of such cases are not recorded on centrally collated statistical databases and could only be obtained at disproportionate cost by examination of individual case records.

Asylum: Children

David Lammy [40120] To ask the Secretary of State for the Home Department, how many unaccompanied child refugees have been reunited with relatives in the UK since the announcement, Unaccompanied asylum-seeking children to be resettled from Europe, on 4 May 2016.

Reply from James Brokenshire: As announced by the Prime Minister on 4 May and now reflected in the Immigration Act 2016, we will work to admit unaccompanied refugee children to the UK from elsewhere in the EU, where this is considered to be in the child's best interests.

As the legislation sets out, we need to consult with local authorities first and we are also working closely with NGOs, the UNHCR, UNICEF and relevant Member States to establish suitable processes to implement this initiative.

Ministers and senior officials are in ongoing discussions with Greece, Italy and France to identify and transfer to the UK unaccompanied refugee children where it is in their best interests. We are also consulting local authorities, non-governmental organisations and UNHCR. In addition, we have worked with France to improve the operation of the Dublin family reunification process, and accepted over 30 transfer requests between January and the end of April with many more cases in train.

We are committed to act as quickly as we can but we must take the necessary time to ensure we have the capacity to support those who are resettled. We must

Detainees: Children

Rushanara Ali [40318] To ask the Secretary of State for the Home Department, how many children in England have been detained in immigration removal centres in each year since 2015; how many of those children so detained have been deported; and how many children are still in detention.

Reply from James Brokenshire: In 2015, 133 children left detention, of which: 50 were removed, 81 were granted temporary admission or release and 2 for other reasons. As at 31 December there were no children held in detention.

The Home Office publishes quarterly and annual statistics on the number of persons removed or departed voluntarily from the UK within Immigration Statistics. Education

Monica Lennon: To ask the Scottish Government how it will ensure that its educational attainment strategy reflects the additional challenges that young (a) BME, (b) disabled and (c) LGBTI people can face. (S5W-00595)

Reply from John Swinney: The Education (additional support for learning) (Scotland) Act 2004 requires education authorities to identify, provide and review the additional support needs of their pupils. An additional support need may arise for any reason and may be of short or long-term duration. The additional support provided is intended to overcome barriers to learning which may arise as a result of learning environment, health or disability, family circumstances and social and emotional factors. The Scottish attainment challenge was established to close the educational attainment gap between young people from our most and least deprived communities. The attainment Scotland fund, currently provides funding to those primary schools and authorities identified as having the highest concentrations of The Scottish index of multiple deprivation (SIMD) one and two. We will also allocate additional funding to schools on the basis of the number of eligible children that meet the criteria for free school meals. If a BME, disabled or LGBTI child's educational attainment is affected by poverty related disadvantage, they will also benefit from increased support through the Scottish attainment challenge. This is in addition to existing policies aimed at addressing the support required by other groups of young people.

Female Genital Mutilation

Baroness Tonge [HL629] To ask Her Majesty's Government whether they have instigated, or plan to instigate, undercover police investigations into potential female genital mutilation perpetrators in the UK.

Reply from Lord Ahmad of Wimbledon: How the police enforce the law in any particular case, including decisions on arrests, is an operational matter. This is in line with their duties to keep the peace, protect communities and prevent the commission of offences, working within the provisions of the legal framework set by Parliament. It is for the police to decide what might assist them in enforcement. The instigation of undercover investigations and the deployment of undercover officers is an operational matter for chief officers. Female Genital Mutilation (FGM) is a crime and it is child abuse. We will not tolerate a practice that can cause extreme and lifelong physical and psychological suffering to women and girls. To support the police in investigating cases of FGM, in March 2015 the College of Policing published Authorised Professional Practice and on 1 April we published updated multi-agency guidance on FGM for all professions, which we have put on a statutory footing to support compliance.

To support the police in investigating cases of FGM, in March 2015 the College of Policing published Authorised Professional Practice and on 1 April we published updated multi-agency guidance on FGM for all professions, which we have put on a statutory footing to support compliance.
