### Scottish Parliament Question

#### Asylum seekers

**Linda Fabiani:** To ask the Scottish Government whether any dawn raids on the homes of asylum seekers have been carried out since May 2015. (S5W-00998)

**Reply from Angela Constance:** The Scottish Government does not hold this information. The Scottish Government is fundamentally opposed to dawn raids and believes asylum seekers must be treated humanely and sensitively at every stage of the asylum process. This is particularly important in cases where claims are not successful, where people are returned to their countries of origin and where children are involved.

## UK Parliament Ministerial Statement and Q&A

#### EU Nationals: UK Residence

**The Minister for Immigration (James Brokenshire):** EU nationals make an invaluable contribution to our economy, our society and our daily lives. They should be assured that, as the Prime Minister and the Home Secretary have repeatedly said, there will be no immediate change in their status in the UK. The Prime Minister has made it clear that decisions on issues relating to the UK's exit will be for a new Prime Minister. I am therefore not in a position to make new policy announcements this afternoon.

The discussions that we have with the European Union to agree the arrangements for the UK's exit will undoubtedly reflect the immense contribution made by EU citizens to our economy, our NHS and our schools, and in so many other ways; but they must also secure the interests of the 1.2 million British citizens who live and work elsewhere in the EU.

The Home Secretary was clear yesterday when she said that we should seek to guarantee that the rights of both groups were protected, and that this would be best done through reciprocal discussions with the European Union as part of the negotiations to leave the EU. It has been suggested that the Government could now fully guarantee EU nationals living in the UK the right to stay, but that would be unwise without a parallel assurance from European Governments regarding British nationals living in their countries. Such a step might also have the unintended consequence of prompting EU immigration to the UK.

It is in the best interests of all for the Government to conduct detailed work on this issue, and for the new Prime Minister to decide the best way forward as quickly as possible. In the meantime, let me stress that EU nationals continue to be welcome here. We have seen some truly abhorrent hate crimes perpetrated against EU nationals in the past week or so, and we will not stand for attacks of that kind. They must be, and will be, tackled in the strongest possible terms.

EU nationals can have our full and unreserved reassurance that their right to enter and to work, study and live in the UK remains unchanged, but to pre-empt future discussions at this point would risk undermining our ability to protect the interests of EU and British citizens alike, and to secure the best outcome for both.

### UK Parliament Questions

#### Immigration Act 2016

*The following two questions both received the same answer*

**Chris Stephens** [41574] To ask the Secretary of State for the Home Department, whether she plans to extend or give effect to the provisions in the Immigration Act 2016 in respect of (a) residential tenancies, (b) transfer of responsibility for unaccompanied children and (c) limitations on local authority support for people who have been refused asylum, adult migrant care leavers and other migrants.

#### Immigration Act 2016: Scotland

**Chris Stephens** [41575] To ask the Secretary of State for the Home Department, if she will place in the Library copies of any correspondence with Ministers of the Scottish Government since the passing of the Immigration Act 2016 relating to that Act.

**Reply from James Brokenshire:** The Immigration Act 2016 received Royal Assent on 12th May 2016. Provisions in the Act that create a mechanism to transfer responsibility for unaccompanied asylum seeking children from one local authority to another in England came into force on 31st May. Announcements about implementation of the other provisions mentioned and extensions to other parts of the UK will be made in due course once discussions with the Devolved Administrations have taken place. There has been no correspondence with Ministers of the Scottish Government relating to the Immigration Act 2016 since the Act received Royal Assent.

#### Immigrants: Health Services

**Martyn Day** [41770] To ask the Secretary of State for the Home Department, what assessment she has made of the effect of the immigration health surcharge for visa applications on the number of visas applied for; how much funding has been raised by that surcharge since its introduction; and if she will make a statement.

**Reply from James Brokenshire:** There is no evidence to suggest that there has been a reduction in visa applications as a result of the introduction of the Immigration Health Surcharge.

A summary of Immigration Health Surcharge income collected during 2015-16 will be published shortly in the Home Office annual report and accounts.

#### Visas: EU Nationals

**Alison Thewliss** [41445] To ask the Secretary of State for the Home Department, what plans her Department has to change visa requirements for EU citizens who wish to travel, study and work in the UK.

**Reply from James Brokenshire:** There will be no immediate changes in the circumstances of European nationals who wish to travel, study and work in the UK.

EU nationals do not currently need to apply for an entry visa, residence card or a permanent residence card in order to enjoy their free movement rights and responsibilities.

#### Pupils from Non-UK EU Countries

**Patrick Grady:** 6. If she will make it her policy that all school children who are non-UK EU nationals retain access to the education system in the event of the UK leaving the EU. [905614]

**Reply from the Secretary of State for Education (Nicky Morgan):** As a matter of principle all children resident in the United Kingdom receive a free state school education. That provision goes back to 1880, when compulsory attendance at school to age 10 was introduced in England and Wales. The UK remains a member of the EU until the article 50 negotiations have concluded, which could take two years or more. Until the process is completed, nothing will change. Let me tell the hon. Gentleman my view, because the Home Secretary is about to make a statement on this issue: I think that EU citizens already here, including children, should have the right to remain.

**Patrick Grady:** I thank the Secretary of State for that answer, but does she recognise the impact that such uncertainty is having on young people and their education? The First Minister, the National Association of Head Teachers and others are seeking precisely these assurances, so can she give an assurance that children from EU countries will be allowed to complete their education and will not be used as bargaining chips in negotiations about Brexit?

**Reply from Nicky Morgan:** The hon. Gentleman makes a very powerful case. There is obviously an awful lot to discuss in the light of the result of 23 June, which is not the result that I campaigned for. I completely accept his point that we should of course make sure that children of non-UK EU nationals resident here are educated.

#### Cost of Interpreters

**David Davies:** 9. What the cost to the public purse was in 2015-16 of providing interpreters for people using the NHS who did not speak English.[905661]

**Reply from the Parliamentary Under-Secretary of State for Life Sciences (George Freeman):** Until now, data on NHS foreign language translation and interpretation have not been gathered centrally, but I am delighted to say that, as a result of the representations of my hon. Friend and other colleagues, we have changed that, and NHS England is now conducting a major piece of work looking at both commissioning and provider organisations' expenditure as part of a procurement review. It is worth saying that in view of the importance of effective communication in good diagnosis, informed consent, safeguarding and public health, it is in all our interests that all our patients understand what the doctors and clinicians are saying to them.

**David Davies:** I am grateful for that answer, but may I respectfully suggest to the Minister that if we are to have a serious discussion about the costs and the impacts of large-scale migration into the UK on the NHS, we must have access to figures on this cost and we should not have to wait months and months to get them? The figures must be out there somewhere.

**Reply from George Freeman:** My hon. Friend will find no more passionate champion of good data in the NHS than myself. He makes an important point about getting on with this, and I have already signalled to the team in NHS England that we will need to get a grip on this quickly, not least so that the new Administration implementing the Brexit decision will know the figures and have them to hand.

**Philip Davies:** I did a recent freedom of information request to my local hospitals to find

out the cost of interpreters. Airedale hospital reported that last year the cost was almost £200,000 and I suspect that, when I receive an answer, it will be even higher at Bradford royal infirmary. This money could be better spent on patient care. Surely it is better for these patients, if they want to contribute to the British way of life, to be able to speak English themselves. What is the Minister's Department doing with other Government Departments to make sure that people who live in this country can speak English so that money for the NHS goes to the purposes for which it was intended?

**Reply from George Freeman:** Let me gently and respectfully point out that those who work in the NHS and the leaders responsible for it have made it very clear how dependent it is on people who come to work here in the NHS from overseas. Under the terms of our own mandate and indeed our own laws, the NHS has a duty to make sure that it provides proper diagnosis and treatment for all our citizens. For public health and safety, it is in nobody's interests for citizens of the UK not to be able to integrate, deal with and get proper diagnosis from the system. My hon. Friend's wider points about the speaking of English are well made, but they are not relevant to this particular question.

### Refugees: Syria

**Jim Cunningham** [41729] To ask the Secretary of State for the Home Department, what estimate she has made of the number of people who will be relocated through the Syrian Vulnerable Persons Relocation scheme in the next 12 months; and if she will make a statement.

**Reply from Richard Harrington:** We are continuing to work productively with local authorities and International Partners to deliver the Government's commitment to resettle 20,000 Syrian refugees by the end of this Parliament. We are on track to do this. The number resettled in a particular period will depend on a range of factors. This includes the number of referrals we have received from the United Nations High Commissioner for Refugees and the number of confirmed places we have received from local authorities that are suitable for the specific needs of those who have been accepted for resettlement. Progress on resettlement will be indicated in quarterly immigration statistics.

### Undocumented Migrants

**Gareth Thomas** [41687] To ask the Secretary of State for the Home Department, what assessment she has made of the systems for measuring levels of illegal immigration in other countries; and whether such systems could be applied to the UK; and if she will make a statement.

**Reply from James Brokenshire:** The Home Office published a report as part of the European Migration Network work programme entitled 'Practical Measures for Reducing Irregular Migration' (Toms and Thorpe, 2012) which discusses the various measures available to estimate illegal migration in the UK.

### Deportation

**Chris Law** [41177] To ask the Secretary of State for the Home Department, how many people have been forcibly removed on chartered flights in 2016 to date; and how many of those people had a criminal conviction in the UK.

**Reply from James Brokenshire:** Home Office records indicate that 718 individuals have been forcibly removed on charter flights in 2016. In at least 194 of these cases the primary reason for return was a criminal conviction in the UK. This is provisional management information that is subject to change. It has not been assured to the standard of Official Statistics.

### Asylum: Deportation

**Chris Law** [41178] To ask the Secretary of State for the Home Department, whether it is her Department's policy to prepare for the removal of asylum seekers from the UK before they have exhausted all legal remedies in their claim for asylum.

**Reply from James Brokenshire:** Section 77 of the Nationality, Immigration and Asylum Act 2002 prevents a person from being removed from the UK whilst a claim for asylum is pending, and section 78 of the 2002 Act has the same effect where an appeal is pending. In both cases this does not prevent the giving of directions for the person's removal or the taking of any other interim or preparatory action.

Where a person has claimed asylum and the claim has been refused preparations for removal can be made. Those preparations may involve gathering relevant information and applying for an emergency travel document.

### Deportation

**Chris Law** [41217] To ask the Secretary of State for the Home Department, what her Department's policy is on over-booking flights chartered for people being forcibly removed from the UK.

**Reply from James Brokenshire:** Charter flights are routinely overbooked to ensure the flight is fully utilised and delivers value for money. We reassess attrition rates for each flight on a monthly basis to ensure the number of individuals booked onto the flight who ultimately do not travel is kept to a minimum.

### Deportation

**Chris Law** [41218] To ask the Secretary of State for the Home Department, what her Department's practice is for the number of security guards per detainee aboard mass deportation charter flights.

**Reply from James Brokenshire:** Prior to each charter a risk assessment is undertaken for each detainee. This assessment will take into consideration many factors including history of non-compliance and medical issues. This information will be shared with the Home Office's overseas escort provider, Tascor, who will make a decision on the necessary detainee to escort ratio.

**Chris Law** [41221] To ask the Secretary of State for the Home Department, what the cost to the public purse of deportation by chartered flights has been in each of the last five years.

**Reply from James Brokenshire:** Home Office records indicate that the cost of chartering aircraft for removal flights over the past 5 years is as follows:

2011/12 - £8.5 million

2012/13- £13.8 million

2013/14 - £12.7 million

2014/15 - £13.2 million

2015/16 - £9.1 million

### Deportation

**Chris Law** [41223] To ask the Secretary of State for the Home Department, how many flights for the purposes of deporting people whose asylum or human rights claims were refused were chartered by the Government in each of the last five years.

**Reply from James Brokenshire:** Home Office charter flights are used to remove individuals who have been refused asylum in the UK, but also individuals who have committed other immigration and criminal offences. Home Office records indicate that there were 45 charters in 2012, 48 in 2013, 46 in 2014, 38 in 2015 and 18 to date in 2016.

In addition to charter flights the Home Office also removes people via scheduled commercial services.

This is provisional management information that is subject to change. It has not been assured to the standard of Official Statistics.

### Deportation

**Chris Law** [41307] To ask the Secretary of State for the Home Department, what her Department's policy is on having independent witnesses and monitoring groups aboard mass deportation charter flights.

**Reply from James Brokenshire:** Home Office records indicate that there were at least 1999 foreign nationals who, having been detained in a UK prison, were removed on charter flights in the past 5 years; 367 in 2012, 424 in 2013, 498 in 2014, 486 in 2015 and 224 in 2016 to date.

This is provisional management information that is subject to change. It has not been assured to the standard of Official Statistics.

Immigration Enforcement charter flights are regularly monitored by Her Majesty's Inspectorate of Prisons (HMIP) and the Independent Monitoring Board (IMB).

### Human Trafficking

**Henry Smith:** 2. What recent steps have been taken by the Church of England to tackle human trafficking. [905694]

**Reply from Caroline Spelman:** The Bishop of Derby has been at the forefront of working to tackle human trafficking and modern slavery within the Church. I had the pleasure of serving with him on the pre-legislative scrutiny Joint Committee on the draft Modern Slavery Bill. He has set up and been part of the Santa Marta process to improve collaboration between Churches and police forces in the detection of instances of human trafficking.

**Henry Smith:** ... What plans does the Church have to roll out that scheme to the rest of England. With Gatwick in my constituency, I would certainly like to see that.

**Reply from Caroline Spelman:** We all understand my hon. Friend's concern because of his constituency's location. The Church is building on the Bishop of Derby's work and intends to launch the Clewer initiative against modern-day slavery in the autumn. It will be designed to combat modern-day slavery across England and provide parishes and dioceses with strategies to detect instances of modern-day slavery.

**Philip Hollobone:** One of the most powerful ways to get any message across is from the personal testimony of victims. A lot of people are realising that human trafficking is hidden in local communities, so what efforts is the Church making to identify and encourage Christian victims of human trafficking to bear witness in their churches and communities?

**Reply from Caroline Spelman:** When I served on the Joint Committee on the draft Modern Slavery Bill, the hidden nature of trafficking became apparent, and Churches can lift the lid on the prevalence of trafficking in the society in which we live. It is incumbent on us all to have our eyes and ears open and to ask questions when we suspect that someone may be being exploited as result of trafficking.

### Human Trafficking

**Jim Shannon** [41718] To ask the right hon. Member for Meriden, representing the Church Commissioners, what steps are being taken by the Church of England to tackle human trafficking.

**Reply from Caroline Spelman:** In March 2014 the Archbishop of Canterbury, with Pope Francis and other global faith leaders, gave their backing to the Global Freedom Network ([www.globalfreedomnetwork.org](http://www.globalfreedomnetwork.org)), a ground breaking ecumenical initiative to combat modern slavery and human trafficking. The Archbishop is planning an international conference in 2017 with the Ecumenical Patriarch. The Bishop of Derby has also been at the forefront of work to tackle human trafficking and modern slavery for the Church of England. He has been part of the Santa Martha Process (which looks to improve collaboration between churches and police in the detection of instances of human trafficking) and has developed strategies in his diocese to combat human trafficking and modern slavery. The Church of England will launch The Clewer Initiative against Modern Day Slavery this autumn. It will provide English dioceses and parishes with strategies for the combating of modern slavery and guidance on how to assist in the provision of victim support and care. The initiative is intended to build on existing capacity and the assistance to dioceses and church networks will be carefully tailored to their specific contexts and needs.

### UK Parliament Early Day Motions

**Greg Mulholland (291) Status of EU nationals in the UK** – That this House expresses strong concern that the Government has not guaranteed the rights of EU nationals to stay in the UK after the country leaves the EU; notes that there are three million EU nationals currently living, working or studying in the UK; further notes that many of them have developed strong family and business ties to the UK; believes that a refusal from the Government to give all these people a guarantee about their long-term status throws their lives into great uncertainty; further believes that all these EU citizens, including families and children, should not be used as bargaining chips to negotiate the terms of a deal under which Britain will leave the EU; urges the Government to consider the strong implications for families, public services and the economy if many EU nationals start to or are forced to leave the UK; and calls on the Government to remove this uncertainty, recognise the huge contribution that EU nationals have made to Britain and, in line with the cross-party consensus, immediately guarantee the rights of all EU nationals already in the UK.

A key part of the strategy was the development of an action plan to help drive the change necessary to secure improvement in outcomes. A draft action plan was considered by the group in August 2015. The group raised a number of issues, which were important in terms of the developing action plan and required further consideration. Work on the strategy was therefore paused to allow a period of reflection. We recognise that there is still much to do to address the needs of Gypsy/Travellers and the further development of the programme of work for Gypsy/Travellers is currently being considered. However, work to improve outcomes for Gypsy/Travellers is continuing. The Scottish Government has provided £200,416 funding from the equality budget in 2015-16 and £229,159 in 2016-17 to organisations working with Gypsy/Travellers to improve outcomes across a range of areas of work. Through the Scottish traveller education review group, we are developing guidance which will be published for consultation in 2016, to improve the educational outcomes of Gypsy/Traveller children and young people. Additionally, the review process for local housing strategies looks at how the needs of Gypsy/Travellers have been considered and addressed (within the strategy), and highlights any concerns to the local authority for further consideration.

### UK Parliament Questions

#### Hate Crime

**Lord Rana:** To ask Her Majesty’s Government, in the light of the reported increase in the incidence of hate speech against immigrants following the referendum on the United Kingdom’s membership of the European Union, what steps they are taking to tackle xenophobia and racist extremism.

**Reply from the Advocate-General for Scotland (Lord Keen of Elie):** My Lords, the Government are committed to tackling hate crime. The United Kingdom has one of the strongest legislative frameworks in the world to tackle it. In terms of recent events, we are working across government, the police, including national community tensions teams, the Crown Prosecution Service and community partners to send out a clear message. Hate crime will not be tolerated and those who commit these reprehensible acts will face the full force of the law.

**Lord Rana:** My Lords, I fear that many hate crimes have occurred against the backdrop of a campaign to which certain elements gave the stamp of racism. Did the Government make any preparations before the referendum for the rise in hate crime? Will the Minister agree that the status of EU citizens and other immigrants in this country must be assured?

**Reply from Lord Keen of Elie:** My Lords, the Government have implemented a series of educational programmes, including by the Anne Frank Trust and the Crown Prosecution Service, which have received the support of the National

Union of Teachers. It is close by this afternoon, I believe. In the circumstances, we have taken steps to address this issue. In addition, a cross-government hate crime action plan is to be published imminently. This will drive forward our proposals to deal with all forms of hate crime.

**Lord Bilimoria:** My Lords, I came to this country from India as a 19 year-old in the 1980s. At the time of the referendum, I received this tweet: “You are not British-born, so your input into the vote of the true Brits is not required and of no interest to true workers”. Last weekend, a member of our team for 16 years who is from abroad, with an English husband, went to hospital with a broken, bloodied finger and was told by somebody waiting next to her, “You are a burden on this country”. What is going on? Will the Minister and the Government acknowledge that this wretched referendum has caused this? Are the Government really doing enough to address something which I have not witnessed in any way for 30 years, but am now witnessing?

**Reply from Lord Keen of Elie:** No matter what may divide us, we are united in this country by shared values of democracy, free speech, mutual respect and opportunity. If we maintain these standards, we can drive out the criminals who would perpetrate the sort of crimes that the noble Lord has referred to.

**Lord Rosser:** My Lords, if there had been no split on Europe within the Conservative Party, there would have been no Conservative Party referendum. If there had been no Conservative Party referendum, there would have been no significant rise in hate crime. Will the Government now at least do the decent thing and accept that what is happening today is because party interest was put in front of national interest? Can the Minister tell us what specific new initiatives or decisions—as opposed to discussions, messages and plans—the Government have taken since the referendum campaign to address the serious and damaging situation they have helped to create?

**Reply from Lord Keen of Elie:** With respect to the noble Lord, it is not appropriate to seek to draw a line between the referendum result and those who have taken it as an opportunity to express xenophobia and racist positions. I think it is obvious to all that the vote in the referendum can be attributed to a split in the Labour Party and not to a split in the Conservative Party.

**Baroness Hussein-Ece:** My Lords, there has been a fivefold increase—500%—in reported hate crime. As we know, the majority of these incidents are not reported. I have been abused online. In the last fortnight, since Brexit, members of my family and people I know, of all colours, races and religions—and of no religion or faith—have been subjected to this. Will the Minister support the initiative by a national coalition of race equality groups, including the Runnymede Trust? These groups have come together to ask for leadership and solidarity from all politicians around this House and in the other place and from the media to reject racism and hate crime and to stop pandering to intolerance. We should have zero tolerance of this kind of behaviour in this country.

**Reply from Lord Keen of Elie:** I agree with the noble Baroness that we, on all sides of this House, are ready to condemn racism and xenophobia. We have a common interest and a common outlook in so far as this is concerned. With regard to the increase in reported race crime, there have been significant increases in the period 2010 to 2016, but one must be careful of these statistics because much of the increase is attributed to the fact that we have introduced a better reporting system, including the reporting portal, True Vision. ...

**Lord Harris of Haringey:** My Lords, it is not simply a question of the referendum campaign making xenophobia and racism respectable again; this is also the responsibility of the Minister’s right honourable friends in the other place who have consistently pandered to this in exactly the same way—for example, the right honourable Theresa May and the campaigns run by the Home Office against illegal immigrants. The Prime Minister’s intervention in the mayoral election in London, talking about extremists,

was all part of the same picture. Is there not a pattern which has led to this increase in xenophobic incidents in the last few weeks?

**Reply from Lord Keen of Elie:** With respect to the noble Lord, nothing makes xenophobia and racism respectable, least of all the referendum.

**Ben Howlett:** On Tuesday evening, a Bath mum, Kerry Parkinson, was travelling home and was hit in the face after confronting a passenger who told their son to “Shut up, or we will send you to Istanbul with the other Muslims to join Isis”. I am sure that whole House will join me in condemning such disgusting racist views and in congratulating Kerry on standing up against hate. Will my right hon. Friend speak to the Home Secretary to see what more can be done to tackle xenophobia in our society and look at staging further debates in the House?

**Reply from Chris Grayling:** That instance is absolutely shocking. We send all our good wishes to my hon. Friend’s constituent for what she has done. Let us be absolutely clear: the Muslim community plays a valuable role in our communities up and down the country. The Muslim community is full of people who have made a real difference to our society, and we should support them. The fact that there are a small number of people in the Islamic world who pursue an ideology of hate that we all stand up against should not in any way tarnish the good, hard-working decent Muslims of this country. We should abhor, tackle and prosecute insults and attacks against them.

It is quite right that we all abhor that, but do we not need to take a stand as a society and prosecute people who take part in such behaviour? **Reply from Chris Grayling:** I wholly agree with the hon. Gentleman. One of the most extraordinary things is that British Asians, who have had nothing whatever to do with the debates in recent weeks, should be singled out in this way. That is a sign of a streak of opinion in our society. I believe that we are as tolerant a society as any in the world, but we none the less have a core of people whose beliefs are disgraceful and whose actions are disgraceful, and when they act in the way that we have seen in recent weeks, there is absolutely no excuse for our police and our prosecuting authorities not to put them in court where they belong.

Data for 2015/16 are due to be published in October 2016.

As stated by the Office for National Statistics, action taken by police forces to improve their compliance with the National Crime Recording Standard has led to improved recording of crime over recent years, especially for violence against the person offences. Together with a greater awareness of hate crime, and improved willingness of victims to come forward, this is likely to be a factor in the increase in hate crimes recorded by the police shown in the table.
