### **Scottish Parliament Questions**

#### Refugees

**Rona Mackay:** To ask the Scottish Government what discussions it has had with the United Kingdom Government regarding Scotland's role in supporting refugees entering the UK. (S50-00481)

**Reply from the Cabinet Secretary for Communities, Social Security and Equalities (Angela Constance):** Scottish Government officials are in regular dialogue with Home Office officials about support for refugees who settle in Scotland. Ministers have also discussed the issue and I discussed the resettlement of refugees and unaccompanied children, among other issues, when I met the immigration minister in October. I am very proud that Scotland has now welcomed around 1,250 Syrian refugees under the Syrian resettlement programme since October 2015.

**Rona Mackay:** I welcome the fact that East Dunbartonshire Council has at long last agreed to take refugees: four families and four unaccompanied children. Does the cabinet secretary agree that, in addition to providing the refugees with housing and education, it is essential that a welcoming committee from the communities involved helps to integrate the families socially by helping with language and local knowledge?

**Reply from Angela Constance:** Like the member, I welcome East Dunbartonshire Council's decision to participate in the resettlement programme. I am pleased to say that, by 2017, all local authorities in Scotland will be involved in supporting refugees to settle in Scotland. It has to be acknowledged that considerable preparatory work needs to be done by local authorities before refugees arrive in their communities to ensure, for example, that the right accommodation, services and supports are in place.

I know that there is a wealth of expertise in the Convention of Scottish Local Authorities, other local authorities and third sector organisations that East Dunbartonshire Council is drawing on as it prepares to welcome refugees. Many councils have engaged closely with their local communities through volunteering programmes or other means to make best use of the enormous good will that is out there to provide befriending and other support, whether it is English language practice or other ways to welcome refugees into our communities. I am pleased to acknowledge that Ms Mackay is working closely with the Twechar healthy living and enterprise centre to arrange a community team to help with that integration from day 1 and to give a very warm welcome to refugees when they arrive in East Dunbartonshire.

## **UK Parliament Questions**

### **Immigration Controls**

The following two questions both received the same answer

**Baroness Jones of Whitchurch** [HL3320] To ask Her Majesty's Government whether they are giving consideration to the establishment of variable immigration rules to take account of the specific needs of the agricultural and food production sectors.

### **Migrant Workers: EU Nationals**

Baroness Jones of Whitchurch [HL3321] To ask Her Majesty's Government what

guarantees of the right to remain will be given to EU citizens living in the UK and working in the agricultural and food production sectors after Brexit.

**Reply from Baroness Williams of Trafford:** The Seasonal Agricultural Workers Scheme and Sectors Based Scheme for agricultural and food production sectors were closed at the end of 2013 when the transitional employment restrictions applied to nationals of Bulgaria and Romania were lifted. Until exit negotiations are concluded, the UK remains a full member of the European Union and all the rights and obligations of EU membership remain in force.

There are a number of options as to how EU migration might work once we have left. We are about to begin these negotiations and it would be wrong to set out further positions in advance. At every step of these negotiations we will work to ensure the best possible outcome for the British people.

The Prime Minister has been clear that she wants to protect the status of EU nationals already living here, and the only circumstances in which that would not be possible is if British citizens' rights in European member states were not protected in return.

### **Overseas Students**

**The Lord Bishop of Winchester** [HL3840] To ask Her Majesty's Government what assessment they have made of the financial contribution of overseas students to the UK economy.

**Reply from Lord Young of Cookham:** The Government estimated in 2013 that overseas students (EU and non-EU) in higher education in the UK contributed  $\pounds$ 9.7 billion to the UK economy in 2011, through tuition fees and living expenditure.

The Department for Education will publish a new estimate of the total value of education exports to the UK economy shortly, based on data from 2014. This will include updated estimates on the financial contribution of overseas students.

### Immigration: International Students

**Lord Holmes of Richmond:** To ask Her Majesty's Government what plans they have to amend the visa requirements for international students and to remove those students from the immigration figures. ...

**Reply from the Minister of State, Home Office (Baroness Williams of Trafford):** My Lords, the Government will shortly be seeking views on a range of proposals to reform the visa system for international students. Like other migrant groups in the UK, international students use public services, contribute to population levels and affect local communities. The independent Office for National Statistics therefore includes international students in its net migration calculations, following international best practice in this regard. ...

**Lord Holmes of Richmond:** ... Can she give the House information on the tier 4 pilot that is being undertaken? What are the results so far and what can be done to extend it to give even greater benefit across the sector?

**Reply from Baroness Williams of Trafford:** ... The four institutions chosen were Oxford, Cambridge, Bath and Imperial College London, which were selected due

to their consistently low level of visa refusals. But the pilot is intentionally narrow in scope in order that its outcomes against the stated objectives can be monitored, and to minimise the risk of unintended consequences. If the pilot is successful we will consider rolling it out more widely.

Lord Morgan: My Lords, has not the Foreign Secretary described the Government's policy in this area as totally crazy and pointed to the fact that the number of Indian students in our universities has roughly halved? He has called for post-study work visas to be restored, and has asked for reassurances to be given to the Indian Government and for international students to be removed from the total of recorded immigration, because it is completely misleading. Would the Minister like to commend the wise words of a sometimes misrepresented colleague?

**Reply from Baroness Williams of Trafford:** My Lords, I do not know who is misrepresenting who but I do not feel that I can speak for the Foreign Secretary. In fact, sometimes I do not know if the Foreign Secretary speaks for others. It is indeed true that Indian student numbers have gone down, but Chinese student numbers have gone up. Indeed, figures for the Russell group have gone up.

**Baroness Smith of Newnham:** My Lords, is not the figure of tens of thousands as a cap on immigration entirely arbitrary? If we accept the importance of international students, they should be taken out of that target. That does not mean taking them out of the OECD numbers, but it does mean that we could look again at the international numbers. I declare my interests as listed in the register.

**Reply from Baroness Williams of Trafford:** My Lords, there is no cap on the number of students who come here. As long as students are compliant with immigration rules, they should make only a very limited contribution to the migration numbers. The Government's ultimate goal is to get migration numbers down to the tens of thousands rather than the hundreds of thousands, but that will take time. ...

### **Entry Clearances**

**Lord Browne of Belmont** [HL3468] To ask Her Majesty's Government how many entry clearance visa applications have been received in the last 12 months for which figures are available.

**Lord Browne of Belmont** [HL3469] To ask Her Majesty's Government how many entry clearance visas have been granted in the last 12 months for which figures are available.

**Reply from Baroness Williams of Trafford:** The information requested for the latest 12 months available is published in table vi\_01\_q (visa data tables volume 1) in 'Immigration Statistics, April - June 2016', available from the GOV.UK website.

In the year ending June 2016, there were 2,866,872 entry clearance visa applications (including visitors and those on transit visas). Over the same period there were 2,457,977 grants. These figures include main applicants and dependents.

### **Immigration: Appeals**

**Paul Blomfield** [53312] To ask the Secretary of State for Justice, how many applications were made to her Department to remit or reduce fees in exceptional circumstances under Article 7 of the First-tier Tribunal (Immigration and Asylum Chamber) Fees Order 2011 in each year from 2011 to 2016; and how many of those applications were granted in each such year.

**Reply from Oliver Heald:** The cost of running our courts and tribunals is unsustainably high. It is absolutely right that those using the system, who can afford it, should pay more to relieve this burden. We make no exception for immigration and asylum cases and these appellants will continue to pay a fee. However, we have suspended the higher fees introduced in October this year. The Lord Chancellor's exceptional power to reduce or remit fees will remain in place, along with exemption and waiver arrangements in particular for those who cannot afford to pay. Our management information system does not collate data on unsuccessful applications for exceptional fee remissions. The number of applications granted since fees were introduced for proceedings in the First-tier Tribunal (Immigration and Asylum Chamber) in December 2011 are set out below:

### Refugees

**Lord Roberts of Llandudno** [HL3692] To ask Her Majesty's Government who will select the refugees coming to the UK as part of the Government's pledge to welcome 20,000 refugees by May 2020.

**Reply from Baroness Williams of Trafford:** The UK sets the criteria and then United Nations High Commissioner for Refugees (UNHCR) identifies and submits potential cases for our consideration. Cases are screened and considered on the papers and we retain the right to reject on security, war crimes or other grounds.

### Refugees

**Lord Hylton** [HL3709] To ask Her Majesty's Government, further to the Written Answer by Baroness Williams of Trafford on 21 November (HL3027), how many persons have been admitted to the UK so far in 2016 under the Mandate resettlement scheme for refugees; and what plans they have to enhance the effectiveness of this scheme.

**Reply from Baroness Williams of Trafford:** Mandate plays an important part in facilitating the resettlement of refugees in various locations across the world. The referral of cases under Mandate is dependent on UNHCR identifying cases which meet its criteria. The number of people resettled under the Mandate scheme is reported in the quarterly immigration statistics.

We continually review processes to ensure Mandate cases are processed as effectively as possible.

### **Refugees: Syria**

**Lord Scriven** [HL3787] To ask Her Majesty's Government, further to the Written Answer by Baroness Williams of Trafford on 1 December (HL3335), and in the light of the inclusion in the vulnerability criteria of persons at risk due to their sexual orientation, how they determine whether people are being accepted into the scheme because of their sexual orientation or gender identity; and how the application of the vulnerability criteria relating to sexual orientation is audited and validated.

**Reply from Baroness Williams of Trafford:** We are clear that our scheme will prioritise the most vulnerable refugees, and that is why under the Syrian Vulnerable Persons Resettlement (VPR) scheme the United Nations High Commissioner for Refugees (UNHCR) identifies refugees for resettlement using its established vulnerability criteria. The seven vulnerability criteria used by the UNHCR are Legal and or Physical Protection Needs; Survivors of Torture and/or Violence; Medical Needs; Women and Girls at Risk; Family Reunification; Children and Adolescents at Risk and Lack of Foreseeable Alternative Durable Solutions.

Persons who are at risk due to their sexual orientation or gender identity are usually referred for resettlement using the category "Legal and Physical Protection Needs", however they can also be referred under one of the other categories if more applicable. We are working with the UNHCR and other partners to intensify their outreach to groups that might otherwise be reluctant to register for fear of stigma or discrimination and who may be unaware of the options available to them.

### **Refugees: Employment**

**Lord Roberts of Llandudno** [HL3695] To ask Her Majesty's Government whether they plan to revise their immigration policy so that refugees welcomed to the UK are able immediately to earn a living.

**Reply from Baroness Williams of Trafford:** Under our current immigration policy all those granted refugee status or humanitarian protection in the UK or resettled under one of our resettlement schemes have immediate access to the labour market.

### **Refugees: Doctors**

**Lord Crisp** [HL3904] To ask Her Majesty's Government what plans they have to support refugees arriving in the UK, who are medical students or trainees, to complete their training.

**Reply from Lord Prior of Brampton:** Health Education England is supporting a range of initiatives to help refugees who are qualified or student health professionals to access support to enable them to complete their training and register, so that they can practice in the United Kingdom. These include language support, work placements and courses to refresh skills and knowledge for those returning to practice.

### Doctors: Refugees

**Lord Crisp** [HL3905] To ask Her Majesty's Government why they have decided not to proceed with the proposed refugee medical fellowships for refugee doctors which were planned for London, Manchester and Oxford.

**Reply from Lord Prior of Brampton:** There are no agreed plans for medical refugee fellowships. However, NHS England has been discussing opportunities, including the idea of fellowships, to provide additional support for refugees who wish to practice as a doctor in the National Health Service in England, to see whether such support would help to increase the number of doctors working in general practice by 2020-21. A decision has yet to be taken on this issue.

### **Universal Credit**

The following two questions both received the same answer

**Baroness Lister of Burtersett** [HL3927] To ask Her Majesty's Government what is the average time taken to make a decision on (1) all universal credit claims, and (2) UK claims relating to individuals who have been granted leave to remain as a refugee.

### **Universal Credit: Refugees**

**Baroness Lister of Burtersett** [HL3928] To ask Her Majesty's Government what evidence, if any, they have of people who have been granted refugee status facing problems claiming universal credit because they do not have a bank account.

**Reply from Lord Freud:** The Department does not track individual claims made by refugees. However, where people have problems getting a bank account, they are not prevented from making a claim for Universal Credit. Furthermore, DWP in conjunction with the Home Office, are currently piloting a new process to assist asylum seekers granted refugee status and needing support to make a claim to benefits.

Officials are currently assessing the data for Universal Credit and will only release information once the necessary quality assurance work has taken place. These statistics will be published in accordance with the relevant protocols in the Code of Practice for official statistics. The Department does not track individual claims made by refugees and therefore this information could only be provided at disproportionate cost.

### Refugees: English Language

**Lord Roberts of Llandudno** [HL3694] To ask Her Majesty's Government what steps they are taking to ensure that English language tuition is available in refugee camps in Jordan, Lebanon, Turkey and the Greek islands to assist those coming to the UK.

**Reply from Baroness Williams of Trafford:** UNHCR counsel refugees before they are resettled under the Government's resettlement schemes. Additional advice is also provided through cultural orientation sessions with practical information about life in the UK and rights and responsibilities. Those arriving in the UK are provided with English language lessons by their receiving local authority.

### Calais: Child Refugees

**Baroness Sheehan:** To ask Her Majesty's Government what is their estimate of the number of children formerly in the Calais camp who will be eligible for transfer to the United Kingdom under their recently published general criteria for eligibility under Section 67 of the Immigration Act 2016.

**Reply from the Minister of State, Home Office (Baroness Williams of Trafford):** My Lords, we are working closely with the French authorities to identify eligible children and transfer them as soon as possible. Since 10 October, we have transferred more than 750 children, including approximately 200 children who meet the criteria for Section 67 of the Immigration Act. More eligible children will be transferred from Europe, in line with the terms of the Immigration Act, and we will continue to meet our obligations under the Dublin regulation.

**Baroness Sheehan:** I thank the Minister for her reply. Section 55 of the Borders, Citizenship and Immigration Act 2009 requires the Secretary of State to safeguard the welfare of asylum-seeking children. Where a child is outside the UK, the spirit of the duty should be applied. Frankly, what I saw on my recent visit to French centres to which children from Calais have been moved makes a mockery of that duty. When will the Government finally transfer to the UK children whose eligibility they themselves established some time ago?

**Reply from Baroness Williams of Trafford:** My Lords, I think I set out in my first answer that that is precisely what we will do.

**Lord Dubs:** My Lords, while I appreciate that children have been dispersed to many parts of France from Calais, have all of them now been contacted by Home Office officials? Do they know their situation? If they have not all been contacted, by when does the Minister think they will be told what will happen to them?

**Reply from Baroness Williams of Trafford:** My Lords, as the noble Lord knows, we have been working closely with the French authorities in line with what they wish us to get involved with. We will continue to do that.

### **Refugees: Children**

**Lord Roberts of Llandudno** [HL3693] To ask Her Majesty's Government how much welcoming each unaccompanied child refugee will cost the UK.

**Reply from Baroness Williams of Trafford:** The Home Office funds local authorities for the care and support of unaccompanied asylum seeking and refugee children. The rates are based on a detailed analysis of financial information sent to the Home Office by local authorities about their actual cost of caring for UASC. The analysis showed that the average cost across all local authorities of looking after a UASC aged under 16 was approximately £41,610 per annum and the average cost of supporting those aged 16 and 17 was approximately £33,215 per annum.

### Asylum

**Diana Johnson** [56172] To ask the Secretary of State for the Home Department, how many and what proportion of her Department's asylum caseworkers are trained in how to treat evidence from the Medico-Legal Report service when making asylum decisions from people who claim to have been tortured in their home country.

Reply from Robert Goodwill: All members of staff who make decisions in

asylum, receive training on inter-national and domestic law and safeguarding issues supplemented by a men-toring programme with an experienced caseworker that can last up to 6 months. Within this course there are specific sections that detail torture and Medico Legal Reports and how they should be used and analysed in asylum claims.

Asylum Operations recently received funding from the Asylum Migration and Integration Fund to review and redevelop its training prospectus. As part of that work, Asylum Operations is liaising with a range of external stakeholders including migrant charities and non-governmental organisations - to ensure a robust and effective safeguarding training product.

Liverpool, Cardiff, Birmingham, London, Wakefield and Glasgow.

### **Asylum: Sexual Orientation**

**Lord Scriven:** To ask Her Majesty's Government how many people claiming asylum in the last year did so on the grounds of sexual orientation or gender identity; and of those, how many have been granted asylum.

**Reply from the Minister of State, Home Office (Baroness Williams of Trafford):** My Lords, the Home Office does not publish statistics on the basis of asylum claims or the decisions arising from them. This is true for claims relating to gender and sexual identity. The Home Office is considering how data from its casework database may be assured and used to provide such information to a sufficiently accurate standard.

Lord Scriven: My Lords, I thank the Minister for that Answer, but those who sit on the Home Office strategic engagement group, set up after the Vine report in June 2014, will be surprised by it. At the last meeting, in September of this year, a senior civil servant said that the only reason that the statistics have not yet been published is because they are waiting for authority from the Minister. Which is wrong: the Answer from the Dispatch Box or the civil servant, who says that they will be published with the authority of the Minister?

**Reply from Baroness Williams of Trafford:** ... However, I can say that the Home Office collects information that records whether a claim is based on sexual orientation, and it is likely to correlate with the claimant's sexual orientation, although an individual may have an asylum claim that is quite distinct from their sexual orientation. The data are management information only—I can assure the noble Lord of that—and they do not form part of our published statistics because they have not been quality assured to a sufficient standard.

**Lord Cashman:** My Lords, claiming asylum on the grounds of sexual orientation and gender identity is deeply intrusive and personal. Often claimants have to prove their sexual orientation by disclosing elements of their private lives. Therefore, given the noble Baroness's commitment to issues of equality, will she work with organisations such as the UK Lesbian & Gay Immigration Group, Stonewall and others to ensure that the approach taken towards them is fair, just and balanced?

**Reply from Baroness Williams of Trafford:** The Home Office works, and continues to work, with groups like Stonewall, and we know that some of the training received by people who process claims has improved and that questions are much more sensitively put than perhaps some of the anecdotal evidence from the past suggests. The 2014 report of the Independent Chief Inspector of Borders and Immigration into the handling of sexual orientation claims praised our guidance. ...

There are a number of specific initiatives to increase the number of organ donors from BAME communities. These include the National BAME Transplant Alliance to coordinate the work of BAME organisations working within these communities, a Peer Educator Project working with the Pakistani Muslim Community in Birmingham and the Bangladeshi community in Tower Hamlets and NHS Blood and Transplant has developed a behaviour change campaign strategy in support of the *Taking Organ Transplantation to 2020: A UK Strategy*. This includes increasing its education and engagement activities with BAME communities and a Faith Action Plan outlining action to work in partnership with faith leaders.

## **UK Parliament Ministerial Statement**

### **Race and Faith Policy**

The Secretary of State for Communities and Local Government (Sajid Javid): Today, I am pleased to inform the House that the UK Government are the first European Union country to formally adopt the International Holocaust Remembrance Alliance working definition of anti-Semitism. The Government believe that the definition, although legally non-binding, is an important tool for criminal justice agencies, and other public bodies to understand how anti- Semitism manifests itself in the 21st century, as it gives examples of the kind of behaviours which depending on the circumstances could constitute anti-Semitism. It will be for public bodies and agencies to implement the definition and embed it within operational guidance as relevant.

In addition, the Government have published its response to the Home Affairs Select Committee's report on anti-Semitism, and provided a progress update to the All-Party Parliamentary Group against Anti-Semitism Inquiry into the rise in the number of anti-Semitic incidents following the Gaza conflict in 2014.

Our response to both reports demonstrates the significant progress we have made in combating anti-Semitism which has been acknowledged by the Home Affairs Select Committee and the All- Party Parliamentary Group against Anti-Semitism. Our approach has also been cited as best practice across Europe and the Americas.

However, we cannot be complacent. Anti-Semitism continues to be a problem in this country and it is right that, as a Government, we are able to demonstrate the seriousness with which we take it, as we do for other forms of hate crime. Anti-Semitism must be understood for what it is—an attack on the identity of people who live, contribute and are valued in our society. Our relationship with the Jewish community has been built on the solid work of the cross-Government working group on tackling anti-Semitism, which ensures that we are alive to any issues and concerns of the Jewish community and can respond quickly.

The adoption of the definition and our positive response to both reports underlines how the Government have done much to establish Britain as a safer place for Jewish people.

**Lord Patel of Bradford:** To ask Her Majesty's Government what assessment they have made of the review by David Lammy MP of racial bias and BAME representation in the criminal justice system.

**Reply from the Advocate-General for Scotland (Lord Keen of Elie):** My Lords, the Government welcome the Lammy review's emerging findings and continue to support it. David Lammy has indicated a number of areas he wants to examine in more detail in the second phase of the review. We look forward to responding to the final report, due in the summer of 2017.

**Lord Patel of Bradford:** My Lords, I thank the Minister for that Answer. I want to give the House some early figures that we already know. The total number of young people held in secure institutions has halved since 2005, which is good. However, over the past 10 years, the number of young black prisoners has risen by 67% and the number of young Asian prisoners by 75%, meaning that one in four prisoners is black or Asian. In contrast, the number of white detainees has dropped from 75% to 60%. Does the Minister agree that these are shocking figures and that we need a vital step change in our policies for and treatment of young black people in the criminal justice system?

**Reply from Lord Keen of Elie:** There is no doubt that a series of complex reasons lie behind the figures that the noble Lord referred to and that custody rates among black, Asian and minority-ethnic males are materially higher than they are in respect of white males. At present and so far in his review, David Lammy has provided research findings rather than final conclusions. He has of course said that he is concerned by those findings but that the issue needs to be explored further before firm conclusions can be drawn.

Lord Marks of Henley-on-Thames: My Lords, the Lammy review raises a number of questions. Will the Government continue after the review to monitor disproportionate outcomes in the criminal justice system using the relative rate index method of analysis pioneered in the UK in the Lammy review? Secondly, does not the finding that black offenders are disproportionately likely to receive custodial sentences highlight the urgent need for greater ethnic diversity among the judiciary, which the Lammy review is now also to consider?

**Reply from Lord Keen of Elie:** We are of course committed to greater diversity within the judiciary, and are endeavouring to take that forward. With regard to the particular statistics that the noble Lord referred to, there are a variety of complex reasons why these figures have emerged. For example, the rate at which black, Asian and minority-ethnic men plead not guilty at Crown Court and go to trial is distinct from those who plead at an earlier stage and perhaps receive a lesser sentence. The Government are not committed to any particular means of analysing the relevant statistics at this time. ...

### **Islam: Tenet of Abrogation**

**Lord Pearson of Rannoch:** To ask Her Majesty's Government whether, as part of their strategy against Islamic terrorism, they will encourage United Kingdom Muslim leaders to re-examine the Muslim tenet of abrogation.

**Reply from the Minister of State, Home Office (Baroness Williams of Trafford):** My Lords, freedom of speech and religion are core values that make our country great. Britain is home to diverse communities, which are free to practise their religion in accordance with the law. The Government's strategy for tackling Islamist terrorism is firmly based on strengthening our partnership with communities, civil society groups and faith organisations across the United Kingdom.

Lord Pearson of Rannoch: My Lords, I thank the noble Baroness for that reply, which was helpful as far as it went. I should explain that Islamic abrogation holds that the Koran's later, violent verses, of which there are many, take precedence over the earlier, peaceful verses, and so it lends support to the jihadists. Have the Government noticed that we can say what we like about any other religion, but we get into all manner of trouble if we try to discuss Islam? If they have noticed, what can they do to encourage civilised national debate about Islam, in the hope that that will encourage our peaceful Muslim friends—who are, of course, in the vast majority—to do more to stand up to their violent co-religionists?

**Reply from Baroness Williams of Trafford:** My Lords, I have to say that I think that the first part of the noble Lord's statement is factually incorrect. We work with communities to make them resilient and we certainly support the discussion of religion, as we are doing now, as we speak. This is a country that prides itself on freedom of speech—unless people are actually inciting others to intolerance or hatred—and that is something of which I am very proud.

Lord Lamont of Lerwick: My Lords, is the Minister aware that a Muslim scholar, whom I consulted today, told me that there is no unanimity in the Islamic world about which verses of the Koran are abrogated by later verses? It is completely wrong of the noble Lord, Lord Pearson, to ascribe the views of some hard-line Wahhabis and Salafists as though they were the views of mainstream Sunni, Sufi and Shia Muslims. That is not the case, and all that the noble Lord does by repeating this—as he has done before—is to undermine the position of moderate Muslims in this country.

**Reply from Baroness Williams of Trafford:** I could not have put it better than my noble friend; that is absolutely right. The vast majority of Muslims in this country share our values and share most of the things that we would aspire to for our children and our communities. We should not make blanket statements about a very small minority. ...
